Note: The comments are those of myself, Robert R. Hill, & are based on my genealogical knowledge and understanding of the matter involved. The figure after a name indicates what known generation that person belongs. The figures were not on the original documents but were placed there by me in order to be more undertanding of whom we were dealing with.

LAND DEEDS OF THE HILL FAMILY OF EDGECOMBE COUNTY, N.C AND OTHER PERSONS SHOWING SOME TYPE OF CONNECTION TO THEM.

Edgecombe County Deed Book 00, Page 91, dated 17 May 1760:

Arthur Bell of Halifax County, N.C. to WILLIAM BENNETT of Northampton County, N.C. for 30 pounds, a tract of 250 acres on the north bank of Peachtree Creek, adjoining Thomas Carney, it being part of a grant bearing date of 25 March 1749.

Wit:

Robert Ruffin Green Hill 4/

Comments: Because of the Wm. Bennet name, I suspect this may have been Green Hill 4/, who married Grace Bennett, daughter of William Bennett, but it might well be Green Hill 4/, son of Robert Hill 3/...

Edgecombe County Deed Book OO, Page 145, dated 3rd Sept. 1760

WILLIAM HILL 4/ of Edgecombe County, N.C. to Cooper Williams of the same county, for 15 pounds current Va. money, 196 acres on Swift Creek, part of land containing 206 acres granted unto William Hill 4/ by Earl of Granville on 8th March 1760/

Cooper Williams is believed to be a son of Wilson Williams. It seems that William Hill 4/ obtained a land grant for this

EDGECOMBE CO. DEED BOOK OO, PAGE 145 DATED 23RD SEPT. 1760:

WILLIAM (W) HILL 4/ of Edgecombe County, N.C. to Cooper Williams, for 15 pounds, a tract of 196 acres on Swift Creek, adjoining Shelley, it being part of a tract of 206 acres granted to said Hill by Earl of Granville on 8th March 1760.

Comments: This was William Hill 4/, a son of Robert Hill 3/ & wife Tabitha. William Hill 4/ had earlier married Charity Lewis and obviously received a land grant of 206 acres on 8th March 1760.

Edgecombe Co. Deed Book 00 (OO?), Page 214, dated 8th October 1760:

WILLIAM (H) HILL 4/ of Edgecombe County, planter, to William Harris of same county, for 18 pounds 10 shillings Virginia money, a tract of 80 acres, lying on both sides of Peachtree Creek, it being part of a patent granted to ROBERT HILL 3/ for 200 acres, bearing (a) date of April 20th, 1745.

Witnesses:

William Lasitter (sic) ABNER (A) HILL 4/ his mark

Note: William Hill 4/ was a son of Robert Hill 3/. The witness, Abner Hill 4/, was another son of Robert Hill 3/. Robert Hill 3/ got the original grant to this property on 20th April 1745 and apparently sold or gave it to his son, William Hill 4/.

Deed Book 1, Page 379, dated 1st April 1761:

THOMAS (X) HILL SENIOR 4/ and wife SARAH, of Halifax County, N.C. to Benjamin Whealese Sr., for 50 pounds Virginia Money, a tract of 412 acres, lying on both sides of Swift Creek, adjoining John Phillip Shelley and said Whealese, it being a grant to THOMAS HILL SR. 4/, bearing a date of April 5th, 1762. Benjamin Whealese and Benjamin Rice were chain carriers for the surveyor.

Comments: This Thomas Hill 4/ was son of Robert Hill 3/ & wife Tabitha. Wife was Sarah Etheridge. The deed is dataed before the land was obtained from a grant and is questioned.

EDGECOMBE CO. DEED BOOK OO, PAGE 311, DATED 23 MAY 1761:

ABNER (A) HILL 4/, of Edgecombe County, N.C., planter, to James Mathias of same county, planter, for 20 pounds, a tract of 200 acres lying on both sides of Peachtree Creek, it being part of a tract of 543 acres granted to said Hill bearing date of 30th December 1760.

Comments: We must be careful here. I believe this to be Abner Hill 4/, son of Robert Hill 3/, primarily due to the location of land on Peachtree Creek and in Edgecombe County, but a study of land deeds in Orange & Chatham County seems to show there was an Abner Hill, the son of a Sion Hill of Greenville County, Va., and possibly the brother of Robert Hill 3/. This particular Abner Hill, of Chatham County, is suspected to have married Sarah Mathias. The fact that a James Mathias buys this land and a Isaac Mathias witnessed the above deed signals us to be careful in our evaluation.

Edgecombe Co. Deed Book 1, Page 29, dated 11th Sept. 1761: William Barmor of -----to THOMAS HILL 4/ of Halifax County, planter, for 22 pounds, 2 shillings 6 pence current money, a tract of (?) acres on the south bank of Fishing Creek, according to a deed granted to William----? bearing date of March 7th 1755.

Comments: This buyer was Thomas Hill 4/ son of Robert Hill 3/ & wife Tabitha, and the witness, Thomas Hill, was probably Thomas Hill Jr. 5/, son of this Thomas Hill 4/.

Edgecombe Co. Deed Book OO, Page 362, dated 21st Sept. 1761:

Phillip Shelly of Edgecombe County to THOMAS LEWIS of Halifax County for 15 pounds current money of Va., a tract of 100 acres on the Creek, which land was granted to John Phillip Shelly by patent bearing date of April 20th, 1745.

Comments: Thomas Lewis was the brother in law of William Hill 4/, one of the witnesses, who was married to Charity Lewis, sister of Thomas Lewis. Both Thomas & Charity Lewis were children of Richard Lewis & Ann Lewis.

Edgecombe Co. Deed Book 1, Page 27, dated 16th December 1761:

(First of two land sales on same day & year)

Thomas Davis of Halifax County, N.C. to SION HILL 4/ of same (county), for 10 pounds Proclamation money, a tract of 118 acres on Great Peachtree Creek and Beaver Dam Branch, adjoining ROBERT HILL 3/ and Bass, it being part of a tract of 618 acres granted to Davis.

Witnesses: William Davis Edward Moore Arthur Smith

Comments: This shows that Thomas Davis had once obtained a grant of 618 acres of land but was selling part of it (118 acres) to Sion Hill 4/. Sion Hill 4/ was buying this land that was adjacent to the land of his father, Robert Hill 3/.

Edgecombe Co. Deed Book 1, Page 19, dated 16 December 1761:

(Second of two land sales on same day and year)

Thomas Davis of Halifax Co., N.C. to Thomas Hardiman of Edgecombe County, for 37 pounds 5 shillings, Proc. money, (sells) the remainder (500 acres) of a 618 acres grant from Earl of Granville bearing date of March---, 1761, after deducting from this a tract 118 acres conveyed to said Davis by SION HILL 4/.

Wit: Edward Moore Wm. Davis Arthur Smith

Comments: This deed shows that Thomas Davis had received a land grant in March of 1761. Just prior to this sale, on this very same day (16th December 1761, Thomas Davis had sold 118 acres of this 618 acres to Sion Hill 4/, son of Robert Hill 3/, then he sold to Thomas Hardiman, the remaining 500 acres of the 616 acres to Thomas Hardiman.

Later, Sion Hill 4/ then conveyed the land that was obtained

from both his father Robert Hill 3/ & Thomas Davis, to his brother Green Hill 4/ in 1762. A deed later on shows Green Hill 4/ was combining & selling the two tracts of land, as one tract (318 acres), to Isaac Bass, who along with Robert Hill 3/ had obtained a land grant.

Edgecombe Co. Deed Book 1, Page 101, dated 20th March 1762:

THOMAS (mark) LEWIS of Halifax County, N.C. to WILLIAM HILL 4/ of Edgecombe County, for 18 pounds current money of Virginia, a tract of 100 acres of Swift Creek.

Witnesses: Thomas Mann Wilson Williams Benjamin Bridges

Comments: The buyer, William Hill 4/, was a son of Robert Hill 3/ & wife Tabitha and the brother in law of Thomas Lewis, the seller. William Hill 4/ married Charity Lewis, sister of Thomas Lewis and a daughter of Richard Lewis & wife Ann Lewis. Richard Lewis d. ca. 1761 and his widow, Ann, remarried to Wilson Williams, one of the witnesses. Wilson Williams also was a witness to the 1762 Will of Robert Hill 3/, father of the buyer, William Hill 4/. Wilson Williams had a daughter (Mary or Martha) that married a Hill. (Ref: his will).

Edgecombe Co. Deed Boo 1, Page 379, dated 1st April 1762:

THOMAS (X) HILL SR. 4/ and wife SARAH, of Halifax Co., to Benjamin Whealeses Sr. for 50 pounds Va. money, a tract of 412 acres, lying on both sides of Swift Creek, adjoining (lands) of John Phillip Shelley and said Whealses, it being a grant to Thomas Hill Sr. 4/, bearing date of 5th April 1762. Benjamin Wheales & Benjamin Rice were chain carriers for the surveyor.

Wit: Elias Hillard Benj. Whealess (sic)

Comments: Notice the date of the grant to Thomas Hill Sr. 4/ & the date of this sale. The grant was dated four days before the land grant was made to Thomas Hill Sr. 4/. Since Thomas Hill 4/ was Lord Proprietor for the Earl of Granville, it would seem to show that Thomas 4/ knew he would obtain the grant on the 5th of April 1762 but went ahead and sold it on the 1st of April 1762 or four days before the actual grant was made. Speculation on my part.

Edgecombe County Deed Book 1, PAGE 317, dated 16th June 1762: THOMAS (T) HILL of Halifax County N.C. to GREEN HILL of Edgecombe County, June 16th 1762, for L20 Virginia money, a 200 acre plantation on the south bank of Peachtree Creek Creek, it being part of a tract granted to Robert Hill 3/ by patent bearing date of May 7th, 1742.

Wit: Henry Hill Matthew Gibbs Sion (x) Hill

Comments: Based upon the date, location & fact that the land was once Robert Hill's 3/, this seems to be Thomas Hill 4/, son of Robert Hill 3/ selling land to his older brother, Green Hill 4/. It was witnessed by another son of Robert Hill's 3/, Sion Hill 4/ & Matthew Gibbs, who later married Milbry Hill 4/, youngest child & daughter of Robert Hill 3/ and a sister to Thomas Hill 4/, Green Hill 4/, Sion Hill 4/.

Henry Hill may be Henry Hill 5/, a son of Thomas Hill 4/. This Henry Hill 5/ has been said in a court record (law suit) of Halifax County to be a son of Thomas Hill 4/, even though no other record shows this, including the will of Thomas Hill 4/. That can be explained as Henry Hill 5/ died before his father made his will. This Henry Hill's 5/ wife was Winifred Alston, daughter of Phillip Alston. They had a daughter named Elizabeth Henry Hill 6/. Many researchers had speculated that it was Henry Hill 5/, son of Green Hill 4/ & Grace Bennett that had married Winifred Alston, but this court record seems to imply differently.

Edgecombe Co. Deed Book 1, Page 334, dated 1762:

SION (X) HILL 4/ of Halifax County, N.C. to GREEN HILL 4/, of Edgecombe County, for 20 pounds Proc. (Proclamation) money, a tract of 118 acres on the bank of Great Peachtree Creek near Beaver Dam Branch, adjoining Robert Hill 3/ & Isaac Bass. The-

Here the copier unknowingly cut the deed off.

Comments: This is sad as this deed seems to have been between two brothers, Sion Hill 4/ & Green Hill 4/, both sons of Robert Hill 3/, and of whom we know very little. The 118 acres seems to have been the land that Sion Hill 4/ purchased from Thomas Davis on 16th December 1761 (see deed listed further above). If we knew the date of the grant to Robert Hill 3/ and the date it was conveyed to son Sion Hill 4/ it would perhaps help to determined the age of both Sion Hill 4/ & his brother Green Hill 4/. TOO BAD!

Edgecombe Co. Deed Book C, Page 26, dated 4th March 1763: William Bennett of Northampton County N.C. to Nathan Boddie of Edgecombe County, N.C. for 40 pounds Proclamation money, a tract of 250 acres on the north bank of Peachtree Creek, adjoining Thomas Kerney, it being part of a grant deed bearing date of 25th March 1749.

Wit: Samuel Ruffin William Boddie G. Hill (Green Hill?)

Comments: The witness G. Hill could be the son of Robert Hill 3/ but I am inclined to think it was Green Hill Jr. 5/, son of Green Hill Sr. 4/ & Grace Bennett.

Edgecombe Co. Deed Book C, page 29, dated 17 March 1763:

Willebe (W) Tucker of Edgecombe County to WILLIAM LASSETER of Granville County, N.C. for 40 pounds Va. money, two tracts of land: (1) 75 acres on the north bank of the Creek, it being part of a patent of land granted to Robert Hill 3/, bearing date of May 17th, 1742; (2) a tract of 150 acres on Horse Pen Branch, adjoining Robert Rodgers & John Rodgers, it being part of a Granville grant to said Willeby Tucker bearing date of June 1st 1762.

Wit: Nathan Boddie Micajah Thomas

Comments: Obviously this Robert Hill mentioned, was Robert Hill 3/. Note the date that Robert Hill 3/ received the land grant of 75 acres was 17th May 1742.

Edgecombe Co. Deed Book C, Page 68, dated 9th September 1763:

TABITHA HILL COLWELL, late the wife of Edward Colwell, deceased, of Edgecombe County, to SARAH COLWELL, the widow of John Colwell, deceased, of same county, for 10 pounds a tract of 300 acres of land on the south side of Tar River, purchased by said Edward Colwell, deceased, from Francis Williamson on 4th September 1752 and conveyed by said Edward Colwell, to John Colwell, reserving to said Edward Colwell and his wife Tabitha Hill Colwell, a lifetime right in the land.

Wit: John Flew John King Estes Comments: Was this Tabitha Hill 4/, daughter of Robert Hill 3/, with a previous unknonw marriage? At first glance, it appears not as she is listed as having married David Chapman Sr. ca. 1737 BUT what if she was by this time remarried to David Chapman, had Chapman children BUT, due to some legal reasons, was having to use her previously married name (Colwell) in order to transfer this land over? If, so, then the married date to David Chapman was after 1752.

Tabitha Hill 4/ was one of the eldest of eleven children of Robert Hill 3/. She is thought to have been born ca. 177 and married David Chapman ca. 1737. Just who this Tabitha Hill was that was married to Edward Colwell is unknown. I personally suspect this Tabitha Hill Colwell was a daughter of either Sion Hill 4/, Green Hill 4/ or Abner Hill 4/, all sons of Robert Hill 3/ & wife Tabitha (West?). This needs to be explored more thoroughly.

Edgecombe Co. Deed Book C, Page 207, dated 29th October 1763:

THOMAS (T) HILL 4/, of Halifax County, N.C. to Francis War of Edgecombe County, for 20 pounds Virginia money, a tract of 100 acres on the south bank of Fishing Creek (in Edgecombe Co.) adjoining Blunt, according to a deed granted to said Hill bearing date of 11th September 1761.

Signed Thomas (T) Hill 4/. mark?

Wits: Thomas Hill Jr. 5/ Henry (H) Hazel mark?

Comments: This was Thomas Hill Sr. 4/ who married Sarah Etheridge and who resided in Halifax County, N.C. Thomas Hill Jr. 5/ was his son. This Thomas Hill Sr. 4/ was a brother of Sion Hill 4/, William Hill 4/, Green Hill 4/, Abner Hill 4/, Tabitha Hill Chapman 4/, Agnes Hill Harrington 4/, Lawrana Hill Arrington 4/, Ann Hill Steed 4/, Mary Hill Bryant 4/ & Milbry Hill Gibbs 4/, all children of Robert Hill 3/ & wife Tabitha.

Edgecombe Co. Deed Book C Page 143, dated 2nd December 1763 or 1764:

William (x) Bennett, elder of Northampton County, N.C. to William Ruffin, for (?) current money of Virginia, a tract of 200 acres on the north side of Sapony Swamp, it being a tract of land (granted?) bearing date of October 31st, 1753.

Wit: Green Hill 5/ Robert Ruffin Comments: This seems to be Rev. Green Hill Jr. 5/ and his

son, Bennett Hill 6/ as witnesses.

EDGECOMBE CO. DEED BOOK C, PAGE 206 DATED 18TH JANUARY 1764:

William MeGee (sic) of Edgecombe County to ABNER HILL 4/, of same county, for 20 pounds Virginia money, a tract of 377 acres adjoining said Abner Hill 4/, it being a tract granted to said MeGee by Earl of Granville, bearing date of 13th December 1760.

Comments: This was Abner Hill 4/, a son of Robert Hill 3/ & wife Tabitha. He was a brother of Sion Hill 4/, Green Hill 4/ Thomas Hill 4/ & William Hill 4/.

EDGECOMBE CO. DEED BOOK C, PAGE 214, DATED 23 FEBRUARY 1764:

George Holder and wife Mary (x) Holder of Edgecombe County, N.C. to Lemuell Sugg of same county, for 13 pounds 6 shillings 8 pence of Proclamation money, a tract of 100 acres on the south bank of Town Creek, which land was conveyed to George Holder from Jacob Dun (Dunn?) by deed bearing date of 13 June 1764(?)

Comments: James Hill 6/, the witness, was probably James Jones Hill 6/, the son of William Hill 5/ & Mary "Polly" Jones, a son of Green Hill Sr. 4/ & Grace Bennett, son of Richard Hill 3/ & Hannah Briggs, a son of Sion Hill Sr. 2/ & Elizabeth (Smith) Spiltimber, the son of the immigrant Robert Hill 1/ & wife Mary Webb.

Edgecombe Co. Deed Book C, Page 244, dated 1st March 1764:

CHARLES HERRINGTON (ARRINGTON-HARRINGTON) OF Orange County, N.C. to Eley Williams, for 35 pounds Virginia money, a tract of 380 acres on the north bank of Peachtree Creek and on Bare Branch, adjoining William Hill 4/ and John Odom in Edgecombe County, and Drury Herrington (Arrington-Harrington) in Granville County, it lying partly in both counties.

Nathan Whitehead Wilson Williams WILLIAM (H) HILL 4/.

Comments: Charles Arrington married Agnes Hill 4/, a daughter of Robert Hill 3/ & wife Tabitha. She was the sister to William Hill 4/, one of the witnesses. Apparently this land was right on the county line between Edgecombe County and Granville County, which in 1746 split from Edgecombe County. Drury Arrington was a son of Charles Arrington & Agnes Hill 4/.

Edgecombe Co. Deed Book C, Page 239, Dated 22 May 1764:

William Davidson of Edgecombe County to JAMES HILL 6/ of same county, for 150 pounds Proclamation money, one certain lot in the town of Tarborough (Tarboro) on Trade Street, known as Lot No. 80 in the plan of the town.

Comments: This was probably James Jones Hill 6/, the son of William Bennett Hill 5/ & Mary (Polly) Jones, a son of Green Hill Sr 4/ & Grace Bennett.

Anthony Warwick of Nansemond County, Virginia to JAMES HILL 6/ of Edgecombe County, N.C. for 100 pounds Virginia money, one lot in the Town of Tarborough (Tarboro), known as Lot No. 80 in the plan of the town.

Comments: This was James Hill 6/, son of William Bennett Hill 5/ & Mary Polly Moore, son of Green Hill Sr. 4/ & Grace Bennett.

Edgecombe Co. Deed Book C, Page 352, dated 12th April 1765:

GREEN HILL 4/ of Edgecombe County to Isaac Bass of same county, for 25 pounds, 2 shillings 6 pence Virginia money, two tracts of land joining in one tract of 318 acres: (1) 200 acres on Great Peachtree Creek, it being part of a patent

granted to Robert Hill 3/ bearing date of May 7th, 1742: (2) 118 acres on the Creek adjoining Robert Hill 3/ & Isaac Bass, as by a deed from Thomas Davis to Sion Hill 4/ on December 16th, 1761 and (then) conveyed from Sion Hill 4/ to said Green Hill 4/ by deed bearing date of 1762.

Comments: This deed shows that Robert Hill 3/ had received a land grant of 200 acres on May 7th, 1742 & apparently on some un-given date, conveyed the 200 acres to his son Sion Hill 4/. Thomas Davis, who's land was adjacent to the aforesaid mentioned land, then sold 118 acres of his land to Sion Hill 4/ on the 16th of December 1761. Then sometime in 1762, Sion Hill 4/ then combined and conveyed the land that was obtained from both his father (200 acres) and the land obtained from Thomas Davis (118 acres) for a total of 318 acres, to his brother Green Hill 4/. This deed now shows Green Hill 4/ was selling the two tracts of land that he had received from his brother Sion Hill 4/, as one tract (318 acres), to Isaac Bass.

EDGECOMBE CO. DEED BOOK C, PAGE 412, DATED 20TH MAY 1766:

ABNER (U) HILL, of Orange County, N.C. to William Andrews of Edgecombe County, N.C. for 62 pounds, 10 shillings Proclamation money, a tract of 200 acres on the north bank of Turkey Creek (in Edgecombe Co.).

Comments: This Abner Hill of Orange County, was NOT the son of Robert Hill 3/ as many say BUT WAS the son of a Sion Hill of Greenville County, Virginia and it appears (to me) that this was Sion Hill Jr. 3/, brother of Robert Hill 3/. This Abner Hill married Sarah -- believed to be Sarah Mathias.

EDGECOMBE CO. DEED BOOK C. PAGE 416, DATED 20TH MAY 1766:

ABNER (X) HILL of Orange County to William Ross (of Edgecombe Co.), for 4 pounds Proclamation money, 28 acres on the north bank of Turkey Creek.

Comments: Notice this was same date as previous deed and the same witnesses. This Abner Hill was the son of a Sion Hill (Sion Hill Jr. 3/?) of Greenville County, Va.

John Norwood and wife Leah of Bute County, N.C. to Jacob Sessums of Edgecombe County, for 90 pounds Virginia money, two tracts of and: (1) 190 acres on Maple Swamp adjoining said Sessums and Bird, formerly Price: (2) 100 acres adjoining both parties.

Comments: This shows that Green Hill Jr. 5/ signed as a witness and since he signed as Junior indicates that his father, Green Hill Sr. 4/ was probably still alive. The Ben Hill that signed as witness may be Benjamin Hill 6/, a son of Bennett Hill 5/ of Franklin County, N.C.

EDGECOMBE CO. DEED BOOK C, PAGE 467, DATED 17TH JUNE 1767:

JAMES HILL 6/ and wife BARBARY of Edgecombe County, N.C. to William McClellan of Edgecombe County and James Gibson and Josiah Granberry of Nansemond County, Virginia, for 25 pounds Virginia money, one lot in the town of Tarborough (Tarboro) on Trade Street, known as Lot 80 in the plan of the town.

Barbary Hill was examined separately concerning her right of dower.

Comments: This was James Jones Hill 6/, son of William Bennett Hill 5/ & Mary (Polly) Jones.

Agnes Hill 4/ was born 1729, d. 1797 in Chatham County, N.C. She was married in Fayette District of Chatham County to Charles Arrington Sr. At some later time, the name was changed to Harrington. Charles Harrington was a Revolutionary Soldier and was wounded in the Battle of Alamance, now in Alamance County. He later died on the wounds sometime after May of 1771 but before July 19th, 1773.

Could this long delay be a result of the death of William Clanton Hill Sr. 4/ (in

FOLLOWING TAKEN FROM PENSIONS ROLLS, DAR ROISTER OF CHATHAM COUNTY, N.C.

Abner Hill, Thomas Hill, both were appointed Captains by the Provincial Congress. Abner Hill was later a Presiding Justice of Chatham County, N.C.

Comments: Abner & Thomas Hill have been thought to have been Abner Hill 4/ & Thomas Hill 4/, sons of Robert Hill 3/. That may be true for Thomas Hill BUT according to information taken from land Deeds, it appears that this Abner Hill was the son of a Sion Hill of Greenville County, Virginia who is thought to have been Sion Hill Jr. 3/, a brother of Robert Hill 3/, both sons of Sion Hill Sr. 2/ & Elizabeth Spiltimber.

Obviously, Thomas G. (Gilliam?) Hill had died prior to the 14th of April 1848. The unnamed widow, with sons Fielding Hill, Green Hill & Asa Hill were buyers of the estate.

What connection does this family have to the Thomas G. Hill, who died ca. 1795 in Warren Co., Ga. who married Phoebe Brantley and who had a son Fielding Hill)? This needs to be checked out.

Comments by Robert Hill: Richard Hill 5/, son of son of Thomas Hill Sr. 4/ & Sarah Etheridge, of Halifax County, N.C.

married a wopman nnamed FRances and moved into Johnson Co., NC. Later, they moved to Warren Co., GA. I think Thomas G. Hill was a son of Richard Hill 5/, I think that the above Thomas G. Hill was the Thomas G. Hill 6/ that married Phoebe Brantley and who died in Warren County, Ga. They were the parents of a Fielding Hill 7/ but is it the same family that is mentioned above?

Information below taken from "Family Puzzlers, Number 1085, Page 13:

Warren County, Georgia: Phoebe Hill applied for letters of dismission as administratrix of the estate of Thomas Hill, deceased, on May 10th, 1795.

Henry Height was appointed guardian of Fielding Hill, the son of the deceased Thomas Hill & Phoebe (Brantley) Hill, February (Court?) 1800.

A Fielding Hill married Isabelle Gibson on 30th January 1812.

Phillip Brantley's will in 1819 mentioned his daughter Phoebe Height and her son, Fielding Hill.

Wylie Gilbert Height married Nancy Brantley on 19th of December 1811 and named a son, Fielding Height. It is suspected that he was a son of Henry Height & Phoebe (Brantley) Hill Height and a half brother of Fielding Hill.

In the 1850 census of Warren County, Georgia, Henry Height had Amanda Hill, age 43 (b. ca. 1807) living in is household.

There is no doubt that Phoebe Brantley first married Thomas G. Hill, who I believe was named Thomas Garner Hill 6/, a son of Thomas Hill Jr. 5/ of Halifax County, N.C. and Elizabeth Garner. Thomas Hill Jr. 5/ was a son of Thomas Hill Sr. 4/ & Sarah Etheridge of Halifax County, N.C. This still has to be proved!

It is not clear as yet what the connection is, but I do not think there is much doubt that this family of Hills was somehow related to the Hills of Edgecombe, Nash & Halifax County, N.C.
