Note by R. Hill: In the book "East Goes West," by Craft, William Hill Sr. 1/ (known as the Elder) is listed as a 4th generation son of Sion Hill Jr. 3/ son of Sion Hill Sr. 2/ son of the emigrant Robert Hill 1/ & Mary Webb.

Since this writer (and others) are completely convinced that this particular William Hill Sr. was NOT related, or part of the preceding Robert Hill family of Surry County, Virginia (i.e. Robert 1/; Sion 2/; Sion Jr. 3/) this William Hill Sr. is being listed as a first known generation and all of his children are therefore listed as a 2nd (known) generations. I believe that Wm. Hill's Sr. family originated in Maryland. He was born ca. 1710 in Caroline Co., Va. There children:

Details for children listed below. REVEREND WILLIAM HILL JR. 2/.

1. William Hill Jr. 2/ was born in 1737 in Caroline County, Virginia. He died on the 29th of September 1792 in Rockingham County, North Carolina. Note: Court records in Guilford Co., NC shows he was dead by February 1785.

{Note: This death date in bold print is wrong! Win Jacob says a Mr. Jeff Brdley has found a court document dated February 1st, 1785 that shows Rev. William Hill Jr 2/ was dead prior to to this date and his widow Elizabeth Halbert applied to administer the estate. She later remarried John

Glenn Jr. Court records support death ca. 1785.

The death of September 1792, seems to be the death of another William Hill, who lived on Fisher River.

Rev. Hill married in January of 1758 to Hannah Elizabeth Halbert in Carolina County, Virginia. WRONG!

NOTE: [Another error. CA 1764 ourt paper from Caroline Co., Va. shows that Elizabeth Halbert was a single female and a ward of her mother, Frances Halbert due to the death of the father, Joel Halbert Sr)]. They married between 1764 and 1770 when they arrived in NC. SHE WAS NOT THE MOTHER OF THOMAS HILL, BORN 1759. Alos, there is no evidence or documentation to show she was named Hannah, as is listed frequently).

Elizabeth was born on the 17th of September 1742 in Carolina County, Virginia and died in North Carolina. She was a daughter of Joel Halbert & Elizabeth Frances Jones.

William Hill Jr. 2/ & wife Elizabeth had eight children: See notation above.

Elizabeth Halbert WAS NOT the mother of any Thomas Hill.. Ref: Estate Papers, of Rev. Hill in Guilford & Rockingham Counnties of NC naming children.

- A James Hill 3/, second child, born 25th July 1761 in Guilford County, (today's Rockingham County), N.C. NotE; Questionable birth date and location. The mother was still single in 1764 in Va. (Ref: Court record of Caroline Co., Va). The father, Rev. Eiliam Hill died not arrive in NC until 1770. I estimate his birth In Carolne, Va. ca. 1768. He is listed as marrying Nancy Royalty on the 6th of June 1789 in Surry County, N.C. She was the daughter of Isham & Catherine Royalty. She was born on the 22nd of February 1768 in Albemarle County, Virginia and died after the 8th of September 1834. James Hill 3/ died in Claiborne County, Tennessee in 1833 or 1834.
- B. Elizabeth Hill 3/, born ca. 1768 in North Carolina, married John Moore ca. 1795. No other information.
- C. William Hill III 3/, born on the 23rd of September 1773 in Surry County, N.C. (now Stokes Co.), married Sarah Geddy in January 1803, daughter of Colonel John Geddy,a staunch Whig. She died on the 4th of February 1833. William Hill III 3/ later married 2nd time to Frances (Conner) Blount, widow of Joseph Blount III. William Hill III 3/ died in Raleigh, N.C. on the 29th of October 1857.

- D. Cynthia Hill 3/, born ca. 1776 in Surry County, N.C., married a Mr. Crawford in 1848. No other information.
- E. Frances (Franky) Hill 3/, born ca. 1778, married on the 26th of January 1796 to Major Mark Hardin (1776-1812).
- F. John Hill 3/, born ca. 1780 in Surry County, N.C. (Ref. to a Surry County, N.C. Land Transaction, Book 3, Page 57), John Hill of Davidson County, Tennessee, sold "all his part of a certain tract on Ash Camp Creek, where the Rev. William Hill Jr. 2/ (deceased) lived and which he (the said John Hill) is entitled to as one of the heirs of said William Hill," containing 464 acres, "undivided" to William Hill 3/ of city of Raleigh, N.C. for 100 pounds. This was John Hill 3/ selling to his older brother, William Hill III 3/.
- G. Green Hill 3/, born ca. 1782 in Surry County, N.C.He married Nancy Mitchell, went to Wake County, NC & died there. No other information. (He may be a Green Berry Hill but in any case, he was not related to those in the Surry Co., Va family. Note by Robert Hill of Brandon, Fl: I think this is the man that Rev. Baines got nfused with when he stated Wm. Hil Sr (b. 1714 in Caroline Co., Va. & m. Susannah Smithers) was son of Sion Hill Jr. 3/. That is absolutely incorrect!
- H. Mary (Polly) Hill, listed as m. Thomas Gibbons. THis was the wrong Mary Hill. She was the youngerst sister of Thomas Hill and the parents were another William Hill & Hannah Bridges.

ELIZABETH HILL 2/.

3. Elizabeth Hill 2/, 2nd child of William Hill & Suisannah

Smithers, born September 18th, 1747 in Caroline Coo., Va. She m. in 1765 to William Halbert. She d, at Belton in Anderson Co., SC on November 6th, 1836

CAPTAIN ROBERT HILL 2/.

4. Captain Robert Hill 2/ was the fourth child of William Hill Sr. 1/ (1710-1787) and Susannah Smither. He was called Captain Robert Hill due to his military service in the Revolutionary War and to help separate him from many other Robert Hills listed.

Robert Hill 2/ was born on the 17th of February 1752 in Caroline County, Virginia. (Some other sources say he was born on the 19th of February 1752). He died on the 2nd of August 1834 in Stokes County, N.C. He will was drawn up on the 6th of April 1833 and was probated in September of 1834.

Robert Hill 2/ married Martha Halbert in September of 1769 in Henderson County, South Carolina. Martha was born in 1750 in Caroline County, Virginia and was the daughter of Joel Halbert Sr. (1712-1762) and Frances Elizabeth Jones.

Martha Halbert Hill died on the 20th of September 1833 and according to information from a grandson, Dr. L. H. Hill 4/, both are buried in the Hill cemetery, located four miles west of Walnut Cove, in Stokes County, N.C.

Robert Hill 2/ served in the army during the Revolution from 1776 until 1781. Since he was a resident of Surry County, N.C. he started as a Private in the North Carolina Regiments. In 1780 he was a Lieutenant in Captain William Meredith's Company and early in 1781 he was a Captain under Major Joseph Winston's and Colonel Robert Smith's Companies.

It appears that all of the children of Robert Hill 2/ and Martha Halbert were born in Stokes County, N.C. This information comes from a letter by the grandson, Dr. L.H. Hill 4/, to his grandson, William C. Rierson 6/. children:

- A. Susannah Hill 3/, born on the 25th of June 1770, she married Edmund Samuel on the 15th of March 1788 (marriage bond # 147222), Surry Co., N.C. He was born in 1767 and died in 1833.
- B. William Hill 3/, born on the 8th of April 1773, died young. He was not named in the Will of his father.
- C. Caleb Hill 3/, born on the 12th of July 1775, died in either Bone or Cooper County, Missouri. He married on the 28th of December 1797 in Stokes Co., N.C. to Mary (Nancy?) Flint.
- D. Elizabeth (Betsy) Hill 3/, born on the 17th of

September 1777. She died on the 23rd of January 1853, Walkerstown, Forsyth County, N.C. She married on the 21st or 27th of October 1797 in Stokes County, N.C. to Tandy Matthews, born in April of 1775 or 1777 and who died on the 11th of August 1856. They had 10 children.

- E. Joel Hill 3/, was born on the 4th of July 1780 and died on the 12th of September 1857 in Stokes County, N.C. His marriage bond was issued on the 28th of January 1813 in Stokes County, N.C. for a marriage to Mildred Golding. She was born on the 29th of December 1794 and died on the 20th of September 1869. They are buried in the Hill Cemetery in Stokes County, N.C. They had 12 children and Dr. L. D. Hill 4/ was the youngest son.
- F. Sarah (Sallie) Hill 3/, was born on the 30th of December 1782 and died on the 20th of September 1805 in Stokes County, N.C. She is buried in the Hill Cemetery of that county.
- G. Martha (Patsy) Hill 3/, (said to be a twin of Robert Hill Jr. 3/) was born on the 30th of December 1785, and died in Stokes County, N.C. (no date listed). She married on the 3rd of March 1810 to William G. Haynes. They had one daughter.
- H. Robert Hill Jr. 3/, (said to be a twin of Martha Hill 3/) was born on the 30th of December 1785. He died in Surry Co., N.C. in 1844. He married Elizabeth Vest on the 9th of May 1807 in Stokes County, N.C. Elizabeth Vest was born on the 9th of May in 1787 and died ca. 1870. Both are buried at Hill's Chapel Church (Hill Cemetery?) in Stokes Co., N.C.
- Frances Hill 3/, was born on the 23rd of February 1788, and was dead by 1833. She married on the 25th of July 1809 to Thomas Locke Davis, born 2nd September 1789 in Virginia.
- J. John Hill 3/, born on the 9th of September 1797 at Germantown, Stokes County, N.C. I personally think his birth date is wrong and should probably be 1787 but it has been listed as 1797 in two different sources, this is listed as such. He died on the 25th of May 1861 at Raleigh, Wake County, N.C., the day before N.C. seceded from the Union. He married Julia Crawford in 1819. He served various times for the government from 1819 until his death. He was Clerk of Court for Stokes Co., N.C.

UEL HILL 2/.

5. Uel/Ewell Hill 2/ was the fifth child of William Hill Sr. 1/ & his wife Susanna Smither. Some sources question if Susanna was the mother of Uel Hill 2/. Research has not found any marriage of William Hill Sr to anyone except Susannah Smithers. Perhaps Elizabeth Williams married another William Hill.

Uel Hill 2/ was born ca. 1755 in Caroline County, Virginia and he died on the 17th of October 1832 in Abbeville, Anderson County, South Carolina. He was married twice, 1st to a Miss Hartfield and then to a Miss Duval. This order of marriage is not certain and could be the reverse order.

Uel Hill 2/ was a Baptist minister in South Carolina for many years. He was also listed as "Major" so he apparently served in the Revolutionary War. It is unknown just how many children he had but it has been said that he raised his brother's (Jesse Hill's 2/) son named William P. Hill 3/, who was also a Baptist minister.

The Will of Uel Hill 2/ was dated the 22nd of August 1832, and probated on the 3rd of November 1832 in Anderson County, South Carolina. His brother, Joshua Hill 2/ & his nephew William P, Hill 3/ were the Executors. Those persons named in his will were:

A. Daughter, Elizabeth Hughes 3/, wife of James Hughes. Niece, Sarah Ann Hatfield 3/ (sic) (?) (may be Hartfield) and children Betty & Ale (sic). Mariam Hartsfield (sic) (?) (Hartfield). Nephew, William P. (Pittman) Hill 3/, son of Uel's brother. Jesse Hill 2/.

Granddaughter, Ann Palmer 4/, wife of William Palmer. Granddaughter, Catherine Hughes 4/, wife of Singleton Hughes. Granddaughter, July Williams 4/, wife of W.G. Williams.

Other legatees were: W.G. Williams, Frances Hughes, James Hughes, Pamealy Hughes.

NOTE: The Will of Uel Hill 2/ was found in the Collection of Upper South Carolina Genealogy & Family Records, Volume 2, Page 138, edited by James E. Wooley.

DANIEL HILL 2/.

6. Daniel Hill 2/ was the sixth child of William Hill Sr. 1/ & Susanna Smither. He was born on the 16th of October 1756 in Caroline County, Virginia and he died on the 28th of May 1826 in Williamson County, Tennessee. He was buried there in the Veteran's Cemetery.

Daniel Hill 2/ married Martha Hickman on the 16th of October 1779. She was the daughter of James Hickman and Hannah Lewis. Martha was born on the 16th of October 1758 in Williamson or Maury County, Tennessee. His will was probated in July of 1826 and his son, William H. (Hickman?) Hill 3/, his son in law Nathan Ewing and grandson John Ewing 4/ were executors.

Daniel Hill 2/ was a Revolutionary Soldier while living in (then) Surry County, N.C. (now Stokes Co.). He may have served under his brother, Captain Robert Hill 2/ but was listed as serving under General Nathaniel Green's army.

Information differs in some sources. Daniel Hill's Family Bible says that Martha Hickman's father was James Hickman but the "Roster of Soldiers," etc.. says it was William Hickman.

Daniel Hill 2/ was one of the executors of his father's estate, which was probated in February of 1787 (Vol. 2, Surry Co., N.C. Wills, Page 73). His father gave "unto my son Dan Hill, the land and plantation on which I now live."

Later Daniel Hill 2/ moved to Nashville, Tennessee. The county's name later changed to Davidson County. From there the family moved into Franklin County, Tennessee and which later became Williamson County. The children of Daniel Hill 2/ were:

- A. Sarah Hill 3/, born on 28th of July 1780, she died sometime between 1830 and 1855. She was married to Nathan Ewing, born on the 17th of February 1776 and dying on the 1st of May 1830.
- B. Mary Hill 3/, born 4th of September 1782, died on 23rd of July 1757, married Henry Bateman.
- C. Nancy Hill 3/, born on 7th April 1785, she died on 27th of January 1829. She was married to John Creecy on the 10th of September 1807.
- D. William Hickman Hill 3/, he was born on the 1st of May 1788 and died on the 12th of August 1867 in Dallas County, Texas. He was married to Sally Brown on the 20th of September 1810. She was born in 1790 in Virginia, and was a daughter of Daniel Brown & Patience Vick.
- E. Ggreen Hill 3/, was born on the 15th of October 1790 and died on the 7th of February 1825.
- F. Mildred Hill 3/, was born on the 8th of July 1793, married Mr. Burris. Other sources say the name was Burrows or Burroughs as was spelled in her father's will.

- G. Elizabeth Hill 3/, (TWIN) she was born on the 14th of March 1796, died in March of 1855. She married on the 12th of January 1815 to Henry Clay Ewing in Williamson County, Tennessee.
- H. Lucinda Hill 3/, (TWIN) she was born on the 14th of March 1796. She married William Garner in 1817. He was born in 1788 and died in 1851. (The dates are not from the family bible, but does not say what the source was).
- I. Susannah Smither Hill 3/, born on the 20th August 1800 and died in December of 1807.

JESSE HILL 2/.

7. Jesse Hill 2/ was born ca. 1759-1761 probably in Caroline County, Virginia and was the seventh child & son of William Hill Sr. 1/ & Susannah Smither, both of Caroline County, Virginia, later of Surry County, N.C. His first wife was named Mary (maiden name unknown) but they had a daughter named Sally 3/, who is named in Jesse's 2/ will as Sally Garrett 3/. Mary Pittman was the 2nd wife and married Jesse Hill 2/ before 1794. Their three children were John Hill 3/, William Pittman Hill 3/ and Joel Hill 3/, all named in the will of Jesse Hill 2/. William P. Hill 3 was raised by his uncle Uel Hill 2/. Colonel John Hill 3/ had a son Thomas Jefferson Hill 4/, born on the 29th of June 1802 in Edgefield County, S.C. and died near Maretta (sic), Cobb County, Georgia.

Jesse Hill 2/ married a third time to Elizabeth Weldch (sic) (Welch?). She was born ca. 1812 in Edgefield County, S.C. and died on the 20th of August 1849. They were married on the 16th of February 1832 (Ref DAR APPLICATION #434303-Helen (Hill) Warwick). Jesse Hill 2/ signed a will on the 13th of July 1818, probated on the 4th of January 1821. The wife is listed as Elizabeth Hill (3rd wife). Children named were:

- A. Susanna Hill 3/, married a Cossy or Casey.
- B. William P. Hill 3/, his mother was 2nd wife.
- C. Sally Hill 3/, married Thomas Garrett.
- D. John Hill 3/.
- E. Joel Hill 3/, listed in will as a minor.

The wife named in Jesse Hill's 3/ will was his third wife and evidently was not the mother of any of his children. The will stipulated that quote "My youngest son, Joel Hill, is to reside with his step mother and to heir the home plantation when she died." Executor: Son in law, Thomas Garrett." Wit. was Joshua Hill 2/ (brother), James Oliver, & Jno. Simpkins.

Information & Abstract of the Will of Jesse Hill 2/, taken from Book "East Goes West," by Alta Craft, Page 102.

Will of Jesse Hill 2/.

I Jesse Hill... do make and ordain this my last will and testament.

Item....I will that my wife, Elizabeth (third wife) have possession of all the premises where I now live during her natural life or widowhood.

Item....I give unto my daughter, Susannah Cossy 3/ (mother was Jesse's first wife, Mary?) a piece of land and two slaves.

Item....I give to my daughter Sally Garrett 3/ (mother was first wife) all that plantation or tract of land whereon Thomas Garrett now lives..and a Negro girl.

Item....I give unto my sons John 3/ & William 3/ (their mother was second wife, Mary Pittman) the land I now live after the decease of my wife, and I wish him (Joel?) to make his home and take up his residence with his step mother (underlining supplied) (sic) during her life or until he becomes of age.

Also I give to my wife, Elizabeth (third wife) during her life or widowhood---? (the copy ended here).

JAMES HILL 2/.

8. James Hill 2/, the eighth child of William Hill SR 1/ & Susannah Smithers. He was born between 1759 & 1761 in Caroiline Co., Va. m. Mary--? he died in SC (no date given)

JOSHUA HILL 2/.

- 9. Joshua Hill 2/, b. 26 May 1763, d. 20th June 1855 in Abbeville Co., SX. He was the nionth child of William Hill Sr 1/ & Susannah Smithers, apparently served in the Revolutionary War as mention was made by a certain researcher about a pension record in Abbeyville, South Carolina on the 29th of October 1852. In his father's will, probated in February 1787, William Hill Sr. 1/ (father) stated "I give unto my three youngest sons, James Hill 2/, Joshua Hill 2/ & Joel Hill 2/ each five pounds, to be applied in schooling them at the discretion of my son Dan Hill 2/." After deducting the special legacies, they shared in equal distribution of the balance of the estate. The children of Joshua Hill 2/ & Nancy Wyatt Collier were:
 - A. Nancy Ellen Hill 3/, born on the 6th of February

1791 in Abbeyville, S.C., she died on the 9th of January 1843 and was married to James Foster on the 19th of December 1807. (Note: It was their son that old Joshua Hill 2/ gave testimony to, about the Hill family history, and known as the "Joshua Hill Foster Papers," filed in the Alabama State Archives.

- B. John Hill 3/, he was born on the 7th or 10th of December 1792 and died on the 20th of August 1859.
 He married on the 20th of January 1819 in Jasper County, Georgia to Julia Dyer. She was born on the 17th of December 1799 and died on the 8th of March 1826 in Jasper County, Georgia.
- D. Elizabeth Wyatt Hill 3/, was born on the 13th of March 1795, and died on the 23rd of April 1883. She married on the 9th of August 1813 to Hardy Foster, who was born on the 25th of May 1792 and died on the 18th of August 1849.
- E. Sarah Blackwell Hill 3/, was born on the 1st of August 1797, married on the 18th of January 1824 to Robert Jones.
- F. Susannah Smither Collier Hill 3/, was born on the 3rd of October 1799, and married Elisha Brown, who died in 1833. She remarried on the 4th of February 1839 to John Cameron Jones.
- G. William Wyatt Hill 3/, was born on the 22nd or 27th of April 1802, married Harriet Withington/Witherinton who died in 1887.
- H. Ormond Hill 3/, according to the "Directory of the Maryland State Society of the DAR," (1906) Page 389, he was born on the 30th of June 1803 but this date is not shown elsewhere.
- I. (Judge) Edward Young Hill 3/, was born on the 10th of January, February or July in 1805 (conflicting dates from different sources). He died on the 20th of November 1860. He was married on the 12th of December 1827 to Arabella Dawson (1810-1873).
- J. Martha Ann Hill 3/, was born on the 1st of September 1807. She married first to Alexander Reid Buchanan and second to John Bruce.
- K. Hulda Hill 3/, she was born on either the 10th, 15th or 20th of February 1810. (Three different dates from three different sources). She married John Daniel.
- L. (Senator) Joshua Hill Jr. 3/, was born on the 10th of January 1812 and died on the 6th of March 1891. He

married on the 2nd of January of 1834 to Emily Reid. They had eight children, & one of his four sons was killed in the civil war.

Joshua 2/ was tutored and later self-taught for the practice of law. In 1848, soon after moving to Madison, in Georgia, he turned to politics and in 1857 was elected by the American party to the 35th and 36th Congresses, serving until 1861 when he resigned. In 1860 he was a delegate to the Constitutional Union Convention at Baltimore, Md. and took part in discussions about how to avoid the impending war. He was an outspoken opponent of session and refused to sign the letter confirming Georgia's secession; he flatly refused to have anything to do with the war. In 1863, supported by a growing Union sentiment in the northern part of Georgia, he ran for governor, but lost the election to Joseph E. Brown.

At the close of the war Joshua Hill was elected to the state constitutional convention and, in 1866, under the new constitution, he ran unsuccessfully for the United States Senate. In 1868, however, conservative Democrats gave him their support and he was able to defeat Joseph E. Brown for that office. Immediately after being elected, he voiced his Republican principals in support of the policies of Congress. In 1873, he resigned from the Senate and returned home to Madison, Georgia and remained politically inactive, except for his activities in the state constitutional convention.

Despite the fact that he opposed secession, during the war he led a peace movement, later joined the Republican party and worked for radical reconstruction policies. He never lost the respect of the people of Georgia.

JOEL HILL 2/.

10. Joel Hill 2/ was the tenth child of William Hill Sr. 1/ & Susannah Smither and the twin to Joshua Hill 2/ (his brother). As with the other brother, some researchers have questioned as to whether Susannah Smither or Elizabeth Williams was his mother, but again the majority feels Susannah was indeed the mother.

Joel Hill 2/ was born on the 26th of May 1763 in Caroline County, Virginia. He enlisted at the age of 16 for service in the American Revolution from Surry County, N.C. (later Stokes County). He served three months, from July 1779 in Captain Woodridge & Captain John Morgan's companies in Colonel Martin Armstrong's regiment; another three months in 1780 in the company of his brother, Captain Robert Hill 2/, under Colonel Paisley's regiment and engaged in several skirmishes with the Tories; again with his brother, Captain Robert Hill's 2/ company. He served two months in 1781 in Colonel Joseph Winston's regiment; and after his last tour he served almost constantly until January 1782 in the company

of his brother, Captain Robert Hill 2/, in protecting the area from small raiding parties of Tories. He was granted a pension for his Revolutionary Service. Later, after his death, his widow was granted a pension (File #W-232881), Bounty Land Warrant 28-636-160-55).

After the war, in 1787 he moved to Richmond County, Georgia where he married on the 16th of October 1791 to Anne Watson, who was born on the 10th of October 1773. In 1800 Joel Hill 2 & his wife moved back to Edgefield County, S.C. and in 1808 they moved to Limestone County, Alabama and in 1832 to Jackson County, Arkansas.

Both Joel Hill 2/ & Joshua Hill 2/ were named as twins in their father's will and shared the same equal legacies.
