Information relating to Sion Hill 5/ by Robert Hill: Figures after names indicate what known generation that individual belongs to. Sion Hill 5/, the deceased, was a son of William Hill Sr. 4/ and his wife Charity Lewis, the daughter of Richard Lewis and his wife Ann Lewis. William Hill Sr. 4/ (b. ca 1731) was a son of Robert Hill 3/ and his wife Tabitha (West?), a son of Sion Hill Sr. 2/ & his wife, the widow of John Spiltimber named Elizabeth (Smith) Spiltimber. Sion Hill Sr. 2/ was a son of Robert Hill 1/ & his wife Mary Webb, both of whom came from England in 1642 to Isle of Wight County, Virginia.

Earlier researchers have listed him as Sion Lassiter Hill but that is the wrong man. His name was Sion Lewis Hill 5/. Sion Lewis Hill 5/, the deceased, was a grandson of Robert Hill 3/ & wife Tabitha and he is thought to have been born ca. 1761 in Edgecombe County, N.C. and his wife filed inventory of his estate on the 11th of February 1795, so his death was probably in late January or very early February 1795. He was married to Drucilla Lane on the 2nd of October 1783, the daughter of Newet Lane.

Sion Hill 5/ was apparently the third child of William Hill Sr. 4/ & Charity Lewis. He had two older brothers, Lewis Hill 5/, b. ca. 1755 and Richard Hill 5/, born in 1757. He also had three younger brothers, William Clanton Hill 5/, Enoch Hill 5/ and Henry Hill 5/.

There has only been found one child of Sion Hill 5/ confirmed by this marriage and that was a daughter named Elizabeth Hill 6/. Another source says there was a son named Richard Hill, who is said to have had a son , a doctor, named Duncan Hill, but this is questionable and has not been confirmed, also this same son was said by other sources to have been a son of Richard Hill 5/, brother to this Sion Hill 5/.

The first of the following documents was a machine or press printed document. The bold print shows the data that was filled in by the spaces provided. It was noted that in every entry of the name of Drucilla Lane Hill, the middle name Lane was scratched out, indicating that her maiden name was not wanted or required on the document.

KNOW all Men by these presents, that Drucilla Lane Hill, William Jackson and Jeremiah Etheridge are held firmly bound unto Edward Nicholson Esquire Chairman of said court, in the sum of Two Hundred & Fifty pounds, current money, to be paid to the said Edward Nicholson or his successors, to which payment well and truly to be made, we bind ourselves, our heirs, executors, and administrators, jointly and severally, firmly by these presents. Sealed with our seals, and dated this Eleventh day of February Anno Domi 1795

THE CONDITION of this Obligation is such. That if the above bounden DRUCILLA LANE HILL administrix of all and singular the goods and chattels and credits of SION HILL, deceased, do make or cause to be made, a true and perfect inventory of all and singular goods and chattels, rights and credits of the deceased, which have or shall come to the hands, knowledge or possession of the said Drucilla (Lane) Hill or into the hands or possession of any person or persons for him; and the same so made, do exhibit or cause to be exhibited into NASH County court, within the time prescribed by law, after the date of these presents; And the same goods, chattels, and credits, and all other the goods, chattels and credits of the deceased, at the time of his death, or which at any time hereafter shall come into the hands or possession of the said Drucilla Lane Hill or into the hands or possession of any other person or persons for her do well and truly administer according to law; and further do make or cause to be made, a true and just account of her said administration, agreeable to law, after the date of these presents; And all the rest and residue of the said goods, chattels and credits, which shall be found remaining upon the said administration account (the same being first allowed by the Governor Council, Superior or county court) shall deliver and pay unto such person or persons respectively as the same shall become due, pursuant to the true intent and meaning of the act in that case made and provided. And if it shall appear that any will or testament was made by the deceased, and the executor or executors therein named do exhibit the same in court, making request to have it allowed and approved of accordingly, if the said Drucilla Lane Hill above bounden, being thereto required, do render and deliver the said letters on administration (approbation of such testament being first had and made made in the said court) then this obligation to be void, otherwise to remain in full force and virtue.
