STATE OF NORTH CAROLINA, SEPTEMBER FOURTH, SUPERIOR COURT OF BRUNSWICK COUNTY, SEPTEMBER 13TH, 1889

Personally appeared before me W. L. Doshier, Clerk of Superior Court for the County aforesaid, JOSEPH LONG, who after being duly sworn, deposes and says that he is the sole Executor named in the will of GABRIEL LONG, deceased, that the value of the Gestations property is about One Hundred & Twenty Five Dollars consisting of castle and household and kitchen furniture. What the names of the heirs are JESSIE LONG, WILLIAM LONG, JNO. LONG, EDWARD LONG, MARY BENNETT, CHASTAINE FLOYD, ELIZABETH STENEN & MARY ANN LONG.

The said JOSEPH LONG prays that the said will be administered to probate.

A paper writing herefore pertaining to be the last will and testament of GABRIEL LONG is this day exebited before me the undersigned Clerk of Superior Court of said county and is proved by the oath and examination of ALFRED BENNETT and WILLIAM BENNETT, the subscribing witnesses thereto, who being duly sworn, depose and say each for himself, that they are the subscribing witnesses to the paper writing now shown them (herohonking) the last will and testament of GABRIEL LONG, that the name at the end of the said paper writing which is now shown as aforesaid and which has a date the 21st day of April 1883, is in this (in?0 the proper hand writing of the said GABRIEL LONG and the deponents for them sayeth that the said GABRIEL LONG the testor aforesaid did at the time of such subscribing his name as aforesaid declare the said paper writing to be his last will and testament and the

deponents did thereunto subscribe their names at the end of said Will as attesting witnesses thereto as aforesaid that the said GABRIEL LONG was of sound mind and memory, of full age & made a will, and was not under any pressure to the said witnesses or information or belief of these deponents--and from them, the said deponents--say not.
