THOMAS HILL OF RANDOLPH COUNTY, N.C.

The earliest known record of this non-quaker Hill family of Randolph County, North Carolina, is a Land Grant to Thomas Hill on 10th February 1763. The grant was for 243 acres located in Tract Number 10 of the Earl of Granville's lands. The agent representing the Earl of Granville was Henry Eustace McCullough. (Deed Book 19, pps 445-453 in Land Grant Office, North Carolina State Archives, Raleigh, N.C..

At the time of this grant (1763) this 243 acres was in Rowan County, N.C. In 1771 Guilford County was formed from the part of Rowan County in which Thomas Hill's 243 acres was located. In 1773 Thomas Hill's land was still in Guilford County and he was among the signers of a petition to have the Guilford County Court House moved nearer to the center of the county. (Vol V, No. 1, 1981 of the Genealogical Journal of Randolph County, N.C.).

In 1779, Randolph County was formed from Guilford County and Thomas Hill's 243 acres of land was situated in the northwestern corner of the new Randolph County.

Thomas Hill was a Regulator (Ref: Regulator Advertisement No. 9, Colonial Records Vol. VII, pps 733-737). A Regulator was a person who rebelled against the government. They complained of injustice, extortion, corrupt courts and being complled to pay taxes to the Bristih agents. There were many Regulators in Rowan, Anson and Orange Counties of N.C. They refused to pay taxes; netween 1764 and 1771.

In 1771, Governor Tryon marched against them and defeated the. At least three hundred persons died as a result. At the beginning of the Revolution, the Regulators espoused the cause of the British and were defeated by Colonel Caswell in February of 1776. (North Carolina ratified the Constitution of the United States on 21st November 1789).

In 1779, Thomas Hill proved himself a Patriot by taking the Oath of Allegiance to the Provincial Congress. On Page 183 of the 1779 Tax List of Randolph County, Thomas Hill retruned an inventory of his taxable property in William Millikan's tax list. The names of people who did not take the oath of

allegiance and refused to list their property are at the end of the list.

On the 20th of February 1768, Thomas Hill and his wife Elizabeth sold 100 acres of land to Stephen Alexander and in both the 1779 and 1785 Randolph County Tax Lists, Thomas Hill had 143 acres instead of the 243 acres granted him.

Samuel Lowe listed the taxables in Captain Clark's and Captain Gray's District. In this list, Thomas Hill & Thomas Lowe are on adjoining lines. Samuel Millikan was listed on the line next to Thomas Lowe. (Note: Samuel Millikan witnessed the Will of Thomas Hill in 1798. See later).

In the 1788 Militia List of Randolph County, John Hill was listed under Captain York's command (Ref: The Genealogical Journal of the Randolph County Genealogical Society, VOL. III, No. 1, 1978-1979, Page 37). John Hill and Nathan Lowe are on adjoining lines. William Millikan was also on this list.

Thomas Hill made out his will on the 7th of March 1798 (Will Book B, Page 112, N.C. State Archives, Raleigh, N.C.). The Will was proved in court in the November 1800 Randolph County Court Session. Sometime between March 7th, 1778 and November 1800 Thomas Hill died.

Where or when Thomas Hill was born or married is unknown. His wife apparently preceded him in death as only his children are mentioned in his will. They were Margaret, Richard, JOHN, Francis, William, Mary and Daidi. Thomas Hill called Winifred his daughter, but he did not name her as one of his children so she may have been a daughter-in-law.

Thomas Hill named his sons John Hill & William Hill exceutors of his estate. The plantation on which he lived was given to the son John Hill. The remainder of his land was given to th son William Hill. His other children shared in what was left of the estate. The will is listed below.

Where as I THOMAS HILL of the County and State afforesaid, being weak of body but of sound mind do think (it) proper the Seventh day of March 1798 to make the following Distribution of such property as I am blessed with to wit:

and first my will is that all my just debts be paid.

- 2... I give to my son JOHN (HILL) the plantation where on I now live Beginning up the creek where the line crosses Carraway then down to the mouth of the Still House branch then up it to where the lines crosses S(ai)d branch then along the same to M(c)CRACKENS line and so along the beginning be the same more or less.
- 3... I give to my son WILLIAM (HILL) the remainder of my land bounded by Sd (said) Creek and branch be the same more or less.
- 4...I give to my daughter WINIFRED (HILL) the sum of ten shillings.
- 5...My Will (is) that the remainder of my estate be equally divided between my seven children to Wit: MARGARET; RICHARD; JOHN; FRANCIS; WILLIAM; MARY & DAIDI.
- 6...An lastly I do hereby appoint my two sons JOHN & WILLIAM Executors to this my last will declaring this and no other to be my last will & testament.

JOHN HILL 2/

John Hill 2/, son of Thomas Hill 1/, was born ca. 1756-1767 in what was then Rowan County, N.C. The date of his marriage to Rachel Sargent is unknown. A marriage bond was not required if the couple was to be married by a minister in the Presbyterina or Methodist churches, or in the Church of England, or if the couple was of the Quaker religion. Except for Quaker records, most of the early church records have been lost.

Based on the biography of Doctor Hill 3/, his parents, John Hill 2/ & Rachel Sargent, had nine children. They were:

Doctor Hill 3/ stated that he was born in the same house that his father was.

Randolph County Deed Books shows John Hill 2/ had purchased 495 acres of land in 1804 from a Henry Youst. He also bought another 22 acres from him and was granted 10 acres from the state of North Carolina. These purchased lands totaled 527 acres on the Uhwarrie River on which he paid taxes in 1815 in Smith's District.

Charles Hill 3/, son of John Hill 2/, paid taxes on 323 acres on Carawy River in Smith's District. John Hill's brother, William Hill 2/, paid taxes on 243 acres on the Caraway River. Thomas Hill 3/, son of William Hill 2/, had 235 acres on Carawar River, on which he paid taxes.

John Hill 2/ inherited his father's plantation of 143 acres of land. He apparently sold this to his brother William Hill 2/. The state of North Carolina sold William Hill 2/ 100 acres of land, bringing it back to 243 acres, which is the number of acres originally owned by his father, Thomas Hill 1/.

In 1816, John Hill and wife Rachel Sargent and their children moved to Sullivan County, Indiana, near Farmersburg.

Two of the sons, Charles Hill 3/ & Doctor Hill 3/ married Boyd sisters, Hannah & nancy, in Randolph County, North Carolina. They were the daughters of James Boyd of Guilford County, North Carolina. Charles Hill 3/ married Hannah and Doctor Hill 3/ married Nancy Boyd.

While a death date for James Boyd of Guilford County has not been found, it appears he died between 1790 and 1800. His three sons, John, Archibald and Adam Boyd traveled with the Hill family to Indiana, as did some Newlin family members.

Adam Boyd remained in Indiana when his two marroed sisters and two brothers moved to Crawford County, Illinois in 1818, along with the Hill family.

Many of the descendents of the Hill and Boyd families lived in Crawford County, Illinois in 1983.

WILL OF W. L. HILL

Camp Mangum near Raleigh, N.C. December 15th, 1861

Henry Hill: This evening being at leasure I will drop you a few lines. I can inform you alol (all) that I am well and pretty well satisified. The Most of the company are well. Though the Measles have got hold among the Company there is one boy in my hut very sick with the Measles. I will now tell you something about what I want done with my property, provided I never get home. I expect to send some money home before lon (long), then I will send you word what to do with it. The ballance of my property after my just debts are

paid, I want father and mother to have it while they live. Then I want it to fall in to the hands of Margaret and Jane M. Hill. I write this in the Service and the fear of my God.

God almighty grant that if I never get home to attend to my own business that my affairs may be disposed of Just as this letter prescribes. The reason why I want my Sisters to have my little property is because my Brothers both have so much more than they have. I want you to put this letter away and let nobody see it for the present, but my own folks at home. I write this because life in (is?) uncertain and death is certain. We know not what a day may bring forth. You need not think because I write this that I am uneasy in the least for I am not. I intend to have written something like this before I left home but I failed to do so for I did not know where to put it so you would get hold of it. Ma, Pa, and J, M. Hill, I am very well and make no other calculation but what I shall come safe. I would be very glad to see you all. But don't by uneasy about me at all. YOur son, W.L. Hill, 5th Regiment.

Note by Robert Hill of Brandon, Fla.: This letter was wrote by a W. L. Hill and was apparenty sent to a Henry Hill, who's relationship to the writer is unknown for sure. It is obvious from the letter that Margaret and Jane M. Hill were sisters to this W.L. Hill.

Notice that a Micajah Hill was one of the witnesses to this unsual will. Just who the brothers were is not exactly clear UNLESS it was this Henry Hill and Micajah Hill?
