

NC.063 THIS DOCUMENT RELATES TO A HILL FAMILY OF NORTHAMPTON COUNTY, NC, AND INCLUDES THE WILLS OF HARMON HILL, HIS SON HENRY HILL, HIS SON GREEN HILL OF NORTHAMPTON COUNTY.

ALSO INCLUDED IS A LAND DEED IN CHATHAM COUNTY BETWEEN THOMAS HILL SR. & JOHN R. HILL & HIS WIFE AND ATLAS HILL & HIS WIFE, DATED 31 MARCH 1871.

Entered in March of 1993 by Robert R. Hill of Brandon, Florida.

Source: Photo copy of the following deed was sent to me by Jerry R. Hill of Siler City, N.C. The comments are my own.

There was a Harmon Hill 1/ (WIFE ELIZABETH) that died in March of 1777 and left a will (below) in Northampton County, who had a son named Henry Hill 2/. Henry Hill 2/ died in 1804 and left a will (below) naming sons Augustine Hill 3/, Merritt Hill 3/ & Green Hill 3/.

Augustin Hill 3/ was the father of Atlas A. Hill 4/. As will be seen later there was a John Hill, who died in Chatham County, N.C. with a son named Atlas Hill, and this causes me to think that perhaps this John Hill was a son of Atlas A. Hill 4/ or somehow related to the Hills of Northampton County.

WILL BOOK ONE, 1759-1792

Will 13, Page 20, Harmon Hill-January 1772, (proved) March Court 1777...to my son HENRY HILL and my daughter FANNY HILL (each) Negroes etc... son HARMON HILL Negroes, Still, and the lands and plantation whereon I now live. Daughters JEAN HILL, MARTHA LEWIS, BETTA WEBB, NELLIE HART and SARAH SWEET, 5 shillings each, 5 shillings also to MARTHA WARDIN and HARMON TARVER (?), _____? _____ use and befit (sic) of Negroes and residue of my estate while HENRY HILL comes of age, residue of estate to be divided between my two sons HENRY & HARMON (HILL) at wife's death.

Extrs: beloved wife ELIZABETH HILL & son HENRY HILL, THOMAS HART.

Wits: HARDY (H his mark) HART, JANUS---(x his mark)

Note by R. Hill: The maiden name of Harmon Hill's wife was

first thought to be Martha DeLoach, but think that was the wife of the son Harmon Hill 2/.

Take note that Harmon Hill 1/ had a daughter NELLIE HILL 2/, who was named as NELLIE HART in the will. She was probably married to THOMAS HART, one of the executors.

Now referring to that portion of Harmon Hill's 1/ will that states Quote: "an residue of my estate while HENRY HILL comes of age," end of quote. This seems to indicate that the son HENRY HILL 2/ was a minor (under 21) when Will was wrote in January of 1772.

Below is the will of Henry Hill 2/, son of Harmon Hill 1/ of Northampton County, N.C.

Note by R. Hill: Figures have been placed after names to show what generation they belonged to, based on known generation. It is believed that this Henry Hill 2/ is the same Henry Hill named as a son in Harmon Hill's 1/ will.

NORTHAMPTON COUNTY, N.C. WILL BOOK 4, PAGE 296
(dated ca. 1800)

Note: This will is thought to have been wrote in 1800 & probated in 1804. See comments at end of will.

In the name of God Amen I HENRY HILL of the County of Northampton and (the) state of North Carolina, being weak in body but in perfect sound mind and memory do make and ordain this my last Will & Testament in Manner and form following:

First, I give and bequeath to my grandson ROBERT C. HILL 4/ a Negro boy by the name of Caleb. Should the said Robert C. Hill 4/ die without a lawful heir (then) my desire and wish is for the said Negro Caleb to be equally divided between GREEN HILL 3/, MERRITT HILL 3/ and FANNY HART 3/ and my grandson WILLIAM HILL 4/.

I give and bequeath to my grand daughter MARTHA HART 4/ one feather bed and furniture.

I give and bequeath to my grandson HENRY HART 4/ one feather bed & furniture, one cow and calf; I lend to my daughter FANNY HART 3/ the plantation whereon she now lives during her ** single life (but) at her decease I give and bequeath the said plantation to my grand children MARTHA HART 4/ & HENRY HART 4/.

I give and bequeath to my grandson CURTIS DUPREE 4/ one dollar.

I give and bequeath to (my) granddaughter MARTHA DUPREE 4/ one dollar.

I give and bequeath to son AUGUSTIN HILL 3/ five dollars.

I give and bequeath to my son MERRITT HILL 3/ Two Hundred & Fifty Dollars.

I give and bequeath to (my) son GREEN HILL 3/ One Hundred & Eighty Three Dollars.

I give and bequeath to my daughter FANNY HART 3/ One Hundred & Eighty Three Dollars.

I give and bequeath to my two grandchildren BENNITT (sic) HILL 4/ & WILLIAM HILL 4/ One Hundred & Eighty Three Dollars.

And (regarding) all the balance of my property, if any, my desire and wish is for it to be equally divided between GREEN HILL 3/, MERRITT HILL 3/, FANNY HART 3/ and BENNITT (SIC) HILL 4/ and WILLIAM HILL 4/, my two grandchildren, to draw One Fourth BENNITT 4/ (sic) & WILLIAM HILL 4/.

Of the balance (of my estate) I leave my three old Negroes GURRAH, ESTHER, DINAH to live with any of my children they please. I leave my son GREEN HILL 3/ & MERRITT HILL 3/ (as) Executors to my last Will & Testament. Given under my hand & Seal this the 28th of October 1800 (or 1840?).

End of Will of Henry Hill

WILL OF GREEN HILL 3/.

(Son of Henry Hill 2/Harmon Hill 1/)

Located in Will Book 4, Page 74 of Northampton County.

Wrote 17th January 1831, Probated in March Court 1831.

In the name of God Amen, I GREEN HILL of the county of Northampton and State of North Carolina, being weak in body but in perfect mind and memory, do make and ordain this my last will and testament in the following manner:

First, I give and bequeath to my son LEWIS B. HILL one Negro boy named James.

2nd, I give and bequeath to my daughter CASSANDRA HILL one Negro girl named Harriett.

3rd, I give and bequeath to my son HENRY ISAAC HILL one Negro boy named Eli-?

4th, I lend to my well beloved wife NANCY HILL one Negro woman named Mary and her increase, my tract of land, household and kitchen furniture and stock of all kinds during her life. I also give my wife NANCY liberty to sell any part of the above named lent (sic) property that she may think proper to raise my children to school them or to pay just debts and at her death to be equally divided between my three children above named (Lewis B. Hill, Cassandra Hill & Henry L. Hill). My desire and wish is that (the) Negro Gurrah and his wife should have the privilege of livein (living) on my land so long as they both live-

5th, I leave NANCY HILL Executrix to this my last will and testament-GIVEN UNDER MY HAND AND SEAL THIS 17TH OF JANUARY 1831.

Northampton County March Court 1831: this will was exhibited in open court and proved according to law by the oaths of Merritt Hill & Augustine Hill, the subscribing witnesses thereto and on motion was ordered to be recorded. Whereon NANCY HILL, the Executor thereon named qualified as the law directs.

End of Green Hill Will

Comments on Will of Green Hill 3/ by Robert R. Hill:
This was obviously Green Hill 3/, the son of Henry Hill 2/ (listed above). His two brothers, Merritt Hill 3/ & Augustin Hill 3/ were witnesses to the above will and also testified at proving the will. It is important to us that he did not name Robert C. Hill 4/ as a son, so the father of Robert C. Hill 4/ had to be either Augustin Hill 3/ or Merritt Hill 3/. I suspect Augustine Hill 3/ as will be explained later in this document.

Northampton County, N.C. Will Book 7, Page 208, Index of Wills shows a date of 1894, which is probably the Probate date for this will.

STATE OF NORTH CAROLINA) NORTHAMPTON COUNTY)

I ROBERT C. HILL of the county and state above mentioned, being of sound mind and disposing mind, do make this paper writing to be my last Will & Testament, as follows-

Item first- I lend unto my beloved wife LUCINDA HILL for and during her natural life all of my property both real and personal, as it stands, (and) at my death-and what debts I may owe my will is that my wife pay these.

Item second- At the death of my wife, the property I have lent to her in the first item of this my will, I lend unto James E. Bowers, my son-in-law, (son of my wife 1- (sic) and if he should leave a child or children surviving, then I give and bequeath the afore mentioned property to him, her or them, but if he should die, leaving no child or children, lawfully begotten, then I give and bequeath the property aforesaid to LEWIS A. HILL and JAMES A. HILL, sons of ATLAS A. HILL, to them and their heirs forever, equally share and share alike-this NOVEMBER 29th, 1883.

End of Will of Robert C. Hill

Now the attempt to show a possible connection to the above Hill family of Northampton County to a Hill family in Chatham County, N.C. This is based mostly on the name of a Atlas Hill being among the Hill family of both Northampton & Chatham Counties.

Below is a deed in Chatham County, N.C. between William Henry Hill & John Hill, thought to have been two brothers. I will give to the reader what information I have on the two men.

First, Some information regarding William Henry Hill of Chatham County, N.C. He is part of a Hill family that had it's origins in Boston, Massachusetts, and who later made their was into North Carolina. (see below).

Honorable William Henry Hill 4/, son of Lt. William Hill 3/, was born on 1st May 1767 and died in 1809. (MEMBER OF

CONGRESS). He was married 3 times: 1st in 1788 to Elizabeth Nash (c. 1762-4 Nov. 1788) She was widow of James Moore, son of Brig. Gen. James Moore and daughter of Abner Nash). 2nd to Alice Starkey, (ca. 1773-5 June 1791) daughter of John Starkey of Onslow County, N.C. 3rd time to Elizabeth Ashe (1765-1810) daughter of Maj. General John Ashe and Rebecca Moore of Orange Co., N.C.

children:

1. William Henry Hill Jr. 5/, married Eliza Marshall.
2. Anna Hill 5/ married on 4th February 1813 Charles J. Wright, son of Judge Joshua Grainger Wright & Susan Bradley.
3. Mary Ashe Hill 5/ married Dr. James Fergus McRee, son of Griffin John McRee of Wilmington, N.C.

John Hill 4/, son of Lt. William Hill 3/, and brother to William Henry Hill 4/, was born 12th April 1761 and died between 1812 and 1818. He married Elizabeth Swann Jones (b. 20th April 1761), widow of Harry Neile and the daughter of Frederick Jones (1732-1797) and wife Jane Swann (1740-1781 Wilmington, N.C.). ("Fairfields" Plantation, Northeast Cape Fear River.) {It is not clear if they married, lived and or died at Fairfields}

1. Eliza Jane Hill 5/, daughter of John Hill 2/, was born 1794 and died in June of 1875. She married on 14th February 1811 to William Campbell Lord (30 May 1793-7 June 1847). Children:
 - a. Sally Margaret Lord 6/, b. 17 March 1814, d. 3rd Nov. 1857. She m. on 29 February 1832 to Henry Adolphus London (5 April 1808-27 November 1882), son of John London and Ann Mauger, of Wilmington, N.C.
 - b. Frederick James Lord 6/ m. Columbia A. Brown.
 - c. Eliza Jane Lord 6/, born 11 January 1812/23 and died on 23rd October 1876. She m on 13th March 1829 to Dr. Armand John de Rossett, III (6th October 1807-9 Dec. 1897).

2. Dr. Frederick Jones Hill 5/, son of John Hill 4/,

(1790-1861) was married 1st to Ann Watters and 2nd to Miss Stith ("Orton" Plantation, Lower Cape Fear River, N.C.). He had no children.

3. William H. Hill 5/, son of John Hill 4/, married Ann Claypoole. Children:

Now below is a Chatham County, N.C. Deed between William Henry Hill 4/ & John Hill, who is thought to have been his

brother, John Hill 4/.

A DEED IN CHATHAM COUNTY, N.C DATED 25 MAY 1798 BETWEEN WILLIAM HENRY HILL AND A JOHN HILL (DEED BOOK O, PAGE 244).

THIS INDENTURE made this 25th day of May 1798 between WILLIAM HENRY HILL of the first part and JOHN HILL of the second part, WITNESSETH that the said WILLIAM HENRY HILL for and in consideration of the sum of Thirteen Hundred Dollars, paid by him the said JOHN HILL, be the said WILLIAM HENRY HILL received and is therewith satisfied doth hereby grant bargain sell alein (sic) convey and confirm to the said JOHN HILL, his heirs and assigns all that plantation or parcel of land containing Five Hundred Acres, more or less, situate in the county of Chatham, about two miles above the town of PITTSBOROUGH (sic) on the main road leading from said town to the town of HILLSBOROUGH (sic)--beginning at three White Oak bushers (sic) on the road on James Mossley's line, thence running West two hundred and forty poles, along Mosseys (sic) Larris' and Stewart's (line?) to a Hickory, thence North 20 poles to a White Oak, thence North forty poles to a Post Oak, thence West Sixty poles to a Post Oak, thence North 36 poles to a Black Oak, thence East 26 poles to a Hickory, thence North 62 poles to a Black Jack, thence East 35 poles to a Hickory, thence South 15 poles to a Black Oak, thence East 200 poles to a Black Oak, thence South 56 poles to a Black Oak, thence East 54 poles to a Black Oak, thence North 20 poles to a White Oak an the aforesaid road, thence along said road to the beginning, it being the same plantation, tract or parcel of land which lately was possessed by NATHAN STEDMAN and by him conveyed to the said HARRY (sic) (and meaning Henry) by indenture of bargain and sell duly proved and registered in the records of said Chatham County TO HAVE AND TO HOLD the said tract of land and plantation and every part and parcel thereof and all and singular, the buildings, erections, improvements, advantages and appurtenances to the same in any manner belonging or appertaining to him the said JOHN HILL, his heirs and assigns to his and their onley (sic) proper use benefit and behoof for each and the WILLIAM HENRY HILL for himself, his heirs, executors, administrators, doth hereby covenant (sic) and agree with the said JOHN HILL his heirs and assigns that the said plantation & parcel of land and every part and parcel thereof to him the said JOHN HILL, his heirs and assigns against the claims of all persons, he the said WILLIAM HENRY HILL, his heirs, executors and administrators, shall and will always warrant and forever defend, IN WITNESS whereof the said WILLIAM HENRY HILL hath hereunto set his hand and seal the day and year first written. (25th May 1798).

End of Chatham County, N.C. Deed

Comments by Robert R. Hill: I had some suspicions at first that the above John Hill was connected to the Harmon Hill 1/ & Henry Hill 2/ family of Northampton County, N.C., listed at the beginning of this document but after talking to Jerry R. Hill of Siler City, N.C. on the phone, I checked out my files on the so called Boston Hill family and agree that is not the case..

While the thought now is that the above John Hill 4/, was the brother to William Henry Hill 4/, we must acknowledge that there apparently was another John Hill, who died in Chatham County, N.C. and whom I still think may have ties to the Harmon Hill 1/-Henry Hill 2/ family of Northampton County, N.C. This certainly needs to be investigated thoroughly.

Note later in this document a deed that relates to the estate of a John Hill of Chatham County. At first my thought was it was the same John Hill as John Hill 4/, who made a deed with his brother, William Henry Hill, but now I do not think so.

This particular John Hill also had a son named Atlas Hill. This is a peculiar given name (Atlas) and it is the basis for my suspicions of this particular John Hill having a family connection to Harmon Hill 1/, Henry Hill 2/ & Augustin Hill 3/, all of Northampton County, N.C.

By an agreement dated March 31st, 1871 between THOMAS HILL (SENIOR), JOHN R. HILL and ATLAS HILL and their wives, It was agreed by the said THOMAS HILL and his wife NANCY, JOHN R. HILL and his wife and ATLAS HILL and his wife SARAH E. that the lands of which MARY HILL and WILLIAM L. HILL died?? (deceased) seized and possessed in fee simple, should be divided according to said agreement by William M. Harper.

Whereas I have allotted to each as follows (viz):

LOT NO. 3 on which THOMAS HILL'S name is written, is allotted to him, containing Forty-One and three fourths (41 & 3/4)

acres, bounded (document at end of page)???

MEMORANDUM: There as JOHN HILL, late of the County of Chatham, State of North Carolina died intestate (and) possessed of certain lands in fee simple, which by the laws of this state descends to his children, the said lands having been partitioned among the children of the said JOHN HILL, deceased, and his son GEORGE HILL, died intestate, leaving but a child WILLIAM L. HILL, who died in his minority, leaving no issue. Therefore THOMAS HILL (SENIOR), JOHN R. HILL and ATLAS HILL, deceased, claim that by the laws of the state the lands of said WILLIAM L. HILL, son of GEORGE HILL, have descended to them. It is agreed by and between THOMAS HILL & his wife NANCY, JOHN R. HILL and his wife MAHALA ANN, of the County of Chatham, State of North Carolina and ATLAS HILL and his wife EMELINE of the County of Cumberland and state of North Carolina to partition the said lands as follows and that William M. Harper make the surveys and plot each lot as designated (viz) that THOMAS HILL shall have allotted to him as his full share of the lands of WILLIAM L. HILL the following tract or parcel of land on the waters of Lyanis (sic) Creek, known as the tract of land allotted to MARY HILL, who died without issue, which is undivided, adjoining the lands of THOMAS HILL, Ruben Burroughs (Burroughs) and other bounded as follows: Beginning at a Red Oak (tree) (on) Andrew Cox's corner running South with Cox's line to a White Oak (tree) (on) THOMAS HILL'S corner, thence EAST with Burrough's line to a Post Oak (tree), thence North with Burrough's other line to a Red Oak (tree) (on) Cox's corner, thence West with Cox's line to the beginning, containing Forty Eight acres, more or less.

Second: That JOHN R. HILL shall have allotted to him as his full share, the following tract or parcel on the waters of Bear Creek, adjoining the lands of ATLAS HILL and others, bounded as follows (viz) Beginning at a stake with three Hickories (trees) and two Post Oak (trees) (bounded by) ATLAS HILL'S corner in (on) Solomon Ellis' line, running East with Solomon Ellis's line, one hundred and eight poles, to a Post Oak (tree) thence South with Green Brewer's line one hundred and forty nine poles to a Pine (on) Beal's corner, thence West with Beal's line one hundred and eight poles to a Post Oak (tree) with three Post Oaks (on) Minter's & ATLAS HILL'S corner, thence North with ATLAS HILL'S line one hundred and forty nine poles to the beginning, containing One Hundred acres, more or less.

Third: That ATLAS HILL have allotted as his full share the following tract or parcel of land on the waters of Bear Creek, adjoining the lands of Solomon Ellis and others, bounded as follows: Beginning at a Post Oak (tree) on Solomon Ellis' corner running East with his line one hundred and eight poles to a stake with three Hickories (trees) and two Post Oaks, bounded (by) JOHN R. HILL'S corner, thence

South with JOHN R. HILL'S line one hundred and forty nine poles to a Post Oak (tree) with three Post Oaks (on) Pointer's & JOHN R. HILL'S corner in Beal's line, thence West with Beal's and William H. Ellis' line one hundred and eight poles to a Hickory (tree) (on) William H. Ellis' corner, thence North one hundred and forty nine poles to the beginning, containing One Hundred acres, more or less.

IN WITNESS whereof the said THOMAS HILL (SR.) and his wife NANCY, JOHN R. HILL and his wife MAHALA ANN and ATLAS HILL and his wife EMELINE have hereunto set their hands and seals this 31st day of March A.D. 1871.

End of the above Deed in Chatham County

Comments by Robert R. Hill of Brandon, Fla.: The above document is very interesting and it is one that just about any person doing genealogical research would love to find on their own family. It tells us many things, such as that a JOHN HILL, of Chatham County, died intestate (no will) and as the law required, the land was distributed among his children, which included sons GEORGE HILL, THOMAS HILL, JOHN R. HILL and ATLAS HILL.

GEORGE HILL had died intestate (no will) and apparently left a widow named MARY HILL and one child, a son named WILLIAM L. HILL. Naturally the lands of GEORGE HILL fell into the possession of his one and only child, a son named WILLIAM L. HILL, who's mother (MARY HILL) apparently seized in her son's right.

The son, WILLIAM L. HILL, died as a child, and having no children of his own, and due to the fact that the widow, MARY HILL, had no legal right to any of the inheritances, the remaining children of JOHN HILL, deceased, (Thomas Hill; John R. Hill and Atlas Hill) petitioned that the land was to fall

into their ownership and thus petitioned the courts for a equal distribution among them as was obviously agreed upon by them all.

This document also gives the given names of the wives of Thomas Hill; John R. Hill and Atlas Hill. Notice that the full given name of the wife of ATLAS HILL is revealed in this document to have been SARAH EMELINE HILL.

By the fact that a son was named ATLAS HILL, causes me to speculate that perhaps this HILL FAMILY was a spin off of the Harmon Hill-Henry Hill family of Northampton County, N.C. (See document labeled NC.40). It does not seem to be part of the so called "Boston Hill Family," at least as far as I can determine.

Note the name of Atlas Hill. A man named Atlas A. Hill 4/ was the son of AUGUSTIN HILL 3/, who was a son of the above Henry Hill 2/, a son of Harmon Hill 1/, all of Northampton County, N.C.

There are two possibilities on this Hill family, one is that Harmon Hill 1/ was the son of a George Hill, who's origins are unknown, or possibly This is on record, however the names in the will of the above Green Hill 3/ seems to suggest a connection to the Green Hill Sr. 4/ (m. Grace Bennett) family, possibly through his son Green Hill Jr. 5/. Green Hill 4/ had a son named Henry Hill 5/ and of whom we have no information on.

If this is later found to be true then all of the generation figures after the individual's names will have to be changed to reflect all of this.
