

NC.057 (AL.004) INFORMATION ON A HENRY HILL FAMILY OF NC & A
WILLIAM GREEN HILL, WHO LATER MOVED TO TEXAS.

Entered in August of 1992 by Robert R. Hill of Brandon, Fla,
updated in October 1992. Revised in January of 1996 &
January of 1997.

Source of Information: Henry Hill data & the article
concerning William Green Hill was first provided by Jerry R.
Hill of Siler City, N.C, who did not send 3rd page of Henry
Hill data. Later on, a revised or corrected copy of the
Henry Hill family was provided by Byron Hill of Nashville,
Tenn. in January of 1996 who obtained it from a Mrs Ingram.

Note of Explanation: Since we do not know the name of the
parents for Jonas & Henry Hill, I have listed both Jonas &
Henry Hill as the first KNOWN generation.

There was a Henry Hill 1/, who's descendents appear to
include a William Green Hill 3/, a son of Henry Hill Jr. 2/.

The fact that a William Green Hill 3/, son of Henry Hill Jr.
2/ died in Texas, as did my original listing of a William
Green Hill 1/, at first caused me to think they were the same
men BUT the dates do not agree, indicating it was not the
same William Green Hill. Until such proof is given, I am
treating them as two separate men, despite the fact that I
think they may be of the same Hill family.

HENRY HILL 1/. (First KNOWN generation)

Henry Hill 1/, son of a unknown Hill, was born ca. 1763
(another source says 1770) in Granville District (county) NC.
He was later found in Morgan County, Alabama. He died on the
23rd of September 1854 at Somerville, Morgan Co., Ala. He
left no will and probate records are in Books 10, 11 and 12
of that county. He appears to have had a brother named Jonas
Hill, born ca. 1763 (another source says 1770) in Granville
Co., NC. He died on 31st August 1840 in Franklin Co., TM.
**(See note at end of document).

Henry's wife was named Sarah Elizabeth Cox, b. ca. 1764 in
S.C., d. on 28th January 1866 in Morgan Co., Ala. Her
estate papers found in Book 23 of Morgan Co., Ala.

Henry Hill's 1/ children named in estate files were 2nd known
generation of this Hill family. They were Rebecca Hill 2/,
Allen G. Hill 2/, Alfred Hill 2/, James Hill 2/, Henry Hill
2/, Lucinda Hill 2/, Sally Hill 2/, John Thomas Hill 2/ &
Nancy Jane Hill 2/. See information on these children below.

2. Allen G. Hill 2/, b. ca. 1792 in NC, died in Shelby County, Ala. before 1850 census. One Wife named Liddy--? Another wife unknown. Children (mother not stated):

 - b. Mary Hill 3/, b. ca. 1825/27, m. a John L. Royalty on 12 January 1842 in Franklin Co., TN.

5. HENRY HILL Jr. 2/, b. ca. 1803 in SC, d. in Titus Co., Texas 1870. He married Charity Austin on 9th May 1825 in Decatur Co., AL. He d. in Titus Co., Texas in 1870.

- a. John Charles Hill 3/, b. 4th January 1826 in Morgan Co., AL. He d. on 26th September 1905 in Ark. at age 79. He m. Susan R. Hill on 28th June 1857 in Ark. (Another source says wife was Susan E. Hill).
- b. Allen Monroe Hill 3/, b. ca. 1829 in Ala. He m. on 29th July 1852 to Elizabeth Lovey Gunn in Lafayette County, Ark.
- c. George Washington Hill 3/, b. 22nd of June 1830 in Ala., m. Louisa Jane Trackett (Tackett?) ca. 1850 in Franklin County, Ala. She was dau. of Coffee Trackett. He died 15th May 1913 in Montgomery Co., ARK. at age of 82.
- d. Benjamin Hill 3/, b. ca. 1833 in Ala., m. ca. 1860 Mary Lena Tackett, (another dau. of Coffee Trackett & sister of the above Louisa Trackett).
- e. Nancy Jane Hill 3/, b. ca. 1835 in Ala.
- f. Richard Henderson Hill 3/, b. ca. 1836, d. ca. 1892 at Mt. Vernon, Franklin Co., He m. Caroline--? in 1856.
- g. WILLIAM GREEN HILL 3/, (see later) b. ca. 1838 in Ala., d. 1870 Titus Co., Texas.
- h. Mary Elizabeth Hill 3/, b. 1 May 1847 in Miss., (another source says Ala.), she d. on 30th of June 1920 in Montgomery County, Ark.

6. Lucinda Hill 2/, b. 1804 in S.C., d. 1865 in Ala. m. James O. Rutledge on 18th February 1822 in Ala. Children:

- a. Mary Rutledge 3/, b. 1824 in Ala., m. Ezekiel Burns on 16 November 1838 in Ala.
 - b. John D. Rutledge 3/, (twin?) b. 1826 in Ala., d. 1867 in Ala. He m. 1st Sarah E. Lawrene; 2nd to Susan Cagle, b. 1826, John Rutledge 3/ d. on 7 May 1862 in CSA at St. Louis, MO.
 - c. Alfred Rutledge 3/, b. 1826 in Ala. (Twin?) m. Jane Harrison on 12 August 1845 in Ala.
 - d. Mourning Eliza Rutledge 3/, b. 1828 in Ala., m. Thomas Jefferson Dunkin on 28th July 1854 in Ala.
 - e. Henry Wilborn Rutledge 3/, b. 1835 in Ala.
 - f. Elias Seborn Rutledge 3/, b. 1836 in Ala.
 - g. Minerva Lucinda Rutledge 3/, b. 1837 in Ala.
7. Sarah (Sally) Hill 2/, b. 1805; m. George Rutledge on 7th May 1823 in Ala. Children not named. She later m. 2nd time to William L. Galloway.
8. John Thomas Hill 2/, b. 1806 in N.C., he d. in 1880 in Tarrant County, Texas. He m. Nancy McCain on the 17th of July 1829 in Lawrence County, Ala. He m. 2nd time after 23 December 1845 to Adeline Simpson, no children by 2nd

marriage. Children by 1st wife:

- a. William Washington Hill 3/, b. 1830 in Lawrence County, Ala., m. Sarah J. _____? in 1856 in Texas.

 - d. Sarah Jane Hill 3/, b. 10th October 1843 in Tippah County, Mississippi; died on 20th January 1913 in Tarrant County, Texas. She m. Thomas Allen Neace on 5th December 1865 in Denton County, Texas.
 - e. Lucinda C. Hill 3/, b. 23rd December 1845 in Tippah County, Mississippi, she d. on 21st April 1877 in Denton County, Texas. She m. Robert Wright ca. 1860.
9. Nancy Jane Hill 2/, b. 1812, d. 12th February 1820 in Morgan County, Ala. She m. Elijah B. Nunn on 20th February 1830 in Morgan County, Ala. Nancy died on 12th February 1842 in Morgan Co., Al. Their Children:
- a. Sarah Eliza Nunn 3/, b. 1832 in Morgan Co., Ala., m. William H. Chaney on 2nd May 1865 in Morgan Co., Ala.
 - b. William H. Nunn 3/, b. 1833 in Morgan Co., Ala., m. Lucinda Cooper on 15th February 1863 in Morgan County, Ala.
 - c. Mary L. Nunn 3/, b. 1837 in Morgan County, Ala., m. James Y. Morris on 29th January 1857 in Morgan Co., Ala.

My original document received from Jerry R. Hill says continued on page 3 BUT no other pages were included so this ends the Henry Hill 1/ information.

The following information was provided to me by Jerry R. Hill of Siler City, N.C. in 1992. The similarity of the above Hill family being in Texas causes me to think that the following William Green Hill is somehow related.

WILLIAM GREEN HILL.

Note: This William Green Hill DOES NOT APPEAR TO BE THE SAME man listed above, under "g" as a son of Henry Hill Jr. 2/. Notice that this William Green Hill was born in N.C. in 1801 while the son of Henry Hill Jr. 2/ named Wm. Green Hill 3/, was born ca. 1838 in Ala.

Later information in April 2000 that this man was a son of Jordan Hill 6/ & Mary Green, of Franklin Co., NC. Jordan Hill 6/ was a son of Major Green Hill Jr 5/ & first wife, Nancy Thomas.

His young wife is known to have died in Tennessee in 1829, during the birth of their first child, a daughter. They also had a son, Thomas E. Hill. The wife's name was not given.

It has been speculated that it was her death that may have caused William G. Hill to leave for Texas. He obtained land in Brazoria County, Texas and eventually put together a large farm that he named "Osceola Plantation."

In October of 1835 he joined Fannin's "Brazos Guards" as a private-although he was known as "Colonel Hill." He fought in the battle of Mission Concepcion on the 28th of October 1835? and in Grass Fight on the 26th of November 1835?

(Note by R. Hill: It is assumed these battles were all fought in 1835).

William G. Hill was discharged on the 13th of December 1835 and he was the first man to sign the "Goliad Declaration of Independence on the 20th of December 1835."

By January of 1836 Hill was embroiled in the impeachment of Henry Smith, provisional governor of Texas. Hill received one of the abusive letters that Smith wrote.

"libelling (sic) the volunteer army and the General Council as one

The article ended abruptly at this point.

*** Note: (From Byron Hill:
I assume this was from a Pension Application:
Mary Castleberry (formerly Mary Barnes Hill, widow of Jonas Hill of the NC line) filed for the claim on May 14, 1857, while living in Van Buren Co., AR at the age of 65. The

Claim states: "Jonas Hill applied for pension on January 23, 1833 while in Franklin Co., TN. He was born about 1763 in Granville Co., NC and lived in Surry Co., NC at time of enlistment. Married Mary Barnes in June of 1808. Mary Barnes was born ca. 1792. After the REvolutionary War, Jonas Hill moved to what is now East Tennessee, then moved to Pendleton Co., SC for 22 years. He then mpoved to Overton Co., TN for 2 years, then to Franklin Co., TN. Jonas Hill died on August 14, 1838 in TN. His widow remarried next to David Castleberry on March 7, 1846 in Van Buren Co., AR. David Castleberry died on June 12th, 1856.
