June 20th, 1752, (Proved) August Court 1753. SON & EXECUTOR: HENRY HILL. ("all my lands"). DAUGHTERS: Mary Campbell; Sarah McCulloch (400 acres of land on Roanoke River). Priscilla Hill. Other legatees: Margaret Cockran EXECUTOR: Thomas Jones of Petty Shore.

Witnesses: Jamews Browne, Robert Hardy, John Pett.;

Codicil to Will: dated June 6, 1753, gives land in Cashia Neck to grandson, Benjamin McCulloch. Same Witnesses to codicil. Clerk of Court was Samuel Grimes

Comments: I suspect this Harmon Hill was the son of the above George Hill.

Clerk of Court: I. Edward

Comments by Robert Hill: This was William Hill 3/, son of

Sion Hill Sr. 2/ & wife Elizabeth Spiltimber of Surry Co.,
Va. He was born ca. 1690 and married Ann DeLoach. As noted,
he died in 1748.

March 10, 1750/51 (PROVED) April Court 1741. GRANDSONS: Aaron
& Robert Hill. SONS: William, and Aaron Hill (EXECUTOR). SONS
IN LAW & EXECUTOR: Thomas Nicholson. DAUGHTERS: Rachel Hill,
Sarah Barrow, wife of Joseph Barrow.
Wits: James Griffin, Jethro Ramey, Ann Peters.
Clerk: Jas. Craven.

Comment:: Note that apparently there was a un-named daughter
that appears top be dead and who was once married to Thomas
Nicholson, the executor.

BENJAMIN HILL of Bertie Co., NC & Nansemond Co., Va.
Page 56 dated 13 January 1752. Benjamin Hill of Bertie
County, NC to David Meade of Nansemond County, VA. for 100
pounds current money of Va., 400 acres more or less, joining
Roanoke River, and a creek, as by patent dated 15 November
1728.

Comments by Robert Hill of Brandon, Fl.: The name of Henry
Hill in and around Nansemond County, Va. and of Bertie Co.,
NC make me suspicions (but not proved) that this family
connects into the Hill family with such names as Henry,
Theophilus that went into Georgia.
