### R.022 INFORMATION ON CHARLES APPLEWHITE HILL 6/, SON OF WILLIAM HILL 5/, GREEN HILL SR. 4/ AND WIFE GRACE BENNETT.

Source of Information: Mostly from a book entitled "Green Hill," by Thomas Neal Ivy (1934). Actually the book is mostly about Rev. Green Hill Jr. (son of Green Hill & Grace Bennett).

EARLY-BRIEF HILL GENEALOGY

Robert Hill 1/ & Mary Webb emigrated into Isle of Wight County, Virginia in 1642 and had two known sons, one son being Sion Hill 2/, who m. widow Elizabeth (Smith) Spiltimber. Among their children was a son Richard Hill 3/ who married Hannah Briggs and they were the parents of Green Hill Sr. 4/.

Green Hill 4/ & Grace Bennett had four sons and four daughters. This included a son William Hill 5/, born on 20th February 1750 and a daughter Mary Hill 5/ who was born on the 24th of August 1754. William Hill 5/ married in 1776 to Mary (Polly) Jones, daughter of Col. Sugre Jones and she was granddaughter of Edward Jones Sr. & Abigail Sugre.

Mary Hill 5/ married Edward Jones Jr., another son of Edward Jones Sr. & Abigail Sugre, so both William Hill 5/ & his sister, Mary Hill 5/ had the same father & mother in laws, Edward Jones Sr. & Abigail Sugre.

Edward Jones Jr. and Mary Hill 5/ had a son named Colonel Sugre Jones who married Sarah Franklin and they in turn had a son named Reverend Sugre Jones (Methodist minister), who went to Campbell County, Tennessee and on the 27th of January 1817, sold land on the Clinch River to Matthew Hill Jr., who was a grandson to William Hill 5/ & wife Mary (Polly) Jones.

#### WILLIAM HILL 5/ (REVOLUTIONARY SOLDIER).

As stated before Lt. William Hill 5/ was a son of Green Hill Sr. 4/ & Grace Bennett. He was therefore the grandson of both William Bennett of Northampton County, N.C. and Richard Hill 3/ & Hannah Briggs, residents of Surry County, Virginia.

Lt. William Hill's service in the American Revolution is clearly established among the files of the DAR.

William Hill 5/ left a will that was dated 12th June 1784 in Franklin County but which was probated in Warren County, N.C.

No probate date was listed.

Married in 1776, William Hill 5/ & wife Mary (Polly) Jones had the following children:

- 1. William Bennett Hill 6/, born 1779 m. cousin, Mary Clayton.
- 2. Samuel Sugre Hill 6/, born 1781.
- 3. James Jones Hill 6/, born 1782.
- 4. Charles Applewhite Hill 6/, born 1784.
- 5. Nancy Hill 6/, born 1786, m. Mark Cook

# CHARLES APPLEWHITE HILL 6/.

Charles Applewhite Hill 6/ was the son of William Hill 5/ & wife Mary (Polly) Jones, a son of Green Hill Sr. 4/ and his wife Grace Bennett.

Charles A, Hill 6/ was born in old Bute County, North Carolina (split in 1779 into today's Warren & Franklin County) on the 20th of February 1750 and died ca. 1784-1787 in Franklin County, N.C. The birth of Charles Applewhite Hill 6/ was in what is today's Franklin County, N.C.

In 1806, Charles Applewhite Hill 6/ married Rebecca Wesley Long, a daughter of Gabriel Long and she was the granddaughter of Colonel Nicholas Long. Of this marriage there was born nine children (listed in order of birth):

William George Hill 7/ married Saluda Patterson in Surry County, N.C. on 1st March 1867.

Mary Ann Hill 7/, no information on her has been located.

Daniel Shine Hill 7/, born 1812, married in 1835 to Susan Irwin Toole, who was the granddaughter of the famous Reverend John King, M.D., who was educated in England for the ministry of the Established Church, and afterwards became a Methodist minister and came to Baltimore, Maryland, before coming south to Virginia and N.C.

Susan Irwin Toole was also the granddaughter of Geraldus Toole, who owned fourteen thousand acres of land in Edgecombe County, N.C. (the "Conetone Plantation"). Her grandmother on her father's side of the family, was a sister of Col. Henry Irwin, who was killed at the battle of Germantown. She inherited considerable property from her father.

It should be realized that since Lt. William Hill 4/ was a son of Green Hill 4/, he was a grandson to Richard Hill 3/ and Hannah Briggs, both of Surry County, Virginia. This in turn means that Charles Applewhite Hill 5/ was a great grandson to Richard Hill 3/ & Hannah Briggs.

In turn, all of the children of Charles Applewhite Hill 5/ (listed above) were the great great (or second great) grandchildren of Richard Hill 3/, the Third great grandchildren to Sion Hill Sr. 2/ & wife Elizabeth (Smith) Spiltimber, both of Surry County, Virginia and the fourth great grandchildren to the immigrants, Robert Hill 1/ & his wife Mary Webb, who came into Isle of Wight County, Virginia in 1642.

## DANIEL SHINE HILL 7/.

Daniel Shine Hill 7/ and Susan Irwin Toole had the following known children:

- 1. Sarah Louisa Hill 8/, born 1836 married in 1857 to Matthew S. Davis of Louisburg, N.C.
- 2. Dr. Charles Geraldus Hill 8/, moved to Baltimore, Md. where he died in 1925. He was a prominent physician.

(Other children were given only as married ladies)

- 4. Mrs. Madeline Best 8/.
- 5. Mrs. Pauline Brooks 8/, m. Dr. John R. Brooks of the Methodist Ministry.

- 9. William Hill 8/.
- 10. Mrs. Carrie Painter 8/.

Kemp Plummer Hill 7/, was the father of William H. H. Hill 8/ who married Tempe Hillard Gee, daughter of Charles J. Gee and Martha Williams, daughter of Captain Solomon Williams and wife Tempie. (Ref: History of Alston Family, pp 445 & 486).

Nicholas Long Hill 7/. A Nicholas Hill married Alberta Hughes on the 30th of December 1866 in Northampton County, N.C. This may be the same man.

Richard Henry Hill 7/. A Richard H. Hill married Anna M. Powell in Gates County, N.C. on 27th February 1860. This may be the same man.
