Source: The following was part of my notes taken during my own research on June 12th, & 13th 1987 while visiting the S.C. State Archives at Columbia, S.C. with my son. This is just part of the notes. I have not tried to copy all of the notes as they do not concern this particular Woodward family. Also information on Family Group Sheets received from Mr. John Mobley of Columbia, S.C.

#### TODAY'S FAIRFIELD COUNTY

At this time (1760s, early 1770s) it is was known as Craven County, then Camden District, S.C. It became Fairfield County in 1785.

A Richard Woodward bought land from Philip Walker on the 15th of April 1777. Mrs Day and I both suspect this was Richard Woodward Jr. 10/ (tenth generation).

John Woodward 10/, brother of Richard above, sold land to his son Burbage Woodward 11/ on the 5th of November 1790 in Fairfield County, S.C. (as of 1785).

# BARNWELL COUNTY S.C.

S.C. land grants shows a Charles Woodward obtained a land grant for 150 acres on 3rd September 1787 in Orangeburg District, S.C. This means he was at least 21 years of age in 1787, showing he was born no later than 1766, and probably before.

The 1790 Census in Orangeburg District, S.C. (included today's Barnwell, Orangeburg, Lexington, and parts of Aiken & Bamburg Counties)

Charles Woodward 1 free white male of 16 yrs old 4 white males under 16 3 white free females (probably includes wife

From the above census it seems that Charles was the 1 male 16

and above. It appears that he had 4 sons (under 16) and 2 daughters, or a total of 6 children. The other female listed was his wife Keziah Woodward.

My guess is that Charles Woodward was a married man by 1787 when he got the above land grant and was born in the early to mid 1750s. (wonder if he was a Revolutionary Soldier).

Following Entered in May 1993: Reference to Charles Woodward of Barnwell County, S.C.:

I am assuming that the oldest child was 15 years old in the above 1790 census, or born ca. 1775, and allowing 2 years between the 6 children, and working back in time, then we would have children born ca. 1775, 1773, 1771, 1769, 1767 and 1765. This suggest to me that Charles Woodward & wife married ca. 1773-1774. Charles Woodward was probably born about 1750-1755 (in Va.).

# CHARLES WOODWARD ESTATE.

Charles Woodward probably died in the very last days of December 1813 or very early January of 1814. In these days, the estates were administered very quickly after a death and Charles Woodward's estate was administered on the 3rd of January 1814 by his widow KEZIAH WOODWARD and her bond was signed by (sons or brothers, probably sons?) Charles Woodward and James Woodward. There was no listing of any heirs.

BARNWELL COUNTY DEED BOOK B, PAGE 180 Mrs. KEZIAH WOODWARD, (widow of Charles Woodward Sr.) made a deed of Gift, dated 10 March 1825, to (probably her sons) Richard Woodward & James Woodward, the heirs of Charles Woodward Sr., 1 acre of land for a family graveyard. It was witnessed by Daniel W. Johnson & William Woodward.

Reference to the above deed:

Since Richard & James Woodward were named as "heirs of Charles Woodward Sr." suggest that they were his sons. I suspect that a Charles Woodward (Jr.); a James Woodward; a William Woodward & Richard Woodward were the four sons of the deceased Charles Woodward (Sr.?) and his widowed wife, Mrs. Keziah Woodward.

Note dated 1 May 1993 by me:

In a letter from Mr. John Woodward III of Jesup, Georgia, dated 21st April 1993, he states that Charles & Keziah Woodward had a daughter named Keziah Woodward that MAY have married Robert Rutherford in Baldwin County, Ga. I wonder who their other daughter was?

Andrea says that the wife of Charles Woodward, KEZIAH WOODWARD, was a sister in law of a JAMES WOODWARD, meaning

her husband had a brother named James Woodward.

We know there was a James Woodward that moved from the Fairfield County area into the vicinity of today's Barnwell County. I am fairly certain that he is the one that married Annie Feaster.

Maybe he is the James Woodward mentioned in the above deed of gift, but I think that this James Woodward was a son of Charles & Keziah Woodward.

- 1. A Charles Woodward had a land grant in what is today's Barnwell County, S.C. on the 3rd of September 1797. (Probably Charles Sr. with wife Keziah).
- 2. James Woodward Sr... had land grant there 7 March 1814. (probably brother or son of Charles).
- 3. James Woodward Jr. had a land grant 3 July 1820. (probably son of the above James).
- 4. William Woodward had a land grant 7 Feb. 1814. (thought to be son of Charles).

Following taken from Andrea Collection at U. of S.C. Library:

James Woodward Sr. wed Annie Fasly or Feasler... She is buried at Rosemary Baptist Church and her tombstone reads.. "ANNIE/ Wife of James Woodward/ Died 10 August 1887/Age 93." This makes her born ca. 1794. This James Woodward was the youngest son of RICHARD WOODWARD (# 57) of Fairfield County S.C.

end of Andrea file.

I strongly suspect that the wife's name may have been Annie Feaster of Fairfield County, S.C.! The Feaster family is well known among Fairfield County researchers. From a combination of these two items above, I suspect that James Woodward Sr. and Charles Woodward (Sr.?) the deceased, who had the wife named Keziah, could both be children of a Richard Woodward, who is listed in Andrea's collection under Number 57. Check this out to see if there is a connection to Thomas (Regulator) Woodward's family line!

Later investigation shows that there was no connection to Thomas Woodward, the Regulator.

Notation on 1st May 1993: Mr John Woodward III of Jessup, Georgia provided data that there were children.

DATA (RECEIVED) FROM MRS. PAULINE WOODWARD. RICHARD WOODWARD was a son of Thomas Woodward, the Regulator, by his 2nd wife nee Elizabeth Stokes (May).

I shall have to examine all of this data in Winnsboro to see if the above is correct.

I have entered the following into the Andrea collection, just below the above:

"NOTE BY ROBERT HILL: The above is WRONG! Richard Woodward was not, repeat WAS NOT the son of Thomas Woodward, known as the Regulator. Perhaps he was the son of the other Thomas Woodward, a Revolutionary Soldier from N.C."

end of my note.

My research notes in June 1987:

The Regulator and his 2nd wife Elizabeth Stokes May had no child by the name of Richard Woodward. It appears that Mrs. Johnson is confused about the father of Richard Woodward being the Regulator. With the help of Mrs. Day, also a genealogist that has helped me on the Woodward family of the Jamestown-Bedford County area of Virginia, we have come up with the following possibility or probability that a Richard Woodward, originally of Virginia, but who settled in today's Fairfield County, S.C., had the following children: (not necessarily in order of birth)

George Woodward mMorgan.
Margaret Woodward died single and see (# 50).
John Woodward , listed as number 53 by Andrea.
Charles Woodward m. Keziah?
James Woodward, youngest m. Annie Feaster.
If we are right in our thinking, he was the James Woodward Sr. listed in Barnwell County, S.C. & probably the brother of Charles Woodward (m. Keziah?).
Information based upon FGS from Mr. John Mobley of Columbia,

S.C.:

#### DR. HENRY WOODWARD.

Said to be the son of John Woodward & his wife, a daughter of Captain William Pierce.

Dr. Henry Woodward was born ca. 1646 and is said to have died while in his early forties. This would be about 1686-1690.

Dr. Henry Woodward (Surgeon) is said to have been the first permanent "white" settler in South Carolina. He arrived in South Carolina in 1666 as part of an exploratory expedition of the coastal areas of the Carolinas. He was captured by the Spanish & taken to St. Augustine, Florida and became a "Catholic."

Henry Woodward is said to have married three times. His first marriage was to Elizabeth Yeardley, daughter of Francis Yeardley. She had given him up for dead and had married Edward Ward.

Henry Woodward married the second time to Margaret "Meg" Winter, who was living in 1677. She is said to have died on board a ship that left England and was captured by the Spanish and sunk.

His third marriage was to (widow) Mrs. Mary Godfrey Brown, daughter of Colonel John Godfrey and wife Mary---? After the death of Henry Woodward, Mary remarried again to Lieutenant William Davis. It appears he may have had children by an Indian woman.

The children of Dr. Henry Woodward were: by first wife:

1. Francis Woodward, born 1657, married Mary Hayes.

- 2. Coosapomokeese (Mary) Woodward, married Johnny Musgrove.
- 3. A child by Tw Que La Que, a niece of the Carique Santa Clara Niquesalla (Indian names).

# children by 3rd wife:

- 4. John Woodward, born 19th February 1861 in South Carolina. He married on 11th May 1702 to Elizabeth Stanyarne, he died on 7th January 1726/27. (see below).
- 5. Richard Woodward, born 9th June 1683 in South Carolina. He married Sarah Stanyarne. He died on 13th June 1725.
- 6. Elizabeth Woodward, married William Wilkins. Had a child named William Wilkins. No other data given.

Henry Woodward was said to have been rescued from the Spanish by Robert Seale & taken to the Leeward Islands. Her joined the first fleet which was sailing from England to Port Royal (Jamaica). At Nevis (sic) ??? he served as interpreter and Indian Agent. He became agent of Lord Ashley's Plantation; later made agent for the Lord's many enterprises. His will of 17th July 1671 was prematurely probated in 1671. He returned critically ill while on an expedition to the Lower Creek Indians in 1686. (Proof only of children 1, 2 and 3 above)

#### JOHN WOODWARD.

Son Dr. Henry Woodward & 3rd wife, Mary Godfrey Browne. John Woodward was born on the 19th of February 1681, married on 11th of May 1702 to Elizabeth Stanyarne, daughter of Colonel James Stanyarne & Rachel Fitch, who died in 1742.

John Woodward died on the 7th of January 1726 or 1727.

# Children:

- 1. Mary Woodward, born 24th May 1703, married 25th July 1719 to Col. John Gibbs (1696-1764). Mary's death date not given.
- 2. Elizabeth Woodward, born 3rd March 1704-05, married Col. Joseph Edward Flower on the 22nd of December 1737. She died on the 31st of May 1707? (sic) (an obvious error).
- 3. John Woodward, born 29th March 1707, unmarried.
- 4. Richard Woodward, born 8th June 1709, married 1st Susanne Mazyck (1712-1735 on 4th June 1734. They had no children. She was the daughter of Isaac Mazyck. His 2nd marriage was to Elizabeth Godin on 4th November 1736, daughter of Benjamin Godin.
- 5. Henry Woodward, born 22nd of June 1711, died 21st August 1712.
- 6. James Woodward, born 27th March 1715, died 9th August 1716.
- 7. Sarah Woodward, born 20th July 1717, died 18th September 1718.
- 8. Elizabeth Woodward, born 3rd September 1719, married 1st in 1737 to Col. Joseph Edward Flower(s) at Beaufort, S.C. His 2nd marriage was to Connelius DePont.
- 9. Thomas Woodward, born 13th September 1722, died 7th August 1737.
- 10. James Woodward, born 6th July 1727, died 10th August 1730.
- 11. John Woodward, no information or dates given.

# FRANCIS WOODWARD.

Francis Woodward was born ca. 1657. He married Mary Hayes,

daughter of Owen Hayes. No locations or dates were listed.

FRANCIS WOODWARD (WHO MAY BE THE SON ABOVE NAMED FRANCIS WOODWARD).

Francis Woodward married Lydia---? Their children:

- 1. Thomas Woodward.
- 2. CHARLES WOODWARD, born ca. 1755, said to have been a Revolutionary Soldier in Virginia, married 1st --- ?; 2nd to Keziah Morris, a Quaker. Marriage before 1779. Charles had a land grant in Orangeburg District (County), S.C. He named his home place as Montmorienci, where he died before 9th December 1813 (now Aiken County, S.C.)

MARY WOODWARD, DAUGHTER OF JOHN WOODWARD & WIFE ELIZABETH STANYARNE.

Mary Woodward, born 24th May 1703, married on 25th July 1719 to Colonel John Gibbes, born 1696, died 1764. Mary Woodward Gibbes' death date was not listed.

#### Children:

- 1. Mary Gibbes, born 26th February 1722, married 7th August 1738 to Colonel Nathaniel Barnwell. She died on 4th December 1801. It is said that she had 22 (twenty-two) children, 14 are known, but no names were listed.
- 2. Sarah Gibbes, born 17th February 1725/26, married John Matthews on 10th November 1741. She died in 1760.
- 3. Elizabeth Gibbes, born 5th May 1728, married 1st on 14th March 1744 to John Ladson; 2nd marriage to Dr. James Carson on 8th December 1752.
- 4. "Annie" Gibbes, born 31st May 1730, married William Ladson on 5th October 1752. She died on 12th October 1755.

- 5. Robert Gibbes, born 13th July 1732, 1st married Anne Stanyarne on 17th November 1753; 2nd to Sarah Reeve in March 1764.
- 6. John Gibbes, born 27th December 1733, married 2nd May 1754 to Margaret Anne Stevens.

# ELIZABETH WOODWARD, DAUGHTER OF JOHN WOODWARD & ELIZABETH STANYARNE.

Elizabeth Woodward was born on the 3rd of September 1719. She first married Colonel James Edward Flower(s). Her second marriage was to Cornelius DePont.

They had two known children:

- 1. Mary Flower(s).
- 2. Woodward Flower(s).

No other information given.

# RICHARD WOODWARD, SON OF JOHN WOODWARD & ELIZABETH STANYARNE.

Richard Woodward was born on the 8th of June 1709 and died in 1744 (will recorded). He first married on the 4th of June 1734 to Susanne Mazyck, daughter of Isaac Mazyck. She was born 1712, died 1735.. They had no children. His second marriage was to Elizabeth Godin, daughter of Benjamin Godin. Elizabeth died on 26th of March 1751, had one child.

1. Elizabeth Woodward, born 28th June 1738, married Stephen Bull of Sheldon, who was a Brigadier General in the S.C. Militia during the Revolution. He later married Mrs. Ann Middleton, widow of Colonel Thomas Middleton and the daughter of Colonel Nathaniel Barnwell.

# ELIZABETH WOODWARD, DAUGHTER OF JOHN WOODWARD AND ELIZABETH STANYARNE.

Elizabeth Woodward was born on the 3rd of March 1764/65 and she married on the 22nd of December 1737 to Colonel Joseph Edward Flower(s). She died on the 31 of May 1707 (obvious error in date). They had two children:

- 1. Richard Woodward, Flower(s), born 24th February 1744, died 22nd of March 1786, he never married.
- 2. Mary Flower(s), born 8th November 1741, married 1st William Bower in 1761; 2nd marriage to Cornelius DuPont in March 1764.

RICHARD WOODWARD, SON OF DR. HENRY WOODWARD AND WIDOW MARY GODFREY BROWNE.

Richard Woodward was born on the 9th of June 1683, died in

JUne 1725 and was buried on 13th June 1725. His wife was Sarah Stanyarne, who died in 1748. She was a daughter of Colonel James Stanyarne and Rachel Fitch (d. 1742). They had three children:

- 1. Elizabeth Woodward, born 5th May 1715, married on 10th March 1729 to Richard Wright, son of Chief Justice Robert Wright. They had no children.
- 2. Mary Woodward, born 6th December 1717, first married on 6th November 1735 to Isaac Chardon (d. 1736); 2nd marriage to Reverend William Huston in March 1743.
- 3. Richard Woodward, died 1723, no other dates or information given.
