R.042 RESEARCH INFORMATION ON THE CHARLES WOODWARD FAMILY OF BARNWELL COUNTY, SOUTH CAROLINA, ALSO SOME BRIEF INFORMATION ON OTHER WOODWARDS, OF BARNWELL, KERSHAW COUNTIES OF S.C., INCLUDING A MICAJAH WOODWARD.

### CHARLES WOODWARD SR. 1/.

The origins of Charles Woodward Sr. 1/ are unknown as are the names of his parents. His birth is thought to have been about 1755, probably in Virginia. His death took place in Barnwell County, South Carolina in 1813.

In the Anson County, North Carolina Court Minutes for 1771-1777, a document dated 15 October 1774 shows the following: Quote: "Ordered that Samuel Skipper be summoned to bring Henry, William & Charles Woodward, Orphans of Charles Woodward, deceased, to next court." End of Quote.

It is very possible, but yet to be proved, that Charles Woodward Sr. 1/, of Barnwell County, S.C. was the son named above as Charles Woodward, along with his brothers, Henry and William Woodward.

The first definite information known about Charles Woodward Sr. 1/ was that he apparently settled on 50 acres of land in Kershaw District (County) South Carolina on some unknown date. On that 50 acres, he reserved a 10 square yard spot for a family cemetery, indicating that he was already a man with a family.

On the 4th of November 1804, Charles Woodward 1/ sold this 50 acres to Hebbs Bradley for \$ 200.00. (See deed below).

# STATE OF SOUTH CAROLINA DISTRICT OF KERSHAW

Know all men by these presents that I, CHARLES WOODWARD of Kershaw District, in the state aforesaid, planter, in consideration of the sum of Two Hundred Dollars, to me in hand paid by Hebbs Bradley, of Kershaw District in the state aforesaid, planter, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto Hebbs Bradley, all that certain tract of land containing Fifty Acres, more or less, being and lying on FRANCES QUARTER CREEK, containing and bounded and butting as follows:

On the North by Robinson's Mill land.

On the West by land belonging to Joseph Randero and William Brown and to a certain Sweet Gum tree on that line, and from thence (on) a straight course to the spring and to keep it west as (it?) strikes the West line of said land and takes all (of) the lower part except for a square part (The square yards known to be a burying place) when granted.

Together with all and singular the rights, members and appurtenances and hereditaments to the said premises belonging or in any wise incident to or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Hebbs Bradley, his heirs and assigns forever, and I do hereby bind myself, my heirs, executors and Administrators to warrant and forever defend all and singular the said premises unto the said Hebbs Bradley, his heirs and assigns against myself, and heirs and against every person whomsoever lawfully claiming or to claim or any part thereof.

Witness my hand and seal this 7th day of November in the year of our Lord, One Thousand Eight Hundred and Four (7 November 1804) and of the Independence of the United States of America as the Twenty Eights & Twenty Ninth.

Charles Robinson personally appeared before me and made oath that he was present and I saw the within mentioned Charles Woodward make his mark there and as his act and deed, delivered this within deed for the uses and purposes therein mentioned and that he also saw Hugh Micklin subscribe his name thereto as a witness, together with the deponent. Sworn to this 24th day of January 1806.

Meanwhile, it seems that Charles Woodward 1/ had purchased 460 acres of land for \$ 390.00 from a Mr. Abraham Richardson. This land was called "The Pole Cat Tract." Based upon the wording of a law suit filed in October of 1833, by the heirs of Charles Woodward 1/, it appears that Charles Woodward 1/ bought this 460 acre tract, known as the Pole Cat Tract about 1793.

Later, around 1802, a Mr. John Franks informed Charles Woodward 1/ that he was the owner of the land. He held a state grant. While details of this claim are unknown, there

must have been some merit to the claim by Franks because on the 6th of May 1802, Charles Woodward 1/, by deed, paid John Franks for the 460 acres known as "Pole Cat Tract." He then filed a law suit for "fraud" against Abraham Richardson, and got his money back.

There is another date listed for this deed, 12th September 1808. Mr. John R. Woodward III, who furnished this information, did send this writer a copy of the deed nor did he explain what this last date was so it is not understood just what occurred but it may refer to the final settlement that Charles Woodward 1/ had against Abraham Richardson. (Ref: Barnwell Deed Book D, Page 62).

Charles Woodward Sr.'s 1/ wife was named Keziah, and one Woodward family member states her maiden name was Morris, although there has been no actual proof of this. Keziah (Morris?) Woodward's birth & death dates are unknown but it is estimated by this writer that she was born ca. 1764-1765 in South Carolina.

James Woodward 2/ was a son of Charles 1/ & Keziah Woodward and James died in 1820 or 1821. (Ref: Testimony of 1833 Law Suit). In 1833 his widow and children filed a law suit which stated that Charles Woodward 1/ had possession of the land known as "Pole Cat Tract" for about 20 years and since he died in 1813 it seems that Charles Woodward 1/ obtained the land ca. 1793.

Charles Woodward 1/ had died in 1813 and his widow, Keziah Woodward sold part of the Pole Cat Tract as seen by the deed below dated 29th October 1823, with some exceptions, and one of those was a small chunk of land set aside for the family cemetery.

Keziah Woodward made the deed to William D. Wade for 1/3 of the "Pole Cat Tract" for \$ 150.00. (Reference: Barnwell Deed Book P. Page 180). It seems that she made an affidavit relating to this sale on the 10th of March 1825. so Keziah Woodward was alive as late as that date.

State of South Carolina )

Barnwell County ) Know all men by these presents that I Keziah Woodard (sic) of the District of Barnwell for the consideration of \$ 150.00 do relinquish all my rights, title and claim to 1/3 part of the Pole Cat Tract of land unto William D. Wade, excepting 2 parts out of 8, which includes the whole of 1/3 acre, which said 2 parts or 2/8 is one to go to RICHARD WOODARD and the other to the heirs of JAMES WOODWARD at my death, also one fourth part of an acre where the grave yard is, which I reserve for myself and family. IN WITNESS whereof I have here unto set my hand and

seal this 29th day of October 1823, in the 47th year of the Independence of the United States of America.

Charles Woodward 1/ and the Simeon Cushman family appear to have had close relations with each other because four of their respective children inter married.

While we have the names of the children of Charles & Keziah Woodward, we do not have any complete birth dates or death dates but from the Cushman family genealogy, we do have a four marriage dates. This gives us the opportunity to estimate four of the Woodward children's births. Below is a listing of the children, their estimated birth and their spouses.

- 1. Elizabeth Woodward 2/, born ca. 1783-1787, married James Cushman in 1803, a son of Simeon Cushman. This early marriage date gives cause to think she was the oldest child. Births estimated on her age of 16-20 when she married.
- 2. James Woodward 2/, born ca. 1784-85, married Judith Cushman, dau. of Simeon Cushman about 1809-1810. James Woodward 2/ died ca. 1820-1821. No actual marriage date was given but the age of the eldest on (Carpus Woodward) in 1833 law suit shows his birth was ca. 1809, thus the marriage is estimated ca. 1807-1808.
- 3. Charles Woodward Jr. 2/, born ca. 1787, married Rebecca Cushman in 1812, the daughter of Simeon Cushman.
- 4. William Henry Woodward 2/, born ca. 1790, married 1st Annie Johnson; 2nd Nancy Hair and he died in 1865.
- 5. Keziah Woodward 2/, birth estimated ca. 1792, married Wilson Stuart. (Birth date a guess).
- 6. Richard Woodward 2/, born ca. 1795, wife was named Sarah-?. (Birth date based on 1850 census).
- 7. Sarah Woodward 2/, born ca. 1797, married George LaMar.
- 8. Mary Woodward 2/, born ca. 1800-1803, married on 12th July 1819 to Carpus Cushman, son of Simeon Cushman. He was a farmer and teacher in Barnwell County, S.C.

It has been established that James Woodward 2/ & wife Judith Cushman had the following children:

- 1. Carpus Woodward 3/, born 1809 (based on testimony in a 1833 law suit).
- 2. Sarah Woodward 3/.

- 3. William Woodward 3/.
- 4. James Woodward (Jr.) 3/.
- 5. Emily Woodward 3/.
- 6. Oliver Woodward 3/ (b. Feb. 1821)

On the 23rd of October, 1833 Judith Cushman Woodward, widow of James Woodward 2/, along with her children, filed a law suit against Edward W. Wade and Daniel W. Johnson over this land known as Pole Cat Tract. (Note: The daughter of Daniel Johnson married William Wade, son of the above Edward W. Wade). This law suit provides us with some valuable information regarding Charles Woodward Sr. 1/ and his family.

The petitioners (widow & children of James Woodward 2/) state that their father's father (Charles Woodward 1/) died intestate (blank date but it was 1813) and that Charles Woodward 1/ was survived by the following children as his heirs:

The said James Woodward 2/ (father of the petitioners); William Woodward 2/; Richard Woodward 2/; Sarah Woodward 2/ who married George Lamar; Keziah Woodward 2/ who married Wilson Stuart; Elizabeth Woodward 2/ who married James Cushman; Charles Woodward Jr. 2/; and Mary Woodward 2/ who married Carpus Cushman.

These children, by inheritance from their said father, became possessed of a tract of 460 acres in Barnwell District, on Polecat Pond, adjoining lands now owned by James Cushman, Ezekiel Evans and Judith Woodward.

The petitioners state (or claim) that their father, James Woodward 2/, was in possession of 1/8 part of the land (or 57 and 1/2 acres) that he had inherited from his father, Charles Woodward Sr. 1/ who had died in 1813. James Woodward 2/, their father had died (date left blank) intestate, at which time, the land descended to his widow, Judith Woodward and the petitioners known as the children of James 2/ and Judith Woodward.

The law suit goes on and states that about 9 or 10 years ago (1823-1824) William Woodward 2/; Richard Woodward 2/; Sarah Woodward 2/ Lamar (m. George Lamar); Keziah Woodward 2/ Stuart (m. Wilson Stuart); Elizabeth Woodward 2/ Cushman (m. James Cushman); Charles Woodward Jr. 2/ and Mary Woodward 2/ Cushman (m. Carpus Cushman) all children of Charles Woodward Sr. 1/ & wife Keziah Woodward, and brother and sisters to James Woodward 2/ (father of the petitioners) sold and deeded their interest in the said land to Edward W. Wade (or perhaps to other parties who in turn deeded it to Wade) and that the latter (Edward W. Wade) has been in possession of the land for 9 or 10 years (since ca. 1823-1824) and received the

profits thereof, and declines to account for same or agrees to a partition.

The court then allowed an amendment by the petitioners naming Daniel W. Johnson as a party defendant, and Johnson states in his answer that he bought the interest of Charles Woodward Jr. 2/ (son of Charles Sr. 1/) and that he has been in possession of (that) part of the premises for the past ten years (since ca. 1823), living on the land, making improvements etc..having about 15 acres in cultivation. He admits the interest of the plaintiffs and consents to a partition.

Edward W. Wade, in his answer, admits the plaintiffs' interest in the land and he denies having refused partition; states he has been in possession of the land for about 10 years (1823) and that Charles Woodward Sr. 1/ was in possession of the land for about 20 years and after his death (1813) the land descended to the widow Keziah Woodward and eight children: William Woodward 2/; Richard Woodward 2/; Sarah 2/ Lamar; Keziah 2/ Stuart; Elizabeth 2/ Cushman; Charles Woodward 2/ and Mary 2/ Cushman.

The widow, Keziah Woodward, was entitled (by law) to one third of the land and the children 1/12 each. The defendant has purchased the shares of the said widow Keziah Woodward and six of the said children; says that up until lately, the complainants have been minors and that no one would represent them as "next fried" and that he has been unable to bring about a partition. He says that he has made improvements, built a home and made other valuable improvements, has planted 50 acres a year for the first 5 years and for the last 4 years an average of 100 acres each year; says the land is poor. He asked that the property be assessed or appraised and that he be allowed to pay the complainants for their undivided interest on that basis.

On the 30th of January 1835, the commissioner's report showed that Charles Woodward 1/ had bought the land from Ab Richardson, who gave him some kind of a instrument (a note, deed or receipt) but which "is not to be had" but is supposed to be in the file of a law suit in Edgefield District, in which Charles Woodward 1/, finding or believing that his title from Richardson to be defective, sued Richardson to recover the money he had paid him; AND HE RECOVERED THE MONEY.

Meanwhile, Charles Woodward 1/ had settled on the property and made improvements. Later, a man named (John) Franks came to Woodward and claimed he had the title to the land; Woodward then bought from Franks and paid him a part of the purchase price and gave his notes for the balance and Franks gave receipts but never did make Woodward a deed. Woodward later died, in 1813, while living on the land, dying

intestate, leaving a widow and 8 children as above stated. Charles Woodward Jr. 2/ later bought five (5) of the shares of his brothers and sisters viz: Elizabeth's; Keziah's; William's; Richard's; and Sarah's, which with his own share, made 6 shares and which he then sold to George Lamar (husband of Sarah Woodward 2/) and Lamar then sold to E.W. Wade. William Woodward 2/ then bought his sister Mary Woodward's 2/ share and sold it to Daniel W. Johnson. JAMES WOODWARD'S 2/ SHARE IS THE ONLY ONE UNSOLD!

The Richardson deal was about twenty (20) years ago.

(Note: This apparently refers to the law suit filed by Charles Woodward 1/ against Abraham Richardson, which would have been about 1813, the year that Charles Woodward 1/ died. This (to me) is obviously wrong and it is obvious that the law suit was filed much earlier, probably about 1804-1807).

Charles Woodward Sr. 1/ died in 1813 and his son James Woodward 2/ died 11 or 12 years ago (about 1821-22) leaving a widow Judith and six children (the complainants). Widow Judith sold her 1/3 of her husband's share to William D. Wade, who in turn deeded it to Edward W. Wade. In June of 1825, Wade obtained the State's grant to the land on the advice of a friend, to make his title doubly secure.

Further testimony by the commissioner shows that Wade had through his son, Martin Wade, cut a good deal of cordwood (or "litewood") off the land and hauled it to the railroad. A certificate is in the file, signed 16th August 1834, by George B. Lythzce?, certifying that since April 1st previously, there had been delivered at the "Johnson Turnout" on the railroad, 140 cords of wood, which he believes came off the lands of D.W. Johnson and E. W. Wade, and for which the South Carolina Railroad Company, is to pay \$ 1.50 per cord to the proper parties.

Testimony shows that Daniel W. Johnson has lived on the land for the last eight (8) years (since ca. 1825) on the place where he now lives on the land. Before that, he lived for about a year in the old house built by Charles Woodward Sr. 1/ (lived there about 1823-1824).

Carpus Cushman (who had married Mary Woodward 2/, daughter of Charles Woodward Sr. 1/) testified that Wade (Edward W. Wade) has made some good improvements on the property; he built a new dwelling-house with a brick chimney, about 10 years ago (built about 1823), and converted the old house into a barn. Two dwelling-houses are (now) on Wade's land. William D. Wade, one of his sons, has married since the family moved there and his father (Edward W. Wade) has settled him on the place. Cushman further testified to the fact that James Woodward 2/ was a son of Charles Woodward 1/; and that said James Woodward 2/, father of the petitioners, died about

1820, and that James' youngest son (not named) was born in February 1821. Carpus Woodward 3/ (son of James 2/) is about 24 years old (born ca. 1810-1811).

The commissioner's report says that the land was not capable of division; that it was appraised as \$ 2.00 per acre, making \$ 920.00 for the land and the improvements valued at \$ 800.00; and it was recommended that Wade, the principal owner, pay the complainants on that basis. The report was dated 30th January 1835, and was duly confirmed. (In other words, the court ruled for the complainants (i.e. The Woodwards).

### End of the Law Suit.

Now this law suit gives us some very good genealogical information. In the law suit it is stated that Charles Woodward Sr. 1/ had possession of the land for about twenty (20) years. Since it is known that Charles died in 1813, and assuming the testimony to be correct, then Charles Woodward 1/ purchased the land from Abraham Richardson about 1793.

Testimony shows that James Woodward 2/, son of Charles 1/, died about 1820-1821. It also shows that Carpus Woodward 3/, son of James Woodward 2/, was probably the eldest son and since he was listed as being about 24 years old at the time of the commissioner's report, dated 30th January 1835, his birth was about 1811. It also states that the youngest son (not named) was born in February of 1821.

This un-named youngest son is thought to have been Oliver Woodward 3/, as testimony shows some children were still minors when the suit was filed on the 23rd of October 1833. The name of Oliver Woodward 3/ is not to be found among those children named in the law suit, probably because he was either dead or he was still a very young minor with his mother, Judith Woodward, acting in his behalf.

Since we have established the birth of the eldest son, Carpus Woodward 3/ as being about 1811, in all probability, his parents, James Woodward 2/ and Judith Cushman, probably married about 1809 or 1810.

Information from the Cushman family shows that James Cushman married Elizabeth Woodward 2/ (daughter of Charles 1/) in 1803 and this early marriage seems to show that Elizabeth Woodward 2/ was the eldest of the eight children of Charles 1/ & Keziah Woodward.

Unfortunately, the Cushman information does not list a marriage date for Judith Cushman and James Woodward 2/ but it appears that James Woodward 2/ was the second child but the eldest son of Charles 1/ & Keziah Woodward, having been born ca. 1784-1785. If this is true, then James Woodward 2/

married at the age of about twenty-five (25).

One must be very careful in using the testimony in this law suit as apparently the different witnesses had trouble in remembering the dates and the related facts. A good example is the following statement in the commissioner's report, dated 30th January 1835, that the "the Richardson deal was about twenty years ago." end of quote.

This appears to be referring to the trouble between Charles Woodward 1/ & Ab Richardson, and not to the original purchase, which based on the testimony made by the defendant, Edward W. Wade, who says that Charles Woodward 1/ had possession of the land for "about twenty years."

Going back some twenty years from the time of the testimony by Wade (which was in late 1833 or early 1834), would indicate that Charles Woodward 1/ had bought the land from Ab Richardson around 1813-1814.

Now it has already been established that Charles Woodward 1/died in 1813, and before that, he had filed a law suit against Ab Richardson, who sold him the land, for "fraud" and got his money back and then had to pay off a Mr. John Franks, who claimed he had title to the land known as Pole Cat Tract.

All of this took time so the "Ab Richardson deal" was obviously much longer than twenty years ago and the suspicion is that it was about twenty-five or thirty years ago (about 1800-1805) when Charles Woodward 1/ filed his law suit against Ab Richardson.

It is recommended that someone make a further study of the Cushman family, especially the 8th generation be studied further as well as research on the Stuart and LaMar families should be conducted.

Reference to the cemetery mentioned in the deed between Charles Woodward & Hebbs Bradley... The above cemetery was once located on a 490 acres tract known as "The Polecat Tract" and it is thought that both Charles Woodward Sr. 1/ and his wife, Keziah Woodward were originally buried here.

In October of 1981, due to the construction of the Nuclear Power Plant at Aiken, S.C., the Institute of Archeology & Anthropology, University of South Carolina, for the Savannah River Operations Office, U.S. Department of Energy, inventoried several cemeteries and relocated several of the graves to other locations. This included the above "Polecat Tract Cemetery."

This particular cemetery was labeled as "Cemetery Number 144." The location given is as follows: Follow SRP 8 (for)

1.7 miles from the Williston Barricade to 8-3 (Laura Weeks Road), take this road .4 of a mile to the cemetery on the right side of the road. Access to this cemetery is extremely good as all roads to the cemetery are paved. The cemetery itself is in fairly good condition, only slightly overgrown with weeds. Of the fifteen graves supposed to be here, fourteen were located, one of which was unmarked (see following map and table for list of individuals).

There was one grave enclosed by a "Wire mesh fence." This grave (Grave No. 1 below) was that of a unknown person or persons and may have been that of either Charles Woodward Sr. 1/ or his wife, Keziah Woodward, or possibly both.

\*\* Reference to Number 3: William Henry Woodward Jr., son of William H. Woodward & wife Sarah, he fell at the Battle of Fredericksburg, Virginia, Corporal, Company H, 1st Regiment of S.C. Volunteers, age 20 years old.

\*\*\* Reference to Number 4: Elias Woodward CSA, son of William Henry Woodward and wife Sarah \_\_\_\_\_\_Woodward was born on 16th October 1830, contacted bronchitis in Virginia while serving under Stonewall Jackson, and came home to die (16th May 1863).

Reference to Number 12, She was wife of Robert Quincy Woodward, who's grave is listed as Number 11 above.

William Woodward 2/, son of Charles 1/ & Keziah Woodward, was known as "Black Bill." He was a Justice of the Peace in and around Barnwell County, South Carolina.

The above William Woodward 2/ had a son also named William Woodward (Jr.) 3/, who was the father of John Ardis Woodward 4/, who married his first cousin, Elizabeth Woodward, and

they were the parents of John Richard Woodward Sr. 5/. John Richard Woodward Sr. 5/ and his wife had among their children a son also named John Richard Woodward Jr. (II) or 6/ (6th generation), who was born on the 13th of April 1906 in Blackville, Barnwell County, South Carolina.

John Richard Woodward Jr. (II) 6/, had a son named John Richard Woodward (III) or 7/ (7th generation), who was born on the 17th of February 1929 at Folkston, Charlton County, Georgia. Other children of John Richard Woodward Jr. 6/ was Carole Virginia Woodward 7/ and Joseph Akin Woodward 7/, born 7th of February 1939 at Jesup, Georgia.

#### JOHN RICHARD WOODWARD SR. 5/ GENERATION.

John Richard Woodward Sr. 5/ was born on the 15th of August 1872. He died on the 27th of September 1946. He was married twice, first to Nilla Anna Hair (b. 12th December 1872. This marriage took place on the 8th of February 1894. Nilla Hair Woodward died on the 9th of July 1901 during the birth of twins, who also died at the same time. Her grave is located in the Hair Cemetery, near Elke, South Carolina, which was inventoried by Jennings Roundtree Jr. in 1986. The marker reads as follows:

"Nilla Anna, Daughter of F.N. & N.E. Hair, Wife of J. R. Woodward I, born 12th December 1872, died 9th July 1901."

John's second marriage was to Lottie Mae Hair on the 22nd of February 1903. She was born on the 26th of August 1883 and died on the 10th of April 1926. Their children were:

- 1. Annie Elise Woodward 6/, born 9th February 1904, died 11th September 1907.
- 2. John Richard Woodward Jr. (II) 6/, born 13th of April 1906 at Blackville, S.C. (Barnwell Co.). He died on the 5th of April 1975 at Jesup, Georgia. He first married Josephine Victoria Goff (Josie) on the 14th of February 1928 at Jesup, Georgia. Josephine Goff Woodward was born at Noma, Holmes County, Florida on the 12th of May 1910. They had three children:
  - a. John Richard Woodward III, 7/, born 17th February 1929 at Folkston, Ga., married Edith Jenelle Williams on 8th February 1958 at Jesup, Wayne Co., Ga., Three children:

## MICAJAH WOODWARD

There is a record of a Micajah Woodward in the Marion District Minute Book of the Ordinary dated 7th October 1811 showing the following...Quote "Item...This day Granted Letters of Guardianship to Shadrick Rice for Micajah Woodward; Margate (Margaret?) Woodward; Joel Woodward; and Sharlotte (Charlotte?) Woodward, minor heirs of Jacob Woodward, deceased." End of Quote.

This clearly shows that Jacob Woodward, the deceased, was the father of a Micajah Woodward. It is not known if the man listed below was the same Micajah Woodward listed above as a son of Jacob Woodward but the possibility does exist.

The following deed was made by Micajah Woodward on the 30th December 1806.

South Carolina ) Know all men by these presents that I, Kershaw District) MICAJAH WOODWARD, of the State & District aforesaid, for and in consideration of the sum of Two Hundred & Twenty Five Dollars, to me in hand paid by Alexander McLead, the receipt whereof is hereby acknowledged, has bargained, sold and conveyed and released unto the said Alexander McLead, his heirs and assigns a tract or parcel of land containing 225 acres, be the same more or less, situate in the District aforesaid on HOUSEFREE BRANCH being the West (was of Scafe whom?) and Black River, and being a part of a tract of 2550 acres granted to Isaac Lenere, the 3rd day of December 1787, the west acres of said tract and bounded on Southeast by Spears' land; Northeast by Jones' land; Northwest by Isaac Lenen's land and hath such shape froms and marks butting & as is referred in a plat made by G.N. Nixon the 30th day of December 1806, TO HAVE AND TO HOLD-Warranty clause. November 17th 1816 in the 39th year of the Independence of the United States of America. Signed/ Micajah (x) Woodward (LS)

Memorandum: Evidently Sarah Woodward was the wife of Micajah Woodward, who sold his 225 acres in 1804 to Alexander McLeod and later on, on the 26th of December 1812, Sarah released her right of dower to Alexander McLeod.
