## R.043 INFORMATION ON SION LASSITER HILL.

## SION LASSITER HILL & FRANCES DISMUKES

The parents of Sion Lassiter Hill are unknown but one unknown source says he was the son of a Robert Hill. If so, then he was not the Robert Hill 3/, who's wife was named Tabitha of Halifax County, N.C. nor was it the Robert Hill of Warren County, Georgia, who did have a son named Sion Hill but who had married Susannah Lewis.

His father is thought (by this writer) to have been a man named Herbert Hill, who lived in Chatham County, N.C. between 1790-1800 and who could possibly be a grandson of Robert Hill 3/ & Tabitha of Halifax County, N.C.

My belief is that this Herbert Hill was a son of Abner Hill 4/ & Sarah Mathias, son of Rovert Hill 3/. Another possibility is that Herbert Hill was a son of Sion Hill 4/ or Green Hill 4/, both sons of Robert Hill 3/. If so, the mother may have been a Lassiter, but this still has to be proved.

Some earlier researchers have mistaken this Sion Lassiter Hill (alias Sion L. Hill), mixed up with another Sion L. Hill, of Nash County,, NC but who was named Sion LERWIS HILL 5/, a son of William Hill Sr. 4/ and wife Charity Lewis, of Chatham COunty. THis William Hill Sr. 4/ was a brother to the above named Abner Hill 4/, both sons of Robert Hill 3/ and his wife Tabitha of Halifax County, NC.

Sion Lassiter Hill is said to have been born in Chatham County, N.C. on the 3rd of February 1796 and he married Frances Dismukes on the 5th of December 1818 at Clinton, in Jones County, Georgia.

Sion L. Hill died in the town of Ozark, in Dale County, Alabama on or about the 2nd of August 1871. (Ref: Petition of Probate Court, Dale County, Alabama on Estate of Sion L. Hill, below).

Frances Dismukes was the daughter of Edmond Dismukes and his wife, Betheny Cox. Betheny Cox was the daughter of Cary Cox Sr., born in Virginia and lived in Halifax County, N.C. during the Revolutionary War. Cary Cox Sr. was married to Mary Horne (b. Va.). Cary Cox Sr. and his son William Cox served in the Revolutionary War. (See Dismukes information at end).

It is on record that Sion Lassiter Hill was a veteran of the War of 1812, having served under the mysterious name of "HERBERT HILL." It is thought this was due to the fact that he had some Indian blood in his veins by the way of the Lassiter's and since, in those times, the Indians were frowned on by many others. I think he used his father's name HERBERT HILL! (Still needs to be proved).

Sion Lassiter Hill is said by some sources to have had a brother named Isaac Abner Hill, born ca. 1800 in Chatham County, N.C. or Halifax County, N.C.). Isaac A. Hill married on 21st November 1822 in Jones County, Georgia, to Isabelle Cox and he died on the 31st of August 1833 in Harris Co., Ga. (Ref: Macon Messenger, Macon, Ga. dated 17th Oct. 1833). Isaac A. Hill is said to have founded the University of Georgia Library, at Athens, Georgia.

Isabella Cox was born on the 16th of November 1801 in Warren County, Ga. and died on the 9th of October 1883 in Haralson? (sic) County, Ga. She was the daughter of Asa Cox and Mariah Rountree, who was the daughter of Captain Richardson Rountree, A Revolutionary Soldier of Edgefield County, S.C.

The children of Isaac Abner Hill and Isabella Cox were:

- 4. Jas. (James) Henderson Hill, born 25th October 1829 in Harris Co., Ga., married Anne Elizabeth Hoaws, who's grandfather was a Revolutionary Soldier.
- 5. Cacelia? Ann Hill, born 5th January 1831 in Harris County, Ga., married John Henry William Stephens.

Some researchers say that Mary Hill, who married Cheadle Cochran, was a sister to Elizabeth Hill (m. Benjamin Lassiter) and James Hill (m. Christiana Lassiter, sister of Benjamin Lassiter.

Cheadle Cochran obviously was a very close friend to Benjamin Lassiter and for this reason his children are listed at this point.

- Elizabeth Cochran, born 11th January 1813, died 27th November 1878 at Roanoke, Chambers County, Alabama. She married William (Willie) Wood, born 7 Feb. 1808, d. 27th Feb. 1840.

- 3. Martin Hill Cochran M.D., no dates listed, married Ella Gates or Bates, was killed by a falling tree in Miss..
- 4. Winston Hill Chochran, killed in Texas.
- 5. James H. (Hill?) Cochran, died at sister's home in Chambers County, Ala. (unmarried).
- 6. Littleton Hill Cochran M.D., born 25th May 1820, died in Campbell County, Ga. (no date given). Wife was Sarah Jane Beavers.
- 7. Berry Wynn Cochran Sr., born 15 November 1828, died 27th January 1895. He married Alice Brewster, b. 12 Oct. 1844, d. 21st Jan. 1922 in Palmetto Co., Ga. (He was Capt. of Co., A, 56th Ga. Regt. CSA)
- 8. Owen Henry Cochran, born 1830, died 5th December 1909 in Palmetto County, Ga. He married 1st Margaret J. Haralson; 2nd Mrs. Virginia Lathem Howard; 3rd Mrs. Stevie Memefee.

Returning to Sion Lassiter Hill: Sion Lassiter Hill and Frances Dismukes had the following children:

(The above was provided by a 94 year old lady named Helen Graves, now deceased, in the late 1970s).

Another source listed as 7th child, a son named James J. Hill, born 1835, which would give a total of ten (10) children.

In 1820, Sion L. Hill lived in Putnam County, Georgia, in 1832 he lived in Jones County, Georgia, from there he moved to Harris County, Georgia and lived there for about ten years. Then about 1845, he moved to Chambers County, Alabama and then to Macon County, Alabama, finally moving to Dale County, Alabama where he died on or about the 2nd of August in 1871.

Sion Lassiter Hill was listed in the 1830 Census for Jones County, Georgia. He was living next to his mother in law, Bethena Cox Dismukes, widow of Edmund Dismukes and his brother in law, Asa Wall.

1830 Census for Jones County shows Sion L. Hill as:

In the 1870 Census he was found in Dale County, Alabama and was listed as follows:

All of the children were married or had died and they now lived alone.

Bass, a widow; Victoria Nelson, Laure and Fleming and Thomas and William Nelson, ALL over (age) 21 and resides in state of Georgia. The heirs of NANCY J. HOWARD, widow, deceased, to wit: E. L. Howard; C.C. Kennedy, wife of --Kennedy, John W. Howard, James Howard and ---Howard whose given name is unknown, over 21 and resides in state of Texas. W. E. Gilbert, son of the said Nancy J. by second husband----Gilbert, deceased; said W.W. Gilbert is a minor and resides in Texas. WADE H. HILL (son) over 21 of Chambers County, Alabama, declined to Administer estatehaving first right has declined to administer estate.
