Agnes Hill 4/ was a daughter of Robert Hill 3/ & his wife Tabitha--). Robert Hill 3/ was a son of Sion Hill Sr. 2/ of Surry County, Virginia, who in turn was a son of the emigrants Robert Hill 1/ & his wife Mary Webb.

Agnes Hill 4/ was said by one source to have been born ca. 1727, another source says 1730 in what was probably at that time Bertie County, N.C. To this writer, her birth in 1729-1730 seems more reliable. One source says she died in 1802 but court records of Chatham County, N.C. seems to imply that she died in 1797.

# CHARLES HARRINGTON 2/ (2ND GENERATION).

(Charles Harrington 2/, son of Thomas Harrington 1/).

(This information furnished by DR. McIver Woody, and therefore Thomas Harrington has been arbitrarily designated as the 1st generation).

# CHARLES HARRINGTON 2/.

Charles Arrington Sr. 2/ & Agnes Hill 4/ (Hill generation) married ca. 1747 in Edgecombe County, N.C. (Fayette District??). The name Arrington was later changed over to Harrington.

There is something wrong with this marriage date of 1747 when comparing the birth of their first born child which was listed as being in 1743. If the birth of the son is correct, then the marriage probably took place about 1742. This certainly needs to be iunvestigated. Charles Harrington Sr. 2/ & Agnes Hill had the following known children: (Third generation of Harringtons).

Comments by Sybil Macomb of Mission, Texas:

Quote "According to information from Bettye Davis, Drury Harrington 3/ served in the American Revolution from both North Carolina and South Carolina, enlisted in Chatham County, N.C, and served under General Clark and General Sumpter; fought against the Cherokee Indians; was Lt. under General Montgomery; served in Brandon's Regt. He took part in the Battles of Moore's Creek, Ramsom's Hill, Cow Pens, surrender of Augusta, Georgia."

"Also according to Bettye Davis, Charles Harrington Jr. 3/ fought beside his father Charles Harrington Sr. 2/, and was wounded at the Battle of Alamance in May of 1771." "General Elijah Clark from Georgia married a Hannah Harrington. We believe she is from our Harringtons, but the researchers I have corresponded with have not pursued the matter nor have I."

According to Henrietta Land (she has researched the Harringtons for a number of years), John Harrington said in his papers that Charles Harrington Jr. 3/ was the oldest, as he inherited all the property of which he squandered." End of quote.

CHARLES HARRINGTON 2/ & AGNES HILL 4/ (Hill generation) Charles Harrington 2/ born 1720, d. 1st June 1773 in Chatham County, N.C., married Agnes Hill 4/ in 1747 Edgecombe County, N.C. Charles Harrington 2/ of Halifax County, N.C. sold 160 acres in that county, the deed stating that he had received it as a grant by Lord Granville on 25th March 1749 (Ref: Halifax Deed Book 8, page 315). A deed dated 18th November 1778, (perhaps this was 1787?) shows wife Agnes Harrington with sons Thomas Harrington 3/; Philemon Harrington 3/, all of Chatham County, N.C. sold 212 acres to John Auld, the deed reciting that the land had been purchased "by Charles Harrington, deceased," from William Petty. (Ref: Chatham Co., N.C. Deed Book B, page 170). The recitation in this deed is inconsistent with the pension's being granted to him in 1787. At any rate, Charles Harrington 2/ was dead when the 1790 census was taken as Agnes Harrington was listed as head of

### FOLLOWING INFORMATION PROVIDED TO ME BY SYBIL MACOMB, WHO IN TURN OBTAINED THE INFORMATION FROM THOMAS H. POPE, A DESCENDENT OF JOHN HARRINGTON, OF UNION COUNTY, S.C.

John Harrington 3/, with his brothers Drury & Charles 3/ and his sister Mary Harrington 3/ Landrum, moved from N.C. to that part of South Carolina that was known as Ninety Six District, which became Union County in the 1770s. They were the sons of Charles Harrington 2/ and his wife Agnes Hill 4/ (Hill generation), who died in Chatham County, N.C. in 1797. Charles Harrington 2/ was the son of Thomas Harrington 1/ and his wife Mary Whitmell.

Agnes Hill 4/ (Hill generation) was a daughter of Robert Hill 3/ and his wife Tabitha of Halifax County, N.C.. She was a granddaughter of Sion Hill Sr. 2/ (m. Elizabeth Smith Spiltimber) & great granddaughter of immigrants Robert Hill 1/ & wife Mary Webb.

Charles Harrington 2/ was a Revolutionary Soldier and was wounded in the Battle of Alamance and thereafter drew a pension until his death. (Ref: Colonial Records of N.C., Book 9, p. 131, Dec. 23, 1771, Book 22, p. 482 and 492; Book 20, p. 429, Dec. 17, 1787).

By deed dated December 15, 1773, Charles Harrington 2/ of Halifax County, N.C. sold 160 acres in that county, the deed reciting that he had been granted the land by Lord Granville on March 25, 1749 (Ref: Halifax Deed Book 8, page 315). BY deed of November 18, 1778, Agnes (Hill) Harrington, Thomas Harrington and Philemon Harrington, all of Chatham County, N.C., sold 212 acres to John Auld, the deed reciting that it had been purchased "by Charles Harrington, deceased," from William Petty (Ref: Chatham County Deed Book B, page 170). The recitation in the deed is inconsistent with the pensions being granted him in 1787. Ar any rate, he was dead when the Census of 1790 was taken because that Census of 1790 lists Agnes Harrington as Head of Household with five slaves in Chatham County, N.C.

JOHN HARRINGTON 3/.

(John Harrington 3/, son of Charles 2/;Thomas 1/)/

John Harrington 3/ married Frances Burt. She died on October 16, 1823, aged seventy-nine, so she was born in 1744. (Ref: Tombstone in Old Rutherford Cemetery, Newberry County, S.C.). They lived in Chatham County, North Carolina, until they moved to present day Union County, South Carolina.

On May 20, 1775, John sold his interest in land in Chatham County, North Carolina (Ref: Chatham County Deed Book ??) and on the same date was granted 240 acres in Union County, South Carolina. He owned 926 acres in the latter county at the time of his death (Ref: Partition Suit, 1814, Union Co., S.C.).

John Harrington 3/ served in Colonel Wade Hampton's State Cavalry during the Revolution (Ref: Stub Indent, Book C-F, p. 132, No. 731, Book C). He was a petit juror in 1786, grand juror in 1788, and is mentioned in the Union County, S.C. records many times (Ref: Minutes of the County Court of Union County, pages 64, 82, 83, 88, 89, 90, 92, 93, 96, 97, 136, 151). He was a Justice of the Peace for Ninety Six District, S.C. in 1784. (Ref: Journal of the House of Representatives, 1783-84, edited by Theodora J. Thompson and Rosa S. Lumpkin, University of South Carolina Press, 1977, pages 230 and 264).

The Census of 1790 for Union County, South Carolina lists him as Head of a Household with two free white males over 16, four free white males under 16, three free white females and five slaves.

John Harrington 3/ died in 1793. His Will was dated November 12th, 1792, being proved in the Union County, S.C. Court on September 2nd, 1793 (Ref: Minutes of the Union County Court, p. 366 in Will Book 1, page 13). Although the children are not named in the Will, they are listed in the partition suit brought in Union County, S.C. on October 3rd, 1814, seeking the division or sale of 926 acres owned by John Harrington.

After the death of John Harrington 3/, his widow, Frances Burt Harrington, entered into a pre-nuptial agreement with Colonel Robert Rutherford on June 2nd, 1794. (Ref: Newberry County, S.C. Deed Book B, page 878). They were married that year, and she and her minor children moved to Newberry County. She and Colonel Robert Rutherford had no children. She died on the 16th of October 1823.

Reference to a Handwritten note in possession of writer, lists these children but adds Sallie Burt, who married a Mr. Cobb and moved to Mississippi and an unnamed sister who married a Mr. Olive and lived in Georgia. However, when Frances Burt Harrington Rutherford's estate was settled in Newberry County, S.C. Probate Court (Box 35, Pkg. 72, Estate 829), on 1st August 1826, distributive shares were paid to Jeptha, Hezekiah and Y. J. Harrington, Gabriel Martin, Birt Harrington, the attorney for Bathsheba Lusk, and the attorney for Ezra Cates.

# YOUNG JOHN HARRINGTON 4/.

(Young John Harrington 4/, son of John Harrington 3/, son of Charles Harrington 2/, son of Thomas Harrington 1/).

Young John Harrington 4/, son of John Harrington 3/ & wife Frances Burt, was born in Union County, South Carolina on the 5th of April 1784. He moved to Newberry County, South Carolina with his widowed mother and was put in charge of his step-father's cotton gin, one of the first in the up country. He was at that time about twelve years old. In 1799 he went to Newberry as clerk in the store of Major Frederick Nance. In 1807, he was appointed Clerk of Court, which office he held for almost forty-three years. Carwile said that probably no one in South Carolina ever filled that office with more ability and success (Ref: Reminiscences of Newberry, by John B. Carwile, 1890, p. 227). O'Neall stated that he had seen every clerk in South Carolina and never had seen one who could or did surpass Young John Harrington (Ref: The Annals of Newberry, by John Belton O'Neall, 1859, p. 136).

Young John Harrington 4/ married Nancy Calmes, daughter of William & Elizabeth Berry Calmes, on the 10th of February 1805. She was born on the 15th of July 1786. He died on the 11th of November 1850 and she died on the 29th of May 1879.

Lieutenant Colonel Birt Harrington 4/, son of John Harrington 3/ & Frances Burt, was born in Union County, South Carolina on the 17th of August 1792. He moved to Newberry County, South Carolina with his mother upon her second marriage. He was a successful businessman in Newberry until 1826, when he and his wife, the former Harriet Catherine Johnston moved to Tuscumbia, Alabama. She was the daughter of Samuel and Catherine Harrison Johnston of Fairfield County, South Carolina, and a sister of Dr. Burr Johnston; of Eliza, the first wife of Cancellor Job Johnstone (who added the "e" to his name later in life); and of Sarah, wife of Colonel Theodore Randall.

Catherine Harrison Johnston Harrington was born on the 1st of June 1799. She died on the 14th of October 1873 and is buried at Tuscumbia, Alabama. Birt Harrington 4/ died while on a visit to his son in Texas on the 18th of April 1860 and is buried at LaGrange, Texas.

Spencer Calmes Harrington 5/, eldest son of Young John Harrington 4/ and wife Nancy Calmes, was born in Newberry County, South Carolina on the 22nd of March 1807. He studied law with Judge O'Neall and, being admitted to the Bar in the spring of 1828, was O'Neall's partner until the latter was elevated to the Bench. He then practiced in partnership with Drayton Nance until he abandoned the practice to become a merchant. (Ref: O'Neall, of. cit., page 158). On the 27th of October 1829, he married Mary B. Maxwell, the daughter of John & Beulah Maxwell of Newberry County. They moved to Mississippi in 1836 and are buried in Old Salem Baptist Cemetery in Oktibbeha County. Spencer C. Harrington 5/ died in 1850 (Ref: Newberry County Probate Court, Box 93, Pkg. 242); his wife survived him but no date appears on her tombstone.

She attended Salem Academy and married Dr. James Henry Thomas Wilson on the 24th of February 1829. He was born on the 6th of July 1805 and was the son of James Wilson & Tabitha Beal of Ninety Six District, South Carolina, and the brother of William Wilson, Ordinary of Newberry District (County). Dr. & Mrs Wilson moved to Texas about 1850 (Ref: Greenwood County Sketches, by Margaret Watson, 1970, pages 424-425). Dr. Wilson died on the 7th of August 1878.

# JOHN CURRAN HARRINGTON 5/.

(Son of Young John Harrington 4/; John 3/; Charles 2/; Thomas Harrington 1/).

John Curran Harrington 5/, son of Young John Harrington 4/ and wife Nancy Calmes, was born in Newberry County, South Carolina on the 27th of January 1811. He married Caroline Besancon at the American Embassy in Paris, France on the 18th of February 1836. They returned to Newberry County and had one child, a son named John B. Harrington 6/. John Curran Harrington 5/ died at the age of Twenty-seven on the 14th of August 1838. (Ref: Newberry County Probate Court, Box 62, Pkg. 155). His widow sued her father-in-law in equity, alleging that she and her husband had removed to Charleston on the 15th of April 1838, and that he had advanced the sum of \$ 2,500 to make him equal to his other children; that they had returned to Newberry in May of 1838 and had settled on the plantation of Young John Harrington 4/ as a partner; that after her husband's death, Young John Harrington 4/ had bought two Negroes and was willing to convey them to her son, and that she demanded an accounting.

Young John Harrington 4/ answered that he had set John 5/ up in business in Abbeville, South Carolina but that he left and went to France; that when he returned the business had failed; that Young John Harrington 4/ had borne the whole loss and had an accounting before John Curran Harrington 5/ went to Charleston; that he had fixed up the house and purchased the two Negroes with his own money; and that he sympathized with his daughter-in-law as mother of his grandchild and as a female in a strange land and that "as far as the peevishness of her deposition would permit" he had treated her with as much kindness as he would have extended to his own daughter.

The complaint was dismissed by Chancello Benjamin F. Dunkin. There is no further record of the widow, Caroline Besancon. (Ref: Newberry Equity Court Records, Box 26).

William Henry Harrington M.D. 5/, son of Young John Harrington 4/ and his wife Nancy Calmes, was born in Newberry County, South Carolina on the 19th of November 1816. He was graduated from the Medical College of South Carolina located at Columbia, S.C. in 1840. He represented Newberry District (County) in the House of Representatives from 1854 to 1856. On November 18th, 1841, Dr. Harrington married Sarah Strother O'Neall, daughter of Chief Justice John Belton O'Neall and his wife, Helen Pope. Sarah Strother O'Neall was born on the 27th of February 1823 and died on the 5th of August 1857.

Dr. Harrington 5/ practiced medicine in Newberry County until the death of his first wife. In December of 1858, he married a second time to Mrs. Annie E. Griffin Hollingsworth of Edgefield County, South Carolina. He gave up the practice of medicine and moved to Crawfordville, Mississippi, in 1856. He was a planter and lived there until his death on the 16th of February 1889. He is buried in the Calmes Square, Rosemont Cemetery, Newberry County, South Carolina, by his first wife. His second wife died on the 18th of November 1889 and is buried at Crawfordville, Mississippi.
