R.068 RESEARCH ON THE MOBLEY-CHAPMAN-HILL FAMILIES OF FAIRFIELD COUNTY, S.C.

Source of Information: The book entitled "The Hill-Hill Mobley Connections of Fairfield County, S.C.," By George A. Hill (now deceased), dated April, 1961 as well as information from the "Mobley Family Collection," provided to me by Mr. Carl Mobley of Orlando, Fla. & Mr. Milton Mobley of Laurel, Maryland & information from my own research on the Hill-Mobley families.

Note: This document was prepared for the benefit of the Chapman Family researchers. They may already have this information, but if so, I have never seen it before.

Brief background: It seems that the Mobley family had it's origins in Maryland, who's members later moved into the area of Lunenburg and Bedford Counties of Virginia. The Richard Hill family is also thought to have originated in the same area of Virginia.

Based on land deeds, Edward Mobley 2/ (son of John 1/) was in Virginia up until 1752 (Tithe (Tax) List) of Lunenburg County. Between 1755 and 1760 the family moved to S.C. in what was then known as Craven County, S.C. which occupied most of upper Carolina. Later one of its subdivision became Camden District and in 1785 Camden District was split into other counties. The Mobleys and Hill lived in the area that became known as Fairfield County, S.C.

Meanwhile, Richard Hill was born ca. 1748 in Virginia and on the 18th of January 1765, he was in S.C. where he received a land grant for 100 acres of land.

He married ca. 1766 Dorcas Mobley 3/, a daughter of Edward Mobley 2/ and wife, Susannah DeRuel? (DeVall?), who now lived in the same area of S.C.

Richard Hill Sr. was dead by 1772 and his wife, Dorcas Mobley Hill received a land grant that year. S.C. laws show that the only way she could obtain a land grant was for her to have been a widow.

Following taken from Page 59 of Hill-Mobley Book by G. A. Hill (deceased)

Edward Mobley 2/ & wife Susannah had 12 children. The

youngest was a daughter named Dorcas Mobley 3/, who married Richard Hill Sr.

Their son, Richard Hill Jr. married Dorcas Funderberg. Richard Hill Jr. was born ca. 1775 and died on the 28th of Oct. 1837. His wife, Dorcas Funderberg was b. ca. 1775 and she d. ca. 1852, and was a granddaughter of Henry & Mary Funderberg.

Richard Hill Jr. & Mary Funderberg had nine (9) children, including a daughter named Mary Hill, born ca. 1815-1820, who married WILLIAM CHAPMAN SR. sometime before 1840.

From Page 63 of Hill-Mobley Book:

"General Statement of Money received and paid by Asaph Hill, Administrator of the Estate of Richard Hill (Jr.), deceased."

Among this item, along with many other transactions was the following:

To William Chapman (Sr.) & Mary, his wife, one Negro girl named Eady, appraised at \$1,600.00

(Mary was daughter of Richard Hill (Jr.), deceased.

The disposal of the landed estate of Richard Hill, Jr.:

"Richard Hill died October 28, 1837... 297 and 1/2 acres of land on John's Creek, Waters of Sandy River in Fairfield
County bounded by Jacob Stone, Solomon Coleman, John
Stevenson, Et Al. Said Richard's heirs at Law, Asaph Hill,
Henry Hill, William F. Hill, Elijah Hill, Matthew Hill,
Reuben Hill, Mary Hill, now Chapman, WIFE OF WILLIAM CHAPMAN,
SR., Dorcas Hill (now Dorcas Stevenson, wife of John
Stevenson), Elizabeth Hill, now Elizabeth Achinson, wife of

"That since Richard Hill's death, Elijah Hill has departed this life intestate, leaving heirs, his widow Margaret Hill and five children, namely: Edward Hill, Dorcas Hill, Savilla Hill, Mary Hill and Asaph Hill. Since the death of Richard Hill, Reuben Hill has departed this life intestate, leaving heirs, widow Ellen Hill, three children, John C. Hill, Susan Hill, and Henry Hill,"

"That William F. Hill, WILLIAM CHAPMAN (SR.) & wife Mary, John Stevenson and wife Dorcas; since Richard's death have conveyed their rights to the administrator (Asaph Hill) ... the parties all being of full age - agrees and deliver up 1/3 to Richard Hill's widow, Dorcas Hill."

Following information taken from pages 216, 217, 218, 219 & 220 of the Hill-Mobley Book, by G. A. Hill (now deceased).

Following in a letter from Mrs. Ida Thomas Page of Yazoo City, Mississippi dated 21st May 1841:

Henry Chapman was born _____? in S.C. and died in Macon Co., GA. (sic) on 21st May 1841. The married ca. 1789 in S.C. or GA. (His wife) Lavinia Mobley was born on the 16th of January 1775 in what is todays Fairfield County.

Note by R. Hill: this (was probably Camden District or Craven County, S.C. at that time). Lavinia died in Macon County, Alabama on 1st November 1839.

*** Wm. Mobley, his son, could this have been Edward Mobley Sr., born 1700 and son of William Sr. ??

Family Historians say that Edward Mobley (Moberley) Sr. was born ca. 1700 in_____ ? and died is S.C. ca. 1782. This death date is considered by family researchers as being questionable. His wife is said to be Susannah DeRuel (DeVall?), born ca. 1702 and died in 1761 in what is today's Fairfield County, S.C. No record of her has been found and makes one wonder how her name was arrived at.

From Page 205 of Hill-Mobley Book:

William Mobley Sr., son of Edward Mobley & wife Susannah DeRuel was born ca. 1725-1730. He left the area of Lunenburg-Bedford County, Va. and moved to S.C. where he received a land grant in 1758. According to the Historical Commission of S.C. both William Mobley Sr. and his son, William Jr., served in the S.C. Militia. However, there were a number of William Mobley's in S.C. at that time and the Bible record of Henry Chapman hinted that he may have been deceased before the outbreak of the American Revolution.

Another son of William Mobley Sr. was Edward Mobley (Jr.)

that married Druscilla Meador and they in turn had a daughter named Lavinia Mobley that married HENRY CHAPMAN.

Another child of William Mobley Sr. was Captain Thomas Mobley, who was the 6th child of William Mobley and his wife, Ann Osborne.

Page 231 & 232 of Hill-Mobley Book

CHAPMAN

Edrington's History states: "The Chapmans were a numerous & prominent family on McClures Creek. They have all left except Giles Chapman and the widow and children of John Chapman, who owned the old "Halselville Property, just beyond the line in Chester County." (adjacent to Fairfield County).

Dr. D.B. Clayton Sr. writes: "Robert Coleman Sr. (we call him Sr, though he should be number one as there were several Roberts) came to S.C. we know not when, but apparently after our Robert Coleman Jr., who married Elizabeth Roe and started our Fairfield family, and his brothers William & Charles, both of whom lived and died in Fairfield (County, S.C.). Robert Sr. had a large family and from Deed Book K, Page 123 we find the following deed of gift.

"Robert R. Coleman, Farmer, to daughter Mourning Coleman, a Negro girl---- 3/1/1795, Witnesses: Anderson Thomas and WILLIAM CHAPMAN."

Page 125. "Robert R. Coleman to son in law WILLIAM CHAPMAN, one Negro woman." 3/31/1795. In Robert R. Coleman's Will, dated 3/31/1795, the same day his deed of gift was made to William Chapman, proved January 20th, 1796, names among his children, Sarah Chapman. He names as Executors of his will, two sons in law, William Chapman and Isaiah Coleman. (Three of his daughters married Mobley's, one a Parker and one a Picket. Two youngest were single). Witnesses to the Will were Anderson Thomas and Thomas Coleman (Robert's son)."

Mr. Clayton continues: "I have tried to find a record of

William Chapman and his wife Sarah Coleman, but so far without success... William Chapman was evidently born around 1740-55. I thought this William below might be the son in law of Robert Coleman Sr., but unless he married twice, this could not be as William's wife named in his Will was Anne, and Robert's daughter was Sarah, who married a William (Chapman). It is possible that Robert's son in law, William Chapman, was the father of this William (Chapman) who married Anne."

Levi Mobley married Sarah Rabb in S.C. and later moved to Jones County, Ga. and lived there between 1808-1818, then moved to Greenville. Alabama where he died.

Mobley marriages in Jones Co., Ga. between 1811-1819:

Barbara Mobley married John Chapman (Levi Mobley performed the marriage ceremony).

Sukey Mobley married Edward Brooks. James Mobley to Norcissa Burford. Reuben Mobley to Grissela Burfore (sic).

Analysis of the above information:

It is very obvious that the Mobley and Chapman families were close and inter married with each other. Some of them moved into both Walton County and Jones county of Georgia. These Chapmans do not appear to be related to the members of David Chapman and wife Tabitha Hill of N.C, who's children (some) later moved into Warren County, Ga.
