Note: The above establishes that a Doctor Collier was in Brunswick County ???? Va. buying land as early as 1771 which means he was of legal age at that time (21 yrs old). This means he would have had to be born at least as early as 1750.

Added Note: I think Brunswick County should have been Mecklenburg County, Va.

The Doctor Collier who was listed in a tax list as paying taxes on 100 acres of land in Franklin County, N.C. in 1804 paid poll tax in 1805 and 1806. In 1810 and 1812 he paid taxes on 100 acres but did not pay poll tax. This could indicate he had reached an age where he was exempted from paying poll taxes. If this age was 60 years old, this would have put his birth date between 1745/1750.

In the November Court 1815 in Granville County, N.C. we find Thomas Collier was appointed administrator of the estate of Doc. W. Collier.
