R.084 INFORMATION SHOWING THE CONNECTIONS OF THE PARHAM FAMILY TO THE HILLS, GILLIAMS, BOOTHS, MALONES AND OTHERS.

Sources of Information: Book entitled Sussex County, Va. Will Books A-F, 1754-1805 by William Lindsay Hopkins; Several different articles that I have received over the years.

Explanation: Virginia records shows that the Parhams, Hills, Gilliams, Tyus, Threewitts, Booths, Malones, Jones, Mason families had very close relationships, often times inter marrying. Just a few examples involving the Hill family:

Richard Hill 3/ & wife Hannah Briggs had a daughter Mary Hill 4/ that married William Malone. A son John Hill 4/ married Mildred Gilliam. Another son, (Capt.) Richard Hill Jr/ 4/ married Margery Gilliam, daughter of William Gilliam & Susanna Green. Margery was a cousin to Mildred Gilliam.

Capt. Richard Hill Jr. 4/ had a daughter, Hannah Hill 5/ that married Ephiram Parham on 15th November 1764. He also a son named Green Hill 5/ that married Mary Booth on 20th May 1773.

There are many other connections, too many to list here, so far this reason, the following wills and inventories are listed to help show the relationships of the individuals to one another.

There are many other wills to show the families relationship to each other, too many to list but below is my attempt to show the reader just how they are related to each other.a Robert R. Hill of Brandon, Fla.

Comments to the above Will by Robert Hill of Brandon, Fl.: This will clearly shows that the deceased Robert Wynne had a daughter that married Butler and had a granddaughter named Mary Butler (who was under age 21). There were three other daughters. One was named Angilicia Wynne that married William Raines, and they had sons named Robert Raines (Jr.) and Jefferson Raines. Another daughter was named Martha Wynne that married Matthew Parham (Sr.). They had a sons Robert Parham, Matthew Parham (Jr.), daughter Eliza Parham. Still another daughter named Lewcretia Wynne married Joseph Tucker and they had a son named Joel Tucker.

He was John Hill 4/, (1718-1765) son of Richard Hill 3/ (1684-1722/23) and Hannah Briggs. Richard Hill 3/ was a brother to the deceased Michael Hill 3/. The Richard Hill mentioned in the above will was Captain Richard Hill Jr. 4/, another son of Richard Hill 3/. John Hill 4/ married Mildred Gilliam, daughter of John Gilliam. Richard Hill Jr. 4/ married her cousin Margery Gilliam, daughter of William Gilliam and Susanna Green.

The witness named Richard Hill, was Richard Hill 4/, brother to the administrator, John Hill 4/, BOTH being sons of Richard Hill 3/, WHO WAS THE OLDER BROTHER TO THE DECEASED, MICHAEL HILL 3/.

Comments by Robert Hill of Brandon, Fl.: The above had a daughter Mary Booth that married John Parham. Their children named in the will were: Matthew Parham; John Parham; Thomas Parham. The Parhams, Malones, Hill families were related in the fact that Mary Hill 4/, daughter of Richard Hill 3/ & Hannah Briggs married a William Malone. Green Hill 5/ married Mary Booth on 20th May 1773. I suspect the above George Booth was father in law to Green Hill 5/ (not proved as yet)

Comments by Robert Hill of Brandon, Fl.:

Notice the marriage of daughter Jane into the Thweat family. There was also a marriage on the 15th of November 1764 of another Ephiram Parham to Hannah Hill 5/, daughter of Captain Richard Hill 4/ and wife Margery Gilliam. Capt. Richard Hill 4/ was the son of Richard Hill 3/ and Hannah Briggs, Richard Hill 3/ being the son of Sion Hill Sr. 2/ and Elizabeth Spiltimber, who in turn was the son of the immigrants Robert Hill 1/ & wife Mary Webb who came to Va. in 1642.

Margery Gilliam was the daughter of William Gilliam and Susanna Green. William Gilliam is thought to have been the son of Hinshea Gilliam. The Gilliams were very close to the family of Richard Hill 4/ of Sussex Co., Va.

Comments by Robert Hill of Brandon, Fl.: This John Hill was John Hill 4/ (1718-1765), son of Richard Hill 3/ (1684-1722/23) & wife Hannah Briggs. His wife was Mildred Gilliam, daughter of John Gilliam. When John Hill named his brother in Law Hinchia Gilliam, it shows us that Hinchia Gilliam was son of John Gilliam and brother to Mildred Gilliam, the widow of the deceased John Hill 4/. The other son in law, William Malone, married Mary Hill 4/ (1716-??) sister to the deceased John Hill 4/.

Same source says Sampson Gilliam married Drucilla Hill in 1796 in Franklin Co., N.C. (went to Union Co., SC) and was the son of either Ephiram Gilliam or Marcus Gilliam. (this is correct).

They also say Marcus Gilliam purchased land in Sussex Co., Va, ca. 1765 that was adjacent to land of Richard Hill that married cousin Margery Gilliam. It was Captain Richard Hill Jr. 4/ that married Margery Gilliam.

Sampson Gilliam 176?-1828?) m. Drucilla Hill (1778-1835) and they went to Union Co., S.C.

Additional Note: Drucilla Hill was daughter of a Thomas Hill & wife Miriam Murphy. (said to be a Md. family).

She was listed as daughter of John Tyus, who, in his will, NEVER names a daughter as Nancy, HOWVER, he does name a daughter as ANN HILL. The above Inventory shows the close relationship between the Hill-Tyus, Booth and Jones families, who all intermarried with each other, The Richard Hill named was probably Richard Hill 4/, son of Richard Hill 3/ & Hannah Briggs.

Comments by Robert Hill of Brandon, Fl.: This inventory is a very good example showing that the Tyus family had some type of connection to the Richard Hill 4/ Family, William Gilliam's family, George Booth Family and many others. A Michael Hill is known to have married a Nancy (Ann) Tyus and he was a cousin to Richard Hill 4/.

Comments to the above will by Robert Hill of Brandon, Fl.: In Sussex Co. Will Book "A" 1754-1764 on Page 14, is the will of Robert Wynne dated? 1754, probated 12 August 1754. It names "Son in Law" Matthew Parham and wife Martha Parham, showing us that Matthew Parham's wife was named Martha Wynne, daughter of Robert Wynne and wife Mary Wynne. His will also names grandchildren Eliza Parham; Matthew Parham and Martha Parham, proving that Matthew Parham and wife Martha Wynne had the three named children.

This abbreviated will of Matthew Parham along with the will (below) of Robert Parham, shows us some other genealogical facts. While the wording of this will is tricky, I can determine the following facts:

- 1. Robert Parham (wife Lucrieta Parham) was the son of the deceased Matthew Parham (in the will above. Notice that Matthew Parham mentions daughter in law, Lucrieta Parham while Robert names his wife Lucrieta. They obviously had a son named Robert Parham as the grandson is named in the will of Matthew Parham. I also think the son Robert Parham was the eldest of the children since Matthew Parham gave his daughter in law 1/4 of the estate.
- 2. The deceased Matthew Parham apparently had a son Stith Parham because in his will above (he named granddaughter Elizabeth Parham, dau. of Stith Parham).
- 3. The deceased Matthew Parham had a daughter that married Matthew Sturdivant (mentioned grandson John Sturdivant son of Matthew Sturdivant and my daughter Martha Sturdivant).
- 4. Matthew Parham had another daughter that married William Wyne (mentioned granddaughter Ann Wyne daughter of William Wyne).
- 5. Matthew Parham had another daughter named Martha Parham that married William Sturdivant. Matthew Parham in his will

mentioned his granddaughter Martha Sturdivant, dau. of William Sturdivant and my daughter Martha Sturdivant).

Comments to the above will by Robert Hill of Brandon, Fl: From the above will is proof that Lucretia Parham, wife of Robert Parham, was Lucretia Sturdivant, daughter of Henry Sturdivant.

His son William Sturdivant, married Martha Parham, daughter of Matthew Parham. This Bible was printed and published by M. Carey and Son., 120 Chesnut Street, Philadelphia, PA. in 1818 and belonged to Elizabeth Pigott. Patsy Haley Pigott had 3 sisters who married 3 Bingham brothers. This Bible is in the possession of Mrs. J. B. Parham of Rt. 6, Franklin, Tenn.

Michael Hill, an 18 year old man, left his land to Mildred Gilliam, who was living on the land at time of Michael Hill's death. She was the mother of Burrell Hill 5/,

John Hill 4/ was a son of Richard Hill 3/ and his wife Hannah Briggs. His wife, Milley Hill, was actually Mildred Gilliam, daughter of John Gilliam.
