R.086 LAND GRANTS, DEEDS FOR HILL FAMILY OF SURRY, GUILFORD, STOKES & ROCKINGHAM COUNTIES OF NORTH CAROLINA

Entered in March of 1988, updated in October of 1991 & updated again in January of 1996 by Robert R. Hill of Brandon, Fla.

Source of Information: Information sent to me by Win Jacob of Beaverton, Oregon; Research Information in 1990 by Mr. Jeff Bradley, some of my own research on the Hill families of Va., N.C. and Ga.

Explanation: Surry County, N.C. was obviously populated with more than one William Hill and also others with the Hill name.

Surry County, N.C. was created in 1771 from Rowan County. Also, in 1771, Guilford County, N.C., another location of several Hills, was created from Orange and Rowan Counties. In 1785, Guilford County was split and Rockingham County was created.

Surry, Guilford and Rockingham counties of N.C. was the home of several Hill families. Much confusion has arisen over the different William Hills and this document is an attempt to help indentify them.

Surry County, N.C. Deeds do show that there was a William Hill of Surry County who had sons named Thomas Hill; John Hill; James Hill; Jacob Hill (see below).

THIS IS THE GENEALOGY OF WILLIAM HILL SR. 1/ OF CAROLINE COUNTY, VA. WHO MARRIED SUSANNAH SMITHER AND WHO MOVED TO SURRY COUNTY, N.C. (HE IS NOT RELATED TO SION HILL JR. 3/ (AS CLAIMED BY SOME) NOR IS HE RELATED TO THAT PARTICULAR HILL FAMILY LINE OF ISLE OF WIGHT & SURRY COUNTY, VIRGINIA AS CLAIMED BY SOME.

Originally entered in March of 1987 but updated and corrected in October of 1991 and again in August of 1996 by Robert R. Hill of Brandon, Fla.

Sources of information: Includes my own research but considerable information provided by Mrs. L. Winifred Jacob of Beaverton, Or.; Bits & Pieces of information sent by various researchers; Southside Virginia Families by Boddie; Southerland Family by Voorhees (1931) and the book East Goes West by Craft (Nov. 1984). Background Notes: This William Hill Sr. has been identified by many researchers as being the same William Hill 4/ that is often listed as the son of Sion Hill Jr. 3/ of the Surry County, Virginia Hill Family. There are many researchers, including this compiler, that does not believe this is correct and feels that there is ABSOLUTELY no connection between the two Hill families what so ever. This compiler agrees with Mr. Felix Earle Luck of New Jersey (and others) who also are disbelievers of this connection.

WILLIAM HILL SR. 1/ (FIRST KNOWN GENERATION).

WILLIAM HILL SR. 1/ (1710-1787) has been said by many researchers to be the son of Sion Hill Jr. 3/ of the Surry County, Virginia Hill line. This compiler disputes that claim and feels that he is in no way related to that Hill lineage of Isle of Wight, Surry County or Sussex County, Virginia. Others say his father was another William Hill (wife Ann) who's origins were in Maryland.

William Hill Sr. 1/ is said to have been born in Caroline County, Virginia ca. 1700-1710, moved his family to Surry County, N.C. He had several sons who fought in the American Revolution from N.C. and in their applications to received benefits for their service, stated they were born in Caroline County, Va, and arrived in N.C. aboyt 1779, indicating this was probably when William Hill Sr. 1/ first came to N.C.. Surry County records shows he arrived earlier, about 1775.

Following taken from book entitled: Abstracted Wills for "Surry County, N.C. Wills 1771-1827," by Jo White Linn.

1. In Surry County Will Book I, Page 69a, there is a will of Abraham Jones, dated 14 February 1775 that was witnessed by a William Hill.

2. Another will is for a Marshall Duncan Sr., dated 26th August 1776 found in Surry Co. Will Book I, Page 74 where it was witnessed by a William Hill and also proved by him.

3. Surry County Will Book I, Page 122a, dated 23 December 1777 ius a will for Benjamin Panniel, which was witnessed by both William Hill and Robert Hill, probably the father and son.

4. Surry County Will Book I, Page 127a, dated February Court 1779 Inventory of Estate of Isaac Gartrison, deceased, mentions a 1782 tax list showing 700 acres in Captain Hill's District.

End of Abstracted Surry County, N.C. Wills

I think these wills of Surry County, N.C., clear; y shows that this William Hill Sr. 1/ moved his familt to N.C. earlier

than what his sons had indicated and shows he was probably present as early as February of 1775.

William Hill Sr. 1/ died in Surry County, N.C. in 1787. In Surry County Will Book 2, Page 120, dated 14 May 1787, is a return on the estate of William Hill Sr. 1/, made by his two sons, Robert Hill 2/ and Dan (Daniel) Hill 2/. ofHis wife was Susannah Smither (Smithers) (1716-?) probably the daughter of Thomas Smither and Susanna Singleton of Gloucester County, Va.

 Reverend William Hill Jr. 2/, (1737-29th September 1792) died in Rockingham County, N.C. He was a Revolutionary Soldier, and was born in Caroline County, Virginia. He married in January of 1758 to Hannah Elizabeth Halbert, probably in Caroline County, Virginia. After his death, in 1792, she remarried to John Glenn Jr. of Rockingham County, N.C. (See her petition later).

War Application (W-1606) states birth was in Guilford County, but Guilford was not created until 1771. The location is in present day Rockingham County) He died on 5th April 1849 in White County, Tennessee, where both he and his wife are buried in the Anderson Cemetery. He married Catherine Shropshire on the 17th of July 1783 in Guilford County, N.C. She was daughter of Winkfield Shropshire & 2nd wife, Jane Jones. Catherine was born in September 1760, Rowan County, N.C. and died on the 14th of February 1854 in White County, Tennessee. He was a Revolutionary Soldier and received a pension (#W-1606)
 - i. Elijah Hill 4/, b. 22nd April 1784 Guilford Co., N.C. (now Rockingham Co.), he d. 25 October 1854 in Van Buren County, Tenn. & buried in Laurel Creek Cemetery. He m. Sarah Cummings, b. 2 April 1784 Henry Co., Va.-d. 5 October 1854 Van Buren Co., Tenn.
 - ii. James Hill 4/, b. 1786 Guilford Co., N.C. & d.6 December 1841 White Co., Tenn.
 - iii. Abner Hill 4/, b. 20 August 1788 Rockingham Co., N.C., d. after 1861 in Texas. He m. 1st in December of 1806 to Sarah Bartlett, who d. 8 December 1808; 2nd marriage to Katherine Cotton on 10 September 1809 in White Co., Tenn.; 3rd marriage to Nancy Matthews. He was for a time a circuit rider Campbellite preacher.

- iv. William J. Hill 4/, b. 1790 in N.C. & m. Sallie Cotton.
- v. Jane Hill 4/, b. 1791 or 1796 in Greene County, GA., d. ca. 1815 & married Robert Patrick Bates, Franklin Co., Ala.
- vi. Winkfield Hill 4/, b. 27 February 1792 Greene Co., GA., d. 8 August 1851 White Co., Tenn. He m. Martha (Patsy) Anderson, b. 1798 in Tenn. & d. on 3rd August 1851 in Tenn.
- vii. Hannah Hill 4/, b. 13th February 1796 Greene Co., GA., she d. 19 January 1837 & m. Ezekiel Bates.
- viii. Cynthia Hill 4/, b. 4 December 1799 in Greene Co., GA., d. near Nashville, Tenn. She m. in August 1816/17 at Sparta, Tenn. to Gillington Chisholm (1796-31 March 1872).
- ix. Thomas Hill 4/, b. 1804 Greene Co., GA., m. Martha----?
- B. William Hill 3/ born in Surry (today's Stokes) County, N.C. on 25th September 1773, died 29th September 1857 in Raleigh, N.C. He married Sarah Geddy on 1st January 1803. She died, on 14th February 1833. He was Secretary of State for forty years (1818-1850). He married 2nd time to Frances (Conners) Blount, no children.
- C. John Hill 3/, is not mentioned in the will of William Hill 1/ and he is thought to be son of Rev. William Hill Jr. 2/ (as is listed here). He moved to Tennessee. Wife was Obedience Cullom (or Cullom). Had a son Gershon Hill 4/.
- D. James Hill 3/, m. Nancy Royalty.
- E. Green Hill 3/, married Nancy Mitchell, daughter of Gabriel and Elizabeth (Geddy) Mitchell. He was the grandfather to the Reverend Thomas Bains.
- F. Cynthia Hill 3/. married <u>Crawford</u>. Children were: Cynthia Hill 4/, Cyrus King Hill 4/ and Julia Hill 4/, who m. Senator John Hill 3/ of the Robert Hill-Martha Halbert lineage. (see below).
- G. Martha Hill 3/ married a Mr. Osborne, no children.
- H. Frances (Franky) Hill 3/, married Major Mark Hardin Jr. of N.C., children were Lauriston Bonaparte Hardin 4/, John Hardin 4/, Pleasant Hardin & William Hill Hardin 4/, m. Maria Hill of the Brunswick County, N.C. Hills and the Hills of Boston, Mass.
- I. Mary Hill 3/, married Osburn Childress. Their daughter Minerva Hill Childress married Giles A. Reynolds, who's daughter Medors (sic) married Charles T. Robinson and had a daughter Caroline, who married a Mr. Cook.
- J. Elizabeth Hill 3/, born in Caroline County, Virginia on 18th of September 1747, died 6th of November 1836 in Belton, Anderson Co., S.C. She

married in June of 1765 to William Anson Halbert in Virginia, who was the son of Joel and Elizabeth (Jones) Halbert, who was born in 1744 in Virginia and who died near Belton, S.C. in 1808.

- II. Thomas Smithers Hill 2/ b. Caroline Co., Va in 1739, died 1825 in Surry Co., N.C., married Susannah Mosley, daughter of Westley Mosley (Ref: Mosely's Will in Surry Co., N.C. Book 3, Page 149, dated 1821). He has often been mixed up with the Thomas Hill 3/, son Rev. William Hill Jr. 2/, his older brother. His children were: Lewis 3/; Jesse 3/; Thomas 3/; Talitha (Tabitha?) 3/; Sarah 3/; Rhody 3/; Rachel 3/; and Elizabeth 3/ m. Stoddard.
- III. Elizabeth Hill 2/, b. Caroline Co., Va. on 18 September 1747, d. 6th November 1836 at Belton, Anderson Co., S.C. 1836. She married in June of 1765 to William Anson Halbert (1744-28 December 1808), who was born in Essex County, Va. He died in Anderson Co., S.C. and they had thirteen (13) children. They both are buried on their home site three miles south of Big Creek Church, located between Toney Creek & Broadmouth, not far from Calhoun, S.C. The husband was son of Joel Halbert & Elizabeth Frances Jones. William was a staunch Wig during the Revolution and served as a 2nd Lieutenant in the Henry Co., Militia 1779-1780.
 - A. Joel Halbert 3/, b. 13 June 1765 or 1769 in Caroline County, Va. He d. on 24th June 1848, St Mary's, Hancock County, Illinois and was buried in St Mary's Churchyard. He m. Mary Lindsey, b. 26 August 1772 and she d. 22 July 1839 near Shoals, Martin Co., Illinois. He served with Andrew Jackson in war of 1812 and had 12 children.
 - B. Martha Halbert 3/ was born 17 March 1771/2 and died on 12 June 1810 in Pickens County, N.C. Another source says she d. on 13 November 1854). She m. John Gresham Jr. on 13 November 1788 in Anderson County, S.C. Their first child was Joseph Gresham 4/, b. 17 November 1789, m. Nancy Wyatt. Joseph's third child was Elizabeth Gresham 5/ (1826-1896) m. Joseph Emerson Brown in 1847 and were the parents to Sally Eugenia Brown, who was the great grand-daughter of Elizabeth Hill & William Halbert.
 - C. John Halbert 3/, b. 6 January or 11th of October 1773 in Virginia. He lived in S.C. & then ca. 1818 moved to Mississippi. He d. on 7 July 1854 on his plantation near Columbus, Lowndes County, Mississippi. He served several years in the S.C. Legislature and m. Margaret Harper ca. 1795. She d. 8 October 1842. They had twelve children.
 - D. Enos Halbert 3/, b. 6 January 1775 in Virginia or N.C., he d. in 1833/34. He lived in Anderson Co.,

S.C. but moved to Tennessee where in 1786 or 1788 he m. Lucy (Nancy) Garner, daughter of Thomas garner & Susannah--? After her death he married 2nd time to Rebecca Harper of N.C. who died on 16 May 1773 in Wilson Co., Tenn.

- E. Arthur Halbert 3/, b. 17 February 1777 in Va., d. ca. 1806. He m. in 1797 to Elizabeth Cobb. They had four children.
- F. James Ira Halbert 3/, b. 8 September 1778, d. ca. 1860. He m. in 1798 to Fanny Pepper (b. 1782-). About 1814 they moved to St. Francis County, Missouri and later to Steelville, Crawford County, Missouri. They had eleven children.
- G. Susannah Halbert 3/, b. 29 August 1780 and died in 1868 in Anderson County, S.C. She married Peter Acker Jr. and they had nine children. After her father died, her mother lived with Susannah. Question is, was Susannah named after her grandmother Susannah Smither?
- H. Frances Halbert 3/, b. 30 May 1782/83 and died in 1857. She married about 1805 to James Charles Garrison (1774-1864). They lived in South Carolina and had thirteen children.
- I. William Anson Halbert Jr. 3/, b. 17 May 1784, married Elizabeth Bowen and they had eight children. She died after 1828 and William remarried to Rachel Lindsey Cooper and they had four children.
- J. Joshua Lucius Halbert 3/, b. 4 October 1785, d. 1842, in Tuscaloosa County, Alabama. He married Sarah Bowles and they had a son that died in infancy. After Sarah's death, he then married Matila Nash, b. 4 June 1793 and had seven children.
- K. Elizabeth Halbert 3/, b. 6 January 1788, Anderson County, S.C,. She married on 30 May 1805 to William Berry, b. 17 August 1780 in S.C. He d. 14 June 1858 in Mississippi. He was son of Hudson Berry and Sarah Anthony. Elizabeth & William Berry had eleven children.
- L. Mary Halbert 3/, b. 10 April 1791 in South Carolina, died 1872. She married John Sterling Sherrill (1784-1855). They were parents of four children. They moved to Missouri.
- M. Lucinda Halbert 3/, b. 16 January 1793 in Anderson County, S.C., d. in Mississippi and married David Berry, b. 30 August 1789. They had thirteen children.

He married in September of 1769 to Martha Halbert, born 1750 in Caroline County, Virginia. She died 20th September 1833, & was the daughter of Joel and Elizabeth (Jones) Halbert. They both are buried 4 miles northeast of Germantown, N.C. In Surry County, N.C. Will Book I, Page 101, under the Inventory of Estate of James McJoin, deceased, dated 20th March 1778, shows that the deceased owned 360 acres of land in Captain Hill's District. Captain Robert Hill and wife had 10 children, 5 sons and 5 daughters. They were:
 - A. Susanna Hill 3/, born 25th June 1770, m. Edmond Samuels on 15 March 1788 in Surry County, N.C. He was b. 1767 & d. 1833.

 - E. Joel Hill 3/, b. 4 July 1780, d. 12 September 1857, (Revolutionary Soldier), he m. on 28th January 1815 in Stokes County, N.C. to Mildred Golding, daughter of Jack Golding. She was b. on 29 December 1794 and d. 20 September 1869. They are buried in Hill Cemetery in Stokes County, N.C. (Voss Burying Ground).
 - i. Robert William Hill 4/, b. 1813 in N.C., d. in 1886 in N.C., m. 1840 to ?? His birth date is before parents married unless there was a 1st wife??
 - ii. Sarah Golding Hill 4/, b. 1816 in N.C., d.1886, m. 1840 to Col. James Madison Covington.
 - iii. John Gideon Hill 4/, b. 11 October 1817 in Stokes Co., N.C., d. 1885, m. in Stokes Co., N.C. on 16 Sept. 1846 to Susan Frances Poindexter.
 - iv. Martha A. Hill 4/, b. 1819 in N.C., d. 1872, m. in 1850 to Samuel Fulton.
 - v. Joel Felix Hill 4/, b. 1821 in N.C., d. 1899, m. a cousin, Harriet Kiser, granddaughter of Rev. William Hill Jr. 2/, through daughter.

- vi. Caleb Hill 4/, b. 1823 in N.C., d. 1893 in Missouri, m. in 1861 to Sallie F. Rierson.
- vii. Elizabeth Hill 4/, b. 1862 in N.C., m. 1844 to Samuel S. Blackburn.
- viii. Isaac Luther Hill 4/, b. 1824 in N.C., d. 1847, m. in 1847 (just before death?) to Mary Fulton.
- ix. Frances Jane Hill 4/, b. 1830 in N.C., d. 1902, m. in 1849 to James M. Hardy.
- x. James Stadler Hill 4/, b. 1832 in N.C., d. 1919, m. on 28 May 1860 in Surry Co., N.C. to Mary Letitia Banner. Their daughter Sallie Hill 5/, b. in Surry Co., N.C. m. Merrill Doyle Arnold.
- xi. Thomas Davis Hill 4/, b. 1834 in N.C., d. 1856 in Texas. No other information.
- xii. Dr. Lauriston Hardin Hill 4/, b. 1837 in N.C., d. 1921, m. Minerva Rierson.
- F. Sally Hill 3/, born 30 September 1782, died 20 September 1805, buried Hill Cemetery, Stokes County, N.C.
- G. Martha Patsy Hill 3/, (Twin to Robert Jr.) born 30th December 1785, m. William G. Haynes on 3 March 1810, lived and died in Surry Co., N.C. 8. Robert Hill 3/, born 20th December 1785, m. Miss Briggs.
- H. Robert Hill Jr. 3/, (twin to Martha) b. 30th December 1785, d. 1844 Surry County, N.C. & m. 9th May 1807 in Stokes County, N.C. to Elizabeth Vest, b. 9 May 1787 & d. ca. 1870. Both buried Hill's Chapel Cemetery.
- I. Frances Hill 3/, born 23rd February 1788, d. by 1833, m. 25 July 1809 in Stokes County, N.C. to --Thomas Locke Davis, b. 2 September 1789 in Va..
- J. Senator John Hill 3/, born 9th April 1790, died 25th April 1861, m. in 1819 to Julia Crawford, daughter of Cynthia Hill. He lived in Stokes Co., N.C. and is buried in the old burying grounds in that county. He was educated in University of N.C., was elected seven times to the legislature and once in Congress in 1839. He was opposed to secession and against his will was appointed to the convention that carried the state out of the Union. He said that if there was secession he did not want to live and during the convention he was stricken with apoplexy and died.

- VI. Uel Hill 2/ born in Caroline Co., Va., no date listed, married 1st to a Hartfield; 2nd to a Duvall and 3rd to ??? He was a Baptist minister and served in the American Revolution.
- VII. Daniel (Dan) Hill 2/, Revolutionary Soldier, b. 16th October 1756 in Caroline Co., Va., d. 28 May 1826 in Williamson Co., Tennessee. (HIS WILL). He married on 16 October 1779 to Martha (Patsy) Hickman, daughter of William Hickman (Revolutionary Soldier). They had 10 children, 2 sons and 8 daughters. They were:
 - A. Sarah Hill 3/, b. 28 July 1780, d. between 1830 & 1855, married Nathan Ewing. He was born 17th February 1776 at Nashville, Tenn., died 1st May 1830.

Rockingham County Court Minutes, 1786-1795 Pt.2, Page 32. Dept, of Archives & History, Raleigh, N.C.

27 August 1792. Ordered that the prayer of William Hill's heirs be granted and that Samuel Henderson, Thomas Henderson, Pleasant Henderson, James Hayes and John Reagen be appointed to lay of (sic) (off?) the lands as the law directs and make (a) report to next court and that Thomas Henderson be appointed guardian to said children to wit: William Hill, James Hill, Eliza Hill, Cintha Hill, Green Hill and Polly Hill.

Comments: This clearly shows that Rev. William Hill Jr. 2/ was dead by this date. A Mr. BRadley stated he died in February of 1785, but since his widow was already married on that date, he must have died in 1784.

Stokes County, N.C. Deed Book 3, Page 12.

14 January 1797. James Hill of Rockingham County, N.C. to William Hill of same.. For 75 pounds current money, 464 acres (of land) on the waters of Town Fork on Ash Camp Creek whereon the REVEREND WILLIAM HILL, formerly lived, joining the lands of John Halbert, Samuel Hampton and others. James Hill

Witnesses: Robert Hill, Thomas (T) Evans Proved June 1797 by Robert Hill.

Comments: I believe this was James Hill 3/ selling 464 acres to his brother William Hill 3/. This appears to be the same land that the widow (& mothrer) filed a petition in the courts for her dowry. SEE PETITION BELOW! I think Robert Hill was their uncle, Captain Robert Hill 2/. Was this 464 acres the same as the one below?

Stokes County Deed Book 3, Page 57.

7 October 1797. John Hill of Davidson County, Tennerssee, to William Hill of the city of Raleigh (NC) for 100 pounds current money, 464 acres (of land) on Ash Creek, waters of the Town Fork, whereon the Reverend William Hill, deceased, formerly lived.

John Hill Witnesses: James Hill, Thomas Henderson. Proved Decembrr 1797 by James Hill.

Comments: This was a son of Rev. William Hill 3/ named John Hill 3/ who was selling his parents home site to his brother, William Hill 3/, 464 acres of land that was later contested by the widow, Elizabeth Halbert Hill (who remarried John Glenn).

Stokes County, N.C. Deed Book 4, Pages 143, 144.

15 June 1802. Division of land to the heirs of William Hill, deceased.

Lot No. 1 to Green Hill, 111 and 1/4 acres. Lot No. 2 to William Hill, 83 acres. Lot No. 3 to James Hill, 104 acres. Lot No. 4 to John Hill, 168 acres.

Comments: The son William Hill was born om the 23rd Of September 1773 would be 21 years old the next September after this deed. The son Green Hill, born 1782, was the youngest son, & aged 20 at the time the property was divided. This proves that a minor could own land, BUT only if the land was inherited.

PETITION OF WIDOW, ELIZABETH (HALBERT) Hill..

10 December 1810. Petition of widow Elizabeth Hill of Stokes County, N.C.. widow of Reverend William Hill Jr.: Petition of John Glen & Elizabeth Glenn, formerly Elizabeth Hill.. that William Hill departed this life orn or about----? intestate, leaving at the time of his death the following sons: John Hill, William Hill, James Hill & Green Hill; ALSO Elizabeth Hill now Glenn by her intermarriage with John Glenn, his widow & relict.

The intestate was seized of a tract of land lying on Ash Camp Creek, a branch of Town Fork containing 464 acres, adjoining James Hampton and Thomas Evans. Elizabeth (Glenn) is entitled to one-third part as her dower.

John Glenn deposes that he agreed with John Hill, who was the guardian of his brother, Green Hill (by appointment of Court of Rockingham County) to buy Green's part at \$ 300.00. Glenn gave a Negro girl, worth \$ 300.00 as payment to John (Hill) & John sold the Negro. Green Hill has not made good the deed since arriving at the age of twenty-one.

John Hill lived at Cumberland (county?) in 1808 and 1811. Green Hill replied to the bill in October 1811. (notes from IBID).

End of Estate Affairs for Rev. Wm. Hill 2/.

Comments: Why William & Hannah Hill were dismissed is unknown. Same as to why Gustavius Hill & wife Margaret Hill were excummunicated. They may have simply moved to another location.. but when "excommunicated" then there was real trouble.

21 January 1781 Sister Charity Hill gave satisfaction again.

Page 5, 15 March 1781 as there was dispute between Brother Gustavius Hill & Sister Hannah Hill, they cum (come) together again.

Sister Charrity (sic) Hill for lying (to?) the church, excummunicated her.

It has not been proved as yet, but I suspect the above William Hill & Gustavius Hill may have been cousins or perhaps brothers. I also think it possible that William Hill with wife Hannah may have been Rev. William Hill Jr., the son of William Hill Sr. and wife Susannah Smithers, who married Hannah Elizabeth Halbert.

William Hill Sr. was born ca. 1710 in Caroline County, Va. and came to Surry County, N.C. along with his family.

"William Hill of the County of Rockingham and State of North Carolina of one part and William Mills of the County of Henry and State of Virginia of the other part... land situated in the county of Rockingham and on waters of Buffalo Island Creek of Dan River, beginning at a white oak on the south side of the aforesaid creek running thence west 186 poles to a black oak in Joseph Gibson's line; thence north along his line crossing the creek 206 poles to his corner; thence the same course continued 80 poles (286 in all) to a pole in Gustavus Hill's line; thence east along his line crossing white oak fork.." Witnessed by: Charles Gallaway A. Walker Lee Murphy

Note: This is the same land of N.C. Land Grant Number 298.

Comments by Robert Hill: This particular William Hill was a different man than the William Hill SR., who married Susannah Smithers and who was dead by February of 1787. However, according to most sources, his son, Rev. William Hill Jr. lived until 1792, which is contrary to what Mr. Jeff Bradley states.. Bradley indicated this could not have neen Rev. William Hill Jr. because he was dead by February of 1785... IS THIS WRONG?

Additional deeds which add information about this Hill Family are:

A. Rockingham County Deed Book A, Page 221 December 1786

Joseph Pain Johnson to John Hill Sr.

" 137 acres on Buffalo Island Creek of Dan River.. on William Hill's line.. on said Hill's own line..." This proves that this John Hill was the same John Hill who bought the property on N.C. Grant 313 and proves that this John Hill was still alive as of this date. This deed also proves a James Hill and a John Hill Jr. are alive as they witnessed this deed.

B. Rockingham County, N.C. Deed Book H, Page 109 Dated 1791

Gustavus Hill to David Alexander, 200 acres on Buffalo Island Creek.

This represents the sale of the grant he received from North Carolina and proves he was alive by this date.

- C. Later Rockingham County Deeds in a time period of 1808-1815 prove heirship of John Hill Jr., Micajah Hill, Dutton Hill, etc.., all as heirs of the John Hill Sr. who bought the N.C. land grant property of William Hill (No. 313) in 1783 as well as the Polly Shropshire connection. (SEE FOOTNOTE BELOW)
- D. The last piece of property on record to be sold from the Hill family land on Buffalo Island Creek was in 1815 when Dutton Hill sold 75 acres to Polly Shropshire.
- E. None of these heirs appears in any land transactions in Rockingham County deeds past 1815.

Comment by Robert Hill: Notice the namss mentioned in paragraph "C" above" John Hill Jr; Micajah Hill, Dutton Hill... It is my opinion that what we may have was a William Hill 1/, son John Hill Sr. 2/, and then his children, (third generation) all listed above. This should be checked out carefully by interested parties.

Rockingham County, N.C. was created from Guilford County in 1785.

THE HILL FAMILY OF FISHER AND LITTLE FISHER RIVER (SURRY COUNTY, N.C.)

Surry Co., N.C. Deed Book D, Pages 404, 405 (380 acres) Dated 20 January 1789:

"James & Catherine Bryson of Surry County of the one part and William Hill of said county and state of the other part... land in said county of Surry and Province aforesaid situated on Fisher's River beginning at a pine on the south side of the Main River and 9 degrees north, 70 degrees west; 80 chains to a Spanish oak; thence north 37 chains to a black oak; thence east 76 chains to a pine; thence south 63 chains to the beginning.."

Witnessed by: John Bryson Jr. Thomas Hill (Possibly the eldest son of Wm.)

Note: This is the very first deed for ANY HILL on Fisher River in Surry County.

Comments by Robert Hill of Brandon, Fl.: From what I can gather, it appears that William Ramsey surveyed 380 acres of land for James & Catherine Bryson, who then sold it to William Hill.

William Hill must have made a verbal agreement with his sons for them to divide the 380 acres (after his death), with each having a certain tract of land, thus the deeds below.

Old English law gave the eldest son the birth right to inherit all property and I suspect Thomas Hill was the eldest son. He must have moved to Wilkes County, Georgia and then sold all of his N.C. lands to his brothers (as his father wanted them to have). He also sold land to a man named Benjamin Cadle. This land did not come from his father, William Hill, or at least it is not indicated so.

William Hill sells to John Hill (350 acres)

"William Hill of the State of North Carolina and County of Surry on the one part and John Hill of the aforesaid State and County of the other part... (sells land) on both sides of Buffalo Island Creek of Dan River beginning at a white oak; running thence north 165 poles to a post oak in the aforesaid Hill's line; thence west along his own line 60 poles to a white oak; thence south crossing a branch 120 poles to a post oak in Henry Seale's line; thence west along his line crossing a branch 60 poles to a black oak; thence south along his line..."

Comments by Robert Hill of Brandon, Fl.:

It appears to me that William Hill was selling land to his son, John Hill (John Hill Sr.). This deed clearly shows that William Hill owned land before the purchase he made in 1789. Apparently Mr. Bradley did not pick up on this, however, Mr. Bradley clarified his position when he states "that the deed of 20th January 1789 was the first recorded deed on Fisher River." Note: This deed was copied by Robert Hill of Brandon, Fla.:

Surry Co., N.C. Deed Book F, Page 274, (100 acres) November 1792

Thomas Hill OF WILKS CO., GA. sells to (brother?) John Hill for 100 pounds current money, a certain tract or parcel of land lying and being situate in the county of Surry on both sides of little Fisher River bounded by the "conditional lines made and agreed on between the said John Hill and his father William Hill, deceased, and the former lines of the Survey deeded by William Ramsey for 380 acres, containing 100 by estimation be the same more or less etc. etc."

Surry County August Term 1795: The execution of the within Deed was proved in open court by Matthew Sims and ordered to be registered.

Comments by Robert Hill: While Thomas Hill is not named as a son of William Hill, I think he was the eldest son, thus had probably inherited the land and was now selling to his brother, John Hill (JOHN HILL SR.).

Note that Thomas Hill was a witness when William Hill purchased land in 1789 and that he also owned other land in Surry County, which he sells on the 2nd of October 1792. (see later).

A Deed between Thomas Hill of Wilks County, Ga. to Jacob Hill for 50 pounds sold 140 acres of land in Surry Co., N.C. located on both sides of Fisher River, on both sides (of) the little river, joining JOHN HILL above and JAMES HILL below, agreeable to the conditional lines made between them and their father WILLIAM HILL in his life time and including the place where he deceased, containing 140 acres by estimation be the same more or less..etc. etc.."

Surry County August Term 1795: The Within Deed was proved in Open Court by Matthew Sims & ordered to be registered. Test: J. Williams CC County Clerk

Comments by Robert Hill: This deed shows Thomas Hill was a resident of Wilks Co., Ga, and was selling another piece of property he owned in N.C. to his brother, Jacob Hill, who still lived in Surry Co., N.C. Again, I am of the opinion that Thomas Hill was the eldest son of William Hill, and as such, inherited the land from his deceased father, William Hill.

From the wording of the deed, it appears to me that the deceased father named William Hill, had made a verbal agreement with all of his sons as to which land was to become theirs after his death. (see next deed)

This deed copied by Robert Hill:

Surry Co., N.C. Deed Book F, Page 274, dated 10th November 1792 (same days as the previous two deeds)

Thomas Hill of Wilks Co., Ga. sells to (brother) James Hill for 90 pounds current money, a tract of land in Surry Co. lying on both sides of Fisher River at the fork in the lower end of Surry made by William Ramsey for 380 acres, "bounded by a conditional line made between the said James Hill and his father William Hill, containing 140 acres"... etc. etc Signed/Thomas Hill Signed, Sealed in presence of J. Mackey John (x) Watson

Surry County August term 1795, the execution of this within Deed was proved by Matthew Sims and ordered to be registered.

Comments by Robert Hill: This was another deed where Thomas Hill, a resident of Wilks Co., Ga. was selling his N.C. land to his brother JAMES HILL, who was still in Surry Co., N.C.

This deed copied by Robert Hill:

Surry Co., N.C. Deed Book F, Page 348, (100 acres) Dated 22 October 1792

Deed between Thomas Hill of Wilks Co., Ga. to Benjamin Cadle for 30 pounds current money, sells land lying on Bull Creek, the waters of Tarrarat River beginning at two chesnut trees, the south side B Run and runs East twenty three chains to a pine the north forty three chains and a half, crossing said Run to a white Oak, west twenty three chains to a Pine then South crossing said Run to the beginning, containing 100 acres etc etc.."

Surry County August Court Term 1796: The execution of this within Deed was proved by the Pat of Joel Mackey & ordered to be registered.

Comments by Robert Hill: This is another deed made by Thomas Hill, who was a resident of Wilks Co., Ga., selling land he owned in Surry Co., N.C. to a Benjamin Cadle of Surry County, N.C. Apparently this land Thomas Hill was selling, did not come to him from his father, William Hill, at least it is not indicated as being so.

Surry County Deed Book K, Page 217, (100 acres) dated 1st December 1795

"John Hill of County of Surry and State of North Carolina of the one part and Colby Creed of the other part... land lying situate in said county of Surry on Little Fish River being part of the survey made by William Ramsey which said Creed is now in possession of from a purchase of Jacob or Joab??) Hill..."

Note: The question to the above name has been solved! Jo Williams, the clerk who wrote this deed as well as the deed from Thomas Hill to Jacob Hill (in) 1792, has a very distinctive handwriting. I compared his writing of both deeds and was easily able to determine that the above deed stating "..from a purchase of.." is JACOB, not Joab. There is no recorded deed of sale from Jacob Hill to Colby Creed, nevertheless the above deed states that Jacob Hill had sold his land to Creed.

(The above comment made by Mr. Jeff Bradley)

Surry County Deed Book G, Page 190 Joab Hill sells to Colby Creed (140 acres) October 1, 1796

"Joab Hill of the one part and Colby Creed... (sells) land lying and being situate in the County of Surry on Little Fish River being part of a tract deeded for William Ramsey of 380 acres divided by and bounded by Fielding Herrin and JOHN HILL, deceased to said Colby Creed at the upper end agreeable to the conditional lines formerly made containing 140 acres..."

Witnessed by Joel Mackey Alexander Mackey Martin Burrus.

Comments by Robert Hill: This deed shows that the son JOHN HILL (SENIOR) was now dead. Based on the fact that this land was for 140 acres, which matches the same amount of land that the son, Jacob Hill obtained from his father, William Hill, I am of the opinion that Jacob Hill was now dead or had moved and HIS SON, Joab Hill had control of the land and was completeing the sale that his father (Jacob Hill) had started with Creed.

Following are comments by Mr. Bradley: The above deeds provide us with the following information:

- 1. A William Hill purchased the first property on Fisher River on January 20th, 1789.
- This date proves that he cannot be William Hill Sr. (dead by February 1787) or his son Rev. William Hill (Jr.) (dead by February 1785) or his son William Hill (later Secretary of State) since he was too young to own

property. Comment by Robert Hill: I do not agree with Mr. Bradley's statement about the death date of Rev. Wm. Hill Jr. Some one is confused! Bradley says Rev. Wm. Hill Jr. was dead by February 1785 YET the above genealogy states he died on 29th September 1792. Everything I have ever seem says he died in 1792, HOWEVER I do agree that this was not Rev. William Hill Jr., but only because of the names of the children.

- 3. This William Hill was dead by November 10, 1792.
- 4. This William Hill was the father of Jacob; James; and John Hill (SR., also probably Thomas Hill).
- 5. This Thomas Hill, although he is never named as a son in any of the above deeds, most probably was since he is selling the same property that this William Hill bought in 1789. It would be probable that he was the eldest son of this William Hill and was his heir. Note: Mr. Bradley & I agree on this matter.. R.Hill.
- 6. This Thomas Hill also owned additional property in Surry County as per the October 2, 1792 deed.
- 7. This Thomas Hill was residing in Wilkes County, Georgia by October 2, 1792.
- John, son of this William Hill, is dead by October 31, 1796, but still living on December 1, 1795. (This was John Hill Sr.)
- The land that Joab Hill sold to Creed was almost certainly the same land that Thomas Hill sold to Jacob Hill in 1792 by the description of the property since only Jacob's property bounded John's property.

OBSERVATIONS (BY BRADLEY)

- 1. If Number 9 is accepted, what happened to the 140 acres which Thomas Hill sold to James Hill in 1792? I cannot find a later deed in Surry County for such a sale!
- 2. Why does the 1795 deed from John Hill to Creed state that Creed is now in possession of property ".. from a purchase of Jacob Hill..." and then in 1796 Joab Hill is selling to Creed the property which was referred to as being sold one year earlier.
- 3. There is, however, no factual evidence to the previous to the previous claims that this Joab Hill was the son of the Fisher River William Hill. Likewise, it is erroneous to have connected him in anyway to the Rev. William Hill (Jr.), the Baptist preacher who died in Guilford/Rockingham County by February 1785.

4. The following Hill family was a Surry County family and much confusion has arisen due to the fact that the property of different Hill families in this area had been originally recorded in Surry County. However, as the counties broke off from one another, the land became part of the newly formed counties, as in the case with the Hill property in Stokes; Guilford; and Rockingham Counties. Nevertheless, property cannot move. This Hill family was ALWAYS a Surry County family with respect to their Fisher River Island holdings.

END OF BRADLEY'S RESEARCH PROJECT

Additional details to be added to Bradley's observations by Robert Hill. also reference to the William Hill Sr. genealogy at beginning of this document:

1. When Bradley speaks about William Hill Sr., he is talking about the William Hill Sr. 1/ said to have been born ca. 1710 in Caroline County, Va. and married Susannah Smithers.

I do agree with his analysis that this date of 20th January 1789 PROVES that this could not have been William Hill Sr. 1/ (m. Susannah Smithers) because he was dead by February of 1787, but I do not agree with him that it could not have been his son, Rev. William Hill Jr. 2/ (m. Hannah Halbert) because the above genealogy says Rev. William Hill Jr. 2/ died on the 29th of September 1792, NOT February 1786 as Bradley states. Someone is very wrong on this matter!

Neither do I completely agree with Bradley when he says that it could not be the son of Rev. William Hill Jr. 2/ (Wm. Hill 3/) due to his being too young to own land. I do not know what age a man had to be to own land, perhaps age 21. If so then Bradley may be correct on this subject BUT the above genealogy states that this son, William Hill 3/, was born on the 25th of September 1773 and in 1792 would have been 19 years old.

- 2. I think this William Hill had sons named Thomas Hill; Jacob Hill; John Hill and James Hill and was dead by 10th of November 1792.
- 3. John Hill, son of William Hill, was still alive on the 1st of December 1795, but was dead by 31st of October 1796. He had a son John Hill Jr.
- 4. Reference to the Question: What happened to the 140 acres of land that Thomas Hill sold to James Hill? Mr. Bradley states that he can find no later deed in Surry

County for such a sale! I think it was because James Hill remained in Surry County, died there at some later date and the deed was never recorded or lost over time.
