THE TWO FEMALES WERE MARGERY HERSELF, BORB IN 1726, WOULD BE ABOUT AGE 60. THE OTHER WAS PROBABLY THE DAUGHTER, REBECCA HILL, , WHO ON THE 30TH OF JANUARY 1788, MARRIED NICHOLAS LONG (JR).

1 MALE PROBABLY SON, WM. GILLIAM HILL. BORN 26 MARCH 1785, WHO WOULD BE ABOUT AGE

WHO THE OTHER MALE THAT IS LISTED IS NOT CLEAR.

IN ADDITION, HER DAUGHTER'S FAMILY IS IN NEARBY GRANVILLE., CO. NC. EPHIRAM PARHAM & HANNAH HILL

WILLIAM RUFFIN & SARAH HILL ARE LISTED IN NEARBY BERTIE COUNTY, NC

THE NICHOLAS LONG FAMILY, WHO'S SON, NICHOLAS LONG JR., LATER MARRIED REBECCA HILL, WAS NEARBY IN HALIFAX CO., NC CWNSUS.

THESE SOURCES, AND THE FACT THAT THAT MARGERY WAS NOT IN VIRGINIA CENSUS OR TAX LISTS, AFTER THE 1775 DEATH OF HUSBAND, RICHARD HILL, MAKES IT SEEM LIKELY THAT SHE IS THE ONE LISTED IN THE ABOVE SOURCES.

In the 1870 census, Burrell Hill nanmed his first listed son, Wiley Hill, indicating to me me that he was a son of Wiley Hill.

A HILL-BRANTLEY CONNECTION IN WARREN COUNTY, GA. TO NC.

The following Hills and Brantleys were from Halifax Ci,m NC.

From the court records it is obvious that Phebe Brantley was first married to a Thomas G. Hill and had a son named Fielding Hill. She was the daughter of Philip Brantley (Ref: His 1819 Will naming her as a daughter).

Thomas G. Hill estate, dated 1st May 1794, wife Phebe (Brantley) Hill named administratrix. Surety: Richard Hill.

On the 10th of May 1795, Phebe Brantley Hill applied for letter of "Dismission" as administratrix of the estate of her deceased husband Thomas Hill.

Henry Hight married the widow Phebe Brantly Hill, date not given.

Henry Hight was appointed guardian of Fielding Hill, son of Thomas Hill & Phebe Brantley Hill in February 1800.

Henry Hight & (wife) Phebe Brantley Hill Hight had a son named Wylie G. Hight.

Fielding Hill, son of Thomas G. Hill & Phebe Brantley married Isabelle Gibson on the 30th of January 1812.

Wylie Gilbert Hight married Olive Harris Baker on the 14th of November 1815.

Philip Brantley's will in 1819 names daughter Phoebe Hight

and her son Fielding Hill.

Wylie Gilbert Hight named a son Fielding Hight.

Henry Hight had Amanada Hill, age 43, in his household in the 1850 census.

BEGINNING QUOTED DOCUMENT FROM HALIFAX COUNTY, NC: NO DATE LISTED

"Halifax Co., NC Deed Book 20, February Court Tern 1806: 696-(218) RICHARD HILL 6/, WILLIE DANIELL, JAMES LONG post bond to JAMES JUDGE for 1250 pounds. The condition is that JAMES JUDGE as administrator of RICHARD HILL 5/ the elder, deceased, of Georgia (one?) of the executors of THOMAS HILL (THIS WAS THOMAS G. HILL), deceased, has paid 625 pounds to RICHARD HILL 6/ for the purpose of paying this over to the heirs of RICHARD HILL 5/ Deceased. FRANCES HILL (widow) must sign the receipt. She was guardian of ROBERT HILL 6/. Other heirs: JOSEPH HILL 6/, BENJAMIN HILL 6/, JOHN HILL 6/, NANCY HILL 6/, POLLY HILL 6/, HENRY HIGHT., guardian of FIELDING HILL 7/, son of TOM HILL 6/, deceased. Each must sign a receipt."

This Richard Hill 5/ was a son of Thomas Hill 4/ & Sarah Etheridge. Richard Hill 5/ married a woman named Frances --? (last name unknown) and they were last known to have been in Johnston County, NC until ca. 1782-85. After that time, they then disappearan, and apparently went to Warren County, Georgia. See the information below.

# R.094 LAW SUIT THAT POSSIBLE ESTABLISHES A CONNECTION WITH N.C.-GA. HILL FAMILIES

TO the worshful, the Justices of the Court of Pleas and Quarter Sessions for said county, November Term 1846.

The petition of NANCY HILL against THOMAS G. HILL, ASA HILL, TABITHA HILL, GREEN HILL, FIELDING HILL, JOHN HILL, MARGRY HILL, DUFFIE HILL, NATHAN HILL and MARK HILL, respectfully showeth unto your worships...

That your petitioner is the widow and relict of PEOPLES HILL, late of said county, who died in the year of 1846, intestate, leaving her wholy inprovched for that- said People died (sic) seized and possessed of the following tract of land, situate in Edgecombe County and in which your petitioner is entitled to dower, that is to say a certain tract of land adjoining the lands of Gray Armstrong, B. HILL, John Ward and others containing Four Hundred & Ninty (sic) acres or there abouts as will more fully appear by reference to the deed in possession of the heirs, which is ready to be produced at any time.

Your petitioner further shows that the above named defendants are the only heirs at law of said Peoples, all of whom are of age except said John, Margry, Duffie, Nathan & Mark, whom your worships will please have representatives by a guardian in this suit.

Your petitioner inviese of the premises prays your worships will order a writ of dower to you, to the sheriff of said county, commanding him to summon a jury of good and lawful men to lay off ans alot- Gonretes and bound to your petitioner her dower in said lands and first (herein?) possession of the sum and that your worships will make what other and further order to you may seem fit.

Signed/ T.L. Bridgers (AM)?? for petitioner

This shows that a Nancy Hill was the widow of Peoples Hill, who had died intestate (no will) and she was asking the court to provide her with her dower rights.

The heirs, Thomas G. Hill, Fiedling Hill and Green Hill were of age (21) but whether or no they were the sons of this People Hill & wife Nancy, is not known for sure. All of the rest were minors (under age 21).

That name of Thomas G. Hill and Fielding Hill, seems to imply a Georgia connection. In Warren Co., Ga a Thomas G. Hill had a wife named Phebe Brantley. They hasd a son named Fielding Hill. I strongly feel that Thomas G. Hill was a son of Richard Hill 5/ & wife named Frances--?. Richard 5/ was the son of Thomas Hill 4/ & Sarah Etheridge of Halifax Co., NC. They first lived in Johnson Co., NC before going tp Ga.

There seeems to be some type of connection of this Peoples Hill family to those mentioned above in Georgia. One ting is sure, the Thomas G. Hill 6/ in Georgia was not the same man as in this law suit because he died years ago.

Court of Pleas & Granting Edgecombe County State of N.C.

To FIELDING HILL, Greeting: FOR certain reasons offered before the worshipful Court of Pleas & Granting for the county aforesaid, you the said FIELDING HILL are commanded and strictly enjoined, that laying all other matters aside, and notwithstanding any excuse, you are personally appear before the said Court, to be held at the Court House in Tarrobough (sic), on the 4th Monday in November next, then and there to answer concerning those things, which shall then and there, be objected to you by NANCY HILL in her petition following against you and others.

And to do further and receive what the said Court shall consider in this behalf, and this you shall in no wise omit, under the penalty of One Hundred Pounds.

Witness John Norfleet, Clerk of our Said Court, at office, the 4th Monday in August 1846 and the Independence of the State the 71st.

Issued the 2nd day of November 1846.

An exact copy of this summons was issed to Fielding Hill & Green HIll. I feekl certian that Thomas G. Hill got one too, however, if so, it was not among the files sent to me.

Now the name that seems important to me is the name of one THOMAS G. HILL.

A HILL-BRANTLEY CONNECTION IN WARREN COUNTY, GA.

From the court records it is obvious that Phebe Brantley was first married to a Thomas Hill and had a son named Fielding Hill. She was the daughter of Philip Brantley (Ref: His 1819 Will naming her as a daughter).

In a query in the magazine "Family Puzzlers" I have seen the name of this husband to Phebe Brantly was THOMAS G. HILL!

Thomas Hill estate, dated 1st May 1794, wife Phebe (Brantley) Hill named administratrix. Surety: Richard Hill.

Warren Co., Ga: On the 10th of May 1795, Phebe Brantley Hill applied for letter of "Dismission" as administratrix of the estate of her deceased husband Thomas Hill. Henry Hight had married the widow Phebe Brantly Hill, date not given.

Henry Hight was appointed guardian of Fielding Hill, son of Thomas Hill & Phebe Brantley Hill in February 1800.

Henry & Phebe Brantley Hill Hight had a son named Wylie G. Hight.

Fielding Hill, son of Thomas Hill & Phebe Brantley married Isabelle Gibson on the 30th of January 1812. Philip Brantley's will in 1819 names daughter Phoebe Hight and her son Fielding Hill.

Wylie Gilbert Hight named a son Fielding Hight.

Henry Hight had Amanada Hill, age 43, in his household in the 1850 census.

The above information from Warren County, Georgia was provided to show a possible link to the Hill family of North Carolina.

Now take note of the Law Suit in Edgecombe County, N.C., found at the beginning of this document. Notice the date. It is later (1846) but note that unsual name of Fielding Hill and Green Hill.

It is my theory that Thomas G. Hill was a son of Richard Hill 5/ & wife Frances, originally of Johnson Co., NC & kater in Warren Co., Ga. Richard Hill 5/ was a son of Thomas Hill 4/ of Halifax County, N.C. & his wife Sarah Etheridge.

There was a Thomas G. Hill & a Fieldinmg Hill listed in the above law suit, but it was not the two men in Georgia that ha the same names, however in considering tjhose names, I think there was some type of family connection. (See below). END OF R.094

# R.117 CONNECTING A HILL FAMILY OF WARREN CO., GEORGIA TO THAT OF THOMAS HILL 4/ OF HALIFAX COUNTY, NC.

Entered in February of 1997 by Robert R. Hill of Brandon, Fl.

Source of Information: Deed Books 19 and 20 of Halifax Co., NC that was provided to me by Byron Hill of Nashville, TN.

First.. Halifax Co., NC Deed Book 19: Begin Quoted Document: "518-(431) ANN LONG of Halifax Co. grants Power of Attorney to her son JAMES LONG of same. 16 June 1804. To receive from Henry Hill, executor of Robert Hill, deceased, who was executor of my father THOMAS HILL, (deceased) all the legacies due me in said will.

Wits: Frances Tate, Thos, Christie, August Court 1804. Signed/ L. Long (Clerk of Court)."

End of Quoted Document.

Comments by Robert Hill: This was Ann (Anna) Hill 5/, daughter of Thomas Hill 4/ & Sarah Etheridge of Halifax Co., NC. Thomas 4/ was the uncle to Lewis Hill 5/. Anna Hill 5/ was married to Arthur Long and their son was this James Long. [Note: He posted bond in item below]. The Robert Hill, deceased, mentioned as executor of Thomas Hill 4/ was Robert Hill 5/, son of Thomas Hill 4/ that was married to Martha Johnson. The Henry Hill mentioned was Henry Hill 6/, son & executor of Robert Hill 5/. Now the wife of Thomas 4/ was Sarah Etheridge Hill. She too had died in 1795. Anna and her sisters, Elizabeth 5/, Fanny 5/, Sally 5/ & Mary 5/ were the only ones left legacies by their mother, Sarah Etheridge Hill. The father's will was different. He died in 1787 & he left legacies to all of the children, but the son Richard Hill 5/ was left a very small amount odf money. He later sued the estate for equal share and won.

We knew that a Fielding Hill of Warren county was a son of a Thomas G. Hill & wife Phebe Brantley, who had remarried to Henry Hight. The thinking originally was that Thomas G. Hill was a son of Thomas Hill, Jr. 5/ & Elizabeth Gardner, he being the son of Thomas Hill 4/ & Sarah Etheridge of Halifax Co., NC. Not so!

Richard Hill 5/ was a son of Thomas Hill 4/ & Sarah Etheridge. Richard Hill 5/ married a woman named Frances --? (last name unknown) and they were last known to have been in Johnston County, NC until ca. 1782-85. They then disappearan, and apparently went to Warren County, Georgia. See the information below.

(Note: Wording unclear in early section of this document).

"(Halifax Co. NC) February Court 1806. L. Long (Clerk of Court)." END OF QUOTED DOCUMENT.

My analysis: Thomas G. Hill 6/ was obviously the son of Richard Hill 5/, son of Thomas Hill 4/ & Sarah Etheridge & had died in Warren Co., Georgia. Apparently, Richard Hill 5/ also had died in Georgia CA. 1805/06. Richard Hill's 5/ estate was being administered by James Judge in Georgia.

It appears to me that Thomas G. Hill 6/ had named his father Richard Hill 5/ as one of the executors of his estate and probably his brother, Richard Hill 6/.

The father, who was Richard Hill 5/, had died in Georgia after Thomas 6/ had died. The brother of Thomas G. Hill 6/, Richard Hill 6/, was the one paying out this money to the heir of Thomas G. Hill 6/, meaning Fielding Hill 7/, who's guardian was his step father, Henry Hight..

Now the mystery.. When Thomas Hill 4/ died in 1789 in Halifax County, the son Richard Hill 5/, got ALMOST NOTHING except for a small amount of money. His mother Sarah left him absolutely nothing! She died in 1795. He filed a law suit, asking for equal share and won. (date unknown).

Now since the money was coming through the court of Halifax County, NC, and considering that Thomas Hill 4/ & wife had been quite wealthy, I believe this money was being passed on down to heirs of Richard Hill 5/, who was now deceased, so

then his legacy went to his children, which included the deceased son Thomas G. Hill 6/. Since he too was dead, his share went to his son, Fielding Hill 7 (a minor) and the other children of Richard Hill 5/.

Notice the widow of Richard Hill 5/,. named Frances, was required to sign a receipt for the minor child Robert Hill 6/ and the other children all had to sign a receipt for themselves.

I do not know the date that Thomas G. Hill 6/ died but it was in Warren Co., Georgia. Richard Hill 5/ died in Warren County, Ga. ca. 1805/06. For that reason, I think this money was coming down to the grandchildren from the estate of Thomas Hill 4/ & (or) Sarah Etheridge of Halifax Co., NC.
