DEEDS, WILLS INVOLVING MICHAEL HILLS.

SURRY COUNTY, VIRGINIA WILLS #9 1738-1754 (PAGE 328) 12TH NOVEMBER 1749. Isreal Pickens of Hanover County to MICHAEL HILL, of Surry County, 120 acres (including the iland) on North side of Nottoway River and bounded by Bolling Lewis Greem, said Pickens and Chambers, (it being part of a tract granted to John Mitchell on 5th September 1723).

Wits: Thomas Oliver, John Threeweet, william malone & John Hill.

Comments: This appears to be Michael Hill 3/, son of Sion 2/Robert Hill 1/. He married Elizabeth Mitchell, daughter of John Mitchell. William Malone married Mary Hill 4/, the daughter of her uncle, Richard Hill 3/ & Hannah Briggs..

SURRY COUNTY, VIEGINIA EWILLS #9 1738-1754 (PAGE 423)

9YJ MARCH 1743. MICHAEL HILL SR. to MICHAEL HILL SR., for 30 pounds current money, 120 acres (including the island on the northeast side of the Nottoway River, bounded by Bolling Lewis Green, Isreal Pickens and Thomas Chambers, (it being part of a tract granted to John Mitchell on 5th September 1723).

Wits: Thomas Oliver, William Willburn, William Oliver Reg. 15 August 1749.

Comments: Michwl Hill Sr 3/, son of Sion 2/Robert Hill 1/, was selling the land to his son, Michael Hill Jr 4/. This appears to be the very same land purchased from Iseral Pickens in thje preceding deed. Bolling Lewis Green was a brother of Burwell Green, who witnessed the will of Richard Hill 4/.

SUSSEX COUNTY WILL BOOK "A" 1754-1764 (PAGE 34)

13th October 1755. INVENTORY OF ESTATE OF MICHAEL HILL, DECEASED, for John Hill, Administrator by William Gilliam,

RICHARD HILL, William Gilliam Jr.

My Comments: This appears to show Michael Hill Sr 3/ had died. John Hill 4/ was the Executor or administrator, and his brother, Rchard Hill 4/ was a witness. Michael Hill 3/ was the brother of Richard Hill 3/. Richard Hill 3/ was the father of both John Hill 4/ & Richard Hill Jr 4/, meraning John Hill 4/ was executing the will of his "uncle" Michael Hill Sr 3/..

SUSSEX COUNTY, VIRGINIA WILL BOOK "A" 1754-1764 (PAGE 49)

John Threewits.. 13 December 1755/9th February 1756, wife Frances Threewits, 310 acres of land for life, son Joel Threewits. Executors: Wife and Michael Hill.

Witness: Mary Hill.

My Comments: Obviously, this Threewits family had close ties with the Hills, Gilliam families. This was Michael Hill Jr 4/ & wife Mary (Welborne?), listed as the witness, Mary Hill. Michael Hill Sr 3/ had died back in 1755.

SUSSSEX COUNTY, VIRGINIA WILL BOOK "B" 1764-1771 (PAGE 94)

18th September 1766. INVENTORY OF ESTATE OF MICHAEL HILL, DECEASED, for Ann Hill. Executrix.

My Comments: This may be MIchael Hill that married (Nancy) Ann Tyus.,

SUSSEX COUNTY, VIRGINIA WILL BOOK "B" (PAGE 183)

17th November 1768. INVENTORY OF ESTATE OF MICHAEL HILL, DECEASED, FOR ANN HILL Administerix by George Booth, Richard Hill, Richard Jones.

Comments: Was this Michael Hill Nr 4/ & wife Ann Tyus?

SUSSEX COUNTY, VIRGINIA WILL BOOK "B" 1764-1771 (PAGE 186)

1769. ACCOUNT of estate of John Tyus, deceased. Michael Hill, Richard Hill James Greenway, William Gilliam, maby Tyus' & Winfields shown.

Comments: Believe this is a carryover from the above.

SUSSEX COUNTY, VIRGINIA WILL BOOK "B" 1764-1771 (PAGE 186)

16th AUGUST 1770. Account of estate of Michael Hill, Sr. deceased, shows payment to Richard Hill, George Booth, Mildred Hill, Hinchea Gilliam

Comments: I believe this was a Michael Hill Sr & wife Mary (maybe Bell). Michael Hill died in 1766. He had a son, Michael Hill jr. that fought in the Reviolution. Mildred Hill was the widow of John Hill 4/, now deceased. Richard Hill ws his brother, Richard Hill 4/. It appears that Michael Hill owed money to John Hill 4/, who was now deceased, this payment went to his widow, Mildred Hill. This may explaun why Mildred Hill was living on the land owned by a son of the above Michael Hill.

SUSSEX COUNTY, VIRGINIA WILL BOOK "C" 1762-1785 (PAGE 175)

3RD OCTOBER 1774/17TH AUGUST 1775. Wife Margery Hill the use of land I live on for life, adjoining Michael Hill's.

Comments: This was related to the death of Captain Richard Hill Jr 4/ & wife Margery Gilliam. Michael Hill Sr was dead & his young sin niw owned the adjoining land.

NOTE: It appeats to me that Michael Hill Sr & son "Junior" owed money to John Hill 4/ & Mildred (Gilliam) Hill. Both Michael Hills died, so the land became the possession of the widow of John Hill 4/, Mildred Hill. She moved onto the property. Her cousin, Margery Gillisam Hill was the widow of Richard Hill Jr 4/, brother to John Hill 4/. Both Mildred & Margery Gilliam, widows, were living next to each other. Margery Hill would still have sons Thomas Hill (age 16) & William Gilliam Hill (age 10) home with her.

SUSSEX COUNTY, VIRGINIA WILL BOOK "C" 1762-1785 (PAGE 346)

JOHN DILLEHAY... 1st July 1778/18 November 1779, wife Sarah Dillehay, my estate for life. (Will mentions) ISAAC HILL, orphan of Michael Hill. John Dillehay, orphan of my brother, Arthur Dillehay, vis. Edmund Eilleehay Dillehau, Arthur Dillehay, Mamcy Dillehay and Betsey Dillehay. In case mt wife should be with child, then this will is void. Executor: Wife, Isaac Robinson, Daniel Malone and William Welborn.

Comments: Obviously this Dillehay family had a close relationship with the Michael Hill family. This will was write July 1, 1778, probated 18 November 1779. Isaac Hill 5/ was listed as born on 31st August 1763 in the Albemarle Parish Records. Parenst were Michael Hill & wife Anne (I

think Mary??). Godparents were: William & Sarah Wellborm. The Michael Hill that died in 1766, had a wife Ann, who administered his will. The fact that the Welborns were godparents causes me to think the mother of Isaac Hill was Mary Welborn.

Michael Hill 3/, son of Sion 2/Robert Hill 1/ was born in 1688, died 1755, married Elizabeth Mitchell, daughter of John Mitchell.

Michael Hill 4/, son of above Michael Hill 3/Sion 2/Robert Hill 1/, was born-in 1721, died in 1766, married Susannah Cook.

Michael Hill 5/, son of Michael 4/, Michael 3/, Sion 2/, Robert Hill 1/ born 1759, died (or killed) 1778.

Michael Hill 4/ and wife Mary (Ann?) were the parents to Isaac Hill 5/, who married Mildred Hines.

Note: Conflicting data from two difference sources shows Michael Hill 4/ married either Ann Tyus or Mary (Bell>). So we have a father, son and grandson:

- 1. Michael Hill 3/, 1688-1755, m. Elizabeth Mitchell.
- 2. His son, Michael Hill 4/1721-1766, m. Susannah Cook.
- 3. His son Michael Hill 5/, 1759-1778, m. Mary (Welborn or Bell).

We also know of a Michael Hill that is listed in the Albemarle Parish as marrying Nancy Tyus, daughter of John Tyus, but, no daughter named Nancy was in the will of John Tyus. That will does kist a daughter as "Ann Hill." I wonder if this was the same man that married Nancy Ann Tyus or did he marry two sisters??
