WITS: JESSE WARD, JOSIAH BLACKMAN.

MY COMMENTS: THIS IS A CONFUSING TRANSACTION AND CAUSES SEVERAL PROBLEMS..

FIRST OFF, THIS TRANSACTION ORIGINALLY TOOK PLACE IN DUPLIN CO., NC BECAUSE SAMPSON COUNTY WAS NOT CREATED FROM DUPLIN COUNTY UNTIL 1787. THIS SALE WAS MADE IN 1737.

SECOND, INFORMATION GIVEN TO ME BY MRS. WARREN STATES THAT FRANCIS HILL AND ELIZABETH HAD ONE CHILD, A SON, BENNETT HILL. I AM TOLD BY MRS. WARREN THAT FRANCIS HILL WAS 20 YEARS OLD IN 1770, BUT IF TRUE, WHO WAS THIS FRANCIS HILL IN DUPLIN CO., NC IN 1737??

THIRD, MRS. WARREN STATES THAT FRANCIS HILL MARRIED A SECOND TIME TO MARY BLACKMAN, WHO WAS 12 YEARS OLD IN 1770. THIS MARRIAGE IS SAID TO HAVE TAKEN PLACE A FEW YEARS AFTER 1770. AGAIN, WHO WAS THE FRANCIS HILL THAT SOLD THE 1737 DOWER OF ELIZABETH IN SAMPSON COUNTY, NC? WAS ELIZABETH HIS WIFE??

FOURTH, IF THE ABOVE DATA PROVIDED BY MRS. WARREN IS CORRECT, THEN WE MUST BE DEALING WITH TWO FRANCIS HILLS AND TWO ELIZABETHS. NOTE THAT MRS. WARREN STATES THE ABOVE FRANCIS HILL IS SAID TO HAVE BEEN BORN IN VA. BETWEEN 1745 AND 1750. THIS 1737 SALE OF DOWER WAS DATED BEFORE THE BIRTH OF FRANCIS

HILL IN VA., HOWEVER, MRS WARREN SAYS THE FRANCIS HILL, B. IN VA., IS LISTED AS HAVING A WIFE ELIZABETH--?

MRS WARREN SAYS A BIBLE RECORDS STATES THAT THE FIRST AND ONLY CHILD OF FRANCIS HILL AND WIFE ELIZABETH IS SAID TO BE BENNETT HILL, BORN IN SEPTEMBER 1769 IN VA.

MRS WARREN SAYS FRANCIS HILL WAS AGE 20 IN 1770, INDICATING HIS BIRTH WAS CA. 1750, AND SINCE BENNETT HILL WAS BORN IN SEPTEMBER 1769, INDICATES TO ME THAT FRANCIS HILL AND ELIZABETH PROBABLY MARRIED IN 1768.

ASSUMING HE (FRANCIS) WAS BETWEEN AGE 20-25 WHEN HE MARRIED, IN 1768, INDICATES TO ME THAT FRANCIS HILL WAS BORN CA. 1743 AND 1748, AND COULD NOT POSSIBLY BE THE SAME MAN THAT SOLD THE DOWRY OF ELIZABETH IN 1737 IN DUPLIN COUNTY, NC, NOR THE ONE MRS WARREN SAYS WAS. BORN BETWEEN 1745 AND 1750 IN VA.

THIS WAS MADE IN 1737. SECOND, IF THE ABOVE DATA IS CORRECT, THEN WE MUST BE DEALING WITH TWO FRANCIS HILLS. NOTE THE ABOVE FRANCIS HILL IS SAID TO HAVE BEEN BORN IN VA. BETWEEN 1745 AND 1750. THIS DEED WAS DATED 1737, HOWEVER, THE FRANCIS HILL, B. IN VA., IS LISTED AS HAVING A WIFE ELIZABETH--?

THE FIRST CHILD OF THE ABOVE FRANCIS HILL WAS BENNETT HILL, BORN IN 1769, AND ASSUMING HE (FRANCIS) WAS BETWEEN AGE 20-25 WHEN HE MARRIED, INDICATES FRANCIS WAS BORN CA. 1768 AND 1773 AND WAS NOT THE ONE SAID TO HAVE BEEN BORN BETWEEN 1745 AND 1750 IN VA.

IT APPEARS THAT A FRANCOS HILL WAS SELLING HIS WIFE'S (ELIZABETH) DOWER. THIS SEEMS TO IMPLY THAT ELIZABETH WAS NOW DEAD... HOW CAN IT BE???

MY COMMENTS: THIS IS CONFUSING AS FRANCIS HILL WAS DEAD BY THIS SATE. BOTH THE DATE OF THIS TRANSACTION AND THE DATE OF THE WILL, PROBATED IN 1799. THIS TRANSACTION WAS PROBABLY STARTED BEFORE FRANCIS HILL DIED, THEN COMPLETED[ON THIS DATE. I HAVE NO OTHER CLUE TO THIS ACTION.

A notation states Quote: "These sills copied as they appear in book. They are not on record." END OF QUOTE.

COURT MINUTES 1799, THE WILL OF FRANCIS HILL WAS PRODUCED TO COURT BY JOSIAH BLACKMAN. see details below from court minutes..

"JOSIAH BLACKMAN PRODUCED TO THE COURT THE LAST WILL AND TESTAMENT OF FRANCIS HILL, DECEASED, WHICH WAS ADMITTED TO PROBATE BY THE OATH OF JOHN THORNTON AND SAMPSON LEE."

"ORDERED THAT THE EXECUTOR OF FRANCIS HILL, DECEASED, SE;; SUCH PROPERTY AS THE WILL REQUIRES."

MY COMMENTS: IT APPEARS THAT FRANCIS HILL DIED IN 1799. WE NEED A COPY OF THAT WILL AS IT APPEARS HE DIRECTED SOME OF HIS PROPERTY BE SOLD. SEE OTHER RELATED TRANSACTION OF THE ESTATE BELOW.

MY COMMENTS: APPARENTLY THE ESTATE WAS NOT YET DISTRIBUTED TO THE HEIRS

COURT MINUTES 9 FEBRUARY 1802, FRANCIS HILL ESTATE: SAMPSON LEE APPOINTED TO COMMITTEE TO SETTLE ESTATE OF FRANCIS HILL, DECEASED.

MY COMMENTS: OBVIOUSLY THE ESTATE HAD NOT BEEN SETTLED.

COURT MINUTES 1802, FRANCIS HILL ESTATE: ALEXANDER FLEMMING RETURNED INTO COURT THE AMOUNT OF THE ESTATE OF FRANCIS HILL, DECEASED, WHICH IS 317 POUNDS, 14 SHILLINGS 10 AND 1/2 PENCE. EACH LEGATTE'S PART 99 POUNDS 16 SHILLING 10 AND 1/2 PENCE.

MY COMMENTS: THE COURT'S FINAL APPRAISAL OF FRANCIS HILL'S ESTATE.

MY COMMENTS: THIS SEEMS TO HAVE BEEN THE FINAL SETTLEMENT OF FRANCIS HILL'S ESTATE.

Green Hill and Feraby Hill to Furnifold Wood: Trans.: 60 pounds "current money" for 75 acres "Beginning at the Run of Kill Peacock Swamp, On the said Wood's line running with the various courses of the Run as it meanders to the upper Pattent line," etc. Tract was "half of a certain piece....of land granted by Patent to FRANCIS HILL and transferred by deed from him the said FRANCIS HILL his Brother" (sic). Wit.: Jos. Slocumb and Noah Smith. (See notes 3, 12, 15K, 21 and 24e).

Comments: This proves a Francis Hill was brother to this Green Hill. I over looked the foot note by accident but they may be very important.

Page 18. Deed: Dated 24 October 1794.
Green Hill to Sion Hill. Trans. 60 pounds "currant money of the State" for 75 acres "Beginning... in Goodricks line." Deed mentions a pond, the run of Kill Peacock Swamp, and Furnifold Wood's and the said Sion Hill Corner." Tract was "half of a certain parcel of land granted by patent to Francis Hill and transferred by deed from him the said

FRANCIS HILL to Richard Hill, his brother." Wit.: Joseph Slocumb & Noah Smith. (See notes 3, 12, 15K, 21 and 24).

Comments by Robert Hill: This deed definitely shows that Francis Hill, Green Hill & Richard Hill were brothers. I am not totally convinced that Sion Hill was a brother, BUT INSTEAD A SON OF THE ABOVE GREEN HILL. I think they tie into the Hill family of Surry Co., Va.

BELOW IS A MARRIAGE CONCERNING A FRANCIS HILL IN CRAVEN CO., NC. THIS HILL FAMILY ORIGINATED IN EASTERN SHORE MARYLAND, THEN TO NC... A RICHARD HILL & LEVI HILL WERE BROTHERS. I THINK FRANCIS HILL WAS TOO... THIS IS NOT THE FRANCIS HILL IN SAMPSON CO., NC
