Bennett Hill, son of Francis Hill & wife Elizabeth, was born on the 24th of September 1769 in Va. Bennett Hill married Mary Lee, daughter of Peter Lee & Mary Cato.. This family moved to Sampson County, NC then to Lowndes and Wilcox Counties in Alabama between 1825-1830. They had 12 children:

administratir of Wm. Kenan estate, and married a daughter named Jean Kenan.

My Comments: Since FRancvis Hill and John Hill were originally named administrators, it appears that Francis Hill gave up that obligation. John Hill continued on and I think he was married to a Kenan daughter (Jean??). Due to the huge bond, it appears this was a large estate.

TO JOHN HILL, ON BEHALF OF HIS WIFE, 5 slaves valued at 530 pounds and to pay the estate 5 pounds & 15 shillings & 8 pence. To James Kenan & his wife, 6 slaves, valued at 510 pounds and to receives from the estate 15 pounds 3 shillings and 4 pence. To Edward Blackmore, on the part of his deceased mother, 7 slaves valued at 546 pounds 3 shilling and 4 pence, and to pay the estate 22 pounds and 10 shillings. To James Love's children, on the part of their deceased father (mother), 7 slaves valued at 510 pounds and to receive from the estate 14 pounds 3 shilling and 4 pence. My Comments: The records is not too clear. No one is mentioned as being deceased, which causes me to think that John & Jean Hill were dissolving their marriage and the land etc.. is being divided up. Remember, a Jean Hill had a bastard child in 1787, and refused to name the father.. Was this her??

The pronlem is, if Jeab was married and had a child, why would he ne called a bastard child, unless the husband knew it was not his.. Maybe they were splitting up now over that affair.

In Deed Book 9, Page 18. Deed: Green Hill to Sion Hill. Dated 24 October 1794. Trans. 60 pounds "currnet money of the State" for 75 acres "Beginning...in Goodricks line." Deed mentions a pond, the run of Kill Peacock Swamp, and Furnifold Wood's and the said Sion Hill Corner." Tract was "half of a certain parcell..of land granted by patent to Francis Hill and transfered by deed from him the said FRANCIS HILL to Richard Hill, his brother." Wit.: Joseph Slocumb & Noah Amith. (See notes 3, 12, 15K, 21 and 24f).

Comments by Robert Hill: This deed definitely shows that Francis Hill, Green Hill & Richard Hill were brothers. I am not totally convined that Sion Hill was a brother. His (Sion Hill) relationship is unknown at this time. I think they tie into those Surry Co., Va. Hill Family via way of Henry Hill 5/, son of Green Hill 4/ & Grace Bennett. (not proved). This Henry Hill 5/ of Northampton Co., NC is somehow connected to the Green Hill 4/Grance Bennett family.

The Harmon Hill family of Northampton Co., NC had a witness named Hardy Hart and a Francis (Frances) Hill is listed as marrying him or her.

The NC listing of marriage shows a Francis (sic) Hill (Frances Hill) marrying Hardy Hart, but that is obviously wrong as Hardy Hart was definitely listed as a male witness to the Harmon Hill will (maybe have been son Henry Hill). He was definitely a male, not female.

I will bet he married a daughter of Hardy Hart, who somehow ties into the Harmon/Henry/ Green Hill family of Northampton Co., NC. She may be Nellie Hart??

It could be that Sion Hill was a son of Green Hill, the brother of Francis & Richard Hill. Note one Green Hill has a wife Turley Hill and another has wife named Feraby Hill. Was this two different Green Hills???
