Comments by Robert Hill: This deed definitely shows that Francis Hill, Green Hill & Richard Hill were brothers. I am not totally convined that Sion Hill was a brother. I think they tie into those Surry Co., Va. Hill Family via way of Henry Hill 5/, son of Green Hill 4/ & Grace Bennett. (not proved). This Henry Hill 5/ of Northampton Co., NC is somehow connected to the Green Hill 4/Grance Bennett family.

The Harmon Hill family of Northampton Co., NC had a witness named Hardy Hart and a Francis Hill is listed as marrying him or her.

The NC listing of marriage shows a Francis Hill marrying Hardy Hart, but that is obviously wrong as Hardy Hart was definitely listed as a male witness to the Harmon Hill will (maybe have been son Henry Hill). He was definitely a male, not female.

I will bet he married a daughter of Hardy Hart, who somehow ties into the Harmon/Henry/ Green Hill family of Northampton Co., NC. She may be Nellie Hart??
