NOTE: It appears that John Roden died intestate ca. 1719, and
his wife Elizabeth, was appointed administratrix of his
estate. Before 1 June 1723, Elizabeth had married again to
George Wade Jr., and both of them had been appointed
administrators of the estate.

WILL BOOK 27, (1749-50)

Page 19, John Winman of Calvert County, Planter, in perfect
health. Willed everything to his beloved wife Mary Winman and
her heirs forever, and she to be executrix. Revoked all
former wills.

Dated 15th June 1747. Signed "John Wenman."-Witnesses..John
Howerton, Susannah (x) Howerton and Daniel Frazier who proved
the will on 17 June 1749 in Calvert County before Gabriel
Parker. Depty of Comry Cavv. Co.

NOTE: This is undoubtedly the John Winman referred to by
Thomas Roden in the deposition filed in Chester County S.C.
in 1795. Thomas Roden stated that John Winman had no children
and the will bears this out. It was about this time (1747-48)
that George Rowden (Roden) stated in his pension application
for his Revolutionary Service, that he moved with his parents
from Calvert Co., Md. to the Shenandoah Valley in Va...Since
John Winman willed everything he had to his wife Mary and her
heirs, it appears that Mary must have been the one related to
the Rodens. But there was a Thomas Winman Roden! See Later.

NOTE: See the index pages for Thomas Wenman (Winman) Roaden
receiving a tract "Long Choice" of 50 acres in 1747. The

index card stated that this land was now in Montgomery Co.,...when working on the Mobley family in Frederick Co., Courthouse, I checked the indices to see if any Rodens ever showed up there-and there was Thomas Wenman Roden's land in the Frederick Co., Deeds:

DEED BK B, pages 401 & 402-Thomas Wenman Roden to James Brooks, recorded 18 June 1751. 8 June 1750-Thomas Winman Roden, late of Frederick County, now of Anne Arundal Co., Planter, Province of Maryland, to James Brooks, planter of aforesaid county for L30 (pounds) current money, and divers other causes, all that tract LONG CHOICE in Frederick County on branches of Patuxent River. Signed THOMAS WINMAN (R) RODEN. WITS: Jno. Rawlins, Nathan Magruder, Dower release by Mary Roden, wife of THOMAS WINMAN RODEN. Receipt also recorded, dated 8 June 1751.

There were no other Rodens, or Wroughtens (any spelling) in the first 2 indices which carried it up to 1803 and nothing for George Wade.

We need the Anne Arundel County records checked to see what happened to Thomas Winman Roden. Is he the same man as out Thomas Roden, who also had a wife Mary (Potts), who moved first to what was then Frederick County Virginia (LOUDOUN CO. TODAY) and then to Chester County S.C. by 1763/64?
