BOOK C-5, PAGE 93, DATED 23 NOV. 1778, Henry Williams and Ann his wife, of Craven County, S.C. to Thomas Roden, same place, for 2000 pounds currency, 3 tracts adjoining each other, on the head waters of Allison and Bullocks Creek, whereon Henry Williams now lives, 500 acres. Wits: Jesse Burgess, James Wilson, Joseph Cole. Recorded in Charleston on 11 Jan. 1780. NEW INFORMATION

BOOK C-5, PAGE 91, DATED 10 APRIL 1779, William Roden and Margaret his wife, of Camden District S.C., to Charles Humpheries, same place, for 1600 pounds currency, 100 acres on a branch of Sandy River, granted to Lazarus Moore on 24 November 1767. Wits: James Tims, John Humpheries, Amy Tims. Recorded in Charleston on 11 Jan. 1780.

## FOLLOWING INFORMATION FOUND IN UNION COUNTY S.C. RECORDS

No wills or estates found. These deeds are recorded in Union County S.C.

BOOK B, PAGE 348, DATED 2 DEC. 1788, William Horrell and Priscilla his wife, of Union County, to George Roden, same place, for 30 pounds sterling, 50 and 1/2 acres, part of a tract of 200 acres granted to Amos Tims on 26 July 1774 by William Bull, Lt. Governor of S.C. on S side of Broad River below Fishdam ford, bound by river, Wm. Armstrong, Richard Givens and vacant land at time of grant. The 50 and 1/2 acres was on the river. The entire tract between Wood's tract and Benjamin Hollingsworth. Wits: Nathan Glenn, Joshua Martin and Joseph Comer. Proved by Joseph Comer 13 Jan. 1789 before Bernard Glenn, J.P. No recording date.

BOOK B, PAGE 349 (THE NEXT DEED IN BOOK) DATED 8 DEC. 1788, Nehemiah Posey to George Rowden (no residence given) for 100 pounds sterling, 300 acres in Union County, on Cain Creek, originally granted to Frances Posey by Gov. Wm. Moultrie, recorded in Surveyor General's Office in BOOK HHHH, page 331, Bound by Jacob Hollingsworth, Nehemiah Posey, Benjamin Posey and William Armstrong. Wits: Benjamin Posey, Joshua Martin and William Stewart, Proved by Joshua Martin on 14 March 1789 before Bernard Glenn, J.P. Recorded 25 March 1790.

BOOK G, PAGE 309, DATED 29 APRIL 1791, George Roden and Tabitha Roden of Union County, to Jacob Hollingsworth, same place, for 90 pounds sterling, 300 acres on Cain Creek, part of a tract originally granted to Francis Posey (same description of grant and land as in previous deed). Wits: Daniel Hollingsworth, Edward Moore and A.B. Posey. Proved by Absolom Posey 10 May 1794 before Charles Sims, J.P. Recorded 2 Nov. 1802.

NOTE BY MRS. CHRISTOPHER, Nathan and Bernard Glenn and Charles Glenn shown in these deeds as wits., J.P..s, etc. were my Glenn Family. They came from Hanover and Cumberland Counties of Virginia to S.C. George Roden in Union Co., had wife Tabitha in 1791 but in Chester Co, when he sold land that he had bought as "George Roden of Union Co." his wife was Darkis in 1793. Darkis could have been a 2nd wife.

## THE FOLLOWING ARE FOUND IN FAIRFIELD COUNTY S.C. DEEDS

Note: Fairfield County early records are now located on micro film-the original records have been transferred to the S.C. Archives in Columbia S.C. The 1st roll of film covering the estate index covers the period from 1785 through 1869. They are indexed by first letter only, in other words, you look through all the "R's" and pick out the Rodens with all the various spellings, indexed.

The deed index and deed books for the period 1785 through 1841 have also been taken to the Archives but micro film copies are in Winnsboro.

BOOK K, PAGE 401, DATED 10 JUNE 1772, George Roden and wife Darkis, to Kedar Coleman, both of Craven Co., S.C., for 150 pounds lawful current money, 150 acres on Wateree Creek,"it being eight feet wide and 4 inches deep," bound NE by Joseph Rowe, other sides vacant. Granted to George Roden on 28 Nov. 1772 (one of these dates must be wrong, but both dates say in the 12th year of his Majesties reign) by Lord Charles Grenville Montague, Gov. etc of S.C. Signed by George Roden and Darkis Roden by marks. Richard Winn, J.P. Recorded 13 March 1797.

BOOK X, PAGE 250, DATED 19 FEB. 1773, William Jones and his wife Abigal Jones, planter of Province of S.C., to Jeremiah Roden, planter of St. Mark's Parish, 100 acres in Craven County, on middle fork of Wateree Creek, all side vacant. (Same tract as listed below) Bland space for the amount of money. Signed by mark by William and Abigal Jones. Wits: John (x) Starn and Mary (x) Starn. John Starns attested on 19 Feb. 1773 before John Winn, J.P. Recorded 10 April 1816 ???

BOOK X, PAGE 247, DATED 14 AUG. 1773, Jeremiah Roden and wife of St. Mark's Parish, Prov. of S.C., planter, to John Agnew, planter, same place, for 150 pounds current money, 100 acres on the middle fork of Wateree Creek, granted to Wm. Jones on 12 March 1768 by the Governor of S.C., (Roden also spelled Rhoden in this deed) Signed by mark by Jeremiah and Mary Rhoden. Wits: Alexander Kennedy and Alexander McQuators. Robert Ellison J.P. Recorded 10 April 1816.?????

NOTE: The reason for a recorded date of 1816 in the two above

deeds is not clear. This was a 40 year difference between the sale and recorded deeds, unless the were originally recorded in Charleston and for some unknown reason had to be re-recorded again when the individual counties started keeping their own records.

BOOK K, PAGE 411, DATED 31 OCT. 1775, John Blake sold the land to Thomas Lewis, 250 acres granted to Blake in 1772 on branches of Wateree Creek, and bound by William Roden on SE, Presley Tidwell on SW, other sides vacant at time of grant. Blake sold 100 acres of the tract to Lewis, the eastward part. "including the plantation where the said Jeremiah Roden lives on." Signed by John Blake and Morning Blake. She signed by mark. Wits: Micajah Pickett and William Blake. Recorded 29 March 1797.

BOOK K, PAGE 412, BOND FOR TITLE, DATED 3 MARCH 1778, Thomas Lewis of Craven County bound to Jeremiah Roden for 1000 pounds of lawful money of Prov. of S.C., 100 acres on Reedy Fork, a prong of Wateree Creek, granted to John Blake. Lewis signed by mark. Wits: John Smith. Note just below says "I do assign over the within bond to Francis Neel." Signed by Thomas (x) Lewis. Dated 5 Oct 1778. Wits: Micajah Pickett and Robert Ewen. Recorded 29 March 1797.

BOOK L, PAGE 217, DATED 22 JAN. 1798, "We, or either of us,"
Randolph Carter and John Carter, planters of Fairfield
County, to William Roden of Chester County, for 65 pounds
sterling, 150 acres in Fairfield Co., on John's Creek of
Sandy River of Broad River. Bound on all sides by David
Hopkins. Part of 2 tracts granted to David Hopkins, one on 9
June 1775 and the other on 15 Oct. 1784. The 150 acres sold
by Hopkins to Henson Day, thence to said John Carter. Both
Carters signed. Wits: Abram Mayfield, John Carter (another
man with same name), and Jane Carter. James Parker, J.P.
Recorded 24 July 1798.

Note by Mrs. Christopher, David Hopkins in this deed was my 3 great uncle by marriage. He married in Va., Mary Glenn, sister of my 2nd great grandfather James Glenn, who lived in Chester Co..The Hopkins also lived in Chester County and another branch of them, David's brothers, lived in Richland County below Columbia.

BOOK Z, PAGE 12, DATED 31 MARCH 1798, George Lott to Jeremiah Roden, both of Fairfield County, for 20 pounds sterling, 50 acres on Wateree Creek, bound NW and SW by Thomas Steels land and E by James Neels land-now in Roden's possession. Part of a 250 acre survey laid out for John Blake by John Winn, D.S. (District Surveyor) on 10 Oct.1770. The 50 acres sold here was on SW side of Reedy Creek, land crosses (at?) Reedy Creek. Signed by mark by George Lott. Wits: James Neil and Ann (x) Neil. William Robinson J.P. Recorded (date left out) 1816???? BOOK HH, PAGE 377 1826, Mary Rowden, Frances (could be Francis) Rowden, James Rowden and Maryan Rowden of Fairfield District, to John Shackleford, same place, for \$ 15.00, 3 acres in Fairfield District on Little Wateree Creek, on SE side of the main road leading to Winnsboro, part of a tract owned by Jeremiah Rowden, deceased, "and being separated from the same land of the said Shackleford N & NE on land the property John \_\_\_\_\_." All four Rowdens signed their names. Wits: James Neal and John Wilson. No Date. James Neal attested in Fairfield District on 3 Sept. 1826 before James Elliott, J.P. Recorded 17 Sept. 1827. ????

## MISCELLANEOUS NOTES....LEONARD RODEN WITNESSED THE WILL OF LURKIN CARDIN IN FAIRFIELD CO. S.C. ON 14 JUNE 1788.
