RODEN.013 OTHER RODEN ESTATE FILES IN SOUTH CAROLINA AS OBTAINED BY MRS. CHRISTOPHER.

ESTATE OF T. T. RODEN

CHESTER COUNTY S.C. FILE 95, PACKAGE 1568

George Carter was appointed administrator of the estate of THOMAS T. (TIMMS) RODEN on 12 September 1844. Before 1848 George Carter died, and W.T. Carter and John Carter, George's sons, requested letters of administration on 1 May 1848. John Carter, W.T. Carter, John Davis, and David Pinchback signed bond for \$ 5000.00 on 15 May 1848 before Peter Wylie, Ordinary.

The estate was appraised on 30 November 1844 by John Davis, Wm. Pinchback, Benjamin Taliaferro, J.L. Bennett and R. Hamilton. Buyers at the sale were Sarah Roden, John Mobley, Elie Hardin, David Thomas, Thomas Wright, George Carter, Jacob Pugh, William Cornwell, William Triplett, William Hardin, John Robinson, Levi Carter etc..

This is Thomas Timms Roden and he had 4 minor children when he died. The estate was held in administration as long as nay of the children were minors, and was still in administration in 1857. See Below.

FILE 95, PACKAGE 1563, RODEN CHILDREN, SARAH RODEN, GUARDIAN DATED 1848.

Sarah Roden, as guardian, John Davis, and Henry Carter signed bond for \$ 1000.00 on 11 September 1848 for Sarah's performance as guardian of MARY EMMALINE RODEN, JAMES RODEN, JOHN RODEN, and HANNAH RODEN. Mary Emmaline, over age 12 and the eldest, requested that Sarah be her guardian on the same day.

Various papers in the file show that W.T. Carter, as administrator of the Estate of Thomas T. Roden, furnished money for the children's upkeep, education etc..

The estate was still in guardianship in 1857. By then John and Hannah were the only remaining minor children, but doesn't state how old they were. No final settlement in the file.

ESTATE OF JOHN D. RODEN

FILE 120, PACKAGE 300, CHESTER COUNTY S.C. 1865

Sarah Roden was appointed administratrix on 23 October 1865 and Sarah, Asa D. Darby, and James M. Simpson signed bond for \$ 500.00. In the papers it was stated that John D. Roden died

on 14th September 1865.

Eli Cornwell Esq., John L. Bennett, John Harden and John B. Cornwell were appraisers. James Simpson, John Harden and Sarah Roden bought at the sale.

The last return was filed in 1869. No settlement shown and no heirs named.

NOTE: This could be Thomas Timms Roden's son John, who was still a minor in 1857 and Sarah, the administratix, could have been his mother Sarah. Maybe John was a Confederate Soldier.

PATSY TIMS died early in 1824, leaving a 156 acre tract on the waters of Sandy River, bound by Eli Cornwell, William Cornwell, John T. Pinchback and the Estate of A. Timms. The land was granted to James Timms in 1791. Amos Timms was the administrator of Patsy's estate and he died in 1831 with his nephew Thomas Timms Roden as executor. Thomas Tims Roden petitioned for sale of Patsy's land. Her heirs were (in 1831)

Johannah Tims and Benjamin Powell also inherited as heirs of Amos Tims who was Patsy's son.

I will have to check Amos Tims' estate and probably some of the earlier Tims, but this definitely proves that Thomas Timms Roden's mother was a Tims girl-otherwise, he couldn't have been the nephew of Amos Tims. If I can find an estate package for Patsy Tim's husband (whoever he was- James?) it may give us a lead on the name of Thomas Tims Roden's father.
