credits of THOMAS RODEN, deceased, do make a true and perfect  
inventory of all & singular the goods chattels credits of the  
said deceased and the same so made do explicit unto the  
Ordinary's Office in this District within Ninety Days next  
insuring and such goods chattels and credits (???word not  
legible) and truly administers according to law and make a  
just and true account of the actings and doings therein, and  
all the rest of the said goods chattels and credits which
