Dennett Hill and William Smith Jr. signed the above will in Laurens District on 4 August 1800.

UNION COUNTY

25. Reference SCMAR, Volume 12, Pages 33 and 37, William Hill & wife along with Tempe Golding and others VS James Golding in law suit involving a slave named "Prissy." Tuesday 9 June 1840.

26. Reference SCMAR, Volume 3, Number 1, Page 32, Susan (Susannah) Elizabeth (Hill) Scaife, wife of Charner T. (Terry) Scaife, died at the residence of her father (James Hill & her mother was Susannah Glenn) in Union District, S.C. on 28th of September 1838. (Note she was a granddaughter of Moses Hill & wife Savilla N. Roden of Fairfield District, S.C.). NOTE BY ROBERT HILL: James Hill was 2nd child of Moses Hill & wife Savilla Roden of Fairfield County, S.C.

27. Reference SCMAR, Volume 11, Number 1, Page 42, A Law Suit between Titus G. Farr, et al, VS. William B. Farr, Extr (Executor?) shows that James Hill was a sworn witness for the defendant, William B. Farr. 23 June 1833.

CAMDEN DISTRICT (YORK COUNTY)

This case was quite lengthy. The case involved the post-Revolution operations of Hill's Iron Works located on Allison's Creek in York County, S.C. Cases involving the Iron Works went through several courts (Chancery Court in Charleston, Western Circuit Equity Court & Camden District Equity Court). Article states Colonel William Hill born in Northern Ireland in 1741, immigrated to York County, Pennsylvania but was in South Carolina by 1762. He married Jane McCall and they had 6

children: Solomon Hill, Andrew Hill, William Hill, Robert Hill, Elizabeth Hill, who married Dr. John Allison and Rachel Hill, who married William Ross.

Tolls, Esquire, Ordinary of said District, I have been informed by Richard Jones, Sr. Administrator of Joseph Day, deceased, that there is a certain portion of money in your hand, due me as one of the distributees of Sara J. Hill. This therefore is to inform you that I wish you to deliver the same in hand of Mr. (Wm.?) J. Taylor and this may be your receipt.

Page 242 of said record, Estate of Joseph Day, deceased.

Receipts dated 6 April 1836 from Richard (X) Jones (wit.
Martin H. Day) for \$ 89.37 in full of the share of his wife,
Rebecca Day, Martin H. Day for the share of James Rogers
"which I am entitled to receive." Receipt dated 27 June 1836
from Jonathan Taylor for the share of Charity Delaughter as
per ordered; 9 January 1837 from Martin H. Day for the share
of Philip Frazier & wife Lucy, which he is authorized to
receive by a Power of Attorney, given him from them; 7 August
1837 from A. Delaughter for the share of Charlotte Lee, which
I am entitled to receive by a Power of Attorney given me by
her; 24 October 1839 from Martin Hitt (Hill?) for his own
share.

Note: The name Hill/Hitt is shown throughout spelled both
ways, and it is impossible to determine which is correct. An
examination of the estate papers of Joseph Day might
determine which is correct. Later research shows a certain
clerk of the court always crossed or slurred the "ls" making
it look like HITT when actually it was HILL.

of Ebenezer Hill, deceased, A law suit was filed by James
Tomkins & wife VS. Edmund Cartledge & wife & others, heirs of

receive 1/3 share (\$ 80.04). A note states the entry was
stricken and the rest of the entries were re-figured and
written over, making some of the entries illegible. Anyone
interested in this family should examine the estate papers of
Ebenezer Hill.

NINETY SIX DISTRICT

SOUTH CAROLINA (AT LARGE)

Roden, also of Fairfield County.

(WASHINGTON DISTRICT COURT OF EQUITY).

60. Reference SCMAR, Volume 3, Number 1, beginning on Page 9 This Article is entitled "ESTATE PARTITIONS IN THE WASHINGTON DISTRICT COURT OF EQUITY 1803-1826."... It is quite lengthy and it continues through several Volumes, starting in Volume 3, Number 1, on page 9-18. It resumes again in Volume 3, Number 2 on page 122-128. It again picks up in Volume 3, Number 3, 183-188. At this point the article is again picked up in Volume 4, Number 1, Pages 31-38; Volume 4, Number 2, Page 79-85; This article is not continued again until Volume 7, Number 3, Page 181-187 when it is concluded.

In SCMAR, Volume 3, Number 1, Page 9 is the opening statement relating to this important article.....The following data were abstracted from a book in the Laurens County Courthouse, but they are pertinent to a much larger area. In the early years, an Equity Court was held in Laurens for "the united districts of Greenville, Laurens, & Newberry," which was called the WASHINGTON EQUITY DISTRICT.

ESTATE PARTITIONS OF WASHINGTON DISTRICT COURT OF EQUITY

PAGES 161-163A: (ESTATE OF JOSEPH HILL SR.) Oratrix Martha Hill and Orators William Hill, Wiley Hill, & Isaac Bunting shew that Joseph Hill Sr., late of the District of Abbeyville (sic) departed this life on or about the ____ day of _____ One Thousand Eight Hundred and _____ being seized & possessed of a large estate, leaving a widow your oratrix and six children:

1. William Hill an orator
2. Wiley Hill, an orator
3. Helen, the wife of your Orator, Isaac Bunting
4. Joseph Hill
5. Isaac Mitchell Hill
6. Melton Hill

That said Joseph Hill Sr. executed a will in his life time in which after making several a number of specific legacies he provided that the whole of the remainder of his Estate shall remain in a common stock subject to the management and control of his Executors until his youngest child come of age or until his Widow may die or marry when a division of the same shall take place after deducting the specific legacies giving to the widow in case of her marriage one third & dividing the remainder among his children giving to each an equal share and appointed these Orators: William Hill, Wiley Hill, & Isaac Bunting and one James Gilliam his Executors, the three first of whom have qualified and took upon themselves the execution thereof, all which will more fully appear from a copy of the said will marked A...the remainder of the personal estate of the said Joseph Hill consisting of about 33 Negroes besides a large stock of every description,

desire that a portion of the Negroes be removedJoseph who is over the age of fourteen years and Isaac Mitchell and Milton Hill who are minors under the age of fourteen years, ...desire an immediate division of the estate.

ABSTRACTED WILL OF JOSEPH HILL

State of South Carolina, Abbeyville District)

To my son

William Hill two Negroes Edmunds & Venus, two cows & calves, two sows & pigs, a bed and a horse, also the tract of land whereon he now lives which I paid for and had Titles executed to him, the value of which is \$ 1450 also sundry articles amounting to \$ 1500;

to my son Whiley (sic) (Wiley) Hill two Negroes Randal & Silvey, two cows & calves, two sows & pigs, a bed and furniture, also a tract of land whereon he now lives which I purchased of John Mitchell for \$ 3100 with sundry articles amounting to \$ 50;

to my daughter Helen Bunting, two Negroes Man & Milly, two cows & calves, two sows and pigs, a bed and furniture, horse, so many Negroes from the common stock as will make her share amount to as much as the shares of my sons instead of the land which I have willed to them, to be given when a final division is made;

to my son Joseph Hill a tract known by the name of Springs tract extending from the river to the Hill Spring and commencing also at Simon Chaney's nearest corner, when he becomes of age or marries, also two Negroes Boston & Judy, two cows & calves, etc;

to my son Isaac Mitchell Hill, the Creek or Mill tract to be appraised as aforesaid, two Negroes Will & Nancy, cows & calves, etc; to my son Milton Hill, the home tract of land adjacent Michel, Simeon Chaney's (land), two Negroes Anne & Peggy, cows & calves, etc; [distribution as stated in the petition]. 13th day of June A.D. 1825
