AARON HILL, he enlisted in the First Regiment on 21 September
1776. He re-enlisted on 1st of February 1780
under Captain William Jackson. Salley Doc., page
28; N.A. 246, N.A. 853.

ABRAHAM HILL, born in 29 January 1758, in Bucks County,
Pennsylvania. While residing in Rowan County,
N.C., he enlisted in a N.C. unit. From April
1781, he served ten months in the light dragoons
under Capt. John Reid, Col. Wade Hampton and
Gen. Sumter. He was in two skirmishes and
helped capture several British (foots?). Salley
Document, page 63: A.A. 3597; M188. N7015 is
Federal Pension Number.

ADAM HILL, he served thirty days in the militia from May 1781
to August 1782 under Capt. Dawson.
A.A. 3598; letter O-494.

BURRIL HILL, (of Camden District, today's Fairfield County)
He served in the First Regiment under Capt.
William Cattell from 4 November 1775. After being
court martialled for desertion in March of 1778, he
was sentenced to enlist for the duration of the
war. South Carolina Historical & Genealogical
Magazine, Vol. 1, page 56; VIII (p ?) N.A. 853.

DANIEL HILL, he enlisted in the Third Regiment on 1 December
1778 and re-enlisted under Capt. Uriah Goodwin on
1 February 1780. South Carolina Historical &
Genealogical Magazine, Vol. V, page ???;(not
legible). N.A. 246; N.A. 853.

DAVID HILL, he enlisted in the First Regiment on 21 September
1776. N.A. 853.

EDWARD HILL, he enlisted on 26 August 1775 in the Volunteer
Company of Horse of St. Mark's Parish under Capt.
Matthew Singleton. South Carolina Historical &
Genealogy Magazine, Vol. I, page 185.

EDWARD HILL, he served in the militia and was wounded in the
shoulder during the battle at Hanging Rock.
Annuitants Claims.

EWIL (EWEL) HILL (of Abbeyville County) he served in the militia from 12 May 1780 to 20 February 1783 under Capt. Cowen. A.A. 3600 O-492.

GEORGE HILL, he enlisted in the Fifth Regiment on 7 September 1778. He enlisted in the First Regiment during 1780. N.A. 246; N.A. 853.

ISAAC HILL, he served in the militia after the fall of Charleston. A.A. 3601; T.389.

JAMES HILL, he enlisted in the Third regiment on 20th October 1776. N.A.853.

JEREMIAH HILL, he enlisted in the Second Regiment on 4 November 1775 as a corporal and was a private on 6 December 1777. South Carolina Historical & Genealogical Magazine, Vol. XVI, Page 30; N.A.853.

JOHN HILL, he served in the militia under Col. Lemuel Benton and Gen. Marion. A.A. 3602. R-5012 Federal Pension Number.

JOHN HILL, died 1 May 1834. Married Savory----? in 1783. He served in the militia during 1782. A.A. 3602; O-678; T391; VI

JOHN HILL, he enlisted in the Fifth regiment on 29 March 1776. N.A. 853.

JOHN HILL, he served as a Captain in the militia. (Mote, Levi, S7245); (Carter, Daniel, S3126).

JOHN HILL, he served as a gunman in an independent company at Fort Rutledge during 1779 and 1783. A.A. 3602; Q488.

JOHN HILL, he served three years under Col. John Baxter and Gen. Marion. A.A. 3602.

JOHN HILL, he enlisted in the First Regiment on 4 November 1775 and re-enlisted on 13 February 1777. On 27th July 1778, he became corporal. N.A. 246; N.A. 853.

JOHN HILL JR., he served in the First Regiment under Capt. Thomas Pinckney during 1775. South Carolina Historical & Genealogical Magazine Vol. I, page 59.

JOHN HILL SR., he served in the First Regiment under Capt. Adam McDonald during 1775. South Carolina Historical & Genealogical Magazine Vol. I, page 57.

JOSEPH HILL (HULL?), he served as a corporal in the Fourth Regiment under Capt. Richard B. Roberts during 1779. N.A. 859.

JOSEPH HILL, he served in the militia under Capt. Joseph

Pickens from 10 November 1779 to 27 January 1780.
A.A. 3603; O-493.

JOSEPH HILL, he served ninety-five days as a captain in the militia under Gen. Marion. A.A. 3603; Q128.

JOSIAH HILL, (who lived in area of today's Chester County) he served in the Turkey Creek Volunteer Militia under Capt. Edward Lacey. In addition, he served four hundred and eighteen days during 1780 and 1782. South Carolina Historical & Genealogical Magazine, Vol. III, Page 131. A.A. 3604; R153.

LEONARD HILL, (of today's Fairfield County) he served one hundred and eighty days in the militia during 1781 and 1782 under Capt. Carter, Col. R. Winn and Gen. Pickens and was in the siege of Augusta. A.A. 3605; N41.

LODOWICK HILL, (LUDAWICK) of Sumter County, he served as a sergeant in the Second Dragoons under Capt. Isaac Ross, Maj. Boykin, Col. Myddleton and Gen. Sumter during 1781. Salley Document, page 83; A.A. 3606; M.386B.

MOSES HILL, (of Fairfield County) he served one hundred and twenty days in the militia during 1781 and 1782 under Col. R. Winn. A.A.3609; R152. (my 4th great grandfather. R.Hill of Brandon, Fl.).

ROBERT HILL, of Richland County, he enlisted in the Third Regiment on 20th October 1776. N.A. 853.

SAMUEL HILL, he served in the militia after the fall of Charleston. A.A. 3611; T390.

THOMAS HILL, (of Camden District, later changed to Fairfield County) he was born 6 March 1758 in St. John's Parish, near Monk's Corner S.C. (Berkeley Co.) and died 5 January 1837 in Kentucky. While residing in Camden District, he enlisted during the winter of 1775 for six weeks as a lieutenant under Capt. John Gordon and Col. Thomas Taylor. From March 1780 to 1 November 1781, he was a lieutenant under Capt. John McKinney and Col. Taylor. During 1781 he was under Gen. Henderson. He was in an engagement at Mott's Hill, the siege of Ninety-Six and the battle at Eutaw Springs. He assisted in the capture of Col. Fletcher. (Moved to Tenn and Ky.). A.A. 3613; R151; V534; Z554. S-31131 was his Federal Pension Number (Note: His father was Jonathan Hill and mother Margaret Hall both from Berkeley County, near Monk's Corner, just outside of Charleston).

THOMAS HILL, he served sixty-one days as a footman under Capt. Thompson during 1781 and seventy-one days as a horseman during 1782. During 1782 he also served thirty-eight days under Capt. Gray. A.A. 3613; Y369.

THOMAS HILL, (of Union County) he served in the militia under Col. Brandon after the fall of Charleston. A.A. 3613; X2871.

WILLIAM HILL, he enlisted in the Fifth Regiment on 5 October 1778. N.A. 853.

WILLIAM HILL, he served in the militia under Col. Waters after the fall of Charleston. A.A. 3614; X2546.

WILLIAM HILL, he served in the militia during 1779 and during 1781, he was under Capt. James Giles, Col. Hill and Gen. Sumter. Salley Document, Page 68. A.A. 3614; M102; X1201.

WILLIAM HILL, (of York County) he was born in Belfast, Ireland in 1740, died 1st December 1816 and was married to Jane McCall in 1765. While serving as a Colonel in the militia, he was in the battle at Rocky Mount, and was wounded in the battle at Hanging Rock on 6 August 1780. In addition, he was in the battles at Kings Mountain and Cowpens. Heitman, page 290; Salley Document, page 65. A.A. 3614; 1301; Moore pages 12-14; N.C.S.A.R., page 132; McCall, Vol.II, page 66.
