31ST OCTOBER 1825.....Administration Bond filed by William Hill, Bird Hill and Sampson Gilliam to Courts of Union County on 31st day of October 1825 to administer the Estate of THOMAS HILL, deceased, who was the father of William and Bird Hill. The bond was signed in presence of Miriam Hill, widow of THOMAS HILL and William Rice, ORDINARY of UNION COUNTY. William Hill posted the Administrative Bond of \$ 500.00. (It appears he is appointed the Administrator)?

Comments: Eleandor Hill was granted letters of administration in Laurens County in 1803. She filed an estate return on 5th 1816 showing that she had made payments of \$75.25 each to: Catherine Hill on 31st December 1821 Chary or Chany Hill on 20th February 1808 Stephen Hill on 20th February 1820 Isaac Hill on 30th March 1825 Benjamin Hill on 11th November 1815 David Hill on 2nd August 1817. Her will is dated 30th August 1828 and names children: William Hendrick Hill, David Hill, Stephen Hill, Benjamin Hill, Isaac Hill, Mary Berne and Catherine Flinn. Stephen Hill was over 26 years of age in 1800, thus born ca. 1774 or earlier, thus would indicate that Henry Hill Jr. was born ca. 1750 and Henry Truman Hill born ca. 1720-1730.

Newberry County, South Carolina Information. The Henry Hill located here is the one that married Alice Ridgley and thus cannot be Henry Truman Hill if the following is correct. It is felt that L.P. Hill is correct when he states that this Henry Hill was the son of Joseph Hill, brother to Henry Truman Hill and that he came to Newberry County ca. 1777. His oldest brother was named Joseph and is buried at Lower Duncan Creek Baptist Church with his wife Ruth and near George Frederick Whitmire. Joseph Hill was born in 1771 and died on 6th October 1839. His will is in Book N, Pages 170-171 (Newberry Co.) and he names his children as: Elijah, Nathan, Elizabeth Prewitt, & Rachel Fowler Ridgely Valentine. Ruth Hill (wife of Joseph) died on 6th March 1836 at age of 64. She is suspected to Gordon Meador to be the daughter of George Frederick Whitmire. Two of Henry Hill's sons went to Warren County, Kentucky and are shown there in the 1810 Census.
