SC.011 DISCUSSION OF THE HILL FAMILY OF FAIRFIELD COUNTY, S.C., INCLUDING CHARTS TO EXPLAIN CONNECTIONS.

Note: Many queries about Asaph Hill & Abel Hill have been received. This shows a connection of them to Richard Hill, however, there were more than one Asaph & Abel Hill with possible connections to Reuben Hill, George Hill of Rutherford Co., NC.

There was two Charles Hills in early Fairfield County, SC. One Charles Hill Sr. (wife Nancy) was in South Carolina by 1749, when he received a land grant of 440 acres, located on the North side of the Broad River, in Craven County (today's Fairfield County).

This Charles Hill stated on his Application for land in 1749 that he and wife Nancy came from Pennsylvania with six minor children. As stated, there were children but we only know of two sons, William Augusta Hill and Charles Hill Jr. William Augusta Hill appears to have been the William Hill Sr., who died sometime between the date he wrote his will (1st July 1790) and the date it was proved (August 1790). There also seems to have been a daughter that married one of the Mobleys, since he had grandchildren named Mobley.

In that will, William Hill Sr. changed his previous will, where he divided his estate among the heirs. In the new will, he left his entire estate to his son, William Hill Jr.

We are assuming the children are those Hills that were present at the sale of this estate, they were: Asaph Hill, Richard Hill, Abel Hill, and probably grandchildren Thomas Mobley, Dannie Major (Mobley?) & Edward M. Mobley.
