

SC.017 A DEED OF CONVEYANCE FROM SARAH WHITMIRE & HENRY WHITMIRE & WILLIAM WHITMIRE & JOHN CASEY TO JOSEPH HILL IN NEWBERRY DISTRICT SC ON 6TH OF JANUARY 1804.

THE STATE OF SOUTH CAROLINA)

Know all men by these presents that we Sarah Whitmire & Henry Whitmire in consideration of One Thousand Dollars, to us respectively, paid by JOSEPH HILL of Newberry District and the state aforesaid, have granted bargained sold and released abd by these presents do grant bargain sell and release unto the said JOSEPH HILL, all that quartely of land, containg Three Hundred and Forty Eight (348) acres, being the same more or less being in Three different parcels, One Hundred & Twenty Four (124) Acres of which was conveyed from George Watkins to HENRY HILL, the 7th day of July A.D. 1787; (Another) One Hundred & Twenty (120) acres was conveyed to HENRY HILL the 14th day of February A.D. 1792 and (another) One Hundred (100) acres was conveyed by Thomas Brandon as the Attorney of William Hendricks to HENRY HILL (1st or 7th) of January A.D. 1789 and was a legatee of HENRY HILL, deceased, have bargained sold and released the above land to the said JOSEPH HILL, together with all and singular the rights hereditements appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said JOSEPH HILL his heirs and assigns forever and we do hereby bind ourselves and every of our heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said JOSEPH HILL his heirs and assigns forever against ourselves and every of our heirs, executors and administrators and assigns and against every person or persons WHOMSOEVER lawfully claiming or to claim the same or any part thereof, WITNESS our hand and seal this 6th day of January 1804 and in the 28th year of the Independence of the United States of America.
