Know all men by these presents that JOHN O'DELL HILL of Union District, in the state aforesaid in consideration of Three Thousand Dollars, to me paid by Captain Bernard Glenn, of Union District in the state aforesaid, have granted bargained sold and released and by these presents do grant sell and release unto the said Captain Bernard Glenn, all that plantation or tract of land, situated in Union District in the state aforesaid, butting and bounding to wit: Beginning at a Maple (tree) 3x and then North to site of Enoree River and (swinging?) N13E (NE 13Deg?) WEST 93 chains 38 links to a stake, bounded by Williams & Lee's land, thence S78W (SW78 DEG 23 chains 5 links (to) stake 3x- Captain Bernard Glenn's land, thence S13E (SE 13 Deg) 29 chains 75 links (to a))Black Bush, bounded by Ditto???, thence S22 chains to an Ash (Tree) 3x and the bank of Enoree River bounded by Ditto ??? thence the various courses of Enoree River, containing by estimate Three Hundred & Sixty Two (362) Acres, be the same more or less, granted to THOMAS HILL SR. and HENRY HILL which will now more fully appear Reference to Public Records, Together with all and singular the rights members hereditaments & appurtenances to the said premises belonging and in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Captain Bernard Glenn, his heirs and assigned forever, and I do hereby bind myself, my heirs, executors & administrators to warrant and forever defend all and singular the said premises unto the said Bernard Glenn, his heirs & assigns against myself & my heirs & against every person or persons WHOMSOEVER lawfully claiming or to claim the same or any part thereof--WITNESS my hand and seal the Thirtieth (30th) day of September Anno Domini One Thousand Eight Hundred & Twenty (1820).
