EXPLANATION: Thomas Hill actively served in the Revolution but he apparently proved at least two horse, and other provisions and it is these that he is claiming below.

STATE OF SOUTH CAROLINA) To THOMAS HILL of Colonel Brandon's Regiment, the sum of 30 pounds, it being for one hundred days service, Lt. in service of (state?), (horse?) taken and made use of for the Continental Troops of horse, on their retreat from NINETY SIX (District) under the comma nd of Colonel Washington, Col Lee and Major Reathford (Rutherford) who promised a receipt for the same but was prevented by a speedy march from that place, also 15 pounds, it being for one (barren) cow also one-----mutton, 5 pounds which was taken at the same time for the use above mentioned and no receipt obtained by reason of a speedy march, as before mentioned: The above named THOMAS HILL being duly sworn, saith on his oath that the above account is just and true and no satisfaction or restituti on received by him. Sworn to before me this 5th day of June 1782.

THOMAS HILL made oath that he loss (lost) the within horse in the expedition to the Cherokee Nation under the command of Colonel (Nelson?) Brandon's (Regiment), Picken's Brigade. Sworn to before me the 3rd day of June 1783. William Kennedy J.P.

STATE OF SOUTH CAROLINA) To THOMAS HILL of Colonel Brandon's Regiment, the sum of 100 pounds, it being for one sorrel horse, taken and entered into the Public Service of the state by Captain John Thompson of? right about 2 days before the Battle of Black Jacks between General Sumpter (Sumter) and Talton and said horse was lost in the above battle and (was) appraised by (Abner?) Casey and Josia Duckett to be worth the sum of 100 pounds, as above described. Appraised and sworn to before me this 5th day of June 1783. Levi Casey J.P. signed by/Abner Casey Josia Du ckett

The above (named?) THOMAS HILL personally appeared before me and did make oath in due form that the above mentioned horse of his property, was taken as above mentioned and that he never received and satisfaction or restitution for the same. Swo rn before me this 5th day of June 1783.

STATE OF SOUTH CAROLINA) To THOMAS HILL of Colonel Brandon's Regiment, Captain George (Auling's?) Company, the sum of 130 pounds, it being for a blue roane horse, taken and

(impressed?) into the Public Service of the state, for the use of the state troops, commanded by Thomas Sumpter (Sumter) Brigadier General, said horse impressed from him in the month of June 1781 and appraised by Abner Casey and Josia Duckett to be worth the sum of 130 pounds, as above described. Appraised and Sworn to before me this 5th day of June 1783. Levi Casey J.P.
