SOURCE: The Magazine entitled South Carolina Magazine of Ancestral Research, Volume VI, No. 1, Page 30. Also the Perpetual Calendar was often used to obtain what day of the week the events occurred. In some instances, that day was printed in the records.

Also the Perpetual Calendar 1 AD-2400 AD of the Smithsonian Institution Physical Tables, 9th Revision ed. p.732 in 1956 was used to obtain what day of the week certain events took place.

The Following were taken from Marriage & Death Notices from the Wesleyan Journal.

"Died on Sunday, 11th September, (1825) at his residence in Williamson County, Tennessee, the venerable Rev. Green Hill, in the 84th year of his age...a native of North Carolina, and a member of the Methodist Church for 60 years, a minister 55 years. He was a member of the first Revolutionary Convention of North Carolina and volunteered as a private, but was later chaplain. In 1799, he removed to Williamson County and settled there, where he died...Nashville Republican. (November 12, 1825).

Comments by Robert Hill: This was Green Hill Jr 5/, son of Green Hill Sr 4/ & Grace Bennett.

(November 19, 1825) (Note: The name appeared as Hitt but closer examination of the county records shows the two L's were simply crossed and believed to be HILL).

This John Woodward (1747-1817) was the eldest son of Thomas (Regulator) Woodward (1729-1779) & 1st wife Jemima Collins. This means that the groom John Woodward, was a great grandson of Thomas (Regulator) Woodward.(Most sources say they (bride & groom) were cousins).

Note by Robert Hill of BRandon, Fl.: Thomas Woodward was my 5th great grandfather on maternal side of my family.

Note by Robert Hill: Henry Harrison was the father of both Juliet & Richard Harrison, and their mother was named Charlotte, who may have been a widow (Axum?) and who married three times in her lifetime before her death in 1831. She is known to have married Henry Harrison & Hugh McMullen, but the first husband is uncertain but believe to be named Axum and they had a daughter named Patsey, who married Maj. John Woodward, son of John and grandson of the Regulator (Thomas Woodward).
