- 17. John Hill, of St George Parish, Dorchester, Berkley Co., (see#10) a will signed 26 Sept. 1729 and no probate date. "All to my wife, Mary Hill." No children named. lands by Daniel Stewart, Gilson Clapp & Thomas Sabur....brother Michael Hill. /wit. Thomas Waring, Thomas Way, John Garton & Daniel Stewart. (NOTE: This John Hill came down from New England with Dorchester Colony).
- 18. Richard Hill, will signed 2 June 1746, probated 3 April 1747...wife deceased. "Grace Farmer Hill who was Grace Farmer & she had an annuity of 30 Pounds yearly from estate and named in our marriage settlement at Bear Forest, otherwise called Carriange, Shonienbegg, Mallow Parish in Cork Ireland and said lands she owned which I bought of Robert Farmer and his wife, Grace." This estate of his wife is entailed to their children:

my eldest son Charles Hill my 2nd son Robert F. Hill my youngest son William Hovell Hill, not yet aged 21.

IF my sons die without heirs this estate of my late wife will revert back to Grace, wife of Robert Farmer in Ireland. (Did not state relationship) my nephew & namesake, Richard Guerrard not yet 21, son of John Guerrard my kinsman, Jacob Motte.

Exs: My son, Charles Hill & brother in law, John Guerrard & my kinsman Jacob Motte. Gives each a diamond ring, valuable silver plate and lands in S.C. by Wm. Cattell....also my hand painted Coat of Arms given to me by my dear father (not named). /Wit. David Hext, John Dart & John Mckinzie.

19a. Likely sons of Richard Hill... Taken from Register Book of St. Phillips Episcopal Church in Charleston.

Buried today, 27 Nov. 1729/30, Farmer Hill & John Hill, twin children.

- 20. Charles Hill (Perhaps son of #32) will signed 18 Nov 1750, probated 22 Nov. 1751, wife Sarah Hill, Ex., and to her heirs (none named). "Bury me in our family vault at Hillsborough." Executors: Charles Faucherand & Richard Gough. Parts of the will are missing. Signed by Andrea. /wit. Jane Stanyarne, B. Stanyarne & Ann Smith. (see #28 Sarah Smith).
- 21. John Hill of Padget Creek (Union Co. S.C.) Merchant. Will signed 6 May 1754, probated 23 July 1754...Has a large estate. Wife, Sarah Hill Ex. with her **Capt. Roger Padget & he to collect my debts. ALL my children (none named) to share

equal and but a new rifle gun for eldest son (not named). He speaks of the indenture & my wife will teach the apprentice the trade. /wit. John Martin, Samuel Wilson & Conrad Burton. **Likely he meant her father or her brother.

- 22. Francis Hill of Charleston, a will signed 15 May 1783, probated 8 Sept. 1783, wife Sarah Hill & see #28. No mention of children. EX: Wm. Fair. /wit. James Lynah, L. Sobgar & Joseph Lloyd.
- 23. Duncan Hill of Charleston, a will signed 5 Dec. 1797, probated 3 May 1799, wife Elizabeth Hill Ex...1 child a minor son. Henry Duncan Hill & if my son die before reaching age 21 to: 1/5 to Ann Hill of Grenocl, 1/5 to Thomas Hill of Bristol, 1/5 to Jennet & Wm. Reid of Genrock, children of my sister. 1/5 to stepson, Samuel Butler, 1/5 to step daughter Mary Ann Kerr. EXS: with wife, James Hamilton & Charles P. Butler. /wit. John Manson, Hester Armstrong & Thomas Hunter.

"What my father left to me was entailed and will go as his will directed. My estate in three parts and one part each to: Mary Butler, dau. of Charles P. Butler; Wm. Henry Inglesby; Henrietta Kerr, dau. of Andrew Kerr. My friend, Capt. Ebenezer McIntosh, I give my double barreled shot gun. All my clothing and \$80.00 each to my faithful slaves, Samuel, Samuel (JR.) son of Samuel; Adam & Sue. EXS: Charles Paxton Butler & Wm. Henry Inglesby. /wit. J.L. Snowden, Wm. M. Scott & Henry Inglesby.
- 26. Asa Hill of Orangeburg, will signed 18 July 1807, probated 10 Nov. 1809. Wife Jane Hill Ex. "When my wife dies, then my estate in equal shares to my brothers & sisters (none named) Wit. A. Burckmeyer, A. Newton & Martyn Alken.
- 27. MARY HILL (I could not determine whether single or widow) will signed 20 June 1833, probated 24 Dec. 1842 (She was a very wealthy woman) Estate to and no relationship stated for any. ????? Susan Harstead and her minor daughter, Caroline Elizabeth Service but if she dies, to Sarah & Margaret Dew, daughters Edward Dew Sr.

Dr. Edward Dew Jr., M.D. of London and to have what his

father, Edward Dew Sr. holds in trust for me in London. Sarah & Dew daughters of Edward Dew Sr. and they to have all the residue of my estate after the legacies paid, and MARY DEW.
