# SC.037 INFORMATION ON SOME BRANCHES OF THE HILL FAMILY OF FAIRFIELD COUNTY, SOUTH CAROLINA.

## Introduction

My main source for this information was the book entitled "The Hill-Hill Mobley Connections of Fairfield County, South Carolina," by Mr. George A. Hill, and also land deeds, wills that I personally researched in Columbia, South Carolina.

The following data on the Hill Families concerns itself with the early times of South Carolina, from ca. 1730 until about 1860. All of these Hill families lived in South Carolina, in what was once called CRAVEN COUNTY.

In 1682, CRAVEN COUNTY was organized and the area that these Hills lived became part of that county. It was rather short lived because in 1768 it was abolished and redistributed into CAMDEN DISTRICT. It was part of ST. MARK'S PARISH, which was organized in 1757 and who's parent parish was PRINCE FREDERICK'S PARISH.

On 12th March 1785, Camden District was abolished and separated into different counties, and FAIRFIELD DISTRICT (COUNTY) was one of the counties that was officially recognized, as was Chester & Kershaw Counties and others.

Geographically speaking, our interest lies in the northwest corner of today's Fairfield County, where Union and Chester counties all come together with Fairfield County.

Among the Hill Families in this area of Fairfield County, South Carolina, formerly known as Craven County and Camden Districts of South Carolina, was Charles Hill Sr. and Jr., William Augustus Hill, George Augustus Hill, Burrill Hill, Moses Hill, Leonard Hill, three different Thomas Hills, several Richard and William Hills, Asaph Hill, John Hill and others.

For some time quite a few of these various Hill Families have been suspected to have been related one way or another by different researchers, but to my knowledge, no one has put together the following information or has come up with the following conclusions. For this reason I hereby submit these conclusions, some not proven, but supported by genealogical evidence and are a result of my own research.

## LAND GRANTS

Reference to South Carolina Land grants... The following information comes from Leonardo Andrea, well known but now deceased S.C. genealogist.... In South Carolina, land was allotted prior to 1745 by the size of a family.

From 1746 until 1775 the land grants were allotted by the size of the family, save for a few years when each person received 50 acress and an additional 50 acres for each member of that person's family. Generally during this time, the land allotted was for 100 acres for a single man or woman OVER the age of 15 OR 16 years of age IF NEARER to 16. Then 50 acres of additional land was allotted for a wife and 50 acres more for each child, under the age of 16. NO MARRIED WOMAN, UNLESS A WIDOW, was allowed land during this time. Often a man took a grant and when his family increased in size, more land was allotted. Often a man had several grants in payment for surveying.

After the Revolution, land was not as limited as it was between 1745 and 1775.

Mr. George A. Hill states in his book that the South Carolina Archives informed him that a man had to be twenty one years of age in order to receive a land grant, yet to some degree, this conflicts with what Mr. Andrea states, and who also implies that this information came from the South Carolina Archives.

## CHARLES HILL SR.

One of the earliest known families in Craven County, in today's northwest portions of Fairfield County was the Charles Hill Family.

Based on the records of the Council Journal, Charles Hill Sr. obtained his first land grant, containing 450 acres in 1749. His application (dated Monday, 2nd October 1749) states that he came from Pennsylvania with a wife and seven children, "under age." The order to survey was dated Tuesday, the 3rd of October 1749 and the actual grant was dated 20th December 1749.

Information taken from land deeds shows that Charles Hill's 1/ wife was named Nancy, and two of his children were William Augustus Hill 2/ & Charles C. Hill Jr. 2/. Charles Hill Sr. 1/ received his first land grant (450 acres) on the 20th of November 1749. Charles Hill Sr. 1/ later sold his original

grant of 450 acres to Philip Raiford.

On the 17th June 1765, Charles Hill Sr. 1/ purchased land from John Griffin, originally granted to Griffin, who obtained the original land grant in 1759. This land was later sold by Charles Hill's 1/ son, William Augustus Hill 2/ to Eli Kershaw (Deed Book L, Page 146, dated 13th May 1769).

In December of 1768, Charles Hill Sr. 1/ applied for a grant of 100 acres, and the grant was made to him on the 25th of February 1769, but Charles Hill 1/ had died between his application in December 1768 and the date of the grant (25 February 1769). The Council Journal ordered the grant be given to his heir and son William A. Hill 2/.

Charles Hill Sr. 1/ and wife Nancy appeared to have the following known children: William Augustus Hill 2/, Charles C. Hill Jr. 2/, and five others who are unknown. I believe that the possibility exists that a Richard Hill could also have been a son but it has not been proven.

#### WILLIAM AUGUSTUS HILL 2/, SON OF CHARLES HILL SR. 1/.

Since he was heir to his father's estate, it appears that William Augustus Hill 2/, was the eldest son of Charles Hill Sr. 1/ and his wife Nancy Hill. He was born in Pennsylvania and was one of six children, of which only he and Charles Jr. 2/ are known. His first land grant appears to have been on the 14th of June 1762 for 100 acres in Craven County, the deed stating that the land was bounded on all side by "vacant lands." Below is a listing of grants made in the name of William Hill, most believed to be made to William A. Hill 2/.

William Hill, 100 acres 13th Aug. 1762 (This taken from a100 acres on Bowers Millland deed)Creek, CRAVEN COUNTY

William Hill, plat for 19th Oct. 1763 100 acres on Bowers Mill Creek, CRAVEN CO.

William Hill, Memorial 17th Nov. 1763 for 100 acres on Bowers Mill Creek, CRAVEN CO.

William Hill, Memorial 17th May 1764 for 100 acres on Bowers Mill Creek, CRAVEN CO.

William Hill, 250 acres 2nd Oct. 1769 CRAVEN CO.

William Hill, plat for 14th Feb. 1771 100 acres, CRAVEN CO.

William Hill, Memorial, 15th July 1771 100 acres on Bowers Mill CRAVEN CO.

William Hill, Memorial, 11th July 1775 50 acres on Beaver Dam Branch of Broad River (CRAVEN CO).

William Hill, Memorial, 19th Aug. 1775 300 acres on Allison Creek, CRAVEN CO. (Summarizing a chain of title to a grant to William Patrick on 19 April 1763

Very little is known of William Augustus Hill 2/, but his wife was named Mary Hill, who was probably a Mobley before her marriage. William Hill 2/ died prior to 1786 because his widow, Mary Hill, received a land grant dated 3rd April 1786, for 100 acres on a branch of Wateree River. (George A. Hill says in his book that by law, she had to have been a widow to receive a land grant).

William Augustus Hill 2/ and wife Mary had two known sons (maybe other children?)... Richard Hill 3/ and Mabry Hill 3/.

Mary Hill (widow) died shortly afterward because in 1796 the following deed was recorded:

"Book R, Page 276-277, Fairfield County Deeds, between Richard Hill 3/ and William Langley, for 50 pounds paid by Langley, Merchant, for 100 acres on a branch of the Wateree, original grant to Mary Hill." Mary Hill had died intestate and her sons and heirs were listed as Richard Hill 3/ & Mabry Hill 3/.

Now for the sake of better understanding, I have added some words to the following deed: (bold print)

On the 5th April 1788, (Book B, Page 112) "Between Richard Hill 3/ and Agnes, his wife, of Fairfield County, South Carolina and Jane Rogers, Spinster and Weaver, land that was granted on 13th day of August 1762 (to William A. Hill) planter, 100 acres on Bowers Mill Creek. William A. Hill 2/, for 100 pounds of good lawful money of the province paid by Joseph Rogers for 100 acres (meaning William A. Hill 2/ had sold the 100 acres to Joseph Rogers)--- and (William Hill's son Richard Hill 3/ had inherited the land and the son) Richard doth grant and give Jane Rogers a new right and title." Recorded 1788.

signed / Richard (x) Hill, his mark Agnes S. Hill

This deed implies that Richard Hill 3/, son of William Augustus Hill 2/, had inherited his father's land and apparently holding the mortgage, issued a new mortgage to Jane Rogers, who apparently inherited the land and the estate of Joseph Rogers, and who's relationship to each other is unknown.

MABRY HILL 3/, SON OF WILLIAM A. HILL 2/(CHARLES HILL 1/).

Mabry Hill 3/ married Rachel Arledge (Aldridge?), the daughter of Isaac Arledge. It was stated in Isaac's will that his daughter married "Mabry Hill." Little else is known of them except that they were still in Fairfield County on 25th August 1798 when they verified a legacy from Isaac Arledge to Isaac Arledge Jr. and William Arledge. They were not shown in the 1790 Census

## CHARLES C. HILL JR. 2/, SON OF CHARLES HILL SR.

Charles C. Hill Jr. 2/ was another son of Charles Hill Sr. 1/ and his wife Nancy Hill. He was born in Pennsylvania. There is very little to tell except that his wife was named Mary, and that he obtained his first land grant for 100 acres on 21st of February 1772.

## LAND GRANTS TO PERSONS NAMED CHARLES HILL IN CRAVEN COUNTY S.C.

Charles Hill, plat 500 16 Aug. 1732 500 acres in CRAVEN CO.

Charles Hill, plat 440 5th Apr. 1733 440 acres in CRAVEN CO.

Note: The two grants above were to Charles Hill Esq. (of Charleston).

Charles Hill, plat 450 20th Nov. 1749 450 acres on North side of Broad River (CRAVEN CO.)

\*\*Charles Hill Sr., plat 25th Feb. 1769 100 acres in CRAVEN CO. (He had actually died by this date and grant was given to son, William A. Hill).

Charles Hill, 100 acres, 28th November 1771, adjacent to lands of William Hill & land laid out to Charles Hill Sr. in Craven County. (This was Charles Hill Jr.)

Charles Hill, Memorial 21st Feb. 1772 for 100 acres on Wateree Creek in CRAVEN COUNTY \*\* (Has to be Charles Hill Jr. See Note below)

Charles Hill, 14th Apr. 1773 100 acres on Wateree Creek (This has to be Charles Hill Jr.)

Charles Hill, Memorial 19th Nov. 1774 100 acres on Wateree Creek, CRAVEN CO. (Has to be Charles Hill Jr.).

\*\* NOTE: Charles Hill Sr. 1/ on 6 December 1768 applied for a grant but died prior to receiving the land grant dated 25th February 1769. On the 13th of May of 1769 his son & heir William Augusta Hill sold the same piece of land, the deed

stating that Charles Hill 1/, father, was deceased. Thus Charles Hill Sr. 1/ died between 6th December 1768 and the 25th February 1769. The grant was ordered to be given to son William A. Hill 2/. Any land grants in the name of Charles Hill after 25 February 1769 would have to be Charles Hill Jr. 2/.

Another item that identifies Charles Hill Jr. 2/ from his father Charles Hill 1/ is a land grant on Wateree Creek on 28th November 1771...." to Charles Hill, adjoining William A. Hill & land laid out to Charles Hill Sr." This shows that Charles Hill Jr. 2/ obtained a land grant adjacent to his brother William 2/ and his (now deceased) father, Charles Hill Sr. 1/.

A deed recorded in 1789 (Deed Book C, Page 101) shows "Between Charles Hill and wife Mary and Phillip Raiford of Fairfield County, State of South Carolina." This was Charles C. Hill Jr. 2/. How do we know?... because of a small fragment of a page from the "Fly Leaf" of the remains of the Moses Hill Bible. It states the following:

"Coz (Cousin) Mary Heyll (Hill) departed this life on the 7th June in the year of our Lord 1827, the wife of CHARLES C. HEYLL (HILL)."

Now there was, and still is an old southern family tradition that if a cousin married, both the husband and wife were referred to as "Cousin Ed, Cousin Mary etc.."

Mary is referred to as the cousin but it is believed that Charles C. Hill was the cousin of Moses Hill, meaning that his father, Charles Hill Sr., was the uncle to Moses Hill.

Now we know that Charles C. Hill 2/ had a wife named Mary, thus the above deed between Charles Hill & wife Mary and Phillip Raiford, dated 1789, was Charles C. Hill Jr. 2/ and his wife Mary.

Now a mystery does exist in the fact that no Charles Hill is listed in the 1790 Census nor was Moses Hill, yet both appeared to still be in the area. (I know both were as the records prove this fact). A Charles & Thomas Hill filed a law suit against Wm. McCleod in 1799 (Judgement Roll 433A in S.C. Archives).

In 1792, Charles Hill (Jr.) 2/ and wife Mary sold land to a T. DeVile ??? on 2nd of October 1792, the land was originally granted to Charles Hill on 28th November 1771 and being 100 acres on the Wateree River, bounded on Northwest by lands laid out to (brother) William Hill and on southwest by lands laid out to Charles Hill Sr. (father, but who was now deceased). All other sides vacant lands. (indicating the first settlers in that neighborhood).

#### GEORGE AUGUSTUS HILL 3/ & BURRILL HILL 3/.

Not too much is known of George Augustus Hill 3/, except that it is believed that he was a son of Charles C. Hill Jr. 2/ and wife Mary Hill, and a brother to Burrill Hill 3/.

George (Augustus) Hill 3/ was listed in the 1790 Census of Chester County, South Carolina with 1 male over 16 and 2 free white females.

There were two deeds located concerning George Augustus Hill 3/. One, Chester County Deed Book D, Page 133, filed April 1794: A deed between John McCullough and George Augustus Hill 3/ of Chester County, S.C. for 100 acres, the land was originally granted on the 23rd of June 1774, situated on a branch of Rocky Creek, bounded by (lands) of Samuel McCullough, James Crawford and Alexander Crawford.

Notice the date of the grant.. it was 23rd June 1774, the exact same date that Charles C. Hill Jr. 2/ was granted land and this date is repeated in the deed below regarding Burrill Hill 3/. It is this date that makes this writer feel that George Augusta Hill 3/ and Burrill Hill 3/ were sons of Charles C. Hill Jr. 2/ and they had either bought or inherited the land from their father, Charles Hill Jr. 2/.

The other was Chester County Deed Book D, Page 291, dated September 1794, George A. Hill 3/ and (wife) Jane sells 50 acres of land to John McGuire." After this deed no other records have been found on this couple.

In the 1790 Census a Burrill Hill 3/ was located in Rutherford County, N.C. We also know that a Burrill Hill 3/ fought in the Revolution in South Carolina, deserted, was tried and convicted for desertion and his sentence was to serve for the duration of the war.

Fairfield County Deed Book N, Page 419, recorded in 1802 shows Burrill Hill 3/ of Rutherford County, N.C. sells 100 acres of land in Fairfield County, S.C. to Andrew McDowell for 2 shillings, land originally granted to Charles Hill 2/ on 23rd June 1774. THIS WAS CHARLES HILL JR. 2/ and it is suspected that Burrill Hill 3/ either bought the land from his father or had inherited it.

## GEORGE AUGUSTUS HILL 3/ OF CHESTER COUNTY, SOUTH CAROLINA AND BURRILL (OR BURWELL?) HILL 3/.

Chester County, South Carolina borders Fairfield County to the north and was once part of both Craven and Camden Districts.

In the 1790 Census George Augustus Hill was listed over 16

years of age with two free white females.

Chester County Deed Book D, page 133, filed in April of 1794, shows a deed between George Augustus Hill of Chester County selling land to John McCullough, land originally granted to CHARLES HILL on 23rd of June 1774.

This date for the grant proves it was Charles Hill Jr. 2/ (wife Mary). It seems likely that George Augustus Hill 3/ and Burrill Hill 3/ were sons of Charles Hill Jr. 2/, and they had inherited the lands from their father and were now selling off those lands since neither lived in Fairfield County, where the lands were located.

If this be true, then George Augustus Hill 3/ and Burrill Hill 3/ were sons of Charles C. Hill Jr. 2/ (wife Mary). Charles 2/ was a brother to William Augustus Hill 2/, and both were sons of Charles Hill Sr. 1/.

The fact that the middle name of both William Augustus Hill 2/ & George Augustus Hill 3/ being Augustus caused this writer to consider the possibility they were brothers, but then the fact that George Augustus Hill & Burril Hill had in their possession land that was originally granted to Charles Hill Jr. 2/ has made me reconsider this probability and instead leads me to feel they were not brothers but that William Augustus Hill 2/ was the uncle to both George Augustus Hill 3/, both sons of Charles C. Hill Jr. 2/, brother to William A. Hill 2/.

Since Charles C. Hill Jr. 2/ appears to have been a cousin to Moses Hill, Leonard & Thomas Hill, then his sons (Burrill & George A. Hill) would therefore be 2nd cousins to Moses, Leonard and Thomas Hill.

CHESTER COUNTY DEEDS (BOOK D, PAGE 133, Filed April of 1794) "Between John McCullough and George Augustus Hill, of Chester Co., (the land was) Granted on the 23rd of June 1774, 100 acres on Branch of Rocky Creek, bounded by Samuel McCullough, James & Alexander Crawford."

## BURRILL HILL 3/

In Deed Book N, Page 419, Recorded in 1802, it shows Burrill Hill 3/, of Rutherford County, North Carolina sells to Andrew McDowell of Fairfield County, South Carolina, for 2 shillings, 100 acres of land (in Fairfield County, S.C.) which was originally granted on 23rd of June 1774 to Charles Hill.

As stated before it is felt that Burrill Hill 3/ was a son of Charles C. Hill Jr. 2/ and wife Mary Hill of Fairfield County, S.C.

An Interesting note is that Mr. Brent Holcomb (genealogist) had done some research for me and in a letter told me of a finding that a Burwell (Burrill?) Hill of Craven or Camden District S.C. had sold to a Thomas Hill (of Virginia) some land in Virginia and also that a Burrill Hill had fought in South Carolina in the Revolutionary War. He was a deserter and was punished by "having to serve for the duration of the war." I suspect that this is the same man, perhaps moving to North Carolina to avoid embarrassment over his service record. No dates were provided.

Listed Below is an important deed...

On the 5th of April 1788, "This Indenture BETWEEN RICHARD HILL and AGNES, his wife, of Fairfield County and State of South Carolina, planter of the one part and JANE ROGERS, spinster and weaver of the other part, WHEREAS in and by a certain grant, bearing date of 13th August 1762, in the second year of his majesty's reign, under the hand and seal of his Excellency THOMAS (BOONE)?, Captain, General and Governor and Chief over the Province of South Carolina, the great seal of said Province for (such?) purposes appointed, did give and grant unto WILLIAM HILL, a plantation or tract of land containing 100 acres, situate and lying on Bowers Mill Creek, in Craven County and State aforesaid above mentioned and bounding on all sides by vacant land and hath such shapes, forms and marks as appears by a plat thereof, to the said grant annexed as in and the said plat duly recorded in the Secretaries Office of the said Province, Reference being thereto had (having?) being more fully appeared... VOID THIS INDENTURE, WITNESSETH that the said WILLIAM HILL for and in consideration of the (sum?) of 100 pounds of good and lawfully money of the Province aforesaid, to him in hand well and truly paid by JOSEPH ROGERS before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged and to be well contented, satisfied and paid, has granted, bargained, sold, aliened, RELEASED, remised (sic), conveyed and contained, and by these presents, DO GRANT, BARGAIN, SELL, ALIENED, RELEASED, CONVEYED AND CONFIRMED unto the said JOSEPH ROGERS and RICHARD HILL doth grant and give unto JANE ROGERS NEW RIGHTS in her actual possession"

## End

This proves William Augustus Hill 2/ was dead by 5th April 1788 (date of the above deed) and that William Augustus Hill 2/ had sold this land to James Rogers and somehow it had come into possession of Jane Rogers. Since William Augustus Hill 2/ had died, his son Richard Hill 3/ (wife Agnes) had inherited his estate, including the above mortgage.

Mabry Hill 3/ was a brother to Richard Hill 3/. Richard 3/, who with wife Agnes, made a new mortgage to Jane Rogers for

the property. Thus by Richard Hill 3/ & Mabry Hill 3/ being the sons of William Augustus Hill 2/, they were the nephews of Charles C. Hill Jr. 2/, (brother of William Augustus Hill 2/). Mabry Hill 3/ & Richard Hill 3/ were thus grandsons to Charles Hill Sr. 1/, who was the father of both William 2/ & Charles Hill 2/. Richard 3/ & Mabry Hill 3/ were thus 2nd cousins to Moses, Leonard & Thomas Hill.

# THIS IS ANOTHER HILL FAMILY, WHO'S CONNECTION TO THE ABOVE CHARLES HILL FAMILY IS DOUBTFUL OR UNKNOWN.

## THE RICHARD HILL FAMILY

This Richard Hill Family also settled in the northwest corner of what is today, Fairfield County, South Carolina, and was one of the early settlers in this area of Camden District, South Carolina. It is possible that he was related to the Charles Hill Family but if so there is so far no record to prove or show that connection.

Mr. George A. Hill in his book states that there is evidence that Richard Hill 1/ and others of his family came from Lunenburg County, Virginia, along with the Mobley Family ca. 1748-1752.

My own research caused me to have doubts to the above, so I enlisted the aid of a professional genealogist, Mr. Jonathan Butcher, to research this matter and we both come to the same conclusion that it is quite possible that this was not the same Richard Hill that was in Lunenburg County, Virginia.

It is true that the Mobleys passed through Lunenburg County, and apparently lived there for a spell, during their move from Maryland into old Craven County, South Carolina.

Note: This Richard Hill 1/ is being treated as a 1st generation since no proof exist of the connection to Charles Hill 1/. It is suspected he is related to the Richard Hill 3/ of Virginia or his brother Robert Hill 3/ (wife Tabitha of Halifax County, N.C. Family).

#### RICHARD HILL 1/.

Richard Hill Sr. 1/ married Dorcas Mobley. She was one of the twelve children of Edward Mobley and his wife Susannah Mobley.

This Richard Hill Sr. 1/ received a land grant of "100 acres on Beaver Creek, a branch of (the) Broad River. The grant was made official on January 18th, 1765, by William Bull Esquire." The original survey can be found in Book 7, Page 461 of Craven County, South Carolina and shows: "Richard Hill-100 acres on Beaver Branch of Broad River, July 4th 1764."

Richard Hill Sr. 1/ was dead by 1772 because his widow, Dorcas (Mobley) Hill received a land grant that year of 203 acres and according to the law at that time, this could only have been done by the fact that she was a widow.

In 1793, Dorcas Hill, widow of the deceased Richard Hill Sr. 1/ sold part of this land to a grandson, William Hill Jr. 3/., son of William Hill Sr. 2/, it being 100 acres on Beaver Creek, "being part of 200 acres granted me (Dorcas Hill) the 14th July 1774?, bounded on the northwest by Dorcas Hill, on the southwest and southeast by Richard Hill's land, west and east by Beam's land." (Reference: Deed Book L, Page 171, dated 6th January 1793 and filed in 1798.

It was witnessed by William Alsup and Richard Hill Jr. 2/, (a son) signed by MOSES HILL, Justice of Peace (writer's 4th great grandfather). Dorcas Hill signed the deed by her mark.

Fairfield Deeds shows that the widow of Richard Hill Sr. 1/, Dorcas Hill, also sold a tract of land to, ASAPH HILL, (Deed Book 1, Page 102, recorded 1795) "103 acres on Beaver Creek, bounded by Albert Beams, ASAPH HILL'S land and on both sides of William Hill's land." There was no other record for Dorcas (Mobley) Hill and it is assumed that she died shortly afterwards.

Land Deeds show that Richard Hill 1/ had a son, who was the eldest son, also named Richard Hill (Richard Hill Jr.) 2/. This Richard Hill Jr. 2/ had a son (the eldest) named William Hill Sr. 3/. William Hill Sr. 3/ had a son named William Hill Jr. 4/, who was the father of William Edward Hill 5/, Simeon Hill 5/, Richard Hill 5/, Sion Hill 5/, Dorcas Hill 5/ and Susannah Hill 5/.

William Hill Sr 3/, son of Richard Hill 2/, had made a will, dated 1st July 1790 and proved that very same year of 1790. He gave all he possessed to his son, William Hill Jr 4/.

This will was probated and present at the sale of the estate was ASAPH HILL, Richard Hill, Abel Hill, Thomas Mobley, Dannie Major and Edward Mobley. Just what connection Asaph Hill was to this family is unclear, but of a connection, there appears to be little doubt.

## JOHN HILL AND WIFE MARY ANN MOBLEY.

Just what relationship John Hill was to the other Hill Families is unknown. There is a belief by this writer of a connection to the Charles Hill Family. This supposition is based largely on his estimated birth and on the fact that John Hill named his first son Richard Hill, and his third child (second son), Charles. None of the other Richard Hills in this area have been found with a son named Charles Hill.

John Hill received a land grant of 100 acres on a branch of Beaver Creek, Craven County on the 6th February 1771 (Plat Book 15, Page 442). Since he received this land grant in 1771, he was probably born no later than 1750 if he was 21 years of age (as was often required to receive a land grant). Also his early birth causes suspicions that he was related to Charles 1/ & son William Augustus Hill 2/.

Elizar Mobley gave three slaves to her daughter Mary Hill and her son in law, John Hill..." one Negro woman named Seal, one girl named Fillis"... dated 19th June 1804.

On that same day, she also made another deed to her three grandchildren, Richard Hill, John Hill and Elizar (Elizabeth) Mobley Hill, children of John and Mary Ann Mobley. This deed was for 100 acres, on Broad River. It appears to this writer that John & Mary Hill paid her for this land to be set aside for their three children. John Hill died in 1810 in Fairfield County, South Carolina.

On the 22nd of September 1810, Mary Hill, widow, of the District of Fairfield, for \$ 150.00 paid by George L. Smith, sold 33 and 1/3 acres of a 100 tract, the 100 acres being originally granted to John Hill on 25 June 1771. She stated this was her dower. It was signed by Mary Hill and witnessed by William Minz, William Hill and Edward Meador.

Mary Ann Mobley, wife of John Hill, was the daughter of Elizar (Elizabeth) Mobley, and who's ancestry is clouded. Mary Ann (Mobley) Hill died ca. 1837. Richard M. Hill was appointed administrator for the Estate of Mary Ann Hill on 1-2-1837 (January 2nd??).

Also noted were "Separation Papers" (dated) 1836, Number 5, Naomi Brennan, late Naomi Hill and her next friend Richard Hill vs. Patrick Brennan the Husband--married in 1833. Property belonging to her from Elizar Mobley,"

"The Court of Appeals, Patrick Brennan vs. Richard M. Hill:"

Basically stated the land in dispute was conveyed by Eleazer Mobley to her grandchildren: Richard M. Hill, John Hill & Eleazer Mobley Hill by a deed dated 19th June 1804. The grandson John & grand daughter Eleazer (Elizabeth) Hill died. The other grandson, Charles Hill died a short time later without any children. Mentioned were Naomi Hill, the wife of the plaintiff, Patrick Brennan, Dorcas Mason, wife of Turner Mason, and all the children of a deceased sister Nancy. Their mother was Mary Ann Hill, daughter of Eleazer Mobley, who's deed to the above was dated 19th June 1804.

It appears that Patrick Brennan tired to get some of the land that was given to the grandchildren by Eleazer Mobley.

Known children of John Hill & Mary Ann Mobley were:

- 1. Richard M. Hill, died 15 August 1840, married Susannah Mobley, a daughter of Keziah Mobley and Cullen Mobley. His will names a son, Thomas L. Hill less than 21 years of age, and wife Susannah.
- 2. Elizabeth Hill died without issue.
- 3. John Hill.
- 4. Charles Hill.
- 5. Naomia Hill m. Patrick Brennan
- 6. Dorcas Hill m. Turner Mason, moved to Sumter Co., Ala.
- 7. Nancy Hill, known to have married and had children. One source states she married a Samuel Hill.

WILLIAM HILL JR. 4/, son of William 3/

William Hill Jr. 4/ was a son of William Hill 3/, (son of Richard Hill Jr. 2/, Richard Hill 1/ & Dorcas Mobley).

Records seems to show that William Hill Jr 4/ was born prior to 1750 and died ca. 1795 (as did his wife) in Fairfield District (County). He was married to another Dorcas Mobley, this one was a daughter of William Mobley Sr. and wife, Ann Osborne.

William Hill Jr. 4/ was the heir to his father's estate, and inherited all of the lands and property.

On May 12th 1792, William Hill Jr 4/ sells to Samuel Mobley, 200 acres for 150 pounds sterling, said land on branch of Little River, called Bowers Mill Creek, 100 acres of the 200 acres was originally granted to William Hill Jr 4/ on 25th June 1772, adjacent to lands laid out for William Hill Sr. 3/.

On the 21st June 1797, William Hill Jr. 4/ sold all his land including all the land he inherited that was originally granted to his father William Hill Sr. 3/ and moved to the area around Beaver Creek and to Bowers Mill Creek, (in Fairfield Co.) which said land was granted to Richard Hill Jr. 2/, inherited by son William Hill Sr. 3/ and given by will to son, William Hill Jr. 4/.

Administrators (IN 1795) of William Hill Jr.'s 4/ estate

were: Abel Hill, ASAPH HILL & Thomas Mobley.

Final Settlement of William Hill Jr's 4/ Estate was dated November 24, 1804 by Thomas Mobley (Box 4, Package 114). On the General return made by the administrators, in the upper left hand corner, shows the following: (children ???)

Children of William Hill Jr. 4/ and Dorcas Mobley:

- 3. Samuel Hill 5/, little is known but Nancy Hill, daughter of John Hill, married a Samuel Hill.
- 4. Elijah Hill 5/, was a minor in 1795.
- 5. Elizabeth Hill 5/, married John Alsup
- 6. John Hill 5/, was a minor when parents died. He moved to Mississippi (today's Madison Co., Ala.).
- 7. Mary Hill 5/, born ca. 1793, married ca.1809 to Matthew Hosch.

## ASAPH HILL

It is not clear but it appears that Richard Hill Sr 1/ and his wife Dorcas Mobley may have had among their children, a son named Asaph Hill, and who later moved westward in the Mississippi Territory, now Alabama.

Asaph Hill is known to have got a land grant in Camden District, South Carolina (today's area of Fairfield County) on the 20th of August 1788. He got 114 acres on "Beaver Creek." This grant can be found in Book 24Q, Page 113, Camden District, S.C., dated 20th August 1788.

Asaph Hill could have been born as early as 1767 because at one time, in order for him to have received a land grant in 1788, he would have had to have been at least 21 year of age, however South Carolina laws governing land grants varied from time to time. For him to have been a son of Richard Hill 1/, he would have to have been born prior to 1772, when Richard Hill 1/ died.

This Asaph Hill is listed in the 1790 Census of Fairfield County as follows:

Asaph Hill

1 male over 16 years of age (living by himself).

It has been noted that Asaph Hill bought land from the widow, Dorcas Hill in 1795, and whom this writer suspects was his mother.

This has not yet been proven but it is obvious that he was some how related to the family because in 1804 he sold land to Samuel Hill 5/ and Elijah Hill 5/ for \$ 300, some 98 acres on Beaver Creek. The deed was recorded in 1806.

Now Samuel Hill and Elijah Hill (5th generations) were the sons of William Hill Jr. 4/, who was in turn the son of William Hill Sr. 3/, the son of Richard Hill Jr. 2/, son of Richard 1/ and wife Dorcas Mobley.

The 1800 Census of Fairfield County (Page 384-385) shows:

Asaph Hill (b. between 1755-1774) 1 male 26-45 years 1 female 26-45 1 female under 10

In 1804, Asaph Hill sells for \$ 300.00, 98 acres of land on Beaver Creek, branch of Broad River, to Samuel Hill and Elijah Hill. The land was bounded on the northeast by Dorcas Hill's land. It was signed by ASAPH HILL, dated 1804, recorded in 1806.

It appears that Asaph Hill moved to Mississippi ca. 1806 as his name can not be found in the Fairfield County records after 1805.

Deed Book Q, Page 390, recorded 1805, shows Asaph Hill to Buch & Randolph (??) (the pages was torn). As stated there are no other records of this Asaph Hill in Fairfield County.

In a 1815 Tax List for Madison County, Mississippi Territory, (now Madison County, Alabama) is found:.

Hill, John HILL, ASAPH Hill, Elijah

In the 1840 Census for Madison County, Alabama (Southern Half) is:

## ASAPH HILL

Males: Females: 1 to 5 yrs of age....1 60-70 yrs of age....1 20 to 30 yrs of age....1 20-30 yrs of age.....1 30-40 yrs of age.....1

## FAMILY OF RICHARD HILL JR. 2/ SON RICHARD HILL 1/.

A Mrs. Irma Ristroph wrote back in the early 1960s that she was trying to trace her line back to a Reuben Hill, who's children were: ASAPH, Scotland, David, William, Arbella & Patsey. Whether this is the correct Hill family, that we are concerned with, is unknown, but it appears that there was an Asaph Hill 3/, who was a son of Richard Hill Jr. 2/ (died 28th October 1837) and had a brother named Reuben Hill 3/.

In the "General Statement of Money received and paid by Asaph Hill, Administrator, of the Estate of Richard Hill, (Jr.) 2/ deceased" is the following:

\*\*Note: This is not the same Asaph Hill discussed above.

In 1849, during the disposal of the estate of Richard Hill Jr. 2/, a statement was made that Elijah Hill 2/ had died and left a widow and five children, Edward, Dorcas, Savilla, Mary and a son Asaph Hill 3/. This indicates that Richard Hill Jr. 2/, and Elijah Hill 2/ each had sons named Asaph Hill 3/.

On the 24th of September 1849, William L. Lyles made an oath that "Nathaniel Achison and Elizabeth, his wife, Matthew Hill, Margaret (Stone?) Hill, widow of Elijah Hill, deceased, Edward Hill, Dorcas Hill, Savilla Hill, Mary, ASAPH HILL, children of Elijah Hill, deceased, all resided beyond the limits of the state (meaning South Carolina).

Now Samuel Hill 5/ and Elijah Hill 5/ were the sons of William Hill Jr. 4/. It has been said by some researchers that an Asaph Hill had purchased this land from a Joseph Hill, who in turn had purchased it from Dorcas Hill, but this has not been proved.

The 1830 Census for Fairfield County shows ASAPH HILL as follows:

The 1860 Census of Fairfield County shows:

It appears that the wife of ASAPH HILL, Jane Hill, died ca. 1856-57. The son James S. Hill was born in 1840 and was killed on 30th June 1862 in Virginia in the battle of Seven Pines, before Richmond and Frazier's farm. He was a member of the 6th S.C. Volunteers, Company "H." It was under Captain Wiston's command and known as the "Buckhead Guards."

RICHARD HILL 3/, AND WIFE MARY MOBLEY

The often repeated names of Richard and William Hill becomes confusing, so much so that the genealogy of this particular family should now be clarified.

Richard Hill 1/, b. ?, died ca. 1768-1772, m. Dorcas Mobley. Richard Hill 2/, (son of above), had an eldest son William Hill 3/, who inherited his father's estate. He also had a son Richard Hill 4/.

William Hill 3/, who died in 1790, had sold the land to his brother Richard Hill 3/, father to the six children involved in this deed. This William Hill 3/ was actually William Hill Sr. 3/, who had a son William Hill Jr. 4/.

William Hill Jr. 4/ died ca. 1759 married Dorcas Mobley, a daughter of William Mobley Sr. & Ann Osborne. Both he and his wife died ca. 1795.

NOTE: Now the important thing to remember is that these William Hills and Richard Hills should not be confused with William Augustus Hill 2/ of the Charles Hill family, who also had a son named Richard Hill.

Richard Hill 3/ was born sometime between 1755 and 1765. Richard 3/ died in 1810 in Fairfield County, South Carolina. His wife was Mary Mobley, eldest daughter of William Mobley Sr., who is known as the eldest son of Edward Mobley Sr. and his wife Susannah DeRuel. Mary Mobley was born sometime after 1765 and her death date is unknown.

The 1790 Census shows:

Richard Hill 1 male over 16 yrs of age. 1 male under 16 yrs of age. 3 females.

The 1800 Census, Volume #4, Page 385 shows:

Richard Hill 3 males under 10 yrs of age. 1 male 26-45 yrs of age. 1 female under 10 yrs of age. 1 female 10-16 yrs of age 1 female 16-26 yrs of age 1 female 26-45 yrs of age.

The will of Richard Hill shows that they had eight children:

William Edward Hill 4/ Simeon Hill 4/ SION HILL 4/ Richard Hill 4/ Dorcas Hill 4/ Susannah Hill 4/ Sarah Hill 4/

The names of William, Simeon, SION and Richard Hill offers some strong evedince about a connection to the family of the emigrant named Robert Hill 1/ wife Mary Webb of Isle of Wight County, Virginia, through his son Sion Hill 2/ and his sons Richard Hill 3/ (wife) Hannah Briggs of Va. or Robert Hill 3/ and wife Tabitha Hill of Halifax County, N.C.

This is especially true in view of the fact that Robert Hill 3/ had a daughter, Milbry Hill 4/, who married Matthew Gibbs and is known to have been in the Craven/Camden District area of South Carolina.

FAIRFIELD DEEDS, BOOK O, Page 354, dated 6th February 1793, shows that this Richard Hill 3/ purchased 100 acres from William Hill Jr. 3/, (brother) it being part of the 184 acre tract that was the old Richard Hill 1/ grant on Beaver Creek, dated 18th January 1765.

Richard Hill 3/ made out his will dated 22nd January 1810 and it was attested to (probated) on 5th February 1811. (File 18, Pkg. No. 224).

His distribution was to his wife Mary, and at her decease, to be divided equally to his five sons, William, Simeon, Richard, Sion, and John Hill. He gave each of the three daughters, forty dollars.

To this writer, the following deed is of great genealogical importance. It is believed that this deed implies that the 100 acre, granted to Richard Hill, was the same Richard Hill 1/, that married Dorcas Mobley and who was the Richard Hill that had died ca. 1768-1772.

While no list of his children is available, it is believed that a Richard Hill (Jr.) 2/ was his son. It is felt that this is the Richard Hill that married Mary Mobley and the one mentioned as the 2nd Richard Hill in the deed below.

Richard Hill Jr. 2/ is believed to be the father of William Hill, mentioned as the eldest son of a Richard Hill, and who inherited by "Rights of Promogeniture" the estate of his father, mentioned in the following deed. Thus William Hill would be William Hill 3/, who sold the land to his brother Richard Hill 3/, and who was the father of the 6 children listed in the deed below.

That deeds states:

On 20th December 1818, Simeon Hill 4/ sold his share of the inherited land from his father, QUOTE

"The State of South Carolina: KNOW ALL MEN BY THESE PRESENTS that I Seimon (sic) Hill. of the District of Fairfield, in the state aforesaid, in consideration of the sum of \$400.00 to me in hand, paid by William Edward Hill, Richard Hill & Sion Hill, of the State and District aforesaid, have granted, bargained, sold and released unto them, the said William E., Richard & Sion Hill all that plantation or tract of two tracts of land containing 184 acres, it being the real estate of Richard Hill, late of Fairfield District, deceased, who died intestate, leaving a widow and 6 children, that is Mary, his widow, William Hill, the said Simeon Hill, Sion & Richard son: Dorcas & Susannah Hill, daughters, & whereas by the laws of this state each of the children of the deceased is entitled to an equal share of the two thirds of said land, it being yet in an undivided state, and as so hereby intended to be conveyed to my aforesaid brothers, the said William E, Richard and Sion Hill, one hundred acres of the aforesaid 184 acres above mentioned was granted to Richard Hill, the father of the aforesaid Richard, who also died intestate, whose eldest son William, according to the Rights of Promogeniture, became the heir of all the landed Estate of the said Richard, who did convey the aforesaid tract of 100 acres to his brother Richard Hill, father of the said William E., Simeon, Richard and Sion Hill, and Dorcas and Susannah Hill, by deed bearing date of 6th February 1793, and is made of record in the Register's Office for the District. The other part of the said 184 acres as aforesaid was conveyed to the said Richard Hill, the father of the said William E., Simeon, Richard, and Sion, Dorcas and Susannah Hill, by deed bearing date the 13th of November 1792, and is made of Record in the Register's Office as aforesaid; this conveyance is for 49 acres, the whole agreeable to the grant to Richard Hill and the aforesaid conveyance from Adam Effort is 149 acres, but contains by a re-survey, 184 acres, situated adjoining Beaver Creek, etc. etc" UNQUOTE.

This deed is somewhat confusing but it appears to deal with the 184 acres that Richard Hill SR. 3/ had bought from his brother William Hill 3/ in 1793.

As this deed is understood, the History of this 184 acres is as follows:

Adam Effort apparently sold 149 acres to Richard Hill 3/, but when re-surveyed it actually contained 184 acres.

On the 13th of November 1792, William Hill 3/ sold 84 acres to his brother Richard Hill 3/ and then sold the other 100 acres to him on 6th February 1793. By this deed, Richard Hill 3/, (wife Mary Mobley) and the father of the involved parties named (viz) William Edward Hill 4/, Simeion Hill 4/, Richard Hill 4/ & Sion Hill 4/, had gained the entire 184 acres.

This deed shows that Simeon Hill 4/, was selling his share of the 184 acres to his brothers, William Edward Hill 4/, Richard Hill 4/ and Sion Hill 4/ and thus his wife (by law), was required to sign the deed, which Elizabeth Hill (wife) signed on the 20th December 1818.

Some of the children of Richard Hill Sr. 3/ and Mary Mobley moved to Georgia (see below).

## WILLIAM EDWARD HILL 4/

William Edward Hill 4/ was the son of Richard Hill Sr. 3/. He was born in 1785\*\* in Fairfield County, S.C. and died on 9th November 1862 in Jackson County, Georgia. His burial is in the family cemetery at his old home near Rockwell Church (Universalist) in Barrow County, Georgia. He was to married Elizabeth Cockrell on 18th December 1823 in Fairfield County, S.C. She was born in 1794 and died 3rd October 1888.

William 4/ was a soldier in the war of 1812 and served as a Private in Captain Nevet's Company, S.C. Militia. After the war he moved to Jackson County, Georgia and lived on Beech's Creek, close to his brother, Sion Hill.

Note: Reference to \*\* (birth of William), there is a confliction to his birth... information from the Veteran's Administration differs with both the 1850 Census and pension records.

Elizabeth Cockrell's birth is listed in a bible as being 1794 but in a pension record it states 1808 and the census given birth as 1800.

## Children were:

- Starling E. Hill 5/, born 16 December 1824, died 24th October 1864 married Lucinda Ann Stewart. Served in CSA, died while a prisoner at Point Lookout, Maryland. Burial in Confederate Cemetery, Point Lookout, Md., grave No. 609, Hospital No. 5104. Children:
  - i. Charity E. Hill 6/, born 30 April 1860, married Joseph Gunnin.
  - ii. William Alexander Hill 6/, born 10 January 1862, married 29th December 1897 to Mattie E. Attaway. He died 5 January 1924. No children.
  - iii. John Emanuel Hill 6/, born 1st November 1862, married 15th November 1892 to Callie Lucy Ella Hill. He died 10th April 1935.
- Moses R. Hill 5/, born 8th October 1826, died 22nd December 1862 while a volunteer in the Confederate Army,

buried in Richmond, Va. He never married.

- Cicero Sandford Hill 5/, born 12th May 1828, died 23rd July 1894, married Margaret White.
- 4. Susan Ann Hill 5/, born 29th May 1830, married James Wills.
- 5. Alexander Abel Hill 5/, born 14 August 1832, died 3rd June 1887, married Margaret E. House.
- 6. Nancy E. Hill 5/, born 16 October 1836, married Robert Shields.
- 7. Lucy A. Hill 5/, born 16 March 1840.
- John P. Hill 5/, born 22 December 1834, died while in Confederate Army on 6th January 1863 of small pox. Buried at Richmond, Va.

SIMEON HILL 4/ SON OF RICHARD HILL 3/

Simeon Hill 4/ was born in 1792 and he died ca. 1857. He married Elizabeth Mobley, daughter of Cullen (Colin) & Keziah Mobley before 1818. He lived in the general area of today's Feasterville in Fairfield County, S.C. He served in the Confederate Army, captured and sent to Point Lookout, Maryland. Children were:

- i. Jethro M. Hill 5/, born 1820, married Harriet Mobley, daughter of Biggers Mobley and Frankie Davis.
- ii. Alexander Abel Hill 5/, born ca. 1821, wife named Mary, had several children but names are not completely known.
- iii. Jehew Hill 5/, born 1822, died 22 October 1891.
- iv. Simeon A. Hill 5/, born ca. 1828, married Frances Estes. Children : Jesse Hill 6/, Charles Hill 6/, Simeon Estes Hill 6/, born 12 April 1868, died 5 December 1933, married Ida Dye.
- v. another child but name not known.

RICHARD HILL 4/ SON OF RICHARD HILL 3/.

Richard 4/ is believed to have moved to Georgia and no information on him has been found. He could be the same Richard Hill found in Walton County, Georgia:

A Marriage record shows a Richard Hill married Sally Elliot on 17th April 1806.

1830 Census (Page 169)

He is not listed on the 1840 Census.

SION HILL 4/ SON OF RICHARD HILL 3/.

Sion Hill 4/ was born (in S.C.?) between 1800 and 1810 and died in 1847 in Walton County, Georgia. He married Mary Wright on 28 December 1826 and they moved to Walton County, Georgia. He lived in what is today Barrow County, Georgia, close to the border. His brother, William E. Hill 4/, lived in Jackson County, just across the border.

1830 Census Walton County, Ga. (Page 169)

1840 Census Walton Co., Ga. (Page 104)

He was one of the largest land owner in the area of Winder (previously known as Jug Tavern) and that included land where the court house of Winder now stands. Children:

- i. David Lumpkin Hill 5/, born 22 September 1831.
- ii. Nancy Jane Hill 5/, born 19 March 1835.
- iii. William E. Hill 5/, born 22 January 1838, died 13 December 1903. Married Mary Frances House, second to Cynthia ? Children : Mary 6/, Wm. D. 6/, John P. 6/, Alexander A. 6/, Nancy E. 6/.
- iv. Simeon Hill 5/, born 1841, moved to Sand Mountain, Alabama.
- v. Philo Wright Hill 5/, born 1843.
- vi. Richard Hill 5/, could have been the eldest child, but he is not shown in the 1850 census with mother Mary Wright Hill. A Richard Hill with wife Mary is shown in the 1850 Census (born 1827). Wife Mary was born 1830. Is said to have been killed in the Civil War. No details available.

## DORCAS HILL 4/ DAUGHTER OF RICHARD HILL 3/.

All is known of her is that she married Richard Barker.

JOHN HILL 4/ SON OF RICHARD HILL 3/.
