Note: To pick up where we left off on SC.37.. we find that we
are dealing with two brothers, Richard Hill 3/ and William
Hill Sr. 3/, sons of Richard Hill 2/. Therefore, in order to
try to help the reader understand the situation, and for
purposes of clarity, a partial & brief run down on the
genealogy of this family is given:

Richard Hill 1/ m. Dorcas Mobley had a son...

Richard Hill Jr. 2/ ...who had two sons....

Richard Hill 3/ (below) & William Hill Sr. 3/.

1. Richard Hill 3/ married Mary Mobley. Children were:
William E. Hill 4/, Simeon Hill 4/, Sion Hill 4/,
Richard 4/ and John Hill 4/. Daughters: Dorcas Hill 4/
m. a Barker, Susannah Hill 4/ & Sarah Hill 4/.
2. William Hill Sr. 3/ had a son named William Hill Jr.
4/, who married a Dorcas Mobley, and they were the
parents of Richard Hill Jr. 5/ that married Dorcas
Funderburgh (listed later below); Samuel Hill 5/; Elijah
Hill 5/; Elizabeth Hill 5/; John Hill 5/; Mary Hill 5/;
and Abel Hill 5/..

RICHARD HILL 3/, AND WIFE MARY MOBLEY (SON OF RICHARD HILL
JR. 2/).

Briefly, this Richard Hill 3/ & Mary Mobley were the parents
to: William, Simeon, Richard, Sion & John Hill, daughters
Dorcas m. Barker, Susannah & Sarah Hill, of whom some moved
to Georgia.

THE WILL OF RICHARD HILL 3/ OF FAIRFIELD COUNTY, S.C

Fairfield County Wills, Volume 1, Section 5, Page 59:

"Last Will & Testament of Richard Hill, deceased."

IN THE NAME OF GOD, AMEN: Know ye that I Richard Hill, of the
State of South Carolina and Fairfield District, being weak of
body but of perfect mind and memory, knowing that it is
appointed for all men to die; and as touching such worldly
property as it hath pleased God to bless me with, it is my

will that my property be judiciously appraised and remain as it is to the use of my family for my wife and children.

Secondly It is my will that my wife Mary Hill do posses, and occupy the plantation whereon I now live, with all the appurtenances thereunto belonging during her lifetime, or widowhood. Then to be equally divided at her decease or marriage among my five sons, VIZ: WILLIAM, SIMEON, RICHARD, SION and JOHN.

Thirdly It is my will that unto each of my daughters namely DARKUS, SUSANNAH AND SARAH, unto each of them to be given to the amount of Forty Dollars of my goods and chattels after they have been appraised, and the remainder if any to be equally divided among my children."

End of Will

The above will was proved in court on January 22nd, 1810, showing that Richard Hill 3/ died in 1810. The three witnesses proving the will was John McCullough, George S. Smith and Daniel A. Mobley.

Richard Hill 3/ was in the process of writing his will when he died and never completed it because the three witnesses stated they were present when Richard Hill 3/ directed John McCullough to write, which was the same substance contained above and called his will, but the deceased became so weak and insensible before the will was perfected, but was truly sensible when he spoke the testamentary words, the said deponent further says that they being present were called upon to witness the above transaction and that they did in the presence of each other did subscribe their names thereto."

Sworn to the 5th day of February 1811

signed by/ John McCully
George (x) Smith
Davis A. Mobley

Davis & Daniel Mobley were nephews to the widow, Mary (Mobley) Hill.

In the final distribution, Susannah, Sarah and John Hill were not listed (John had died in 1810).

Now it should be noted that Richard Hill 3/ had a brother William Hill Sr. 3/, who in turn had a son William Hill Jr. 4/ and it is with him we will pick up this document...

WILLIAM HILL JR. 4/ (WIFE DORCAS MOBLEY, DAUGHTER OF WILLIAM MOBLEY SR. & WIFE ANN OSBORNE).

William Hill Jr 4/ was born before 1750 and both he and his

wife died ca. 1795 in Camden District, today's Fairfield County.

"William Hill's Estate-General Return dated July 1796, Final Settlement dated 24th November 1804, by Thomas Mobley in Box 4, Package 114." Listed was:

6. Mary Hill 5/ "Married Matthew Hosch"
7. Abel Hill 5/.

Administrators (1795) Abel Hill, Asaph Hill & Thomas Mobley.

As shown above several of the children were minors when William Hill Jr. 4/ died.

RICHARD HILL 5/, SON OF WILLIAM HILL JR. 4/

Richard Hill 5/ was born ca. 1775-1776 (census records) and was of legal age shortly after the settlement of his father's estate. Now the fact that there were so many Richard Hills in this area of South Carolina has made it very difficult to trace this family but it appears that this Richard Hill went be the name of "Richard Hill Jr." 5/ (5th generation). He died on 27th October 1837 in Fairfield County, S.C. He was married to Dorcas Funderburgh, granddaughter of Henry & Mary Funderburgh. (see later).

SAMUEL HILL 5/ (SON OF WILLIAM HILL JR. 4).

Very little has been found on Samuel Hill 5/ and it is not clear if he moved westward or remained in Fairfield County. Nancy Hill, daughter of John Hill (d. 1810) married a Samuel Hill but we have not been able to confirm if it was the same man.

ELIJAH HILL 5/ (SON OF WILLIAM HILL JR. 4)

Elijah Hill 5/ was a minor in 1795 and was a ward of Thomas Meador in 1798. Samuel Hill 5/ and Elijah Hill 5/ is known to purchased 98 acres of land from Asaph Hill in 1806 and was witnessed by a Richard Hill. They do not appear again in Fairfield County records and there is an Elijah Hill that shows up in Madison County, Alabama, then Mississippi

Territory in an 1815 Tax List.

ELIZABETH HILL 5/ (DAUGHTER OF WILLIAM HILL JR. 4/)

Elizabeth Hill 5/ married John Alsup (Alsop) and there is nothing else found on her.

JOHN HILL 5/ (SON OF WILLIAM HILL JR. 4/)

John Hill 5/ was a minor when his parents died and his guardian was Abel Hill 5/, later a John Foote was his guardian. After he became of age he moved to Mississippi.

Deed Book W, Page 356, dated 11 August 1814, Fairfield County, S.C..."Know all men by these presents that I John Hill of Mississippi Territory for \$ 535.00, to me in hand, paid by Francis Edrington Jr. of Fairfield County, S.C. sold 77 acres on Beaver Creek, it being part of the Real Estate of William Hill, late of Fairfield County, deceased, being part of the Real Estate that was originally laid out for said John Hill by order of Court of Common Pleas as one of the heirs of said William Hill." signed/John Hill.

John Hill may have moved to Madison County, Alabama.

MARY HILL 5/ (DAUGHTER OF WILLIAM HILL JR. 4/)

Mary Hill 5/ was born ca. 1793. She was a minor when her parents died and she had as her guardian, Abel Hill, Richard Hill and then was raised by Thomas & Naomi Meador.

About 1809 she married Matthew Hosch and they moved to Walton County, Georgia and were there by 1823

THE FAMILY LISTING FOR THE RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH FAMILY.

Richard Hill Jr. 5/ was born in Fairfield County, South Carolina ca. 1775 and died on 27th or 28th October 1837. He married Dorcas Funderburgh (b. ca. 1775) who died ca. 1852.

He was the son of William Hill Jr/ 4 and Dorcas Mobley. He used the designation of "Junior" to distinguish himself from that of another Richard Hill (d. 1810 and m. Mary Mobley). He was a planter and lived on 500 acres on John's Creek in the northwest corner of today's Fairfield County. Their Children were:

1. William F. Hill 6/, b. ca. 1800, wife named Margaret.
2. Henry Hill 6/, b. ca. 1802.
3. Asaph Hill 6/, b. ca. 1804, m. 1st Mary Mobley, 2nd

- Jennie Stevenson.
4. Elijah Hill 6/, b. ca. 1808, died 1848/49. m. Margaret Price.
 5. Matthew Hill 6/, b. ca. 1810.
 6. Reuben F. Hill 6/, b. ca. 1813. died 1848 (August). Married Elizabeth Ellen Housch (b. 1821-d. 8 May 1895). After his death she remarried Jacob F. Hill, his nephew, who was born ca. 1830 thus a younger man and the suspected son of William F. Hill 6/.

When Richard Hill Jr. 5/ died his land was disposed of in the following manner:

Fairfield District S.C.
Pages 9, 10 of 1849 Minutes of the Court

"Richard Hill died October 28, 1837...297 and 1/2 acres of land on John's Creek, Waters of Sandy River in Fairfield County bounded by Jacob Stone, Solomon Coleman, John Stevenson, ET AL...Said Richard's heirs at law (are) Asaph Hill, Henry Hill, William F. Hill, Elijah Hill, Matthew Hill, Reuben Hill, Mary Hill now Chapman, wife of William Chapman Sr., Dorcas Hill (now Dorcas Stevenson), wife of John Stevenson, Elizabeth Hill, now Elizabeth Achinson, wife of Nathaniel Achinson."

"That since Richard Hill's death, Elijah Hill has departed this life intestate, leaving heirs, his widow Margaret Hill and five children, namely: Edward Hill, Dorcas Hill, Savilla Hill, Mary Hill, and Asaph Hill."

"Since the death of Richard Hill, Reuben Hill has departed this life intestate leaving heirs... Widow Ellen Hill, three children, John C. Hill, Susan Hill and Henry Hill."

"That William F. Hill, William Chapman & wife Mary, John Stevenson and wife Dorcas since Richard's death have conveyed their rights to the Administrator...(ASAPH HILL) the parties all being of full age-agree and deliver 1/3rd to Richard Hill's widow, Dorcas Hill."

FAIRFIELD DISTRICT, 24th September 1849

"Personally appeared Major William L. Lyles and made oath that he is informed and believes that: Nathaniel Achinson and Elizabeth, his wife, Matthew Hill, Margaret Hill, widow of Elijah Hill, deceased, Edward Hill, Dorcas Hill, Savilla Hill, Mary, Asaph Hill, children of Elijah Hill, deceased, all reside beyond the limits of the state.

1. WILLIAM F. HILL 6/ (SON OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH).

William F. Hill 6/ was a son of Richard Hill Jr 5/ and his

wife Dorcas Funderburg and was born in Fairfield County, S.C. ca. 1800.

The wife of William F. Hill 6/ is known only as Margaret, but it is possible that she was Margaret Stone. She was a daughter of Jacob Stone Jr. and Margaret Cockrell. Margaret Cockrell was a daughter of Moses Cockrell and Susan Feaster, a daughter of Andrew Feaster and a widow Margaret Fry Cooper.

Margaret Stone's grandfather was Jacob Stone Sr. and was a Revolutionary Soldier, who married Eve Cooper, a daughter of Margaret Fry Cooper and step-daughter of Andrew Feaster Sr.

Margaret Cockrell's sister, Frances Cockrell, married Littleton Hill, who lived to the north and in an area that is today's Chester County, who was a son of a William Hill Sr., but no relation to William F. Hill. or his Hill family.

In the 1830 Census, William F. Hill 6/ is listed on the very same page as that of his father, Richard Hill 5/ and his brothers, Asaph 6/ and Henry Hill 6/. He was missing in the 1840 census but is believed to have been in Walton County, Georgia where a William F. Hill 6/ was listed, along with his brother, Elijah Hill 6/.

In the 1850 census of Fairfield County, S.C., he was listed on the same page as was Elizabeth Ellen Hill, widow of his brother, Reuben Hill 6/. It is unknown if William 6/ died in Fairfield County, S.C., or moved westward.

The marriage of William F. Hill 6/ is somewhat debatable but this writer feels his wife was Margaret Cooper, daughter of Adam Cooper for the following reason:

Fairfield Deed Book NN, Page 95..."Captain William F. Hill, 227 and 1/10 acres of land conveyed to William by Adam Cooper, deceased on November 23, 1833 on branch of McClures Creek, branch of Beaver Creek.

2. HENRY F. HILL 6/ (son of Richard Hill Jr. 5/)

Henry Hill 6/ was the son of Richard Hill Jr. 5/ and wife Dorcas Funderburgh. He was born about 1798-1802 in Fairfield County, S.C. and was found in the census of Fairfield County for 1820 (Vol. 5), page 47, 5th line.

Hill was listed with 6 persons in his household.

Henry F. Hill 6/ moved to Georgia and on the 2nd of May 1847, in Walton County, Georgia, he along with his brother William E. Hill 6/, signed as witnesses to the will of their brother Sion Hill.

Henry F. Hill 6/ was found in Jackson County, Georgia and he signed the will of his brother, Sion Hill. He was shown in the 1840 Census of Jackson County:

It is not certain if this is the same Henry Hill of Fairfield County, S.C. but an elderly lady (descendent) stated that he was and Martha Hill married a Cox and Mary Hill married 1st a Stewart and then Marsh Patman.

In Deed Book N. page 264, Walton County, Georgia, a deed shows that a Henry F. Hill purchased 196 acres from Robert Born, recorded 12 October 1841, witnessed by John Hosch, ASAPH HILL and John McCully.

Deed Book N, Page 265, dated 2nd July 1841, Henry F. Hill sells to Barker & Smith for \$ 517.00 258 and 3/4 acres of land (154 acres in Walton County and 104 and 3/4 in Jackson County, Georgia). Recorded 12 October 1841.

3. ASAPH HILL 6/ (SON OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURG

Asaph Hill 6/, WAS born 1804, married 1st Mary Mobley, the

daughter of Micajah Mobley & Elizabeth Mobley. Children were:

- a. Elizabeth Hill 7/, born ca. 1826/27 married David Stevenson, son of James Stevenson & Nellie Weir. It appears that they moved to Mississippi.
- b. William E. Hill 7/, born 1830 in Fairfield County. No records of his marriage but he was listed in the 1860 Census for Fairfield County as:

Now the fact that that this name is listed close to A.A. Hill and the fact that Simeon Hill Sr. Estate settlement shows a William E.M. Hill and wife "M. Jain" may mean he is related to Simeon rather than Asaph Hill.

When Mary Mobley Hill (first wife) died Asaph Hill 6/ married a second time to Jennie Stevenson (b. ca. 1824) and they had six children.

- a. James S. Hill 7/, born 1840, killed in Civil War on 30th June 1862 at the Battle of Seven Pines.
 - b. Alexander Hill 7/, born 1842, CSA, captured 2nd April 1865 at Garret Station.
 - c. Sarah Jane Hill 7/, b. ca. 1848-49.
 - d. David Hill 7/, born 1850.
 - e. Catherine Hill 7/, born 1853.
 - f. Martha Hill 7/, born 1856.
4. ELIJAH HILL 6/ (SON OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH

Elijah Hill 6/ was another son of Richard Hill Jr. 5/ and his wife, Dorcas Funderburg. He was born ca. 1808 and died ca. 1848 or 1849. His wife was Margaret Price, daughter of William Price and Dorcas Mobley, daughter of Samuel Mobley Sr and wife Mary Wagner of Fairfield County. Samuel Mobley was the son of Edward Mobley and wife, Susannah Mobley.

Elijah Hill 6/ moved his family to Walton County, Georgia ca. 1839 or 1840.

On 23rd January 1839, Elijah Hill 6/ and wife Margaret Hill, of Fairfield County sold all their rights to 200 acres for \$ 625.00 to Dorcas Price, Executrix of William Price, father in law to Elijah. Apparently this land was 200 acres in Chester County, just across the line from Fairfield County and was part of Margaret's inheritance from her father. Elijah Hill lived on the border of Walton & Jackson County,

just on the Walton County side.

In the 1840 Census of Walton County, Georgia, Elijah Hill 6/
is listed on Page 99...

Information on the children of Elijah Hill 6/

A. Dorcas Hill 7/ daughter of Elijah Hill 6/, was born ca. 1834 and married David L. Etchison prior to September of 1852. "Walton County Georgia Records Minutes, Page 281, Monday-September 6, 1852..."To honorable court of Ordinary, Walton Co., State of Georgia...The petition of David L. Etchison in right of his wife, Dorcas P., formerly Dorcas P. Hill and heir at law of estate of Elijah Hill, deceased, apply for distributive share of Negroes of said estate-Freeholders Robert Cooksey, Abram Hammonds, Leonard B. Hayse, John R. Moon, Jonathan Hill & James R. Etchison."

B. Edward Hill 7/, son of Elijah Hill 6/ & Margaret Hill was born ca. 1837 in Fairfield County, S.C. and he moved to Georgia with his parents and is shown in the records as follows: Index to Estates: Returns H, Page 73..."Edward Hill, minor, Joseph Livsey, Guardian."

C. Mary Hill 7/, daughter of Elijah Hill 6/ & Margaret Hill. She was born ca. 1838 in Fairfield County, S.C. and moved as a minor to Walton County, Georgia with her parents. That County Records (Index to Estates) shows Mary Hill (minor of Elijah Hill) M.C. Malone, Guardian.

D. William Hill 7/ son of Elijah Hill 6/ & Margaret Hill. He was born in Georgia in 1842. "Walton County Georgia, Returns H, Page 395, shows..."William Hill in account with his guardian, Margaret Hill (his mother) received from Dorcas Hill's estate...Medical Bill from Dr. John R. Moore...Negro

for this minor was Charles...(account similar to that of his sister, Susan Hill).

E. Susan Hill 7/, daughter of Elijah Hill 6/, was born ca. 1844 in Georgia. Walton County Georgia Returns H. Page 394..."Susan Hill, minor-orphan of Elijah Hill-her guardian was her mother, Margaret Hill."

F. Richard Hill 7/, son of Elijah Hill 6/, was born ca. 1846 in Walton County, Georgia and he is listed among those records very similar to those of his sister Susan.

G. Asaph Hill 7/, son of Elijah Hill 6/, was born in Walton County, Georgia ca. 1847. M.C. Malone was his guardian and he is listed among the county records similar to those of his brothers and sister.

5. MATTHEW HILL 6/ (SON OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH)

Matthew Hill 6/, son of Richard Hill Jr. 5/ was born ca. 1810 in Fairfield County, S.C. and there is no record of a marriage. He apparently was engaged in farming and is known to have purchased a tract of land from his father. There is no other information on him at this point.

6. REUBEN F. HILL 6/ (SON OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH)

Reuben Hill 6/ was a son of Richard Hill Jr. 5/ and his wife Dorcas Funderburg. He was born in Fairfield County, S.C. ca. 1813 and died in August of 1848. He was married to Elizabeth Ellen Housch in Georgia ca. 1839. She was born in South Carolina ca. 1821 and died on 8th May 1895 in the Indian Territory.

Elizabeth Housch was the daughter of Matthew Housch and Mary Hill. Mary Hill 5/ was the daughter of William Hill Jr. 4/ and Dorcas Mobley and thus was the sister to Richard Hill Jr. 5/ and the aunt to his children.

Jacob Feaster Jr. applied to the courts to administer the estate of Reuben Hill and was so appointed in 1853.

Fairfield Probate Court Records show the following:
Dated 5th January 1852..."The petition of Jacob Feaster Jr. sheweth that Reuben Hill 5/, late of the District of Fairfield, departed this life sometime in the month of August 1848, INTESTATE, leaving at his death, a widow, Elizabeth Ellen Hill, who has since intermarried with one Jacob F. Hill-and three children to wit: John C. Hill 6/ who is about 10 years old, Susannah Hill 6/, about 7 years old and Henry W. Hill 7/, who is about 5 years old, his only heirs at law, and personal property to the amount of \$ 2300.00 and your petitioner further prays that he may be appointed Administrator by complying with the requisitions of the law in such cases made and provided."

It is not exactly clear what the problem was but apparently later John C. Hill 6/ (probably by a guardian as he was still a minor) and others filed suit against Jacob Hill & their mother and the court ordered the lands to be auctioned and the proceeds divided among the heirs.

The administrator's accounts contained the proceeds from the sale of the plantation and some of the chattels but did not include the sale of the slaves. These were sold by Jacob Hill in 1859 in Walker County, Georgia, for the estate.

Children of Reuben Hill 6/:

1. John Crawford Hill 7/ was born in April of 1840, died on 3rd December 1910. He was married first to Mary Howell; second to Amanda Jane Anderson.
2. Susannah P. Hill 7/, born 1844, moved to Walker County, Georgia and married a Mattox ca. 1872. Her children were: Buddy Mattox 8/ (never married). & a daughter, who is known to have married ?? and had two children. Susannah Hill 7/ died after 1910 in Georgia.
3. Henry W. Hill 7/, born 1846, died ca. 1891. He married by 1872, a Sarah Hill, born 1848, died 14 January 1905. (Sarah's ancestry has not been

determined, but one source said she had a sister Elizabeth Hill, and they were cousins to Henry Hill 7/.) It is possible that it was the daughter of Asaph Hill 6/, a uncle, who had a daughter named Sarah. Henry Hill 7/ moved from Georgia to Scott County Arkansas, where he died.

The widow of Reuben Hill 6/, Elizabeth Ellen Hill, married a second time to Jacob Hill, nephew to Reuben Hill 6/ and a younger man than she.

The 1850 Census of Fairfield County, S.C, Vol #4, Page 480, P. 592, 593 shows:

After Jacob Hill married the widow Elizabeth Ellen Hill, they had two children:

1. James L.W. Hill, born 1852 Fairfield County, S.C., moved to Walton Co., Georgia in 1853 then in 1880 he moved to Scott County, Arkansas with his mother and brothers. He died shortly afterwards. He never married.
2. Matthew W. Hill, born 1855 in Walker County, Georgia, moved to Scott County, Arkansas with his mother and brothers. He died ca. 1892. He never married.

In 1853, the landed estate of Reuben Hill 6/ was auctioned off to Jacob Stone and the widow and Jacob Hill, her new husband, moved to northwest Georgia, to the southern portions of Walker County, near the Chattooga County line. This was near the brother of Ellen Hill, John J. Housch, who lived in Chattooga County, not far from Trion, Georgia.

Jacob Hill bought a farm and their second son Matthew Hill was born there in 1855. Jacob Hill sold off the slaves belonging to the estate of Reuben Hill 6/ and died later that year, leaving a reputation of being a smart business man and a very good farmer.

Elizabeth Ellen Hill stayed in Walker County through the 1870 Census and in 1880 moved to Scott County, Arkansas with her sons James and Matthew Hill. After the sons died, she moved to the Cherokee Nation at Dwight Mission. Her son, John Crawford Hill 7/, lived close to the Presbyterian Indian Mission School, where his children attended school, Elizabeth

Ellen Hill died on 8th May 1895 in her 74th year and is buried at Dwight Mission Cemetery which adjoins the Mission School.

7. MARY HILL 6/ (DAUGHTER OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURG

Mary Hill 7/, was born in Fairfield County ca. 1815-20. No records on her exist except the knowledge that she married William Chapman, before the settlement of her father's estate about 1840.

8. ELIZABETH HILL 6/ (DAUGHTER OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH.

Elizabeth Hill 7/, was born in Fairfield County, S.C. between 1815 and 1820. She married Nathaniel Achison sometimes after 1840 and before 1849. The 1790 Census shows her as Head of the Household, indicating that she was now widowed.

1790 Census

Mary Aitchison-6 in family

John Aitcheson 5 in family (was this a son?)

9. DORCAS HILL 6/ (DAUGHTER OF RICHARD HILL JR. 5/ & DORCAS FUNDERBURGH.

Dorcias Hill 6/ was born in Fairfield County in 1820 and married John Stevenson prior to 1840. He was born in 1813 in Fairfield County, the son of James & Nellie Weir Stevenson.

Their children: (births from census records)

- a. Ellen Stevenson 7/ born 1840
- b. Elizabeth Stevenson 7/ born 1842
- c. David Stevenson 7/ born 1844
- d. James Stevenson 7/ born 1846
- e. John S. Stevenson 7/ born 1849
- f. Martha Stevenson 7/ born 1851-52

Dorcias Hill 6/ died between 1850-1860 and John Stevenson remarried a second time to Lizzie Levister. The following children were born to John but it has not been found which of the two wives were the mother of the following:

- g. William Chris. Stevenson 7/ born 1856
- h. Hugh M. Stevenson 7/ born 1857
- i. Nancy Stevenson 7/ born 1859
- j. David ? E. Stevenson 7/ born 1861

After the birth of David 7/, there was a gap of 6 years before the next child was born. Whether this was the child of the second wife Lizzie or the third wife, Mary Ann McMullen, is not known.

- k. Jennite Stevenson 7/ born 1867

Now it appears that most of the Hill families shown above moved into South Carolina area of today's Fairfield County before the Revolution. Where they lived prior to that time is unclear, but the Mobley Family came from Maryland via way of Lunenburg County, Virginia, in the portion that became Bedford County, and may have met the Richard Hill-William Hill families there.

JOHN CRAWFORD HILL 7/ (SON OF REUBEN F. HILL 6/)

John Crawford Hill 7/ was born in April of 1840 in Fairfield County, S.C. He moved to Walker County, Georgia in 1853, with his step-father (Jacob Hill) and his mother. He helped Jacob Hill clear land for farming and attended school.

In 1861 he married Mary C. Howell, daughter of Gabe Howell. He enlisted in the Confederate Army (Co. K., 21st Ga. Infantry Regiment) on 21st August 1861. In the November 1861 Muster Roll, he was listed as being sick at Sudley Church Hospital in Virginia and in December he was in hospital as being sick in Culpeper, Virginia.

He came home to Walker County, Georgia in early 1864 on leave, returned to, served his time in the army and came home after being discharged in May of 1865.

The children of John Crawford Hill 7/ and Mary C. Howell were:

- a. a daughter born 1862 -died 1862.
- b. John Huston Hill 8/, born 1865 in Walker County, Georgia, died 1905 in Athens, Tennessee. He married Jane Slack, of Walker County, Georgia and they had one child, Ethel Hill 9/.
- c. Virgil Eugene Hill 8/, born August 3, 1867 in Walker County, Georgia, died in August 1950 in Oklahoma. He married Sarah M. Elizabeth Hamilton on 14 October 1894 at Checotah, Indian Territory. They had 12 children.
- d. Earl Van Dorn Hill 8/, born November 1869, died ca. 1883.
- e. Baxter Hill 8/, born 1871 in Walker County, Ga., died 1883 in Choctaw Nation, Indian Territory.

In 1874, John 7/ & Mary Howell were in Mississippi, where Mary died. In 1876 John C. Hill 7/ married a second time to Amanda Jane Anderson in Walker County, Georgia. She was the eldest child of William Anderson, who was killed in the civil war. Their children were:

- f. Claude Hill 8/, born 29 May 1877 in Walker County, Georgia, died 22 March 1932 at Muskogee, Oklahoma.
- g. Susannah Hill 8/, born 25 July 1879 in Walker County, Georgia.
- h. De Forest Hill Sr. 8/, born 22 March 1882 in Scott County, Arkansas, died 21 July 1955 at Okmulgee,

Oklahoma.

- i. James Arthur Hill 8/, born 27 July 1887.

In 1880, John C. Hill 7/, along with his family, mother and brothers Jimmie & Mathey, moved to the western part of Scott County, Arkansas, near the line of the Choctaw Nation, Indian Territory.

While living there, he was a witness in the court of Federal Judge "Hanging Judge" Parker and also was a witness at Federal Judge McGill's court at Muskogee, Indian Territory in 1899.

In 1883, he moved across the line into Indian Territory and his son Van Hill died about that time. Another son, Baxter Hill 8/ died in 1887 and in that year he moved northward into the Cherokee Nation, one half mile from Dwight Mission, a Presbyterian Indian School. Their children went to school there. He was a devout Christian and served as a Minister in the Disciples of Christ Church, leading services in Sallisaw, Vian and Marble City neighborhoods in the Cherokee Nation.

THE FAMILY OF MOSES HILL OF FAIRFIELD COUNTY, S.C.

Note: This is the family line of the writer, Robert R. Hill of Brandon, Florida.

Moses Hill was born sometimes after July 1st 1757 or in 1758, because on the tombstone of his widow, Savilla N. Roden, it states that he died on July 1st 1821 at the age of 63. His wife, Savilla N. Roden was the daughter of Thomas Roden (originally of Maryland) and wife Mary Potts. Savilla N. (Roden) Hill died in Green County, Alabama on 23rd July 1844.

The names of Moses Hill's parents as well as the origins of his family remain a mystery, even after some 15 years of researching. Based on what information that has been found we have come to think that the following conclusions are fairly accurate:

- a. Moses was not born in South Carolina and was probably a brother to Leonard Hill and a Thomas Hill, both of whom lived in the same immediate neighborhood as he did and who also served in the American Revolution as did Moses Hill. Leonard Hill later moved to Clark County, Kentucky.
- b. Moses Hill was in South Carolina by 1778 as he witnessed a Roden deed. He married Savilla N. Roden sometimes after May 1778, when she had signed as a witness to a deed by her father as Savilla Roden.,.
- c. Charles Hill Sr. 1/ of Craven County, who obtained a

1749 land grant, appears to have been the uncle of Moses Hill. In a fragment of a page from the Moses Hill bible it states that "Coz. Mary Heyll (Hill), wife of Charles C. Hill, died 27th June 1827." Since we know Charles Hill Sr. died in 1769, it has to be his son, Charles Jr. Also William Augustus Hill 2/ son of Charles Hill Sr. 1/ would be a cousin to Moses Hill.

Moses Hill served in the S.C. Militia in the Revolution a total of 120 days as a Private and his service is verified by Salley's Indents of South Carolina in Charleston. He was a Private.

After the war, it appears that Moses Hill gradually gained a high status of living by acquiring land and slaves and he was addressed as "Moses Hill Esquire." He later was a surveyor and then became a Justice of the Peace in the area around Little River, Fairfield County.

Moses Hill and his wife Savilla had the following children:

1. Thomas Hill 2/, born 1780, married Jemima Woodward ca. 1805, died between January and May of 1824 in Fairfield County. (Ancestor of writer, Robert R. Hill Sr. 6/). (Jemima is the link to the Simpson family in Fairfax Co., Va.).
2. James Hill 2/, born 21 November 1782, married Susannah Glenn (b. 24 Mar. 1781, d. 9 June 1855). James Hill died in Union County, S.C. on 27th October 1854.
3. Sarah (Sally) Caroline Hill 2/, b. ca. 1785, married Rev. John Pearson, they moved to Green Co., Ala. She died in Ala.
4. Littleton Hill 2/, born ca. 1788, died single shortly after 1810 census. Buried by his father.
5. Moses Berry Hill 2/, born in 1795, married Mary Bowles Glenn, he died October 14th, 1824.
6. Harriet Windham Hill 2/, born 5th March 1802, married Edward Pickett Mobley, she died 30th April 1857.
7. George Washington Hill 2/, born 8th September 1803, married Sarah A. Moore, they moved to Green Co., Ala., he died there on 8th September 1857.
8. Rebecca Carlisle Hill 2/, born 20th December 1807, married Dr. John Trezevant DeGraffenreid, died in Green Co., Ala. on 11th August 1842.

Note: Thomas Hill was 3rd great grandfather of Robert R. Hill of Brandon, Florida and the writer of this article. His line will be displayed in bold print.

LEONARD HILL FAMILY

It is generally accepted by several researchers that Leonard

Hill was probably a brother of Moses Hill and a Thomas Hill, all three of Fairfield County South Carolina. The evidence, while circumstantial, is quite strong and has been discussed previously by some researchers.

Evidence given to me indicates that Moses Hill was the eldest of the three brothers and Thomas Hill was the youngest. Moses Hill was born in 1757 (but after July 1st) or in 1758. Leonard Hill is suspected to have been born ca. 1760 or 1762. Thomas Hill is believed to have been born ca. 1765-1767.

Leonard Hill, like his suspected two brothers, is known to have served in the South Carolina Militia during the American Revolution. In The Comptroller General's Files, Book N, Indent 41 (AA3605), it shows that in 1781 Leonard served 90 days under General Pickens as a horseman and took part in the siege of Augusta. In the same book it shows that in 1782, he served another 60 days as a footman at Orangeburg and Four Holes Swamp. Moses Hill also served here too.

On 8th of August 1785, Leonard Hill purchased 100 acres of land from Henry Land (Fairfield Deed Book B, Page 55). This deed was witnessed by Burr Harrison, Susannah Dunford and Moses Hill. Susannah Dunford was named as the mother of three of his children in his Clark County Kentucky Will of 1825, but she was never acknowledged as his wife..

In S.C. on the 5th of January 1786, Leonard Hill received a land grant of 82 acres, adjacent to the above land but on the 26th of May 1788, Leonard sold the 82 acres of land to his suspected brother, Thomas Hill. This deed was signed by Elizabeth Hill, wife of Leonard Hill. By the time of the 1790 Census, Leonard Hill was in Fayette (Clark) County.

The life of Leonard Hill is somewhat confusing as he obviously had a wife in South Carolina named Elizabeth, as she signed the deed when they sold their land. Her name does not show up again any place else and no record of any children by her has been found. Neither she nor any children (of hers) is mentioned in the Kentucky will of Leonard Hill in 1825.

Leonard Hill's will was dated 4th July 1825 (Clark County, Kentucky in Book 6, Page 30) and proved in August of 1825. The will of Leonard Hill names Susannah Dunford as the mother of his three married daughters, Mary, Sarah and Elizabeth.

Leonard Hill named Rachel Dunford as the mother of sons John and Moses Hill. At no time does he acknowledge either Susannah or Rachel Dunford as his wives. Neither does he mentioned Elizabeth (his South Carolina wife) or any of their children (if any).

It is believed that Susannah & Rachel Dunford were sisters. Susannah is believed to have been the eldest of the two and probably died first. So far the names of their parents has not been determined.

After Leonard Hill died, the Clark County, Kentucky records show that Rachel Dunford married Jesse Hodges on the 27th April 1826 and surety was her son Moses Hill, who's father was Leonard Hill.

In the 1850 Census of Clark County, Kentucky (Page 8, dwelling # 108) Rachel Dunford is listed as Rachel Hodges, age 75, born in North Carolina. (birth ca. 1775). This information plus the wording of the will of Leonard Hill, suggest that he was not legally married to either of the Dunford (Dunsford?) women.

Kentucky land deeds and other records indicate that Leonard Hill was a well to do land and slave owner and apparently was involved in the tobacco industry and owned some warehouses.

Since Leonard's will was wrote on 4th July 1825 and proved in August of 1825 he obviously died between the two dates.

THE CONNECTING OF THE LEONARD HILL, MOSES HILL AND THOMAS HILL FAMILIES OF FAIRFIELD COUNTY, SOUTH CAROLINA TO MEMBERS OF THE CHARLES HILL 1/ FAMILY.

In 1788, Leonard Hill sold to Thomas Hill his S.C. land (82 acres) that was granted to him on 5th June 1786 and then he moved to Kentucky. Elizabeth, wife of Leonard Hill also signed the deed but she is never heard from again. Neither she nor any children by her is mentioned in Leonard's Kentucky will.

Leonard Hill "assigns forever all that plantation or tract of land, containing 82 acres, which was granted to LEONARD HILL, bearing date of the 5th January 1786 , but transferred from this LEONARD HILL to this THOMAS HILL, the 26th day of May 1788, said land situated in the District of Camden (Fairfield Co.), on waters of LITTLE RIVER, bounding on LEONARD HILL'S land and land laid out to WILLIAM MCCLINTOCK, and part on vacant land when surveyed."

Later when Thomas Hill sold this 82 acres of land, his wife Judith also signed the deed, and thus these deeds seem to connect Thomas Hill to Leonard Hill. This deed, plus the other deeds and indents helps to establish a connection between Thomas Hill, Moses Hill & Leonard Hill.

On the 27th of March 1787, Thomas Hill endorsed the Indent of Samuel Biggerstaff, which was witnessed by Moses Hill. It is believed that this was the same Thomas Hill, that witnessed with Moses Hill the Indent of Samuel Biggerstaff

and whom is known to have had a wife named Judith.

ADDITIONAL FAMILY CONNECTIONS

Now the fragment of Moses Hill's bible seems to imply that Charles C. Hill Jr 2/ was a cousin, thus his brother William Augustus Hill 2/ would also have been a cousin to Moses, Leonard & Thomas Hill. Charles Hill Sr. 1/, father to Charles Jr. 2/ and William Augustus Hill 2/, would then be the uncle to Moses, Leonard & Thomas Hill.

On the 5th of January 1792 Thomas Hill & wife Judith sold to Andrew Allen the same 82 acres of land he purchased from Leonard Hill in 1788 (originally granted Leonard Hill). (Ref: Fairfield Deed Book I, Page 35)

It has long been suspected that a Thomas Hill was the father of Moses Hill and if Leonard & this Thomas Hill (wife Judith) were brothers to Moses, then he could have been a Thomas Hill Jr.

A Thomas Hill Sr. is known to have existed in this area of South Carolina from a tax list of Fairfield District, and which stated he was "deceased in 1792." Whether he was connected to this particular Thomas Hill or not has not been determined.

Now in the Hill-Hill Mobley Book, on page 113, it refers to a sale of land (dated 1802) by a Burrill Hill of Rutherford County, North Carolina and a George Augusta (Augustus?) Hill (page 116) of Chester County, South Carolina (adjacent to Fairfield County and once part of the old Craven County).

In Fairfield County Deed Book N, Page 419, Burrill Hill of Rutherford County, N.C. sells land in Fairfield County, South Carolina to Andrew McDowell, land originally granted Charles Hill on 23rd June 1774.

Based on the date of the grant it seems that this Charles Hill had to have been Charles Hill Jr. 2/ (wife Mary) and I suspect that Burrill Hill 3/ was a son to this Charles Hill 2/, and Charles 2/ had probably died by this time & Burril 3/ had inherited the land or Charles 2/ had sold the land to Burrill Hill 3/.

The interesting thing here is that a Burwell (sic) Hill of S.C. sold some Virginia land to a Thomas Hill of Surry County, Virginia. (This provided to me by Mr. Brent Holcomb when he was researching for me in 1985).

On the 20th day of January in the year of our Lord, 1790 a deed between BURRELL HILL of Rutherford County, North Carolina, planter of the one part, and ANDREW MCDOWELL of Fairfield County and State of South Carolina of the other

part, for the sum of TWO SHILLINGS, current money of the state, paid by the said ANDREW MCDOWELL, deeds over 100 acres in Fairfield County "it being a certain tract of 100 acres of land lying and being on WATEREE CREEK in Fairfield and State of South Carolina "land originally granted unto the said CHARLES HILL, by his Excellency, WILLIAM BULL, Governor in Chief, and recorded in the Secretaries Office, BOOK 222 (or LLL?? not clear) page 598, dated 23 June 1784."

The date of the grant shows that it was Charles C. Hill Jr. 2/ who received the grant and Burrill Hill 3/ probably inherited it from his father, Charles C. Hill Jr. 2/.

Now based on the above information, it appears Charles C. Hill Jr. 2/ (wife Mary) was a cousin to Moses, Leonard & Thomas Hill and the children of Charles 2/, including George Augustus Hill 3/ & Burrill Hill 3/, were 2nd cousins to Moses, Leonard & Thomas Hill of Fairfield County.

Mabry Hill 3/ & Richard Hill 3/ (wife Agnes) and sons of William Augustus Hill 2/, who made a deed out to Jane Rogers, would also be cousins to Moses, Leonard and Thomas Hill.

THOMAS HILL 2/, SON OF MOSES HILL 1/.

Thomas Hill 2/, son of Moses Hill & Savilla Roden, married Jemima Woodward, daughter of Rev. William Woodward & wife Nancy Elizabeth Barrett. They were the 3rd paternal great grandparents of the writer, Robert R. Hill, of Brandon, Fla. Thomas & Jemima Hill had the following children:

1. Nancy Barrett Hill 3/, b. 4th June 1806 in Fairfield County, S.C. She married 1st Edward Mabry Mobley and moved to Alabama via way of DeKalb Co., Georgia. They had 8 children. She remarried 2nd time in Greene County, Alabama to William Price on 27th July 1848, they had a daughter, Jemima Ann Price 4/, b. ca 1849. Her 3rd marriage was to James H. Sims on 4th November 1853, no children. James dead by time of 1860 Census Nancy alive in 1860 Census but then disappears.
2. Charlotte Louise Hill 3/, b. 8th August 1809 in Fairfield County, S.C. She married Moses Cockrell and they moved to Noxubee County, Miss. They had 5 children. Charlotte died 28th October 1864, buried by husband in the Soule Methodist Churchyard in Noxubee Co., Miss.
3. Jemima Hill 3/. (no data available).
4. Nathaniel Barrett Hill 3/, born ca. 1811, m. Judith Eliza Stewart ca. 1835-1836, died in New York on December 13th, 1854, He was brought back to Charleston, S.C., but burial location not known. They were 2nd great grandparents of Robert R. Hill.
5. William Woodward Hill 3/, married cousin Mary Glenn Hill, daughter of Moses Berry Hill 2/.

6. Savilla Hill 3/, married Greenberry Mobley, they moved to Greene & then Sumter Co., Alabama. Had 3 children.
7. Moses Hill 3/, said to have moved to Pickens Co., Ala.
8. Thomas Hill 3/.

Nathaniel Barrett Hill 3/, moved to Columbia, S.C. He was part owner of a firm known as "Stalker & Hill." He and his partner, Gilbert Stalker, operated a steamship line that made runs between Charleston and Columbia. He was sheriff of Richland County, S.C. between November 1849 and April 1853, when he resigned in order to go to New York as a banker. He died in New York City on 13th December 1854. Wife was named Judith Eliza Stewart. Children:

1. Woodward D. Hill 4/, m. Sally Elizabeth Rucker. He was a Civil War veteran, taught school after the war and lived about 15 miles southeast of Columbia in an area known as Sandy Run. They were great grandparents of Robert R. Hill.
2. William Stewart Hill 4/, m. Mary Jane Mobley McCory. He served in CSA, taken prisoner at Chickamauga but survived the war.
3. Eliza M. Hill 4/, m. Henry C. Nunnemaker.
4. John Hill 4/, civil war veteran, was killed in Petersburg, Va.
5. Lawrence Barrett Hill 4/, drummer in CSA, moved to Mississippi, married twice and died there ca. 1918-19.

Note: All four sons served in 7th S.V. Volunteers, Inftry, Co. "C."

Woodward D. Hill 4/ settled in an area of South Carolina about 15 miles southeast of Columbia, called "Sandy Run." He had become involved in a fight with some Yankee Soldiers and was running to keep from being arrested. He reached the farm of William Rucker and was hid from the authorities. He later married the daughter of William Rucker and they had 9 children, all born in Lexington County, S.C. This part of Lexington County became Calhoun County in 1919. The children were:

1. Emma Cornelia Hill 5/, born 14th February 1868 in the Township known as Sandy Run, located in Lexington County, S.C. (later Calhoun County). She married John Victor Bates ca. 1887-1888. Emma Hill Bates died on 28th September 1940 in the town of North, South Carolina.
2. Sally Elizabeth Hill 5/, born 18th February 1869 in Sandy Run, S.C., married ca. 1898 to Ansol Price Dannelly. They moved to Statesboro, Ga., where she died ca. 1918.

3. Nathaniel Barrett Hill 5/, known as "Barrett." He was born on 8th October 1871 in Sandy Run, S.C., married Mary Elizabeth Geiger. He died as a result of a logging accident on 1st April 1927 in a Columbia, S.C. Hospital. He is buried in the Elmwood Cemetery in Columbia, S.C.
4. Peter Joseph Hill 5/, grandfather to Robert Hill, the compiler of this data. He was born on 31st October 1874 in Sandy Run, S.C., married Mary Jane Rickenbaker on 28th December 1900. He died near St. Matthews, S.C. ca. January 1907. He is buried in the church yard of the Congaree Baptist Church in today's Calhoun County, S.C.
5. James Franklin Hill 5/, born 13th January 1878 in Sandy Run, married 13 January 1903 to Essie Isota Furtick, he died 21st March 1950, buried in the Church yard of the Oak Grove Methodist Church at Sandy Run.
6. William Woodward Hill 5/, born 14th May 1880 in Sandy Run, married 21 April 1910 to Rosa Belle Meetze. He died in Columbia, S.C. on 20th June 1957, buried in Elmwood Cemetery in Columbia, S.C.
7. Susan Hill 5/, born 15 April 1883 in Sandy Run, known as "Sooney" to family, she married Charles Saylor. She died in Columbia, S.C. on 16th March 1947, and is buried in Oak Grove Methodist Church yard in Sandy Run.
8. Beulah Lee Hill 5/, born 19th January 1886 in Sandy Run, married Edward K. McQuatters on 25th December 1907 in Columbia, she died in Hampton, Virginia on 13th August 1970.
9. Michael (Mike) Hill 5/, born 1st October 1889 at Sandy Run, never married, she died 15th January 1969, buried in Oak Grove Methodist Churchyard at Sandy Run.

Peter Joseph Hill 5/ & Mary Jane Rickenbaker had three children, Nolton Raymond Hill Sr. 6/, Gertrude Hill 6/ & Flora Dell Hill 6/.
