Note by Robert Hill: While in the book the name is called "Hills" it appears to be for the Hill family.

LEONARD HILL 7/

Joseph Hill 1/, had a son named Samuel Hill 2/. He had a son named Samuel Hill 3/, who had a son Samuel Hill 4/, who had a son Samuel Hill 5/, who had a son named John Hill 6/. John Hill 6/ had a son named LEONARD HILL 7/ (7th known generation).

Leonard Hill 7/ was born on the 6th of September 1791 at Smithfield, Providence County, Rhode Island He died at Hill's Factory, Spartanburgh County, South Carolina on the 19th of September 1840.

Leonard Hill 7/ married Harriett Lapham, daughter of James & Jemima Lapham). She was born on 21st of July 1794 and died on the 27th of December 1873.

Leonard Hill 7/, along with John Clark, who had married Leonard's cousin Mary Hill 7/, and two others (not named) emigrated from Rhode Island in 1816 to the Tiger River in Spartanburg County, South Carolina.

Leonard Hill's 7/ cousin, Mary Hill 7/, was the daughter of George Hill 6/; Samuel 5/; Samuel 4/; Samuel 3/; Samuel 2/ and Joseph Hill 1/.

After Leonard Hill and John Clark reached South Carolina, they erected a cotton mill, which was among the first factories in South Carolina. By 1825 the other partners had sold out to Hill & Clark. In 1830 Clark sold to Leonard Hill 7/ and later, after Leonard's death, the family interest was purchased by his sons. "Hill's Factory is doubtless the location in Spartanburg County that is now called "Hillsville.",

- daughter of Richard & Susan Duggon. She died at Hill's Factory in January of 1883. They had nine children.
- 2. William Hill 8/, born 22nd December 1816 Spartanburg County, S.C., died 13th June 1818.
- 3. Almira Hill 8/, born Spartanburg County, S.C. on 22nd February 1819, died 13th August 1881. She married Levi Morgan; 2nd marriage to James M. Littlefield.
