- BAYLOR HILL, birth & death dates unknown, was a Captain in Virginia Unit, received bounty-land warrant (application 249) on 3 May 1800 for 300 acres.
- 2. CLEM HILL, birth & death dates unknown, soldier in Virginia Unit, married Mary Duglass? pension application 10106, submitted by widow.
- 3. GEORGE HILL, soldier in Continental Line (a Virginia Regiment), married to Hannah----? pension application 4987 submitted by widow; received bounty-land warrant (appl. 614) for 100 acres.
- 4. GEORGE HILL, dates unknown. was a private in Virginia unit; received bounty-land warrants (appl. 12178 and 13236) 19th June 1793 for 100 acres.
- 5. GEORGE HILL, dates unknown, soldier in Virginia Unit, pension appl. 41642 was submitted by himself.
- 6. HENRY HILL, born 17 October 1743, died 12th September 1815, Captain in a Virginia Unit; married to Ann Powell. (See notes at end of list).
- 7. HENRY HILL, dates unknown, soldier in Virginia Unit, appl. 41639 submitted by himself.
- 8. HUMPHREY HILL, dates unknown, soldier in Virginia Unit; pension appl. 5530 submitted by himself.
- 9. JAMES HILL, born January 1750, died. 1781, was a Captain in a Virginia Unit, was married to Sarah Williams.
- 10. JAMES HILL, born 3 December 1745, died 9 April 1854, 2nd Lieutenant in a Virginia Unit, married to Mary \_\_?
- 11. JAMES HILL, born June 1758, died 18th June 1831, Sergeant in a Virginia Unit, married to Anne-----?
- 12. JAMES HILL, dates unknown, soldier in a Virginia Unit, pension appl. 38029 submitted by himself.
- 13. JOEL HILL, born 1734, died 1834, soldier in a Virginia Unit, married to Priscella Bell.
- 14. JOHN HILL, born ca. 1740, died after 4th December 1812, served in Virginia; married to Mary \_\_\_\_\_?; pension appl. 19770 submitted by his widow.
- 15. JOHN HILL, dates unknown, soldier in Virginia Regiment of the Continental Line; married to Nancy-----?; pension appl. 3814 submitted by his widow.
- 16. JOHN HILL, dates unknown, soldier in Virginia Unit, pension appl. 5536, submitted by himself.

- 22. RICHARD HILL, dates unknown, soldier in a Virginia Unit. Appl. 5528 submitted by himself.
- 23. RICHARD HILL, dates unknown, soldier in Virginia, Pension appl. 5008 submitted but rejected.
- 24. ROBERT HILL, born 10th March 1750, died 28th July 1833, orderly sergeant in a Virginia Unit, married to Margaret Vawter.
- 25. ROBERT HILL, born 1745, died 1783, private in a Virginia Unit, married to Mrs. Priscilla Bowen Gaddes.
- 26. ROBERT HILL, born ca. 1750-60, died before 16th November 1818, Private in Virginia Unit, married (1st) wife's name unknown, (2nd) Rebecca Bailey, and (3rd) to Miss Phinney.
- 27. ROBERT HILL, born 5 February 1758, died 15 January 1822, Private in a Virginia Unit, married to Rebecca Caldwell.
- 28. ROBERT HILL, dates unknown, soldier in a Virginia Unit, Appl. 38833 submitted by himself.
- 29. ROBERT HILL, dates unknown, soldier in Virginia Unit, pension appl. 13390 submitted by himself.
- 30. SIMON HILL, dates unknown, soldier in a Virginia Unit. application 41644 submitted by himself.
- 31. SPENCER HILL, born 26 February 1762, died 8th October 1852, Private in a Virginia Unit, married (1st) Mary Denny and (2nd) to Mary Rutherford. (NOTE: IS HE RELATED TO THE THOMAS HILL WHO MARRIED DIANA SPENCER IN PHILADELPHIA, PA IN 1756? Later research indicates no.
- 32. THOMAS HILL, born 1752, died after 1800, Major in Virginia Unit, married to Sally Mayson (Mason??)
- 33. THOMAS HILL, born ca. 1750, died after 15 January 1827, ensign in a Virginia Unit, married to Alianna\_\_\_\_?
- 34. THOMAS HILL, born 17 March 1763, died 22 May 1848, soldier in Virginia Unit, married to Mary Stone.
- 35. THOMAS HILL, dates unknown, Major in a Virginia Unit, received land-bounty warrant (appl. 1067) for 400 acres.
- THOMAS HILL, dates unknown, soldier in Virginia unit, bounty-land warrant (appl. 1429) issued 6th December 1828 for 100 acres to James Hill assignee.
- 37. VIOLETT HILL, (FEMALE), born ca. 1725, died 12th August 1803, did patriotic service in Virginia, married to Robert \_\_\_\_\_\_?
- 38. WILLIAM HILL, born 1740, died April 1812, private in a Virginia Unit, married to Mary Jane Wood.
- 39. WILLIAM HILL, born ca. 1740, died 1812, Private in a Virginia Unit, married to Ann Davis.
- 40. WILLIAM HILL, born 12 April 1759, died 14 March 1841, Private in a Virginia Unit, married to Sarah Cowins.
- WILLIAM HILL, dates unknown, private in Virginia Unit, bounty-land warrant (appl. 12241) issued 7th January 1793 for 100 acres to Robert Means, assignee.

- 42. WILLIAM HILL, dates unknown, Private in a Virginia Unit.
- 43. WILLIAM HILL, dates unknown, soldier in Virginia, married to Anna \_\_\_\_\_?; pension appl. (2939) submitted by widow.
- 44. WILLIAM HILL, dates unknown, Virginia soldier, pension appl. (5529) submitted by himself.
- 45. WILLIAM HILL, dates unknown, Virginia soldier, pension appl. (5531) submitted by himself.
- 46. WILLIAM HILL, R-5016 (N.C. Service) covers the application of a Richard Hill, a son, living in 1857 in N.C. Richard states his father, William Hill, was born in Southampton County Virginia, but resided in Surry County, N.C. when he entered service. States William died in 1840 at age 100, (b. ca. 1740) his widow died in 1846. Another unknown source says he was born on Merherrin River in Northampton County, Virginia.
