1. ELIZABETH HILL married Thomas Thompson in 1682 in  
Middlesex County Virginia.

SOURCE: Following from Mr. Gordon H. Meadors of Jackson,  
Miss.

2. AARON HILL, married Margaret Chepell in Henrico County  
Virginia, (Va. Henrico County Monthly Meeting Quaker  
Records) shows Aaron Hill of Perquimans N.C. married  
Margaret Chepel, of Prince George County, Maryland. Did  
the marriage take place in Henrico County Virginia????  
Mr. Meadors did not give a date but is believed to be  
about 1735-36, based on birth of 1st child Huldah. The  
children of Aaron & Margaret were Huldah Hill, born  
18th September 1737 and William Hill, born 31st January  
1740. Margaret (wife of Aaron) died, and Aaron  
remarried Miriam Hill (must have been a cousin). Their  
children were: Mary Hill, b. 1746, MOSES HILL, b.  
16th September 1748, died 22nd November 1760, Aaron  
Hill, b. 1752, Miriam Hill, b. 1754, Jacob Hill. b.  
1756, Jesse Hill, b. 1758, and Thomas Hill, b. 1760.  
It appears that Aaron Hill might be originally from  
Maryland. This family lived in area of  
PERQUIMANS, CHOWAN AND PASQUOTANK COUNTIES IN N.C.

(NOTE BY ROBERT HILL.....See my Data titled NC.024 "A Quaker  
Hill Family," on NC Disk Number 2. This Aaron Hill was a son  
of William Hill Jr., (b. ca. 1680 Perquimans Co., N.C., and  
who in turn was the son of William Hill Sr. (b. ca. 1655 in  
England). William Hill Sr. came first to Virginia, then to  
the eastern shore of N.C., along the Pimlico Sound in  
Perquimans Co., N.C. My question is, I wonder if this family  
is in any way related to the Hill Quakers, of Maryland with  
same given names.

I have a will of a MOSES HILL (of Md.) who names brothers  
JAMES HILL, AARON HILL, and SAMUEL HILL. I have wondered if  
the above Aaron Hill is in any way connected to the above  
Maryland Hills?

3. Elizabeth Hill, daughter of Leonard Hill of King  
William County Virginia, married George Seaton in 1734.  
Reference VOLUME 25 Virginia MARRIAGES, page 432.

4. Leonard Hill married Sarah Thacker of Middlesex County Virginia on 4 October 1752. VOLUME? 1 Virginia page 119

The figure after names tells what generation he belongs.

5. Robert Hill 1/, who immigrated into Isle of Wight County ca. 1642, married Mary Webb in England. He is the Patriarch of the large Hill Family often referred to as the "SURRY COUNTY HILLS" of Virginia. Had several children but only two known by name, Sion Hill 2/ and Robert Hill 2/. (Ref. Family Charts I made from Book " Southside Virginia Families," Vol. 2, by Boddie).
6. Sion Hill 2/, (1654-1705) of Virginia and son of above Robert Hill 1/, married 1st Elizabeth Green ??? or Marriott (questionable), 2nd to Elizabeth Smith Spiltimber, widow of John Spiltimber and possible daughter of Nicholas Smith. (Ref. same as above).
7. Robert Hill 3/, (1678-1765) known as Robert Hill Jr., son of Sion Hill 2/, moved to what was then Bertie County, N.C., later known as Northampton, Edhecombe & then Halifax Co., N.C., married to Tabitha (West?) ca. 1705. Children were: Sion Hill 4/, Green Hill 4/, Abner Hill 4/, Thomas Hill 4/ (1715-1789) m. Sarah Etheridge, Tabitha Hill 4/ (b. 1724 m. ca. 1747 to David Chapman Sr., Agnes Hill 4/ (b. ca. 1729 m. Charles Arrington, she died ca. 1797 in Chatham Co., N.C., Lewraina Hill 4/ m. William? Arrington, Ann Hill 4/ b. ca. 1718 m. John Steed Sr. in 1734, Milbry Hill 4/ m. Matthew Gibbs (they moved to Craven County S.C.), Mary Hill 4/ m. William Bryant and William Hill Sr. 4/ m. Charity Lewis.
8. Sion Hill 4/, (ca. 1709- ), son of Robert Hill 3/. Little is known of him except he is thought to have been the eldest child and son.
9. Thomas Hill 4/, (1715-1789) son of Robert Hill 3/, m. Sarah Etheridge. Thomas Hill 4/ lived in Halifax County N.C. Their children were Thomas Hill 5/ m Elizabeth Gardner, Henry Hill 5/ m. Winifred Alston, Benjamin Hill 5/ m. Mary Wooten, Robert Hill 5/ m. Martha Johnson, Mary Hill 5/ m. Edward Jones, Elizabeth Hill 5/ m. a Jones, Anna Hill 5/ m. (Author) Long, Fanny Hill 5/, m. a MacNeal, Sally Hill 5/ m. Henry Alston, and Richard Hill 5/ m. FRances -- ?.
10. William Hill Sr. 4/, son of Robert Hill 3/, born ca. 1731 in Bertie County, N.C. He has been said by researchers to have married Elizabeth Clanton & 2nd to a widow, Lydia White Jones in Georgia, which both are

wrong. He married Charity Lewis, dau. of Richard Lewis & wife Ann. They were the parents of Lewis Hill 5/ (m. Rebecca Watkins; Richard Hill 5/, m. Lydia Watkins; Sion Lewis Hill 5/ m. Drucilla Lane; William Clanton Hill (Jr.) 5/, who's wife was Sarah Branch, Henry Hill 5/ m. Agnes Fike, Enoch Hill 5/, m. 1st Martha Brantley; 2nd her sister, Sarah Brantley. William Hill Sr. 4/ married Charity Lewis ca. 1753. Some say that he is the William Hill that died in Jasper County, Georgia ca. 1808-09 but this appears to be wrong. One of his sons was William Clanton Hill 5/, who in HIS 1803 will, he makes a provision for wife Sarah Branch and his "Aunt Lurancy Hill 4/. In that will William C. Hill 5/ names his children as Martha Hill 6/, James Hill 6/, and Henry Hill 6/ (they being the grandchildren to William Hill Sr. 4/ & the great grandchildren to Robert Hill 3/ & wife Tabitha). In 1812 the three children were in Williamson Co., Tenn.

11. Sion Hill Jr. 3/, son of Sion Hill 2/. (1682-1766)  
Information on him is scarce. He is said to have married twice, 1st wife Elizabeth Marriott (1682-17--), daughter of Mathias Marriott. (Ref. 1709 Will of Mathias Marriott, Surry County, Va.). His 2nd wife was said to be Hannah Green? (Marriage info questionable).
12. Richard Hill 3/, (1684-1723), son of Sion Hill 2/, married Hannah Briggs ca. 1713. She was the daughter of Henry Briggs. Children were: Green Hill 4/, (1714-1769), Mary Hill 4/, (ca. 1716-17--?) m. William Malone and had children, John Hill 4/ (ca. 1718-1765) m. Mildred Gilliam ca. 1742, dau. of John Gilliam. They had 10 children, Richard Hill 4/ m. Margery Gilliam. (Ref. Family Charts made by me from "Southside Virginia Families," Vol. 2, by Boddie).
13. Captain Thomas Hill 3/, (1686-1737) son of Sion Hill 2/ and 2nd wife, married Priscilla Gray, daughter of Capt. Thomas Gray, and had children named below but not verified:
14. Michael Hill 3/, (1688-1755). He was son of Sion Hill Sr. 2/, son of Robert Hill 1/. Michael Hill 3/ may have been previously married but not certain. He is known to have been married to (2nd?) Elizabeth Mitchell, daughter of John Mitchell. He is known only to have had a son, Michael Hill Jr. 4/, b. 20 February 1721 (Bristol Parish Register, page 312). Michael Jr. 4/ was married to Susannah Cook (ca 1740), daughter of William Cook. Their known children were Elizabeth Hill 5/, (born 18 July 1743, d. 28 Sept. 1758; Anne Hill 5/, (b. 27 April 1746). (Ref. same as above).
15. Benjamin Hill 5/, son of Thomas Hill 4/, son of Robert

Hill 3/ & wife Tabitha. Benjamin 5/ was born 13 Dec. 1761 in Halifax County N.C. and died ca. 1851 in Green County Alabama). He was son of Thomas Hill 4/ (listed as # 9). Benjamin Hill 5/ married Mary Wooten (1750-1808) on 28th Nov. 1787 in N.C. (Ref: Hill/Lynn History (1976) by Jessie Lynn Bell). Children mentioned in will: Wooten Hill 6/, Sherwood Hill 6/, Berry Hill 6/, ( b. 7 Feb. 1807 in Johnston Co., N.C. and died 23 Sept. 1888 in Caddo Parish, La. Berry Hill 6/ married Elizabeth Reach ( 19 Jan. 1807-26 Jan. 1885) and had nine children, including John Berry Hill 7/, b. 1833. James Hill 6/, Jesse Hill 6/ and Mary Hill 6/ m. John Moore. (Ref. Charts made by me from "Southside Va. Families," Vol 2 by Boddie).

16. John Berry Hill 7/, son of Berry Hill 6/, ( b. 1833-Green Co., Ala. d. Caddo Parish, La.) married Rachel Lucy Wynne Ridgeway (b. 26 June 1836-d. 15 Feb. 1918) in Mansfield, La. Child: Mary Jane Hill 8/, married Douglas Fair Roach. (Ref. Roberts/Ridgeway & Roach (1951) by Fair).
17. Green Hill 4/, (1714-1769) son of Richard Hill 3/ of Surry County Virginia. He moved to what was then Bertie Co., N.C., later becoming Northampton County, N.C. Green Hill 4/ married Grace Bennett in 1739, daughter of William Bennett. Their children were: Henry Hill 5/, Green Hill Jr. 5/, Bennett Hill 5/, Hannah Hill 5/, William Hill 5/ (not the one b. 1710 in Caroline Co., Va), Mary Hill 5/, Sarah Hill 5/, Elizabeth Hill 5/ and Temperance Hill 5/. (Ref. Charts made from "Southside Va. Families," Vol. 2, by Boddie).
18. Mary Hill 4/, (ca. 1716-17--?) daughter of Richard Hill 3/, married William Malone. They had children. (Ref. Southside Va. Families, same as above).
19. John Hill 4/, (ca. 1718-1765) son of Richard Hill 3/, married 1742 to Mildred Gilliam, dau. of John Gilliam of Sussex County, Va. and had the following ten children: Mary Hill 5/ m. Sturdavant; Sally Hill 5/, m. a Green; Anne (Parish Records) or Nancy Hill 5/, m. a Williams; Burrell Hill 5/ died prior to 1796; Elizabeth Hill 5/, m. a Spane; John Hill Jr. 5/; Tabitha Hill 5/ m. a Webb; Susanna Hill 5/ m. Richard Horn on 28 October 1791; Lucy Hill 5/ m. Joel Newman in 1783 and died prior to 1823, probably in Person County, N.C.; Rebecca Hill 5/, m. Shadrick Horn on 3 September 1795 in Sussex County, Va.
20. Captain Richard Hill Jr. 4/, (1720-July 9, 1775) son of Richard Hill 3/, married Margery Gilliam (1726-178-?), dau. of William Gilliam. Their children were: Sarah

Hill 5/, (1743-ca. 1813) m. 1st to Wm. Ruffin, 2nd to James Smith (no children); William Gilliam Hill 5/, (1746-1764); Hahhah (Hannah?) Hill 5/, 1748-17--?) m. Ephraim Parham; Green Hill 5/, (1752-- ?); Richard Hill 5/, (1754---?); Thomas Hill 5/ (1757---?); Mary Hill 5/ (1760-1761); Henry & Howell Hill 5/ (TWINS) (1762-1763??) it is unknown if both twins died 1763 or which one?; William Gilliam Hill 5/, (1765-----) and Rebecca Gilliam Hill 5/, (1768----?), married Nicholas Long.

21. Allen Hill 5/., (b. 27 Dec. 1769 in Pittsylvania, Co., Va., d. 21 Sept 1857 Medon, Tenn.), son of Thomas Hill, of Attleboro, Mass. and Mary Hamlin, (Hamblen? Hamblin?) ...Allen Hill was 5th generation and married Sarah Garrett in 1795 (b. on 22 Feb. 1771- d. on 4 Nov. 1856). He moved to vicinity of French Broad River Tenn. (Ref. Family Group Sheet by Josephine (Hill) Adams, 331 Glen Arms Dr., Danville, Ca. 94526).
22. Lurane (Rainey) Hill 5/, sister of Allen Hill, she married 29 October 1792 in Pittsylvania County, Virginia to George Hanks. (Ref. Family Group Sheet by Josephine (Hill) Adams, 331 Glen Arms Dr., Danville, Ca. 94526).
23. Joseph Hill 5/, oldest child of Thomas Hill 4/ and Mary Hamlin and brother of Allen and Lurane Hill (above), born in ca. 1752 in Pennsylvania but married in Pittsylvania County Virginia on 14 Sept. 1785 to Sara Wildon. (Ref. Family Group Sheet by Josephine (Hill) Adams, 331 Glen Arms Dr., Danville, Ca. 94526)
24. Thomas Hill married Polly Branscomb on 13th November 1816 in Greensville, County Virginia. (Reference "Virginia Marriages, page 255, Arthur's name not given).
25. Thomas Hill married Elizabeth Gray on 3rd August 1731 in Spotsylvania County Virginia. (Virginia Marriages, page 552, Arthur's name not given).
26. Abner Hill married Sarah Parham on 1st January 1794 in Brunswick County, Virginia.

Walker (b. 7 March 1692). James was a physician in King & Queens County Virginia. He married Anne Hill (daughter of Leonard Hill) before 25 March 1725. Proven by record of that date in Essex County Virginia.

JOHN HILL SR. BORN ca. 1745 (Maryland?) DIED 1808 in Clark Co., Ky. married 1st Lucy Luck (B.CA.1748-D.1771), daughter of Samuel and Mary Luck of Hanover County Virginia. 2nd marriage to Elizabeth (?) (B. CA. 1750-D. 1825 in Clark Co., Ky).

1. Garland Hill (b. 11 March 1771 in Virginia, (d. 19 Feb. 1852 at Taylorsville, ILL. (Christian Co.). Married 1st time to Phoebe Samuel on 14 December 1793, in Caroline Co., Va. (dau of James Samuel and wife Sarah, who later removed to Caswell Co., N.C: 2nd marriage to Elizabeth Wade on 4 Sept. 1801, in Caswell Co., N.C. (She d. by 1809): 3rd marriage to Eda Tooll in Clark Co., Ky. on 3rd June 1809.

#### CHILDREN OF JOHN HILL SR. BY 2ND MARRIAGE:

2. William Hill (b.ca. 1775 in Virginia, was dead by 9 Jan. 1827 in Clark Co., Ky. He never married.

3. John Phillip Hill (b. ca. 1778 in Virginia, d. Dec. 1835 in Todd Co., Ky. He married 1st. Elizabeth Marshall on 4 Jan. 1801 in Clark Co., Ky. She d. by Nov. 1814. 2nd marriage was to Malinda Marshall, his former sister in law, they married in Fayette Co., Ky. on 23 Dec. 1814. She d. by Sept 1821 in Todd Co., Ky. 3rd marriage to Mrs. Elizabeth (Trabue) Ingram on 3rd Dec. 1821 in Logan Co., Ky. (widow of Wm. Ingram) 4th marriage to Winniford Browder in Logan Co., Ky. on 6th Oct. 1834. (The above Marshalls were descended from the Marshall Family of Isle of Wight County, Virginia and the Simpson Family of Richmond County, Va.).

4. Daughter Mary Hill (b. 15 June 1780 in Va., d. 12 Dec. 1859 in Monroe Co., Ind. She married Richard Empson ( b. 25 Sept. 1777-d. 8 June 1845 in Monroe Co., Ind.) on 14 Jan. 1801 in Clark Co., Ky.

5. Daughter Nancy Hill (b. ca. 1782 in Virginia, married Nathan Martin in Clark Co., Ky. on 10 Nov. 1802. They removed to Todd Co., Ky in 1819.

6. Daughter Elizabeth Hill (b. ca. 1784 in Virginia, married 15 Aug. 1804 to Josiah Ashley in Clark Co., Ky. Date of her

death unknown.

- a. dau. Lucy Ashley b. 1808 in Clark Co., Ky.,  
married 9 Aug. 1824 to General Thomas Hart in  
Clark Co., Ky, a brother of Joel Hart, the  
famous sculptor.

7. Daughter Lucy Hill (b. ca. 1787 in Virginia, married 30  
March 1808 to Hudson Clark in Clark Co., Ky. They lived in  
Madison Co., Ky.

Note by Robert Hill Jr: Reference to above Clark County  
Kentucky Info... In Volume 5, page 339 of "The Abridged  
Compendium of American Genealogy" located in Columbia S.C. at  
the South Carolinian Library it states:

A Horace Buckner Hill, a banker of Louisville, was the son of  
Leonard Hill and Elizabeth Hill. Horace Hill married Susan  
Talbot Oldham.

Now there was a Leonard Hill with a wife Elizabeth in  
Fairfield District, South Carolina, prior to 1788. He fought  
in the American Revolution in S.C. and later this Leonard  
Hill moved to Kentucky (Fayette County, later Clark County)  
and was in the Kentucky 1790 Census of Clark County. He sold  
his S.C. land (82 acres) in 1788 to a Thomas Hill and wife  
Judith. Both Leonard & his wife Elizabeth Hill signed the  
Bill of Sale, dated 26th May 1788. It is believed that  
Leonard was a brother of Moses Hill, also of Fairfield  
District S.C. and either a brother or the father of the  
Thomas Hill, who bought his S.C. land. (This has not yet  
been proven).

The Thomas Hill, with wife Judith, later purchased land in  
Fairfield County, S.C. that was originally granted to a  
Charles Hill, who left the land to his son William Augusta  
Hill, who then left it to his son Richard Hill (wife Agnes),  
who sold it to a Jane Rogers, a spinster. Jane Rogers then  
sold it to a Shadrick Knowland. Knowland in turn sold it to  
Thomas Hill (wife Judith). One wonders if these Hills are  
somehow related?

5. Joseph Lane Jr. married Elizabeth Hill. (no other data given). Joseph Lane was related to the notable Joel Lane family of Wake County, N.C., who was a brother to Major Sam Lane, both sons of Richard Lane (from England and who drowned at sea) and Alice (Carter) Lane.

Michael Hill 4/ was son of Nathaniel Hill 3/, who was a son of Isaac Hill 2/, who died 1710 in N.C. Isaac Hill 2/ has been said by some sources to have been a son of Adam Hill 1/ of London but this has not been proved.

10. Peter Evans Smith, b. 20 January 1829, married Rebecca Whitmell Hill, daughter of Whitmell John Hill and sister of Thomas N. (Norfleet?) Hill.

HILL MARRIAGES IN GUILFORD COUNTY, N.C. (1771-1840)

2. Joseph Hill, son of Thomas Hill & Mary Marshall, married Francis Woodley (daughter of John Woodlee, and granddaughter of immigrant Andrew Woodlee).
3. Ann Marshall, another daughter of Humphrey Marshall married Henry Applewhaite. [One source thinks this was Henry Applewhaite Hill but I believe Applewhaite is the last name of husband and not Hill]. She was the sister of Mary Marshall, who married Thomas Hill. (Perhaps they had a son

named Henry Applewhaite Hill?).

4. Mary Hill, daughter of Joseph Hill & Francis Woodley, (#2) married her cousin Henry Hill, who apparently was the son of her uncle Thomas Hill (Jr.) the son of Thomas Hill (Sr.) & Mary Marshall (listed as # 1).

5. Joseph Hill (Jr.) son of above Joseph Hill & Francis Woodley, married Martha -----?

6. ELIZABETH HILL, daughter of Joseph Hill & Francis Woodley, married John Harrison. Elizabeth was daughter of John Woodley (son of Andrew) and a sister to Frances Woodley (Woodlee) who m. Joseph Hill. Joseph Hill was son of Thomas Hill Sr. (son of John Hill Sr.) & his wife Mary Marshall, daughter of Humphrey Marshall.

7. John Harrison & wife Elizabeth Hill (above) had a daughter Elizabeth Hill Harrison who married Andrew Woodley, grandson of Thomas Woodley and son of John Woodley Sr.

1. EDWARD HILL, of Elizabeth City County, who died 15 May 1624 was married to the daughter (?) of Richard Boyle, of London, England. He had a brother John Hill, merchant in Lombard Sterrt, (Street?) London.

2. CAPTAIN THOMAS HILL, his widow, ELIZABETH, married Colonel Thomas Bushrod, of York County, 1664.

3. JAMES HILL, Private in the Revolution, married Mildred Clopton, daughter of Reverend Reuben Clopton. Issue: James (see No. 4); John (see No. 5); Thomas; Parker; Nathaniel (see No. 6); William (see No. 7); Robert (see No. 9); Elizabeth (see No. 17); Judith (see No. 18); and Mary (see No. 19).

4. JAMES HILL (JR), son of Number 3, married 21 December 1787 to Sally Graves.

5. JOHN HILL (son of Number 3) married ??? had following children: Sallie Hill m. Alexander Rine; Mildred Hill m. Baylor Walker; & Robert Hill who m. a widow Waller and moved to Alabama in 1837.

6. NATHANIEL HILL (son of Number 3) married Elizabeth Clopton.

7. WILLIAM HILL (son of Number 3) married Catherine

Claiborne.

8. OCTIVIA HILL, daughter of Captain William Hill (Number 7) married Doctor John S. Lewis. Issue: Josephine m. Lt. J.C. Baytop, of Gloucester County; Lavinia m. Doctor C.T. Whiting of Norfolk Virginia; Nora m. F.M. Elphinston, of Newark, New Jersey; Doctor J. Rowland m. Nannie Robinson and Herbert Iverson m. Mattie Parke.

9. ROBERT HILL (son of James Hill Number 3). Robert died in 1844. Was married to Harriet Herbert Claiborne, sister of Judith Brown Claiborne, who married his brother Captain William Hill (number 7). His children were: William (see No. 10); Robert (see No. 11); Mary B.; Mildred; & 5 other, all deceased and unknown.

10. WILLIAM HILL (son of Robert Number 9) married Elizabeth Johnson, daughter of Colonel William Christopher Johnson. Their children were: Clairborne Johnson Hill; Robert Christopher Hill; & James Hill.

11. CLAIBORNE JOHNSON HILL (son of William Hill, Number 7) Major in Confederate Army. Married Susan Ann DeFarges, daughter of John Farges and Adline Neale. He was the 3rd one with this name.

12. ROBERT CHRISTOPHER HILL (son of William Hill, Number 7) married Cornelia Todd Littlepage, daughter of Colonel Hardin Littlepage and Susan Pemberton Robins, granddaughter of Hardin Littlepage and Eliza Suterland Quarles. (See Edwards' Genealogy).

13. JAMES BEVERLY HILL (son of William Hill, Number 7) married Lillian Ochiltree, of Texas. No children. Died 1890.

14. ROBERT HILL (son of Robert Hill Number 9) He died 1886. Married Martha Johnson, daughter of Colonel William Christopher Johnson. Issue: Major Augustus Beverly Hill, Juliette, Harriet m. James A. White; Elmira m. T.B. Waring; Lelia m. John Bowers of Richmond, Virginia; and Johnson, who died young.

THE FOLLOWING GIVEN TO ME BY MRS. ELWIN THRASHER...

SILVESTRA BENNETT HILL (WIFE OF COLONEL NICHOLAS HILL OF ISLE OF WIGHT COUNTY, VIRGINIA).

She was a daughter of of Edward Bennett (m. ca. 1627) and Mary Bourne, daughter of Jasper and Joan Bourne. Edward Bennett was a wealthy merchant in London. He owned a fleet of vessels and was a navigator himself. Edward Bennett was Auditor of the Virginia Company in 1622 and owned the largest plantation in America at that time called "BENNETT'S WELCOME." His brothers Robert and Richard also had Virginia plantations. Edward Bennett now lived in America but made many trips between England & Virginia to tend to his property and business. He was responsible for sending several thousand people to settle in America.

Edward Bennett and his wife Mary (Bourne) Bennett, were living near St. Olave's Church, Hart Street, London in 1638. It is not known when he died but his daughters Mary and Silvestra inherited his plantations in Virginia in 1664. Mary Bennett married a Mr. Bland.

The Issue of Edward & Mary (Bourne) Bennett, all christened in St. Olave's Church, Hart Street, London, England...

LT.COLONEL NICHOLAS HILL (husband of Silvestra Bennett, who was his 2nd wife) was first a Major and then Lt. Colonel of the Isle of Wight Militia, in Virginia. He represented the County in the House of Burgesses, September 1663 and October 1666. He was married twice, first wife's name is unknown but they had the following children:

2. Ralph Hill
3. Nicholas Hill

His 2nd wife was Silvestra Bennett, who died in 1706 in Isle of Wight County Virginia.

The following were children of LT. COLONEL NICHOLAS HILL and his 2nd wife, SILVESTRA BENNETT.

On September 30th, 1664, COLONEL NICHOLAS HILL and his wife Silvestra Hill, received a patent of 750 acres in Isle of Wight County, Virginia "Being the moiety of 1500 acres of land appertaining unto the said Silvestra and her sister, who were daughters and co-heirs of Mr. Edward Bennett, deceased, by the riverside in a valley called the Rock."

NICHOLAS HILL made his will on 19th April 1675 and it was probated on 20th October 1675. His wife (SILVESTRA BENNETT) made her will on 20th October 1706 and it was probated on 9th January 1707. She mentioned no descendents in her will.

FOLLOWING GENEALOGY INFORMATION FOUND IN WM. & MARY QUARTERLY, (SERIES 1) 1899-1901 VOL. 8 & 9 ON PAGE 257.

In York County, Virginia, a jury returned a special verdict on 19th September 1726, which shows that Thomas Vines was the son of Thomas Vines and Mary, his wife, that she Mary, was the daughter of Thomas Hill and Eleanor Charles.

Thomas Hill of York County, was married to Eleanor Charles. In a Deed dated 21 March 1693, Thomas states he was a son of John Hill, who made his will on 9th December 1670.

(Based on following information something appears wrong with the date of the deed being in 1693, perhaps it was 1653

because by 1661 Thomas Hill appeared to have died and his widow had remarried to Thomas Bushrod...See Below).

The deed was to Samuel Eaton for 170 acres, a part of 600 acres called "Essex Lodge," first taken up by Captain William Brocas, a member of the Virginia Council in 1635, and sold by him to Thomas Hill.

In 1657 Thomas Hill patented 500 acres on (the) Potomac due him for emigrants, viz: Captain Thomas Hill, three times, Mary Bushrod twice, John Hill, George Hill, Thomas Hill, Mary Hill and Francis Hill. From this it is inferred that Captain Thomas Hill was the first husband of Mrs. Bushrod, and the other Hills (were) their children, the son Thomas being the patentee.

In 1658, it is stated that Thomas Bushrod purchased goods of Mr. Thomas Barber for Mrs. Mary Hill, of "Essex Lodge."

In 1661, there is a deposition that Thomas Bushrod married the relict and executria of Thomas Hill.

Abraham Piersey, of the Council of Virginia, who married Frances, the widow of Captain Nathaniel West, brother of Lord Delaware, left "the best estate that ever was yet known in Virginia" to his daughter Mary, who married Captain Thomas Hill. (Sainsbury MSS., 1638-39).

Captain Samuel Matthews married the widow Frances about the same time. (Neill's Virginia Carolorum). It is not certain that this Captain Thomas Hill was of "Essex Lodge." Thomas Bushrod lived during his life at "Essex Lodge." His brother, Richard Bushrod, was ancestor of General George Washington's nephew, Judge Bushrod Washington. During the siege of Yorktown in 1781, "Essex Lodge," since called "Washington's Lodge," was the headquarters of General Washington.
