GENEALOGICAL INFORMATION ON THE SPENCER HILL FAMILY OF VIRGINIA. (SOURCE: Letter from Mrs. Doris Redding, 500 Second Street, Apt. 406, Portsmouth, Ohio, 45662.

SPENCER HILL, was born on the 26th of February 1762 in Northumberland County Virginia. He married Mary Rutherford in 1788. Spencer Hill died on 8th October 1852 in Belva, Nicholas County, (today's) West Virginia.

COMMENTS: Could it be that the above Spencer Hill is a son of Thomas Hill who married Diana Spencer in Philadelphia, Pennsylvania at CHRIST CHURCH, in 1755?

REFERENCE VOL. 8, Ser. 2, Page 412, Sweedish Church? A Thomas Hill with a wife Diana is found in the 1790 Census of Fairfield County S.C. and owns land there in the late 1780s and early 1790s. Based on location of his land (on Road from Winnsboro to Charleston) I feel certain he is the same Thomas Hill, and at who's house a witches court was held at and mentioned in Eddington's Book on the History of Fairfield County.

GENERAL COMMENTS ON ABOVE FAMILY: Although the above shows Spencer Hill as being born in the eastern part of Virginia, he married in Botetourt County Virginia. Among Hill notations that have been found, Daniel Boone and a William Hill left Yakin River in N.C. in 1767 and explored the Big Sandy area: Reference: Kozees's book on Early Eastern Kentucky. The Big Sandy area refers to the Big Sandy River which separates Eastern Kentucky and western West Virginia.

SOME GENEALOGICAL INFORMATION ON A MOSES HILL FAMILY, ORIGINALLY OF NANSEMOND COUNTY VIRGINIA, BUT LATER MOVING TO CHOWAN COUNTY N.C.

(NOTE & COMMENTS by Robert R. Hill: In Maryland, there is a Moses Hill, who died in 1763 & left a will. It appears that he was a Quaker and he had no children, but his brothers were THOMAS HILL (could this be the same one that married Christian Meek in Md?), JAMES HILL, AARON HILL (is this the one that moved to area of Chowan, Perquimans & Pasquatank Counties in N.C. and listed in Quaker Minutes as marrying Margaret Chepell? I suspect so!) and SAMUEL HILL.

Note: June 15, 1989... Later information shows that Aaron Hill of Perquimans and Pasquotank Counties N.C. was a Quaker and was a son of William Hill Jr., who in turn was a son of the immigrant, William Hill Sr., who came into Virginia from England. While no data has been found to link the Maryland Hills to the Quaker families of N.C., it is believed that they are somehow related.

Reference: Following Information provided by Mr. Jonathan Butcher, a genealogist specializing in N.C. Research.

MOSES HILL 1/, was born ca. 1680, probably in Nansemond County Virginia. He moved to Chowan County N.C. by 1717 with his wife Dorothy-----? He left a will in Chowan County N.C. in 1745 and had the following sons:

- i. Moses Hill Jr. 2/, b. ca. 1705/12, d. 1762-63, lived in Bertie County N.C. Left no sons.
- ii. Guy Hill 2/, b. 1710/17-d. 1775 of Chowan County N.C. His sons were:
  - a. Kadar Hill 3/, d. 1790 Gates Co., N.C.
  - b. Guy Hill Jr. 3/, d. 1787 Gates Co., N.C.
  - c. John Hill 3/, d. 1776 unmarried.
- iii. Isaac Hill 2/. born after 1716. Sold land and left Bertie County N.C. in 1754.
- iv. Abraham Hill 2/, born after 1716, died in Gates County N.C. in 1786.

His sons:

- a. Moses Hill 3/, d. 1797 Gates Co., N.C.
- b. Aaron Hill 3/.
- c. Henry Hill 3/.
- d. Mills Hill 3/.

William Hill 1/, probably the brother of Moses Hill Sr. 1/,

married Mary Spivey and died in Chowan County in 1750/51. His sons were:

- a. Moses Hill 2/, d. 1750 Chowan Co., N.C. his wife was named Jean. Sons were:
  - i. Aaron Hill 3/.
  - ii. Micajah Hill 3/.
- b. William Hill 2/.
- c. Aaron Hill 2/.

Comments: While this family appears to have mostly lived in N.C. and died there as well, it's origins were in Virginia and therefore has been considered to be Virginia Genealogy.

#### FIRST GENERATION

ROBERT HILL 1/ (1615-1682) b. and m. in England. His wife was Mary Webb (1621-1684). They came to Isle of Wight County Virginia in 1642. They had 2 KNOWN sons, perhaps there were other children?

- i. SION HILL SR. 2/. (c. 1654-1705) born Isle of Wight County Virginia, married Elizabeth (SMITH) Splitimber (or Spiltimber), widow of John, (prbly dau. of Nicholas Smith).
- ii. Robert Hill 2/, (c.1667/70-?) m. Elizabeth Holleman (dau. of Wm. Holleman).

#### SECOND GENERATION

ROBERT HILL 3/, b. ca. 1680, d. ca. 1766 in Halifax Co., NC. Wife named Tabitha. They had many children.

SION HILL SR. 2/ (c 1654-1705) b. Isle of Wight County Virginia, m. 1677 Elizabeth (Smith) Spiltimber, widow of John Splitimber, and probably a daughter of Nicholas Smith of Isle of Wight Co., Va. Had four sons: probably other children.

- i. Robert Hill 3/, (c. 1680-1765), m. Tabitha --?.
- ii. Sion Hill Jr. 3/, (b. 1682/87 Surry County Va., was formed as new county from Isle of Wight, (c. 1685—?). Sion Jr., 3/, m. twice, 1st Elizabeth Marriott and 2nd to? (Marriage data questionable).
- iii. Richard Hill 3/, (c. 1680/81-).
- iv. Thomas Hill 3/ m. Priscilla Gray.
- v. Michael Hill 3/
- vi. William Hill 3/, (c. 1690-?) m. Ann Deloach.

#### THIRD GENERATION

SION HILL JR. 3/, (1682/87-?) born Surry County Virginia, known to have married twice. 1st to Elizabeth Marriott. They

had one known son.

- i. William Hill Sr. 4/, THIS WM HILL IS BELIEVED TO BE THE WRONG WM. HILL! Wm. Sr. 4/ (1710-1787) born Surry County Virginia, d. in Surry Co., N.C. (Will), m. ca. 1736 to Susannah Smithers (1716-) who possibly was dau. of Thomas Smithers. THE 2ND MARRIAGE OF SION HILL JR. 3/. WAS TO A MISS GREENE, CA. 1713. She is believed to the daughter of Colonel Peter Greene. They had one son (Questionable information):
- ii. Green Hill Sr. 4/, (1714-1769) WILL in Northampton Co., N.C., he m. 1739 Grace Bennett (1726-1772) WILL in BUTE CO., N.C. daughter of William Bennett. Had 9 children, 4 sons and 5 daughters. (Note: This Green Hill is believed to be the wrong Green Hill).

Information on Sion Hill Jr. 3/ is questionablen

1750 TITHE LIST TAKEN BY JOHN PHELPS, "FROM FALLING RIVER TO GOOSE CREEK" (LUNENBURG COUNTY VIRGINIA AND THIS AREA LATER BECAME BEDFORD COUNTY).

Comments: This is the area where the Mobley Family and the Hill Families are supposed to have become intermarried, then moving to Fairfield County S.C. It is my contention that the Hill-Mobley connection was earlier in Maryland between a Clement Hill and Edward Mobley, both of Maryland. You will later find in S.C., a Clement Mobley in the Mobley Family, probably named after the close friend of the family.

William Mobberley, Edward Moberley Jr., tithed with him was Thomas Moberly and Roger Conner. Others listed in this area was Edward Moberly, Benjamin Mobberly, Rice Price Jr., and Sr., Thomas Price, Matthew Talbot Jr., CLEMENT MOBBERLEY, Jno. Mobberley (sons Mordecia and Hamon tithed with him), William Stone Sr., William Stone Jr., RICHARD HILL, PAYING TITHE FOR WILLIAM HILL, (WHO PROBABLY IS 16-21 YEARS OLD), Jason Meadors Jr., JNO. HILL, Lawrence & Elias Barker, Robert Irone (Stone?, Euseibus Stone.

1752 TITHE LIST TAKEN BY JOHN PHELPS "FROM FALLING RIVER TO GOOSE CREEK" (This was in Lunenburg County Virginia, and in an area that in 1754 became known as BEDFORD COUNTY VIRGINIA.

Edward Mobberley, Clement Mobberley, Benjamin Mobberley, Thomas Halsey, RICHARD HILL, Jno. Anderson, Jonas Anderson, Stephen Hudson, Peter Hudson, William Stone, William Stone Jr., Joseph Miller, William-Samuel & Yowel Watkins, Thomas & Rice Price, Richard Turner, Jason Meador, Job. Meador, Joel Meador, Lewis Meador, Thomas Wright, Abel Richardson, Benjamin Richardson.

Comments: Note that a lot of these names appear in Fairfield County S.C. by 1760 and just after. The last TITHE LIST was in 1754 BEDFORD COUNTY, VIRGINIA. Deputy Court Clerk of Bedford County states that the Bedford County Tithe Lists are at the Virginia Archives in Richmond.

#### GENEALOGICAL INFORMATION ON VARIOUS HILLS IN VIRGINIA

(SOURCE: Mr. Jonathan Butcher (genealogist) who worked for Robert R Hill in 1985-86.

SURRY COUNTY VIRGINIA.... Captain Thomas Hill 4/(?), (ca.1688-1737), is believed to be the grandson of Sion Hill Jr. 3/, (b. 1682). (WRONG! HE WAS A BROTHER). Thomas Hill's will was administered by Priscilla Hill in 1737 but no list of heirs was given.

In Surry County Records there was an elder MOSES HILL, first mentioned in will books on 19th December 1758 as an appraiser of the estate of John Barker. This Moses Hill made a will dated 21 January 1782, proven 24 September 1782, naming sons LEWIS and STERLING and children of a deceased son BENJAMIN HILL. (NOTE: Suspect this family may be origins of a Moses Hill and Sterling Hill, later of S.C. and Clark County Alabama).

ADDITIONAL NOTE: There is a Moses Hill listed as having married Sally Lewis on 16th September 1820 at the Clerk's Office, Farmville, Virginia. (Taken from Prince Edward County Marriages by the Genealogical Publishing Company). Is there a possible connection to the above families listed to the above Moses Hill and Sally Lewis?

A Moses Hill is also listed in the 1810 Census of Wythe County, Virginia.

Albermarle Parish Register Records: (BIRTHS)

- i. Amy Hill, daughter of Thomas Hill and wife Eliza; born 8th January 1747/48.
- ii. MOSES HILL, son of Thomas and wife Eliza; born 15 November 1750. (Apparently several people has accepted this man as being our Moses Hill (Revolutionary Soldier) in Fairfield County, S.C., but no proof has yet been found and it is not likely to be the same Moses Hill (Revolutionary Soldier) of S.C., who died at age 63 on 1 July 1821, indicating birth of late 1757 or 1758 and married to Savilla N. Roden.

#### THE FOLLOWING TAKEN FROM NOTES OF FANNY PRESCOTT

William Hill 3/ born 1713 in Virginia was the son of Captain Isaac Hill 2/ and Margaret Jennings, son of a Robert Hill 1/, who was the progenitor of the Hills of Carteret, Onslow and Dulpin Counties of North Carolina. Isaac Hill 2/ of Virginia was the son of Robert Hill 1/, who came to Virginia in 1635 and settled in Culpepper County Virginia. (Reference Christ Church Register, Middlesex County Virginia).

It is believed that most of the Hills in North Carolina came originally from Virginia. (Only those in Onslow, Cartaret, Duplin Counties).

(Reference: Following are taken from notes and information of Prof. Claude H. Moore of Mount Olive College)

Robert Hill 1/ came to Virginia in 1635 and settled in Culpepper County Virginia. His wife's name is unknown and he had one (known) son: "Captain" Isaac Hill 2/, born 1680.

Isaac Hill 2/ married Margaret Jennings, daughter of Colonial Governor Edmund Jennings. He and his family resided in King & Queen County Virginia. Isaac died ca. 1734.

Son of Isaac Hill 2/: William Hill 3/, born 1713 and died 1799 in Virginia. He married first in 1741 to Catherine Read, sister of Col. Clement Read. They lived in Brunswick County Virginia, later known as Lunenburg County Virginia. In 1765 they bought and removed to a plantation on Cedar Point. Records are confusing to the exact location, one stating this place was in Onslow County N.C. Another states Cedar Point in Carteret County, N.C.

In 1769 William Hill 3/ purchased two plantations in Duplin County N.C.

His Children were:

- 1. Elizabeth Hill 4/ married Burwell Lanier and had 10 children. They settled in Anson County N.C. Children: William Lanier, Clement, Isaac, Thomas, Fanny, Martha, Elizabeth, Sarah, Nancy and Catherine Lanier.
- 2. Major Hill 4/ died 1772 unmarried.
- 3. John Hill 4/ died 1807 married 1772 to Jane Kenan had the following children: Felix Kenan Hill 5/; Catherine Hill 5/; Sarah Hill 5/; John Hill 5/; James Kenan Hill 5/; Ann Elizabeth Hill 5/; Edward Blackmore Hill 5/ and William Kenan Hill 5/.
- 4. Isaac Hill 4/, died 1815 married to Elizabeth Hatch and they had 9 children. They were: John Hatch Hill 5/; Buckner Hill 5/, Ivy Hill 5/; William Hill 5/; Hatch Hill

- 5/; Edward Hill 5/; Mary Didama Hill 5/; and Permilla Hill 5/. (The Hills of Newport N.C. descended from these).
- 5. Thomas Hill 4/, born ca. 1758. His mother died shortly after he was born. Thomas Hill 4/ married 1st in 1777 to Elizabeth Allen of Virginia. He remarried in 1781 to Frances Smith of Maryland and a lady of wealth. Thomas Hill 4/ died in 1833. Thomas Hill 4/ lived in Dulpin County N.C. Thomas Hill (Sr.) 4/, became a prosperous planter (farmer) and slave holder. He owned 2,099 acres of land and 46 slaves. It appears that his children were by his 2nd wife Francis Smith, daughter of Cuthbert & Elizabeth Smith. Children of Thomas Hill (Sr.) were:
  - a. Elizabeth Chamberlayne Hill 5/, b. 1782, d. 1841, married 1798 to David Wright of Duplin Co., N.C. Their children were: Thomas Wright, John, Marcy, Rebecca, Martha, David, Isaac, Elizabeth, and Catherine Wright, married 1805 to Lewis Dickson. Elizabeth died 1828. She had two daughters who were Martha Dickson and Elizabeth Dickerson.
  - b. Thomas Hill Jr. 5/, became a doctor and married Frances Jernigan. They lived on their plantation near Scott's Store in Dulpin Co., N.C. Children were: Spaight Hill 6/ (other not listed).
  - c. Dr. Calhoun Hill 5/.
  - d. Warburton Hill 5/.
  - e. Antoninette Hill 5/.
  - f. Buckner L. Hill 5/, b. 1800-d. 1860, married Ann Maria (Rhodes? Ward, daughter of Gen. James Rhodes and widow Edward Ward.. Doctor Bucknew L. Hill 5/ was a wealthy planter and a successful physician. His wife Maria is buried in the old Wayneboro Cemetery near Goldsboro N.C.

Other children of Buckner L. Hill 5/ were: William Lanier Hill 6/, Catherine Hill 6/, Thomas Hill 6/, d. 1861, and John Smith Hill 6/..

William Hill 3/ married a 2nd time to a widow, Mrs. Priscilla (Wilkson) Embry. They had the following children:

- 1. Joseph Hill 4/, born 1760, married Margaret Wallace. He died in 1810. Children: William Starky Hill 5/, Thomas Holt Hill 5/, Elizabeth Ann Hill 5/ and Margaret Hill 5/.
- 2. Priscilla Hill 4/, born 1762/63 married Miles Williams and they had 8 children.

After William Hill's 3/ second wife died, he gift deeded his son Isaac Hill 4/ the Cedar Point Plantation. John 4/ and Thomas Hill 4/ received the lands in Dulpin Co., N.C. and William Hill 3/ returned to Virginia, where he remarried a 3rd time but had no further children.

# HILL-WOODLEE CONNECTIONS

One Source ("Lost Tribes') infers that COL. NICHOLAS HILL 1/, THOMAS HILL 1/ and JOHN HILL SR. 1/ were brothers, but gave no explanation or source. Col. Nicholas Hill lived in Elizabeth City County & Isle of Wight Counties of Virginia; Thomas Hill (d. ca. 1711?) lived in York County Virginia and was the administrator of John Hill's estate; John Hill Sr., died in 1647 and lived in Lower Norfolk County Virginia, near Sewell's Point."

It seems that John Hill Sr. had two (known sons) and they were Robert Hill 2/ (married Elizabeth Thomas, daughter of William Thomas) and John Hill Jr. 2/, who lived in Norfolk County Virginia near Lynn Haven Parish. John Hill Jr. 2/ was the Sheriff of that County.

Now Robert Hill 2/ had a son Thomas Hill Sr. 3/, who married Mary Marshall, daughter of Humphry Marshall.

A Will of Thomas Hill 3/ dated May 23, 1719 and probated August 25, 1720, mentions a wife Mary and children: Thomas Hill (Jr.) 4/, Joseph Hill 4/, Mary Hill 4/ & Ann Hill 4/. The wife was Mary Marshall, daughter of Humphrey Marshall. This Thomas Hill 3/ is not to be confused with the above Thomas Hill 1/.

The above Thomas Hill 3/ lived on the farm devised by Sylvester Hill, the daughter of Edward Bennett & widow of Colonel Nicholas Hill 1/, to be sold for the poor of the Parish. It was sold by court order on 16th October 1714 to Lawrence Baker, who conveyed to Alexander Forbes on 24 May 1717 and Forbes conveyed to Thomas Hill 3/ on 27th May 1717. It was situated just outside of Day's Neck and reached the James River in a point at the Rocks and extending back containing 300 acres, more or less, and at the time that it was sold to Thomas Hill 3/, it lay between lands of Sylvester Hill & John Goodrich.

The first mention of Thomas Hill 3/ is found in Isle of Wight records in Book 1, page 2, dated October 9th, 1693. It refers to a suit by Thomas Hill 3/ against William Whitfield. He obtained judgement and appeal was taken by Whitfield to the General Court, which court sustained the verdict below; a new suit was taken out by Thomas Hill 3/ and judgement by him was obtained.

The next record of Thomas Hill 3/ is found in the Will of Humphry Marshall, dated 18th December 1711, in Book 2, page 532. From this it appears that he married Mary Marshall, daughter of Humphry Marshall. Among the provisions left..."I give the land the Point where Thomas Hill lives to my daughter Mary Hill and her heirs forever." This land is situated in Smith's Neck. Marshall left three daughters,

Mary, wife of Thomas Hill 3/, Ann wife of Henry Applewhite Hill and Sarah wife of \_\_\_\_\_\_Scatchins.

In his Will, Thomas Hill 3/ names following children: Thomas Hill Jr. 4/, Joseph Hill 4/, Mary Hill 4/ and Ann Hill 4/.

Mary (Marshall) Hill continued to live on the farm of her said husband (Thomas Hill 3/) which was processioned in her name as appears by the old vestry book until ca. 1733, when it was processioned in the name of her son Thomas Hill (Jr.) 4/ and processioned in his name until 1739. A George Wilson qualified on the estate of this Thomas Hill (Jr.) 4/ ca. 1739-40. Wilson audited the estate as administrator on 28th December 1741, (WILL BOOK 4, page 387). John Newson qualified as guardian for a son of this Thomas Hill 4/ and his name ALSO was Thomas Hill (III) 5/. No information has been found to ascertain as to what became of this Thomas Hill 5/.

His father, Thomas Hill Jr. 4/, the son of Thomas Hill 3/ & Mary Marshall, was clerk of the vestry of the Old Bay Church in 1723. There is a letter from him to the vestry recorded in the vestry book of that date, saying that he was about to sail to England, which would prevent his attendance on the vestry.

In 1723 in the report of the processioners, they stated that they did not run a line between Mrs. Mary Hill & John Woodley's because her son Thomas Hill Jr. 4/ was then out of the country.

Nathaniel Parker mentioned in his will, which bears the date of 29th, believed that the wife Ann was Ann Hill, one of the daughters of Thomas Hill 3/ (& wife Mary Marshall), and who mentioned a daughter Ann in his will. This opinion seems to be based on the fact that the report of the processioners of 1739-40 of the lands in Smith's Neck mentions that they ran a line between James Baguall and Nicholas Parker and that Joseph Hill 4/ was present. Why would Joseph Hill 4/, who lived in Little Neck at that time, be present to represent the processioning of the land of Nicholas Parker? He must have been there as a kinsman or guardian. Nicholas Parker was then an infant and according to conjecture was the nephew of Joseph Hill 4/.

Joseph Hill 4/, son of Thomas Hill 3/ & Mary Marshall, married Frances Woodley, daughter of John Woodley, who was the son of immigrant Andrew Woodley, who settled in Isle of Wight County in 1690. THUS THE HILL-WOODLEE CONNECTION.

Joseph Hill 4/ & Frances (Woodley) Hill lived in Little Neck on land that was given by Andrew Woodley, to his son John, who on his death it descended to the said Frances Woodley. The vestry book shows they lived on said lands and the Will of Joseph Hill 4/, bearing date of 29th October 1775,

recorded 4th January 1776, mentions wife Frances, son Joseph Hill 5/ and daughters Mary Hill 5/ & Elizabeth Hill 5/. Joseph Hill 4/ was Captain of the militia in his district as appears by orders of the county court.

Mary Hill 5/, daughter of Joseph Hill 4/ & Frances Woodley, married a cousin Henry Hill 5/, son of Thomas Hill Jr. 4/. Henry Hill 5/ was then living in Granville County N.C. as appears from a deed of gift of Joseph Hill 4/ & Frances Hill, dated 1st May 1763, of certain slaves to their daughter Mary Hill 5/ as her portion in marriage.

The will of Frances Hill, widow of Joseph Hill 4/, was dated 4th June 1788 and recorded on 5th September 1791. In this will she mentions son Joseph Hill 5/, daughter Elizabeth (Hill) Harrison 5/, wife of John Harrison.

Now the Joseph Hill 5/ that was a son of Joseph Hill 4/ & Frances (Woodley) Hill married Martha \_\_\_\_\_? A deed executed by this Joseph Hill 5/ & wife Martha in 1790, showed that they lived in Southampton. (?).

Now Elizabeth Hill 5/, daughter of Joseph Hill 4/ & Frances Woodley, married John Harrison of Isle of Wight County, the son of Henry Harrison, whose will dated 13th September 1771, admitted to probate 1st October 1772. They had among their children, a daughter Elizabeth Hill Harrison 6/.

The will of said John Harrison on 1 April 1790 & probated 7th February 1791, mentions wife Elizabeth (Hill) Harrison and three daughters, Harriet Harrison 6/, Elizabeth Hill Harrison 6/ & Woody Harrison 6/ (a daughter?).

Andrew Woodley, the emigrant, also had a son Thomas Woodley, who had a son John, who had a son Andrew and he married his cousin Elizabeth Hill Harrison.

This information sent to me by J.R. Blow, who copied it in summer of 1987 but forgot the source. (I suspect it was the William & Mary Quarterly Magazine).

#### ESSEX COUNTY VIRGINIA:

MOSES HILL born 1757 (This might be our Moses Hill who married Savilla Roden and lived in Fairfield County S.C.). He was associated with a Leonard Hill (who moved to Clark County Kentucky ca. 1785) and a Thomas Hill.....all 3 were Revolutionary War Soldiers in S.C.

THOMAS HILL, son of Leonard Hill (of Essex County Virginia) died 1770 in Cumberland County Virginia. His wife was named ELEANOR.

ESSEX COUNTY ORDER BOOK.... AUGUST 28, 1772, PAGE 371 THOMAS HILL, ANN HILL AND MARY HILL, infants of Thomas Hill, deceased, (Thomas Hill was son of Leonard Hill 2/) by Mungo Ray, their guardian, etc...

Mrs. J.E. Warren states "Do not have reference to book but in Essex County Records after the year 1734, the year Leonard Hill 2/ died, there was a great deal about John & Paul Micou, uncles of Thomas Hill 3/ & Leonard Hill 3/, getting all of the estate in their hands and not giving Thomas Hill anything."

FOLLOWING GENEALOGY INFORMATION FOUND IN WM. & MARY QUARTERLY, (SERIES 1) 1899-1901 VOL. 8 & 9 ON PAGE 257.

In York County, Virginia, a jury returned a special verdict on 19th September 1726, (regarding whom & what?) which shows that Thomas Vines was the son of Thomas Vines and Mary, his wife, that she Mary, was the daughter of Thomas Hill and Eleanor Charles.

Thomas Hill of York County, was married to Eleanor Charles. In a Deed dated 21 March 1693, Thomas states he was a son of John Hill, who made his will on 9th December 1670. The deed was to Samuel Eaton for 170 acres, a part of 600 acres called "Essex Lodge," first taken up by Captain William Brocas, a member of the Virginia Council in 1635, and sold by him to Thomas Hill. In 1658, it is stated that Thomas Bushrod purchased goods of Mr. Thomas Barber for Mrs. Mary Hill, of "Essex Lodge." In 1661, there is a deposition that Thomas Bushrod married the relict and executria of Thomas Hill. In 1657 Thomas Hill patented 500 acres on (the) Potomac due him for emigrants, viz: Captain Thomas Hill, three times, Mary Bushrod twice, John Hill, George Hill, Thomas Hill, Mary Hill and Francis Hill. From this it is inferred that Captain Thomas Hill was the first husband of Mrs. Bushrod, and the other Hills (were) their children, the son Thomas being the patentee.

Abraham Piersey, of the Council of Virginia, who married Frances, the widow of Captain Nathaniel West, brother of Lord Delaware, left "the best estate that ever was yet known in Virginia" to his daughter Mary, who married Captain Thomas Hill. (Sainsbury MSS., 1638-39). Captain Samuel Matthews married the widow Frances about the same time. (Neill's

Virginia Carolorum). It is not certain that this Captain Thomas Hill was of "Essex Lodge." Thomas Bushrod lived during his life at "Essex Lodge." His brother, Richard Bushrod, was ancestor of General George Washington's nephew, Judge Bushrod Washington. During the siege of Yorktown in 1781, "Essex Lodge," since called "Washington's Lodge," was the headquarters of General Washington.

John Hill of Northumberland County married Elizabeth Martin on 9 January 1733.

WM. & MARY QUARTERLY, VOL. XVIII, Page 246?, Richard Hill baptised on 12 August 1660, son of Robert & Jane Hill (Northumberland Co., Va.).

WM. & MARY QUARTELY, VOL. XXV, Page 36, Andrew Hill, aged 23 (b. ca. 1615).. in 1638 Norfolk Co., Va. John Hill was between 50 & 60 years of age in Norfolk County, Virginia in 1638 (John Hill born ca. 1578-1588).

WM. 7 MARY QUARTERLY, VOL. VII, PAGE 106 & 107, Patience Hill (daughter of Richard Hill & owner of this Hill's Farm in 1666 in Accomack County, Va. married to Major Richard Drummond. They had a daughter Anne, who m. Thomas Bayly. Her mother was Catherine Harmanson, daughter of Thomas harmanson.

A Isaac Hill & wife Anne Christian had a daughter Susan Browne Hill (Vol. V, Page 263 under Gidieon).
