

VA.005 ALBERMARLE PARISH REGISTER FOR SUSSEX AND SURRY
COUNTIES IN VIRGINIA (1739-1778) Edited by Gertrude
Richard.

Gathered & Entered by Robert R. Hill Sr. in April 1987.

"The Virginia Genealogist," Volume 23, Number 2, April-June 1979 page 125, states that Surry County was formed in 1652 from the portion of James City County that was south of the James River. It ran from the river (southward) to the North Carolina border.

On Page 127 of same book, it states that Sussex County Virginia was created in 1754 from the southern portion of Surry County. Southward Parish was formed in 1647 and Albemarle Parish was formed in 1742.

Note by R. Hill: It should be noted that often times the "Grandparents" are listed at a christening but are not named.

PAGE 14, Burrell, (Burrell) son of John Hill and wife Mildred, born April 8th-Christened May 15th 1748.

PAGE 32, Green Hill, son of Richard Hill and Majory (Margery?) born November 25th 1751, christened January 19th, 1752-Grandparents, John Rolland, Solomon Green, Francis Wilfield. (This was Richard Hill Jr. 4/ and wife Margery Gilliam. This Green Hill later married Mary Booth & went to Georgia).

PAGE 78, William (Hill), son of Richard and Marjory (Margery? Hill), born March 3, 1745/46, Baptised March 30th 1744/45-Grandparents, William Harper, Robert Farrington, Sarah Winfield). This was Richard Hill Jr. 4/ and wife Margery Gilliam.

PAGE 81, Amy, daughter of THOMAS HILL & WIFE ELIZA. born January 8th February 28, 1747/48. Grandparents William Wiggins, Keziah Tatum, Eliza Tatum.

?? Richard Hill, son of Richard Hill & wife Margery was born 18th May 1754.

PAGE ??, Betty Hill, daughter of William & Hannah Hill, born August 1st, 1755, christened August 24th, 1755.

PAGE 112, An Amy Hill, gift to Lucy Obi?m ???, daughter of William & Frances. dated October 1, 1758.

PAGE 132, Robert (Hill) son of William and Hannah Hill, born

December 14th 1756, christened February 6th 1757.

PAGE 135, Sarah, daughter of John Hill and wife Mildred, born March 12th, christened 1744/45. [This was John Hill 4/ & wife Mildred Gilliam, John 4/ son of Richard Hill 3/ & Hannha Briggs].

PAGE 136, Tabitha, daughter of John Hill and wife Mildred, born October 17th- christened November 28th 1756. (This was John Hill 4/, son of Richard Hill 3/ & Hannah Briggs. John Hill 4/ married Mildred Gilliam in 1742). They had 10 children. See Genealogical Data Disk # 3, Data.VA3 item # 12.

PAGE 136, Thomas, son of Richard Hill and wife Marjory (Margery?) born June 19th, christened August 7th 1757. (This was Richard Hill Jr. 4/ and wife Margery Gilliam).

PAGE 202, Amy Hill gift to Elizabeth Hutt??, wife of William & Eliza. Dated July 13th 1755.

PAGE 219, Moses, son of Thomas Hill and wife Eliza, born November 11th, 1750, christened March 17th, 1755-1??? Grandparents John & Miche Wealther, Susanna Wealther.

PAGE 220, Amy Hill, Mildred Oliver and Thomas Billard-Grandparents to Martha Oliver, daughter of Issac---and W. Eliza. Dated September 1, 1751???

PAGE 262, Susana, daughter of John Hill and wife Mildren (Mildred?) born October 17th, died November 25th, 1759. Grandparents, James Cain Jr., Amy Hill, Anne Willson? (Wilson?) (Note: Believe this is John Hill 4/ (ca.1718 d. 1765) and wife Mildred Gilliam, who married in 1742. John Hill 4/ son of Richard Hill 3/ and Hannah Briggs, who m. ca. 1713. Hannah was daughter of Henry Briggs and wife _____ Howell.

PAGE 262, Sally, daughter of William Hill and wife Hannah, born May 31st 1759, christened June 24, 1759.

PAGE ??, John Hill, son of William & Hannah Hill, born May 16th 1761, christened May 24th, 1761.

PAGE 266, William Gilliam (Hill), son of Richard Hill and Marjory (Margery?) born March 28th-christened 1756. Grandparents. (This was Richard Hill Jr. 4/ and wife Margery Gilliam).

PAGE 301, Mary Hill grandparents Sally (Twin) d. John Coats and wife Lucy, October 2, 1763. (above sic)

PAGE 306, William, son of Green Hill and wife Mary. born March 12th, christened April 23, 1775 [This Green Hill probably son of Richard Hill Jr 4/ & Margery Gilliam. He married Mary Booth.

PAGE 308, Mary Hill, a child, died March 3, 1742/43; (Father?) John Hill. [This was John Hill 4/ who m. Mildred Gilliam].

PAGE 317, Mary Hill, a child, died November 2, 1761, (father?) Richard Hill. (Maybe Richard Hill 4/).

PAGE 318, William Gilliam Hill, Richard Hill -----????
Note: This is son of Richard Hill Jr. 4/ & wife Margery Gilliam, who married in 1742. She was daughter of William Gilliam. William Gilliam Hill was born 1746, died 1764.

NOTE: Thomas Hill and Eliza of Sussex County (Albermarle Parish) had a daughter Amy. The records begin in 1739 and it seems that possibly this Thomas Hill is the same mentioned in Botetourt County Records. Note that this Thomas and Eliza had a son Moses Hill. (Later info makes me think this was Thomas Hill 3/ & wife Elizabeth Gray). (Not proved).

NOTE: A Burril Hill married Mary Boone in Sussex Co., Virginia in March 1774, (see earlier S.C. birth of son Peter). It appears that the Burril Hill in Va. and S.C. were different men.

Another Burwell Hill married Maria Shehorn on 8th January 1816 in Greensville County, Virginia. (Reference Virginia Marriages on page 255, author's name not given).

Albermarle Parish, Sussex County, Va. records shows a Burril Hill married in Virginia in 1774 to Mary Boone.

Burril Hill may have moved into S.C. ? Later information in S.C. shows a Burrill Hill (in Fairfield Co.) was son of Charles C. Hill Jr., who was from Pennsylvania.

(Reference to Burril Hill: S.C. History and Genealogical Magazine, Vol. 17, page 451-Parish Register shows James Santee, Peter (Hill) son of Burril and Martha Hill, born March 1st, Baptized November 10th under heading of 1768. (Some other listings under this heading specify birth was 1766/67. Burril's occupation listed as carpenter).

NOTE: I have (or had) a letter from Brent Holcomb that stated a Thomas Hill of (Sussex County Virginia) purchased land from a Burwell Hill, now residing in S.C. I have mislaid the letter so cannot give specifics, but remember it quite well and this would seem to connect one Burwell Hill to the Surry County Virginia Hill Family.
