## WILL OF THOMAS HILL

In the name of God, I THOMAS HILL of the county of Cumberland being in perfect health of body and soundness of memory thanks be to given unto God, calling to mind the mortality of my body and knowing that is appointed for all men once to die do make and ordain this my last will and testament,

First, I give and recommend my soul into the hand of Almighty God who gave it me, and my body to the earth to be buried decently at the discretion of my friends but as touching such worldly estate to which I am intituled (entitled) under the last will and testament of my father JOSEPH HILL, deceased. I give and dispose of the same in the following manner.

ITEM, I give and bequeath unto my brother WILLIAM HILL all money I have in possession with all I am intituled (entitled) to under the last will of my dec'd father, to be appropriated to the most profitable uses for him, until his marriage or arrives at the age of twenty one years at which time my desire is that he may actually enjoy and be put in full possession thereof.

ITEM, I give and bequeath unto my brother JOSEPH HILL my horse and saddle to be sold to the best advantage and the money thence arising to be appropriated to the most profitable uses as the exigences of his affairs may require, until his arrival to the age of twenty one years or marries, at which time my desire is that he may actually possess and enjoy the same.

I appoint my father in law DANIEL ALLEN my executor of this my last will and testament and do hereby revoke disannul and make void all other wills heretofore made by me either verbal or written and do acknowledge this to be my last will and testament. In witness whereof I have hereunto set my hand and seal this twenty seventh day of March one thousand seven hundred and seventy nine.
