Information in bold print came from book "COLONIAL MEN AND
TIMES," edited by Mrs. Lillie DuPuy (VanCulin) Harper.

HILL

This name appears frequently in the early records of the
Colony (Virginia) and the members were so numerous it is
impossible to render a connected account of the family with
the meager data in reach. The first of the name in Virginia
appears to have been:

1. Captain Edward Hill 1/ (first known generation), Of
Elizabeth City County, Virginia, who died 15th May 1624.
A member of the Council and noted character in the early
Government, and ancestor of the Hills of "SHIRLEY." His
wife was the daughter of Richard Boyle, of London. He
had a brother John Hill, mercer in London Street,
London.

Second in descent.. Colonel Edward Hill 2/, of Shirley
(Hundred). He was a member of the House of Burgess in
1639, 1642, 1644-45, 1647, 1649-54. He was Speaker of
the House in 1644 & 1645 & a Member of Council from
1654. He lived a short time in Maryland & was chosen
Governor by the Insurrectinary party but was taken
prisoner by Governor Calvert. He was Commander in Chief
of Henrico & Charles City Counties and in 1656 commanded
at "Bloody Run." He married Miss Elizabeth Williams,
daughter of Sir Edward Williams, a Welsh heiress. They
came together to America. They married in Charles City
County, Virginia, on September 17, 1655.

There may have been a 2nd marriage. Col. Walter Aston
died on 6 April 1656 aged 49 years. He had married a 2nd
time to Hannah___, who afterward married a Col. Edward
Hill 2/. Col Edward Hill 2/ died in 1663.

Third in descent was Colonel Edward Hill 3/, b. ca.

1637, a son of the above Col. Edward Hill 2/. He was member of House of Burgess of Virginia & Speaker of The House and Member of the Council, also Commander of in Chief in Surry and Charles City Counties. Mary Aston Cocke, widow of Richard Cocke, who died in 1665, married 2nd time to Colonel Edward Hill, of Charles City, County & had children. Major General John Brown had married as

his 3rd wife Tabitha Scarborough Smart Browne Custis, He died in 1696, and she remarried in same year Col. Edward Hill, of Charles City County. They had no children.

These marriages are believed to be Edward Hill 3/, based mostly on the dates. It appears that Colonel Edward Hill 3/ died 30 November 1700 & is buried at Shirley Plantation in Va..

Fourth in descent was General Edward Hill 4/, of Shirley in Charles City County. Collector of James River in 1716, he was recommended by the Governor (1707) as "a gentleman of estates & worth, suitable to fill vacancies in Council" (Sainsbury Papers). His daughter Elizabeth Hill 5/ married in 1723 Secretary John Carter of Carotoman (Lancaster Co., Va.). After the death of John Carter in 1743, the widow Elizabeth Hill 5/ Carter remarried (ca. 1745) Bowler Cocke (b. 1696-d. 1771). The marriage took place at Shirley, Charles City County. Another daughter Martha Hill 5/ married Hugh Gifford. Colonel Edward Hill 4/ died in 1748.

2. John Hill, Of Lower Norfolk (County). Burgess 1640-1642. He was in the colony as early as 1621. John Hill, aged between 50-60 states in 1647 in Norfolk Co., Va. that he had continued in Virginia 26 years & upwards & that he had been a book-binder in the University of Oxford & was son of STEPHEN HILL. of Oxford, Fletcher 219. "The Census of 1624-25 also gives the "Muster" of Rebecca Rose, widow living at West & Shirley Hundred. She was 50 years old and came in the ship "Marygold," in May 1619, and her muster included Marmaduke Hill, aged 11, & John Hill, aged 14, who came in the same ship." (Vol. 11, Historical Magazine, Page 361).

3. Captain Thomas Hill, Whose widow, Elizabeth, married Colonel Thomas Bushrod of York County, 1664.
4. Henry Hill, Of Accomac County. Commander of Horse, 1630. Witness to lease from Lyonel Ronlston to "his loving friend," John Neale, 1630.
5. Major Nicholas Hill, Of Accomac County, and James Hill, of Gloucester County, were Vestrymen, 1677.
6. Isaac Hill, Of King & Queen County. Member of Quorum, 1702-1714. From whom the King William family dates.
7. Colonel HUMPHREY Hill, Of "Hillsborough," King & Queen County. Died March 1775. Thought to be the son of the

above Isaac Hill. The coat of arms is identical, and it is reasonably certain that this family is descended from the Hills of Alverton County of Gloucester, England, whose ancestry is recorded in Burke's Landed Gentry for several hundred years before their arrival in America. Colonel Humphrey Hill probably had issue:

Thomas Hill of St. Stephen's Parish, King & Queen County, Lay Delegate, 1796.

Henry Hill, Virginia House of Delegates, 1784.

John Hill, of "Hillsborough," who married Mary Walker Lewis, daughter of of Colonel Zachary Lewis and his wife, Anne Overton Terrill.

James Hill (the following James Hill).

Robert Hill, member of of Committee of Safety, 1774 and other children.

8. James Hill, Private in Revolutionary War and executor will of Charles Neale. Married Mildred, daughter of Rev.

- Reuben Clopton, of King & Queen County. Children: James Hill, listed below as (# 9); John (# 10), Thomas (# 11); Parke (# 12); Nathaniel (#13); William (# 14); Robert (# 16); Elizabeth (# 23); Judith (# 24); & Mary (# 25).
9. James Hill, Son of James Hill (#8), Married 21 December 1787 Sally Graves. A footnote states "21W(2)173 states that he married Mary Walker of Charles City County." This is not clear.
 10. John Hill, Son of James Hill (# 8). Colonel of State Troops. Married _____? Issue: Sallie, who married Alexander King; Mildred, who married Baylor Walker; and Robert, who married a widow Walker and moved to Alabama in 1837.
 11. Thomas Hill, son of James Hill (# 8) Colonel of State Troops.
 12. Parke Hill, son of James (# 8).
 13. Nathaniel Hill, son of James Hill (# 8).
 14. William Hill, son of James Hill (# 8). Captain in State Troops. Born 17th June 1780 at Portobello, York County, Virginia. He Married Judith Browne Claiborne, daughter of Herbert Claiborne (of) Chestnut Grove, New Kent County, born 1746) & Mary Browne, daughter of William Burnett Browne, of "Elsing Green," King & Queen County. Issue Rowland Hill, died young & daughter Octavia (# 15).
 15. Octavia Hill, daughter of Captain William Hill (# 14). She was born 1817, married Dr. John S. Lewis and was still living at West Point, Virginia (when?). Children were: Josephine, who married Lt. J.C. Baytop, of Gloucester County; Lavinia, who married Dr. C.T. Whiting of Norfolk, Virginia; Nora, who married F.M. Elphinstone, of Newark, N.J.; Dr. J. Rowland, who married Nannie Robinson; & Herbert Iverson who married Mattie Parke.

16. Robert Hill, Son of James Hill (# 8). He died 1844. Married Harriet Herbert Claiborne, sister of Judith Browne Claiborne, who married his brother, Captain William Hill (# 14). Children: Robert Hill (# 21); Mary B. Hill (# 22); Mildred Hill (# 23).
17. William Hill, Son of Robert Hill (# 16). He married Elizabeth Johnson, daughter of Colonel William Christopher Johnson. Children: Claiborne Johnson Hill (# 18); Robert Christopher Hill (# 19); and James B. Hill (# 20).
18. Claiborne Johnson Hill, son of William Hill (# 17) of West Point, Virginia. Major in the Confederate Army. Member of State Legislature and Lawyer. Married Susan Anne DeFarges, daughter of John DeFarges and Adaline Neale, and grand daughter of John Neale & Nancy King, great grand daughter of _____ King & Joyce Lipscomb.
19. Robert Christopher Hill, son of William Hill (# 17) married Cornelia Todd Littlepage, daughter of Colonel Hardin Littlepage and Susan Pemberton Robins, grand daughter of Hardin Littlepage and Eliza Sutherland Quarles (See Edwards' Genealogy).
20. James Beverley Hill, son of William Hill (# 17) married Lillian Ochiltree, of Texas. He died 1890. No children.
21. Robert Hill, son of Robert Hill (# 16). He died in 1886. Married Martha Johnson, daughter of Colonel William Christopher Johnson and sister of Elizabeth Johnson, who married his brother William (# 17). Children were: Major Augustus Beverly Hill; Juliette Hill; Harriet Hill, who married James A. White; Elmira Hill, who married T.B. Waring; Lelia Hill, who married John Bowers of Richmond, Virginia; and Johnson Hill, who died young.
21. Mary B. Hill, daughter of Robert Hill (# 16). She married William Brumley.
22. Mildred Hill, daughter of Robert Hill (# 16). She married General F.M. Boykin.

23. Elizabeth Hill, daughter of James Hill (# 8) married Colonel Carver King. (See King Excursus).
24. Judith Hill, daughter of James Hill (# 8) married William Neale. (See Neale Excursus).
25. Mary Hill, daughter of James Hill (# 8) married before 1779 to Bernard Lipscomb, of King William County.

Bernard Lipscomb & wife, Mary Hill of King William County, Virginia had the following children:

- a. James Hill Lipscomb, who married Frances Lipscomb and moved to Sumter County, Alabama.
- b. Reuben Lipscomb, who married Anne Morgan Ellett. They lived in Richmond, Virginia.
- c. Harriet Lipscomb, who married 1st John Meredith, and 2nd to John Lipscomb of Richmond, Virginia.
- d. Mildred Lipscomb, who married 1st William F. Clone and 2nd to Austin Lipscomb of King William County, Virginia.
- e. Louisa Lipscomb, who married Obidiah Winfree, he died intestate. She lived in Richmond.
- f. Minerva Lipscomb, married Thomas B. Mitchell of King William County.

NOTE BY ROBERT HILL: I believe this is the same family that was later located in S.C. and Alabama (Clark Co.). A Moses Hill is listed in the 1830 Census of Clark County, Alabama (age 70-80), one female 50-60. Reference Alabama Records by Gandrud, Vol. 239, Pages 15-16. He had a son Sterling Hill,

who is suspected to have married in Fairfield County, S.C. If so, the wife was Mary Lewis. Moses Hill's Inventory of his estate was taken on October 17, 1832 in Clark Co., Alabama and a son Sterling Hill is mentioned.

"Mary Hill, widow of Captain Thomas Hill, married a 2nd time to Thomas Bushrod, who by a deposition was 53 years old in 1657."

(In other words Mary Presey Hill, wife of Captain Thomas Hill, had remarried Thomas Bushrod and she apparently died in January or early February (before the 21st) of 1661).
