MECKLENBURG COUNTY, VIRGINIA

14 April 1777 The Will of WILLIAM HILL was proved; wrote 17th November 1775. Bequest were made to James Elam, son of Joel and Phebe; William's sisters, Martha Loatham and Catherine Hill; William Hill, son of James Hill; William Hudson, son of Peter. (WILL BOOK 1, PAGES 223-224)

8th January 1787 The Will of WILLIAM HILL was proved; Wrote 25th April 1786. He mentions wife Elizabeth; sons: John, James, William & Elisha; daughter: Frances. (WILL BOOK 2, PAGE 196).

15 March 1813 The Will of JOHN HILL was proved; wrote 4th January 1811. Mentions his wife Elizabeth; Children: William Hill, Evalina, Sarah, Marshall Hill. John B. Hume. (WILL BOOK 7, PAGES 358-359).

LUNENBURG COUNTY, VIRGINIA

6th June 1758 The Inventory and appraisal of the Estate of RICHARD HILL, deceased. Sale of Estate, 14 June 1758. The bedding was purchased by Martha Hill. (WILL BOOK 1, PAGES 239-240).

FRANKLIN COUNTY, VIRGINIA

3 February 1806 The Inventory of the Estate of ISAAC HILL, deceased. (WILL BOOK 1, PAGE 272). List of Heirs: Sally Price (David, Costello Hill, Thomas Hill, Barber Hill, Betsy Hill Jones (William), are all of age. Under age are Nancy Hill, John Hill, Isaac Hill, Winny Hill & William Hill. John Hill was their Guardian. (WILL BOOK 1, PAGE 409). This Family originated in Northumberland County, Virginia.

MIDDLESEX COUNTY, VIRGINIA

3rd November 1684 THOMAS HILL assigned his grant of 345 acres

on the south side of the Rappahannock River to William
Cheyney. (DEED BOOK P.S. 1A, Page 87). P.S. = photostat

21 June 1693 Power of Attorney, LEONARD HILL, merchant of
London, "at present in Virginia," to Thomas Harwar. (DEED
BOOK P.S. 1A, PAGE 309). P.S.= photostat

3rd October 1709 Bond, LEONARD HILL stated that he was 60
years old (DEED BOOK 3, PAGE 211). THIS INDICATES A BIRTH IN
1649.

5th February 1714 Deed; WILLIAM HILL & FRANCES, his wife,
made an agreement for the equal partition of 150 acres in
Shell Neck, land of John Needles, deceased. John Needles, the
father of Frances, left the land to his son William Needles,
who died without issue. (DEED BOOK 3, PAGES 510-512). WILLIAM
& FRANCES HILL undoubtedly the parents of NEEDLES HILL;
NEEDLES HILL Marriage Bond: Letitia Morgan, 4 October 1758,
Middlesex County, Virginia.

7th March 1731 Will of RICHARD HILL was proved. Wrote 18th
January 1731/32. Mentions nephews, William, Russell, Thomas &
Needles Hill; sister Rebecca Whitaker; brother, William Hill;
Niece, Judith Hill; sister in law, Frances Hill; Executors,
Roger Jones, Churchill Jones. No Signatures of Witnesses.
(WILL BOOK B, PART 2, PAGES 166-167).

1760 Inventory, WILLIAM HILL, deceased. (IN WILL BOOK E, PAGE
46).

26 February 1776 Inventory, NEEDLES HILL, deceased, by court
order of 24 July 1775. (WILL BOOK F, PAGE 77).

18 June 1784 Inventory, LETITIA HILL, deceased, by court
order of 24 March 1784. (WILL BOOK F, PAGE 282).

30th July 1787 Mortgage; WILLIAM HILL to John Jackson for the
land mentioned in next item. Witnesses=Dudley Vaughan, Thomas
Boss (or Bass), John Minter. (DEED BOOK 10, PAGE 68).

27th August 1788 Deed; WILLIAM HILL and SARAH, his wife, sold
132 acres in Christ Church Parish, bounded by John Rose, to

John Jackson. No Witnesses shown. (DEED BOOK 10, PAGES 88-90).

18th November 1757 JAMES HILL'S Inventory ordered by the court. Recorded 16th March 1758. (WILL BOOK O, Pages 46-48).

1768 Account of estate of JAMES HILL. Only a fragment of this remains. "due the orphans of James Hill...acct with Robert Wooding Guardian ." (WILL BOOK O. Page 339).

1768 Account page torn at top. "___hans (ORPHANS??) of Mr. James Hill, decd. with_____oding." The eighth item listed is "To pr. Leather Breches for Jas Hill 1 (L) POUND. (WILL BOOK O, Pages 342-343).

August 1773 Account; orphans of James Hill, R. Wooding, guardian. (WILL BOOK 1, Page 37).

20th April 1781 Inventory, EPHRAIM HILL, (WILL BOOK 1, PAGE 348).

19th December 1781 Inventory & Appraisement, Captain JAMES HILL, decd., taken by Benjamin Hall, Thomas Robins, Harrison Irby; recorded 18th July 1782. (WILL BOOK 1, Pages 407-408).

6th August 1782 "The Estate of Captain JAMES HILL in account

with SARAH HILL, Administrator & Guardian to the Orphans."
(WILL BOOK 1, PAGES 412-413).

21 August 1783 "The Estate of Captain JAMES HILL to SARAH HILL, Guardian." One item was "due for Schooling 2 children 6 months, 1 pound." (WILL BOOK 2, PAGES 30-31).

16 September 1784 Account; "Joseph Terry & Sarah his wife, guardians to the orphans of JAMES HILL, deceased." (WILL BOOK 2, PAGES 93-94).

11 August 1785 "The Estate of JAMES HILL'S orphans" Joseph Terry, guardian. (WILL BOOK 2, PAGE 139).

18 October 1787 "The Orphans of JAMES HILL, decd. to Joseph Terry, Guardian." (WILL BOOK 2, PAGE 260).

26th June 1797 The Will of Robert Wooding, Antrim Parish, was proved. Wrote 14th May 1796. He included bequests to sons-in-law, James Taylor and Mary, his wife, and James Chappel and Martha, his wife; "loving friend" ELIZABETH HILL and her daughter Frances; to THOMAS HILL, "Illegitimate son of ELIZABETH, my whole estate both real and personal in Pittsylvania County now in his possession;" Benjamin Rodgers who married NANCY HILL, daughter of ELIZABETH; JOHN HILL, son of ELIZABETH; Petersfield Kent, who married ELIZABETH HILL, the younger: Executor, "my natural son the said "THOMAS HILL." Wits: John Stanley, Moses Roberts, Thomas Roberts. (WILL BOOK 3, PAGES 326-329).

(NOTE: Based on the above, it appears that Robert Wooding was

the illegitimate father of THOMAS HILL, but who was the father of the other Hill children)?

28th October 1799 The Will of ELIZABETH HILL, Antrim Parish was proved. Wrote 30th December 1797. (Almost anti-climactic after the previous item:) She mentions her sons JOHN HILL and THOMAS H. WOODING ("ill appears to have been erased from the original following the middle initial); daughters, Nancy Rodgers, Elizabeth Kent, Frances Williamson. Wits: John Wooding Sr., James Taylor, Jas. Thompson, Thomas Tuck. (WILL BOOK 6, PAGE 114).

NORTHUMBERLAND COUNTY, VIRGINIA.

9 April 1745 Britain Hill's Will was proved this date, (ORDER BOOK 1743-1749, PAGE 55).

9 March 1746/47 EZEKIEL HILL'S Will proved, written 27th October 1746. Mentioned his wife, Sarah Hill: Sons: SPENCER HILL, James Hill, Francis Hill, John Hill & Thomas Hill. Executors: widow and son Spencer Hill. Wits: Thomas Dameron, John Rice, Yarrat Hughiett. (RECORD BOOK 1743-1749, PAGE 175a).

Ezekiel Hill may have lived in Prince William County before he was in Northumberland County. William Bean sold land "on the line of Ezekiel Hill" (PRINCE WILLIAM COUNTY, VA. DEED BOOK A, 1731-1732, PAGES 140-144). Records in 1733 of Price William County refer to Richard Hill of London Town, Maryland (across South River from Annapolis), which may have been their home original home. (DEED BOOK B, 1732-1735, PAGES 213-217).

15 August 1750 JAMES HILL'S Estate administered by Thomas James (ORDER BOOK 1749-1759, PAGE 75. No will found.

13 November 1752 Sarah Hill's will proved this date, wrote 28 July 1752. In addition to the sons named in Ezekiel's will, she named daughters, Winifred Hill, Sarah Hill, and Hannah Hill (RECORD BOOK 2, PAGE 181). Granddaughter: Martha Hill is also mentioned. Executors: Joseph Power, Francis Hill. Wits: Joseph Power, Sarah Power.

21 November 1752 JOSEPH HILL, son of Spencer Hill & Mary, born. (REGISTER OF ST. STEPHEN'S PARISH).

24 February 1754 NANCY HILL, daughter of Spencer & Mary, born in St. Stephen's Parish.

15 June 1756 SPENCER HILL, son of Spencer Hill & Mary, born St. Stephen's Parish.

8 August 1757 JOHN HILL and his wife, Elizabeth, sold 55 acres to Joe Samson (RECORD BOOK 4, PAGES 106-107). John must

have died by 11 October 1765, because only Elizabeth Hill made a deed of gift to William Everit and his wife Ann. (RECORD BOOK 6, PAGE 660). Elizabeth's maiden name was Martin. Her marriage bond to John Hill was dated 9 June 1733, in Lancaster County, Virginia. ("Lancaster County, Virginia Marriage Bonds; 1652-1850 by Ida J. Lee, Page 32).

11 January 1758 MARY HILL, daughter of Spencer Hill & Mary, born St. Stephen's Parish.

9 July 1759 Will of JOHN HILL proved; wrote 16 May 1759, Wife Elizabeth, sons: Thomas, William, John and Nicholas. Executors: Widow and friends John Pope and William Baisey. Wits: John Pitman, Robert Potts (RECORD BOOK 5, PAGES 87-88).

23 March 1760 WINNY HILL, daughter of Spencer Hill & Mary, born St. Stephen's Parish.

26 September 1763 MARTHA HILL, daughter of Spencer Hill & Mary, born in St. Stephen's Parish.

1765 SPENCER HILL voted in Northumberland County (RECORD BOOK 6, PAGES 643-646).

29 June 1766 SUSANNAH HILL, daughter of Spencer Hill & Mary, born St. Stephen's Parish.

3 February 1770 JUDITH HILL, daughter of Spencer Hill & Mary, born St. Stephen's Parish.

12 March 1771 WILL OF SPENCER HILL proved; wrote 3 January 1771. Mentioned his wife but did not name her. Named his sons, Joseph Hill and Spencer Hill. Executors: Thomas Downing, John Christopher, William Rice Jr. Wits: Joseph Power, Henry Christopher. (RECORD BOOK 8, PAGE 172).

17 February 1779 MARY ROSS HILL, daughter of Joseph Hill & Ammone, born St. Stephen's Parish.

23 November 1782 WILLIAM HILL, son of Spencer Hill The 2nd & Mary, born in St. Stephen's Parish.

9 AUGUST 1784 JOSEPH HILL'S Estate ordered to be appraised by John Christopher, Robert, Thomas and Henry Christopher. (RECORD BOOK 12, PAGES 263-264).

11 December 1784 FANNY HILL, daughter of Spencer Hill The 2nd and Mary, born in St. Stephen's Parish.

14 February 1785 WILL of WILLIAM DENNEY proved, wrote 6 April 1784. Mentioned son; William Denney; son in law, Spencer Hill, daughters; Winnefret Denney, Elizabeth Denny, Fanny Denney. Executors: Spencer Hill, William Denney. Wits: Jno.

H. Fallin, Moses Suttin, Leroy Pullin. SPENCER HILL sold the

land he inherited from William Denney on 20th September 1785.
(RECORD BOOK 13, PAGE 80).

6 January 1794 JUDITH HILL marriage bond to William Lewis
(Nottingham).

27 November 1795 Marriage bond to MARY RUSS HILL & John Rock.
(MARRIAGE BONDS OF NORTHUMBERLAND COUNTY, VA. 1783-1850, 1929
by Stratton Nottingham).

2 January 1782 JAMES HILL sold 200 acres to William Trabue of

Chesterfield County for 300 lbs in specie. The land was purchased by Hill from John Fowler (DEED BOOK 1, PAGE 179).

20 February 1783 JAMES HILL sold 6 acres on Swift Creek to Daniel Trabue for 100 lbs current money. It was part of the land purchased by Hill from John Fowler. (DEED BOOK 1, PAGE 193).

23 August 1783 JAMES HILL and ANN, his wife, sold 175 acres to Henry Skipworth of Cumberland County for 350 lbs current money. Land was adjacent to Henry Randolph, Charles Hatcher and said Skipworth. (DEED BOOK 1, PAGE 213).

ESSEX COUNTY, VIRGINIA ADDENDA

16 May 1724 Thomas Blanton of South Farnham Parish sold 47 acres to JANE HILL, widow, during her lifetime and then to her son, JOHN HILL, part of a tract his brother, John Blanton, formerly sold to her deceased husband RICHARD HILL. Wits: Thomas Graves, Phillip Sanders. (DEED BOOK 17, PAGES 310-313).

16 February 1730 LEONARD HILL was named guardian of KATHERINE HILL (WILL BOOK 5, PAGE 14).

14 June 1732 RICHARD HILL, "Pract-r in Physick," of Ann Arundel County, Maryland, named Col. William Beverley his attorney to sue James Steward, alias James Booth, for a debt of eleven pounds, three shilling and seven pence. Wits: Tho. Watkins, Edward Roycroft. (DEED BOOK 19, PAGES 304-305).

21 April 1823 Will of THOMAS HILL proved this date, wrote 6 January 1823. Mentioned but did not name his wife; sons Joseph P. Hill, William H. Hill, and Ransdell Hill. The later was to receive nothing because "he conducts himself so bad." Exec= son William Hill, Wits: W. Fisher, Humphry Hill. (WILL BOOK 19, PAGES 372-373).

1. 10 September 1703 Leonard Hill was in Old Rappahannock County by this date, when he was one of the persons who inventoried the estate of James Sargeant (Wills & Deeds, Book 11, Page 92). Leonard had a wonderful habit of dating each of his signatures.
2. 27 April 1705 Leonard Hill is described as a merchant of (OLD) Rappahannock County (Wills & Deeds, Book 14, page 363).
3. 31 December 1723 Deed, Leonard Hill, South Farnham Parish, to Reuben Welch for 250 acres at 80 pounds. (Deed Book 17, Pages 341-343).
4. 20 February 1727/28 Will of HENRY HILL, St Mary's Parish, proved; written 15 March 1726/27. Mentions wife Anne; son, Richard; daughter Elizabeth. Both children are under 20 years of age. Witnesses: Robert Thomas, Gabrill Tombs, Francis Wilkin (WILL BOOK 4, Page 259).
5. 21 January 1728/29 WILL of Leonard Hill proved; written 12 May 1728. Legatees are daughters, Ann Tunstall, Betty Hill, Catherine Hill (latter two under 18 yrs. of age); son, Leonard Hill; godson John Covington. Witnesses: Stephen Drewer, William Allen, George Berrick. (WILL BOOK 4, Page 284). (Wife was widow (Elizabeth?) Bryant and this is the first Leonard Hill).

Mentions wife, but does not name her; sons: Leonard and Thomas; daughter, Mary (under 21 yrs. of age); sisters Ann Tunstall, Catherine Price, Betty Hill; brother: John Bryant. Son Leonard to receive 300 acres, part of the tract known as "Bridgers North." Son Thomas to receive part of "Bridgers North" that is part of Dragon Swamp. Mary to receive 100 pounds. (WILL BOOK 5, Page 199-200). (This is the second Leonard Hill, son of the first Leonard Hill).

9. 17 September 1745 LEASE, James Hill of Albemarle County and his wife Ann, to John Clondas of Essex County. (Deed Book 23, Pages 303-305).

10. 19 October 1756 Will of Leonard Hill, South Farnham

Parish, proved; written 29 March 1756. Mentions brother, Thomas Hill; wife (unnamed); daughters: Mary and Elizabeth (under 18 yrs.) Executors: Friend Richard Tunstall, Francis Smith, John Clements, Gentleman. Wits: John Clements, Richard Johnson, Samuel Johnson. (WILL BOOK 10, Pages 102-103). (This is the third Leonard Hill, son of Leonard Hill 2 and grandson of the first Leonard Hill).

11. 14 May 1759 DEED, Thomas Hill, Gentleman, Essex County, to Mary and Elizabeth Hill, daughters and legatees of Leonard Hill, deceased, for 300 acres adjacent Dragon Quarter at 150 pounds. (DEED BOOK 28, Pages 154-155).

12. 21 June 1764 DEED, Richard Hill Jr., planter, South Farnham Parish, and his wife Mary, to John Cassell of St. Anne's Parish, 40 acres at 30 pounds. Wits: Leonard Hill, Leonard Hill Jr., Alexander Roane. (DEED BOOK 29, Page 336).

13. 20 August 1764 Will of Richard Hill proved; written 29 July 1764. Legatees are sister Mary Patterson; half-sister Ann Sanders; nephew Richard Hill, son of brother John Hill; Sarah Graves, daughter of Elizabeth & Richard Graves. Brother Leonard Hill is to be executor. Wits: Leonard Sale, James Sullivan, Ann Rennolds. (WILL BOOK 12, Pages 138-139). COMPLETE WILL AT END OF DOCUMENT.

14. 16 September 1776 WILL of Leonard Hill of St. Anne's Parish, proved; written on 8th September 1775. Mentions wife, Sarah; daughters Suca & Molly; Sons: William and Thomas. Executors: (sons) William and Thomas. Wits: William Watkins, Daniel Sullivan, Jesse Hill. (WILL BOOK 13, Pages 47-48).

This provided by Mrs. Summers of Bend, Oregon....

ESSEX COUNTY, VA. made 8th September 1775 LEONARD HILL, perfect sense & memory. Names daughter Luca Hill: 1 Negro girl, Nan, a Negro boy named Robbin, 1 feather bed & furniture of 8 pounds value, 1 pewter dish, 6 plates.

Son William Hill: 1 Negro boy Toby, 1 Negro girl, Pat, 1 bed & furniture of 8 pounds value, 1 pewter dish, 6 plates.

Son Thomas Hill: 1 Negro boy Phill, 1 Negro girl Aggie, 1 bed and furniture of 8 pounds value, 1 pewter dish and 6 plates.

Dau. Molly Hill: 1 Negro boy named Sippio & 1 Negro girl

named Amy, 1 bed and furniture, 1 dish, 6 plates.

Wife SARAH HILL remainder of estate real & personal. Her decease land is to be divided between two sons. Son William to pay sister Luca 1/2 value of his part of land. Thomas to pay sister Molly 1/2 of his part of land. Four children share equal in his estate. Witnesses: William Watkins, Daniel

Sullivan & JESSE HILL.

Filed Essex County in Tappahannock on 16 September 1776. At above mentioned court 15 November 1784, Thomas Hill, an Executor came into Court and qualified as such by taking oath.

Mentioned wife Betty, and "her daughter Sarah, the wife of Isaac Hill. (In a codicil, Sarah is called "daughter in law," but the exact definition of all the "in law" terms is open for debate. It is possible, of course, that Isaac was actually his son and married the daughter of his 2nd wife). Children: Frances, Catey, Jesse,

Thomas, John and Betsy, are all under 21. The implication is that Betty is the 2nd wife. Wits: William Edwards, Andrew Edwards, William Hammontree. (WILL BOOK 2, PAGES 294-295).

27 January 1789 Will of William Costelo Hill, of Littleton Parish, proved this date. Wrote 20 February 1788. Mentioned his wife Susanna; four children under 21; Ann Webb Hill, William Costelo Hill (JR.), Hall Chiswell Hill, Willoughby Suggett Hill. (These names are all right out of Northumberland and Essex Counties of Virginia. William Costelo Hill was the son of Costelo Hill, who died in 1750, in Northumberland County, Virginia). He left land to Isaac & Sarah Hill, Thomas Suggett Hill (The 2nd), Costelo and Barber Hill. Exec: the widow, Isaac Hill & ____? Gentry, Robert Anderson. Wits: Dangerfd. P. Harmon, Billy Tapscott, Edney Tapscott, Charles Allen Merryman, Cynthis H. Merryman. (WILL BOOK 2, PAGES 444-445). Note: The Tapscotts and Merrymans were from Lancaster/Northumberland County areas).

23 February 1789 Marriage Bond, Jesse Hill & Molly Scruggs, daughter of Tabitha Scruggs (Elliott).

18 February 1806 Marriage Bond, John Hill & Sarah Fleming Bondurant (Elliott).

February 1809 Will of Thomas Hill proved this date; wrote 30th January 1809. This is a nuncupative will, told to William Randolph. The estate is to provide for his wife and children, all unnamed, and for his mother and her "young children." Since Major John Hatcher did not compensate Thomas for his last wife, he thought Hatcher should contribute

something to the estate. Also mentioned was a half-brother unnamed. Execs: Tom Hobson, John Hatcher, Dr. Newton Ford. (WILL BOOK 3, PAGE 417).

11 March 1834 Marriage Bond, Sarah Hill & Samuel H. Talley. John Hatcher Sr., was grandfather of Sarah (Elliott).

14 June 1787 William C. Hill witnessed a deed from Isaac & Sarah Hill to Obadiah Reynolds, 100 acres on Little Groome Quarter Creek for 100 lbs. current money. Other witnesses were Joel Meggs and John Reynolds. Recorded 22 October 1787.

21 March 1821 Will of Martha Hill proved this date. Wrote 24 June 1820. Entire estate was left to her brother, John A. Hill, who was under 21. Exec: friend Patrick Ford. Wits: Thomas Gray; John H. Ford, Polly Hasby (?). (WILL BOOK 9, PAGE 256).

19 May 1821 Will of Amey Hill proved this date. Wrote 24 September 1820. Legatees were sons, Cross & William; daughter, Elizabeth Frances, and her son, Benjamin. Wits: John Atkinson, James Atkinson. (WILL BOOK 9, PAGE 85).

17 October 1825 Will of William Hill proved. Wrote 4 August 1825. Legatees were his wife, Mason; sons Everitt, Harry, William. Wits: John Barrett, Jacob Barrett, Richard G. Lankford. (WILL BOOK 9, PAGE 285).

CHESTERFIELD COUNTY, VIRGINIA

11 January 1750 Will of James Hill written, no probate date given. Mentions wife Ann, sons: James and Godfree Hill; daughters, Elizabeth and Frances (two youngest), Susannah, Elan Ann, Martha, Mary Alice(?). Exec: wife. Wits: Benjamin Lockett, Richard Lockett, Jacob Afhurst (?) (WILL BOOK 1, PAGE 23).

April 1761 Inventory of estate of Godfrey Hill, Dale Parish. Will written 21 December 1760, no probate date given. Mentioned his wife, Edith; daughters, Nancy and Betty. Execs: wife and Henry Hatcher. Wits: Lewis ___?, Henry Baker, Thomas Logwood. (WILL BOOK 1, PAGE 383).

11 August 1772 Inventory & Appraisement of estate of James Hill (WILL BOOK 2, PAGE 128).

31 August 1780 Will of Edward Hill, Dale Parish, Written this date. No probate date given. Mentioned his wife, Elizabeth;

daughters, Priscilla Hill (under 21), Martha Nunnally,

Frances Hill; grandson, William Hill, son of Frances; sons in laws Thomas Cogbill and his son, Edward, and William Dance and his son, Edward. Elizabeth Hill, Thomas Cogbill and Jesse Cogbill were to be guardians of Priscilla. Wits: Jesse Cogbill, Elizabeth Raiborn, John Cogbill. (WILL BOOK 3, PAGES 186-289? (186-189?).

19 January 1789 Inventory & appraisal, estate of John Hill Sr. Will written 9th December 1788; no probate date. Stated that the children of his first wife have already received their full portions. Mentioned Ann Puckett, "my present wife," and "the children that I had by her," James Hill Puckett, Annie Puckett, Pleasant Hill Puckett, Edward Hill Puckett, Prudence Puckett (all under 21). Execs: wife, son William, friend Peter Rowlett and Daniel Sbringer. Wits: Matthew Sims, Archer Puckett, David Whiteford. (WILL BOOK 4, PAGES 184-189). Note: To me it seems strange that the last name of the children is listed as Puckett and not Hill. This suggest that they were born BEFORE John Hill and Ann Puckett were married and were probably born out of wedlock, then after the death of John Hill's first wife, they (John & Ann) married. Since the two were not married at the time of the children's birth, they were given the Surname of Puckett and the middle name of Hill.
