Page 467, Matthew Hill, 470 acres in New Kent Co., 24th February 1663, between Chickahomi Swamp and Pamunkey River, beginning at a corner tree by Westover path, running East by South to Mr. Brereton's land, etc..to said path dividing this from the land of Mrs. Joanes' and Jonathan Higby and Robert Garrett. 337 acres was granted to John Hodge on 22th October 1662 for whom it was purchased by said Hill, and 133 acres for transportation of 3 persons: Matthew Hill, Jonathan Norcott & Dorothy Diccars.

Page 467, Gabriel Hill, lived on land granted to Stephen Benbridge in New Kent Co. 4 April 1664.

Page 501, Charles Hill purchased 150 acres from Edward Lucas, and assigned to Samuel Hattaway on Garden Creek. To Hattaway by patent 15th March 1658.

Page 545, Richard Bridger, Robert Hill & John Mayhew, 1200 acres in Rappahannock Co., 20th March 1665, beginning at the westward side of a white marsh at the head of a branch issuing out of the Dragon Swamp, and crossing Mattapony upper path, running West-Northwest, etc. 300 acres formerly belonging to Richard Lawrence & William Bauldine by patent dated 15th June 1663, and by said Lawrence (the whole remaining in him after the death of Bauldine) assigned to said Mayhew. 900 acres granted to Richard Lawrence, Evan Davis & Thomas Williamson on 16th June 1663, and now by several assignments made over to said Bridger & Hill.

Page 143, Richard Kemp Esq., Secretary, and one of his Majesty's Council of State, 4332 acres in James City Co., 17th April 1643, at the head of Archer's Hope Creek upon the Palisades. 1200 acres by purchase from George Mininie, and 940 acres by several former patents, 2192 acres for transportation of 44 persons. 600 acres of said 1200 acre grant to Thomas Hill, and rent to paid by him on 13th June 1642, and by him assigned to William Davis.

Page 665, Will of Edmonds Yorke, of Cotton End, in the County of Northampton, (England), yeoman, dated 18th November 1614, proved 17th April 1614 (1615?)-"To Abigail Hills, my servant, 3 shillings and 4 pence."

Page 63, Will of Richard Gregsen, deceased, dated 21st August 1640, proved 31 August 1640, "To my servant Anne Hill, all the money that she oweth me (to be made up 20 shillings").

Page 70, Will of Mary Goodwyn, of Lyme Regis, in the County of Dorset, widow, last of March 1663, proved 6th June 1665, "To my three cousins, William, James & Inatiuis, the sons of my brother William Hill in New England, 150 pounds to be divided equally among them. To cousin William Hill of Lyme, son of my late brother Benjamin Hill & Mary his now wife, and Benjamin their son and their four daughter, etc.."

Page 258, Deborah, daughter of Capt. Francis Norton, of

Charleston, Mass., married Zachary Hill. Captain Norton was admitted into the church of Charlestown on 2nd October 1642 & died in Charlsetown on 27th July 1667. He left no male issue.

Page 622, Will of Adrian Quiney, citizen and grocer of London, dated 4th February 1692, proved 14th August 1693, "To my friend Charles Hill, 5 pounds to buy mourning."

Page 687, Will of Cicely Hill, of London, widow, dated 7th August 1621, proved 14th September 1621, "I give to the daughter of my late deceased sister Alice, dwelling in the County of Lancaster, 20 shilling and two of my gowns, two petticoats, a kirtle (girdle?) and two aprons. To Eme Clyffe, my chamlett pettycoat. I give and bequeath to Hannah Jadwyn, the daughter of Thomas Jadwyn, scrivener, 20 shillings. To Dorothy Marden, 20 shillings. To the three maiden children of Mr. George Johnson, citizen and merchant tailor of London, 10 shillings. To George Latham, their son, my feather bed, flock bed, boulster and rugs. To Catherine Madoxe, daughter of the said George Johnson, 10 shillings and all my pewter. To Mr. Edward Steney, Clerk, 10 shillings. To my young curate of the parish where I now dwell, 10 shillings. To the poor of the parish 10 shillings. To the eldest son of my deceased sister Alice, 20 shillings. To my kinsman William Radley 40 shillings. To Winifred Latham, daughter of William Latham, 10 shillings. To Rebecca Sayers, 10 shillings. The residue to my cousin Peter Hynde & Katherine Johnson, wife of George Johnson, whom I make executors.

Page 798, Will of Ann Quinsie, of Wigstrapp, in the parish of Lilliforf, in the County of Northampton, widow, dated 29th January 1630, proved 6th April 1631, "My four daughters: Annie Hilles, Ellen Binge, Alice Roodings & Christian Munners."

Page 202, Will of Nathaniel Hulton, citizen and Salter of London, dated 20th July 1692, proved 13th March 1693, with three codicils, last of which was dated 1st January 1693, "Kinsman John Hill; (and) Nathaniel Hill, son of Edmund Hill, deceased; Kinswoman Elizabeth Hill." In the last codicil he makes a bequest of 100 pounds to Mr. Encrease Mather, minister of the Gospel in New England for the use of the College (Harvard) there of which he is President.

Page 103, Edward Hill, witnesses to the will of Thomas Stegg Esq., of the County of Henrico in Virginia, dated 31st March 1669-70, proved 15th May 1671, Edward Hill was a Member of the Council.

Page ???, Will of John Hill of London, merchant, dated 14th December 1665, proved 8th February 1687. "To wife Sarah 1000 pounds. To daughter Sarah 1000 pounds, and a sliver bason. To daughter Elizabeth 800 pounds and a sliver sugar box. Wife

now great with child. If it proves (to be) a son, then he is to have land and tenements in Winthorpe and Croft, and elsewhere in Lincolnshire, of the yearly value of 24 pounds and 600 pounds in money. Whereas my brother Valentine Hill, late of New England, deceased, did owe me at the time of my (sic) decease, above 300 pounds, not yet satisfied, I give and bequeath the said debt unto the children of my said brother Hill, and to the children of my brother in law, Mr. Thomas Cobbett, to be equally divided amongst them, share and share alike. To my niece Bridgett Cobbett, 5 pounds. To cousin Garrett's children 10 pounds, to be equally divided amongst them. To cousin Thomas Browne and his wife, 40 shillings for rings. To cousin John Browne 40 shillings. To brother Hutchinson and sister each 40 shillings and cousin Elizabeth Meredith 20 shillings to buy rings. To brother Nathaniel Hunt and brother Robert Hunt, each 5 pounds. To brother in law John Miles and to his wife, each 5 pounds, and to their son John Miles 5 pounds. To my maid servant Prudence 40 shillings if dwelling with me at the time of my death. To my cousin (cousins?) Charles, Margaret & Katherine Watkins, each 20 shillings for rings. To the poor saints in London, 10 pounds to be distributed at the discretion of my overseers. To the poor of the parish where I now dwell, 40 shillings. The residue to my wife Sarah, who is appointed executrix. Friends, Mr. William Allen, Mr. William Sawyer, Mr. Robert Wakeling, overseers. Witnesses Nathaniel Hunt & Charles Watkins.

(NOTE) Valentine Hill was extensively engaged in Real estate and other transactions in Boston, Lynn, Rumney Marsh, Dover, Oyster River and Pascataqua River, between 1637, when he was in Boston and 1660. In 1651 he conveyed to Mr. Thomas Cobbett, of Lynn (Mass.?), styled "Clarke," afterwards minister of Ipswich and other, all grants of land made to him the said Hill, by the town of Dover, at Oyster River, and the saw-mills erected on them. (From Suffolk Deeds & Wentworth Genealogy, and Vol. 7 of the Register, Page 49).

Page 83, Elizabeth Hill, witnessed the will of Elizabeth Hailes of Lower Shadwell, in the parish of Stebunheath alias Stepney, in the county of Middlesex (England) widow, dated 28th September 1664, proved 22nd march 1664.

Page 238, Jane Hilles (Hill), witnessed the will of Elizabeth Adams, of the parish of Rederith (Rotherhithe) in the county of Surry (England), widow, dated 10th December 1660, proved last December 1660. (She apparently died after 10th of December and before 31st December 1660).

Page 785, Will of Paul Mercer, of Southampton, merchant, dated 6th June 1661, codicil dated 7th June 1661, proved 9th September 1661, mentions "Jane, now the wife of John Hill, and daughter of my brother Francis Mercer."

Page 58, John Hill, witnessed the codicil of the will of David Raswon, citizen & merchant tailor of London, dated 15th June 1616, codicil dated 27th November 1617, proved 25th February 1617.
