Page 449, At the Court of 1746 one of the titne-takers appointed for Lunenburg Co., Va. was William Hill.

Page 468, Elizabeth Underwood married Dr. James Taylor, but in 1655, she asked separation of the Governor and Council, to go and live with her mother. Dr. Taylor died, however, on the 1st May 1655 and his estate came up for settlement, and Mr. Slaughter in right of his wife, asked for his one-third of the estate. The returns were made by Major Nicholas Hill and Lawrence Baker, with James Mason and William Batte as witnesses or bondsmen. (Va. Magazine, Vol. 38, Page 270).

Page 493, John Hill and others were named on a committee to select site for the first courthouse of Tryon Co., NC. and made a report on 26th July 1774.

THOMAS FAMILY OF VIRGINIA

Page 609, William (Ap) Thomas, who died leaving a will in Elizabeth City County, immediately below York County, at the end of the peninsular, also came to York County, but in 1648 he patented 335 acres in Elizabeth City County, 100 acres of which he had previously purchased from Major Nicholas Hill, who had lived there, a close neighbor to Thomas Watts and the Thomas Family, before he moved to Isle of Wight County.

Elizabeth Hill married William Thomas. William (Ap) Thomas was perhaps a cousin of John, William, Richard & Phillip Thomas, and who used the prefic "Ap" in signing his name, a throw-back to the Welsh origin of the Thomas Family. It was dropped by his children and grandchildren.

John Robinson, of York Co., was made overseer of the will of William Ap Thomas, and his daughter Anne Thomas, married into the Parsons Family of York Co. He had also purchased lands in York County from William Hampton, many of whose descendents moved to Isle of Wight County, and intermarried with the related families of the other Thomas tribe of Queen's Creek, who followed in the wake of the Marshalls and Major Nicholas Hill and others.

Page 611, Richard Hill, was a headright of Joseph Croshaw of Queen's Creek, York Co., on 27th February 1649.

Page 612, Thomas Hill, John Hill & Nicholas Hill apparently were brothers (Nugent's, Page 353) and were kinsmen of the

Blands and Bennetts. Thomas Hill perhaps lived in James City or York County. His brother Nicholas, who married Silvestra Bennett, lived in Elizabeth City County (Nugent, Page 175), but later moved to Isle of Wight County, where he died, leaving a will in 1674.

John Hill settled in Lower Norfolk County, at Sewell's Point, where he was a neighbor of Cornelius Lloyd, John Norwood & the Bennetts. His son John Hill became Sheriff and was accused of persecuting the Quakers or dissenter. John Hill died ca. 1647, and his brother Thomas Hill, was his administrator (Nugent Page 172).

But among the persons whose headrights had been acquired by John Hill Sr. were those of Nicholas Smith (later a Burgess) and John Marshall, father of Humphrey Marshall (Nugent page 172).

John Hill, who used the headrights of John Marshall, father of Humphrey Marshall, had a son Robert Hill, who married Elizabeth Thomas (daughter of William Thomas) and a sister of Priscilla Thomas who m. Humphrey Marshall.

Page 8, William Thomas, was the brother of Priscilla Thomas, who married Humphrey Marshall. Robert Hill and his wife Elizabeth Thomas, had a son Thomas Hill, who married Mary Marshall, the daughter of Humphrey Marshall & Priscilla Thomas.

Then William Thomas, brother in law of Humphrey Marshall & Robert Hill, became the son in law of Nicholas Hill, uncle of Robert Hill (who m. Elizabeth Thomas) and John Hill, the old Sheriff of Lynhaven Parish in Lower Norfolk Co., below the Bennett settlement.

It will be noted that John Hill Sr., who patented lands in the Tanner's Creek settlement in Lower Norfolk (Nugent Page 172) used the headrights of both John Marshall and Nicholas Smith. The fact that Humphrey Marshall, son of John, in his old age, married Anne, the widow of this same Nicholas Smith, is ample evidence that Humphrey Marshall was probably a grown man or nearly so, at the time of this patent in 1646. He may even have been married then to Priscilla Thomas, because they had grandchildren by or around 1660, born to their daughter Elizabeth, who had married Richard Thomas, son of John Thomas.

Page 623, William Thomas married Elizabeth Hill, the daughter of Nicholas Hill & his wife Silvestra Bennett. Elizabeth Thomas, their daughter, married Robert Hill, and one of their sons, Thomas Hill, married his cousin Mary Marshall, the daughter of Humphrey Marshall and his wife, Priscilla Hill.

PAGE 507, Silvestra Bennett married Nicholas Hill in Isle of Wight Co., Va. The Bennetts, Thomas, Jordans, Bressies & Harrisons intermarried with the Hill Family of Isle of Wight Co., Va.

PAGE 508, In 1701 Mrs. Silvestra Hill deeded lands to William Thomas, adjoining Thomas Day, in Isle of Wight Co. William Thomas had married a daughter of Mrs. Hill, named Elizabeth Hill.

Page 628, Teresa Thomas, daughter of John Thomas (b. 1704-05) and his wife Christiana Roberts, married Theophilus Hill and had 5 known children, of which only two are known for certainty: a son Lodovick & a daughter Ann. (SEE ANDREA COLLECTION IN S.C. DATA DISK, ITEM 3 85.).

1. Son, Lodovick (Ludwick) Hill, b. 1765, d. 27th July 1822 in Edgefield County, South Carolina, who married Susan Grigsby and who was a Revolutionary Soldier. They had following children: Teresa, Sarah, Ann, Polly & a son Theophilus Hill, who' wife was also named Susan.

Theophilus Hill & wife Susan had: Henry Hill, Rhydon Grigsby Hill & Lodovick (Ludwick) Hill Jr.

2. Ann Hill, b. 6th June 1787.

There were three other daughters of whom there are no names nor records.
