THIS INDENTURE made the Twentieth day of October in the year
of our Lord One Thousand Seven Hundred and Fifty Six (1756)
BETWEEN JOHN ROBERTSON and MARY, his wife of Turs Parish and
County of Fairfax in Virginia of the one part and JOHN
CARGILL of the County and colony aforesaid of the other part
WITNESSETH that the said JOHN ROBERTSON and MARY his wife for
and in consideration of the sum of Five Shillings, to them in
hand, paid by the said JOHN CARGILL at or before the
Ensealing and Delivery of these Presents, the Receipt whereof
is hereby acknowledged, hath granted, bargained and sold and
by these presents doth grant bargain and sell unto the said
JOHN CARGILL all that tract or parcel of land containing one
hundred and twenty and three acres (123 acres) situate and
being in the county of Fairfax in Virginia and bounded as
followeth BEGINNING at a white oak corner of the said JOHN
ROBERTSON'S and Baxter Simpson's land and extending thence
South 4 degrees East 31 (poles) to a white oak corner of
Thomas Simpson, thence South 10 degrees West 64 (poles) to a
white oak corner of Simpson's and Tilletts (lands?) thence
South 26 degrees East 44 (poles) to (a? or 2?) Red Oak corner
of James Roberts (land) thence East Eighty Six poles (86
poles) to a Red oak on the side of a branch of Sandy run
thence North 76 Degrees East 32 (poles) to a white oak on the
South side of Turley's Rolling Road thence North 65 degrees
East 52 (poles) to a Black Oak on the South side of the
(said?) Road thence????

RECEIVED of Mr. JOHN CARGILL the consideration money
mentioned in the written deed being the sixteen pounds nine
shillings current money received by me this Twenty First
(21st) day of October One Thousand Seven Hundred and Fifty
Six (1756).

release and receipt which are ordered to be recorded.

Comments by Robert R. Hill on March 11, 1991:

This shows that John Robertson 4/ was alive at this time and
must have died between this date and January 1763, when his
widowed wife Mary, his 3 sons, John 5/, William 5/ & Henry
Robertson 5/, along with his step-son Thomas (Regulator)
Woodward 2/ and his 6 children, (two sons John & William) and
4 daughters all came to S.C.
