The Following is a Abstracted copy of the above, taken from "Deed Abstracts of Fairfax County, Virginia, 1742-1750" by June Whitehurst Johnson.

It is a classic example of not copying the document exactly as is, thus omitting very important data.

Witnesses: George Mason William Thompson

Received of Lawrence DeButts sum of 4150 pounds tobacco, 52 shillings and 9 pence.

At Court 18 July 1734, Lewis Elzey & Mary his wife, acknowledges this release with receipt endorsed as also a bond to Lawrence DeButts.

Note: Mary Simpson, was first married to Thomas Baxter Sr. Her second marriage was to Walter Griffin Sr. and she is not

to be confused with the above wife of Walter Griffin Jr and Lewis Elzey.

Page 309-310 LEWIS ELLZEY and MARY, husband and wife of Parish of Truro, are held and firmly bound unto Lawrence DeButts of Hamilton Parish in 80 pounds sterling June 19, 1734. The condition of this obligation is such that the above bound LEWIS ELLZEY and MARY his wife, by indenture of lease and release granted unto the aforesaid, a certain tract of land in Truro Parish, shall observe all convenants and agreements which they ought to be observed mentioned in the indenture of release according to the true intent of that indenture then this obligation (is to) be void otherwise to be and remain in full force and virture.

LEWIS ELLZEY MARY (x) ELLZEY her mark

Witnesses: George Mason William Thompson

At Court July 18, 1734 Lewis Elzey and Mary, his wife, acknowledged this bond to Lawrence DeButts.

NOTE BY ROBERT HILL: It should be noted that Mary, the wife of Lewis Elzey, is the same woman who was first married to Walter Griffin Jr. (born ca. 1695-1700) and is not, repeat not, the same woman named Mary, who appears to have been his step-mother, or the 2nd wife of his father Walter Griffin Sr.

That woman was Mary Simpson, who was first married to Thomas Baxter Sr. and then later remarried Walter Griffin Sr.

When Walter Griffin Sr. died, his son Walter Griffin Jr. apparently inherited 409 acres of land, since he was the eldest son. Benjamin Griifin, brother of Walter Griffin Jr., had died, and having no heirs, Walter Griffin Jr. left the land to his sister, Elizabeth Griffin, who had married William Hogan.

Elizabeth Hogan then gave the land to her step mother, Mary Griffin, who remarried to Lewis Elzey. Lewis & Mary Elzey then sold the land in 1734.

Reference to Lewis Elzey (Ellzey): A deed states he was son of Thomas Elzey, who died after 1716. Another (older) Thomas Elzey, father of above mentioned Thomas, died in 1699.

Note: Was this John Simpson the grandfather or brother or uncle of MARY SIMPSON (m. John Woodward)? She was daughter of Thomas Simpson, son of John Simpson. Her father Thomas Simpson died in 1733-34. This is probably her brother.

November 1742, N. Neck Grants, by Gray 1742-1775, Page 1 Grant Book F, Page 9 Joseph Jacobs of Prince William County, 114 acres in said county on Sandy Run, adjacent Col. Carter, THOMAS SIMPSON and John Truley.

November 1742, N.N. Grants by Gray, Page 1 Grant Book F, Page 20 JOHN ROBERTSON of Prince William County, 235 acres in said county, adjacent THOMAS SYMPSON (SIMPSON), Bond Veal, John Turley, James Roberts, Samuel Tillett. Note by R. Hill: John Robertson was the 2nd husband of Mary Simpson, daughter of Thomas Simpson and his 1st wife Elizabeth (Libby) Baxter. Mary's first marriage was apparently to John Woodward and they were the parents to my 5th great grandfather, Thomas (The Regulator) Woodward, born ca. 1729 in Fairfax County and died 12th may 1779 in S.C.

John Woodward with John Wheeler signed deeds for Dennis McCarty, recorded in Prince William County Deed Book A, 1731-1732 and 1732-1735.

FOLLOWING FROM ORDER BOOK ABSTRACTS OF PRINCE WILLIAM COUNTY, VIRGINIA (1753-1757) BY SPARACIO

Page 81, (Prince William Order Book 1755-1757, Page 8, dated 27 October 1755)

Deeds of Lease Release and Receipt Endorsed from JOHN SIMPSON to JAMES HALLEY were proved by the oaths of JAMES HALLEY JR, WILLIAM WILKERSON, and RICHARD SIMPSON witnesses thereto and admitted to record.

Recent research by Mrs. Jean Holley Day on the Simpson family has found (so far) that the first (known) member of this family was JOHN SIMPSON (Number 1). Based on court records of deeds, grants etc, his birth is estimated to have been between 1625-30. He died in Stafford County, Virginia ca. 1689. His wife was named ANN (Fleet's, p.124).

It is known that John and Ann Simpson had a son JOHN SIMPSON JR. (Number 2), who was born during the 1650s, and a daughter MARY SIMPSON, also born in the 1650s. JOHN SIMPSON JR., is believed to have died in Stafford County ca. 1705 or very shortly afterwards, because his name cannot be found on any of the court records after that year. His wife was named MARY.


The daughter, MARY SIMPSON, married 1st Thomas Baxter Sr., and at the death of THOMAS BAXTER SR., she married the second time to Walter Griffin (Sr.). In 1703, Walter Griffin Sr. gave an account to the courts of the Estate of Thomas Baxter Sr. (deceased). The reason for this accounting by Griffin to the courts was his marriage to Mary Simpson Baxter, the widow of the deceased Thomas Baxter Sr., and the mother of her son (his step son) Thomas Baxter Jr., who was

still and a minor, when his father died.

Court records, land deeds etc in and around Prince William and Stafford Counties, shows that the BAXTER-SIMPSON families were closely related, probably due to the above Simpson-Baxter marriage. However it appears there were later marriages as well as friendship between the two families. They also were close to BURR HARRISON FAMILY.

THOMAS BAXTER SR. and his wife MARY SIMPSON, are known to have had a son THOMAS BAXTER JR., born ca. 1681/82, and a daughter ELIZABETH BAXTER, born ca. 1682-84. ELIZABETH BAXTER apparently married her first cousin, THOMAS SIMPSON ca. 1705, son of JOHN SIMPSON (The 2nd) and his wife MARY.

The following chart, while no means complete, shows the Simpson Family and its connection (by marriage) to the Baxter



A. John Simpson Jr. (son of John Simpson/John Simpson. He was born ca. 1680 and died between 10th May 1756 when will was wrote and 10th August 1756 when the will was proven in Stafford County, Va. He was married twice, 1st to Mary ---?, and 2nd to Silent Johnston (possibly widow Jeffries) on 17 August 1740 (Ref. Overwharton Parish Records). He mentioned in his will an Alexander Simpson but does not specify the relationship. He is believed to be a son.

B. Thomas Simpson Sr. (son of John Simpson/John Simpson. He was born ca. 1683 and died in late 1734 or very early in January of 1735. (Will dated 13 October 1734, proved 19 January 1735. He was married twice. His first marriage is suspected to have been to his cousin, Elizabeth (Libby)

Baxter, daughter of Thomas Baxter Sr. and Mary Simpson, (daughter of John Simpson, the 1st, and wife Ann Simpson). At the death of his 1st wife, Thomas Simpson Sr. married a second time to a woman who's name is known only as Jane. When Thomas Simpson Sr. died ca. 1733-34, she remarried a second

time to John Herguson or Ferguson. (Note: His will is dated 13 October 1734, proved 19th January 1734. Obviously this is wrong and the date it was proven was probably 1735. Ref: Prince William County Will Book C, pages 16-18).

His children (all by 1st wife) were:

- b. Mary Simpson, b. 1708-10, married ca. 1728 to 1st John Woodward, 2nd to John Robertson.

C. George Simpson (son John Simpson/ John Simpson. He was born ca. 1686 in Stafford County, Va. and died ca. 1750 in Stafford County, Va. Wife was named Margaret. Records of Overwharton Parish shows children Priscilla Simpson 4/, born 26 September 1744, Susannah Simpson 4/, born 28 January 1748, both daughters of George & Margaret Simpson. If indeed these are his children, then George Simpson would have been between the ages of 58 and 62 when the above were

born.

D. Ann Simpson (daughter of John Simpson/John Simpson. Her birth was ca. 1689 in Stafford County, Va., and she died in Loudoun County, Virginia in 1769. She was married to John Gist. In Tylers' Quarterly, Vol. XXI, Page 60-61, there is a deposition taken from "Mrs. Ann Gist, wife of John Gist, aged about 80 years or thereabouts, taken 23 May 1769 in Loudoun County, Virginia" in which she states she is the daughter of John Simpson, Scotsman.

E. Richard (Withers?) Simpson Sr. (son of John Simpson/John Simpson 1/. Richard was born ca. 1692 in Stafford County, Va.. In a deposition of Catherine Halley, taken in Fairfax County, Virginia on 7 August 1790 (Tyler's Quarterly, Vol. XXI, Page 6) she says that John Simpson intermarried with her mother and that she heard him say many times that he had brothers named Thomas, George and Richard and that Richard was the youngest brother. Richard made his will on 19th September 1761 and it was proved 21 December 1762. He was married ca. 1714 to a widow, Sarah Barker. She died in Aug. 1766 in Fairfax County, Va. (Will).

First, we know that Mary Simpson (sister of John Simpson, the 2nd, and the father of the within named Thomas Simpson) married Thomas Baxter Sr. At his death, Mary Simpson Baxter re-married the 2nd time to Walter Griffin Sr., who was the father of Walter Griffin Jr, Benjamin Griffin (said to be deceased) and Elizabeth Griffin, who is believed to have been previously married to a Halley and had re-

that Walter Griffin Jr. had given life time rights to Thomas Simpson for this entire 315 acres BUT in his will, he devised that AFTER the death of Thomas Simpson, the land was to go to his sister Elizabeth Griffin, now married to William Hogan, except for 100 acres, which he left to James Halley. This seems to have actually been Walter Griffin Jr. Third, due to the fact that a Walter Griffin Jr. left the 100 acres to James Halley, indicates a close relationship between the two. I am of the opinion that this was Walter Griffin Sr., who's daughter Elizabeth, was probably married to James Halley, and upon his death had re-married William Hogan. Fourth, if I understand Mrs. Jean Holley Day correctly, Mary Simpson Baxter Griffin would have been the great aunt of Elizabeth Simpson Halley, (wife of James Halley) thus perhaps the reason why James Halley could have referred to Walter Griffin (Sr.) as "uncle" in a later land deed.

Richard Simpson of Fairfax Co., Va. married Ann Lucas. He is a 4th generation and it was his son Richard Simpson 5/, who married his first cousin Susannah Simpson, in Caswell Co., N.C., SO ---one can recognize by the generation numbers that he IS NOT THE SON OF RICHARD SIMPSON JR. 3/, and his wife, Mary Kincheloe of Caswell County, N.C. Many researchers tend

to go off balance at this point. Their son RICHARD DUKE SIMPSON (III) 4/, married Henrietta Williams, (daughter of Col. John Williams & Betsey (Williamson) Williams. This Col. John Williams is neither the Judge nor the lawyer. Again, researchers go off kilter at this point. My Simpson's have proven to be an intriguing research as they had ELEVEN sons-in-laws!
