Proven by oath of James Long before John Cook, 16 Aug 1794. Recorded 23 Oct 1794.

[894] I, 223-224, 20 Jun 1776, John Splawn and Sibera his wife of Craven County to Babel Hutton of same for £250, 200a on a branch of Wateree Cr, originally granted to sd John Splawn 20 Mar 1765. /s/ John (his mark) Splawn. Wit: Mubrey (X) Hellems, Joseph (his mark) Hellems. Proven by oath of Mubrey Hellems before D. Evans CFC. 16 Oct 1794. Recorded 24 Oct 1794.

[895] I, 224-225, 8 Apr 1794, John Cameron and Sarah his wife of Fairfield County to Robert Gibson of same for £20, 100a on Brushy fork and Hoffmans Cr of Little R of Broad R, adj. Ellison and Jno Cammeron, part of 703a granted to sd Jno Cameron 7 Jan 1788 and recorded in grant book WWWW page 193. /s/ Jno Cammeron, Sarah Cammeron. Wit: Staff'd Curry, Alex'r Dickey, Margaret (her mark) Ross. Proven by oath of Stafford Curry before John Turner JP, 11 Oct 1794. Recorded 24 Oct 1794.

[896] I, 226, 21 Jan 1794, James Hindman planter of Fairfield County to Morris Weaver planter of same for £10, 11a, adj. lands commonly known by the name of James Frurris[?] and Christopher Huffman, part of a tract of 650a originally granted to John McMorris and conveyed by sd McMorris to Christopher Huffman. /s/ James Hindman. Wit: H. Milling JP, David Milling. Recorded 25 Oct 1794. Note: This deed includes a plat.

[897] I, 227, 7 Sept 1793, Michael Riley planter of Fairfield County to Morris Weaver planter of same for £15, 133a on the branches of Jacksons Cr, adj. Thomas Woodard and Robert Hainning, being the third part of a survey of 400a granted to John McBride 31 Aug 1774. /s/ Michael Riley. Wit: H. Milling JP, Robt Milling. Recorded 25 Oct 1794.

[898] I, 228-230, 13 Sept 1794, William Powell planter and Mary his wife of Fairfield County to John Finley planter of same for £100, 150a on the N side of Broad R on Buckhorn branch, adj.
